Mayor Garcetti launches America's first public-private partnership for transportation innovation



Mayor Eric Garcetti today announced the creation of Urban Movement Labs, a first-of-itskind public-private partnership that will work to accelerate transportation innovation across Los Angeles. This unprecedented venture will focus on creating more ways for Angelenos to get around — by bringing stakeholders to the table to develop new ideas, safely testing them on L.A.'s streets, and rolling them out in close partnership with local communities. "Angelenos don't wait for the future — we guide it," said Mayor Garcetti. "Urban Movement Labs will secure L.A.'s standing as the transportation innovation capital of the world — a place where new technologies are tested, proven, and brought to life, and people in every community have a seat at the table today as we think about what our city will look like tomorrow."

Urban Movement Labs (UML) is the latest initiative led by Mayor Eric Garcetti to ensure a sustainable, equitable, and accessible future for transportation in Los Angeles. It will empower a coalition of public and private sector partners, non-profit organizations, academic experts, and local residents to design and deploy creative solutions to the city's critical transportation challenges.

In its first year, UML will work with local communities across L.A. to confront major issues affecting daily life. That includes providing better transportation options to L.A.'s residents and 50 million annual visitors; easing commutes across the region; and converting underused transportation assets into affordable housing.

Beyond working with residents to tackle these immediate challenges, UML will be built around three core initiatives:

- 1. The Ideas Accelerator: UML will identify current challenges, match solutions to each of them, then develop pilot programs to test ideas on L.A.'s streets.
- P. The Economic and Workforce Development Initiative: UML will be laser-focused on one of Mayor Garcetti's top priorities: developing a pipeline of businesses and good-paying jobs for the local workforce.

3. The Urban Proving Grounds Initiative — UML leaders, partners and community members will identify and vet a network of L.A. neighborhoods where solutions can be tested, evaluated, scaled to size, and eventually deployed.

Founding partners of UML include Mayor Eric Garcetti's Office of Economic Development, the Los Angeles Department of Transportation, Los Angeles World Airports, the Port of Los Angeles, Avis Budget Group, the L.A. Cleantech Incubator (LACI), Lyft, Verizon, and Waymo.

"Through our rental car and Zipcar brands, we operate at the intersection of urban mobility and travel and tourism and know the importance of convenient, efficient and sustainable movement of people in, out and around cities," said Arthur Orduna, Chief Innovation Officer, Avis Budget Group. "It's a unique opportunity to be part of this deep public-private partnership and we're excited to leverage UML as the platform to put real transportation solutions into place with the City of Los Angeles as a global stage for mobility innovation."

High-Speed Rail Authority Completes Environmental Clearance into Bakersfield

The California High-Speed Rail Authority (Authority) issued the Record of Decision for the final 23-mile route between Shafter and Bakersfield in the Central Valley. This completes the state's environmental review process between Fresno and Bakersfield and allows the Authority to move toward project construction into Bakersfield. This is the first major environmental action taken under the State's newly granted federal National Environmental Policy Act (NEPA)

and further emphasizes the Authority's commitment to accelerate the project under new executive leadership.

"I'm proud of the collaborative and cooperative effort that went into this process. Together with our local partners, we are prepared to move forward on project implementation into Bakersfield in a manner beneficial to the project, the city and the county," said Authority CEO Brian Kelly. "We look forward to a con-

In order to finalize this environmental document and gather comprehensive feedback, the Authority held over 100 stakeholder meetings, 17 additional public and technical working group meetings, and 15 monthly regulatory agency coordination meetings.

The section receiving clearance extends from Shafter east towards State Route 99 and the existing Union Pacific Railroad tracks, then southward into Bakersfield, ending at a station location at F Street in downtown Bakersfield. This builds upon analysis done previously in the region, narrowing down the specific alignment route that was most amenable to the local communities.

The document released today is a Final Supplemental EIS under NEPA. The document evaluates potential environmental effects of the Locally Generated Alternative, the alternative developed through city and state collaboration. The associated federal approval document also issued today is a Supplemental Record of Decision. This federal approval is similar to the action the Authority's Board of Directors took in October 2018 under the state's California Environmental Quality Act (CEQA) for this project segment.

The Supplemental Record of Decision signed by CEO Brian Kelly and issued today is the first of several environmental documents expected to be released within the next 12 months. In 2020, the Authority will release all six remaining draft environmental documents for public comment, on a schedule to complete the process (via Records of Decision) well ahead of the federal grant completion deadline. Such actions will keep the Authority on track to complete environmental clearance on the full 520-mile project which runs from San Francisco to Los Angeles/Anaheim.

2020 Census and the Digital Divide

California's digital divide remains a big issue given that next year's Census will be digital for the first time. Many barriers already prevent an accurate census count among the 15 million Latinos who make up 39 percent of California's population. This digitalization could result in an undercount of the Latino population, loss of resources, and investments needed for economic development in the next decade.

Internet access is key to improved childhood academic performance, faster job acquisition, and better access to public services. However, in California, over 45 percent of very low-income households lack internet access, and this disproportionately impacts communities of color. Latinos in particular face a disadvantage because only 68 percent of Latino households are connected to the internet. These disparities worsen among monolingual Spanish speakers, of whom only 57 percent have internet access at home. Closing this gap — known as the digital divide — is more important than ever given that the 2020 Census will be the first-ever digital census.

Many barriers already prevent an accurate census count among the 15 million Latinos who make up 39 percent of California's population. These barriers include English proficiency, concerns about data privacy and confidentiality, distrust in all levels of government, and the one least addressed: the digital divide. These barriers particularly affect the five million Latinos who live in hard-to-count tracts in California. which puts them at risk of being ignored. Ensuring everyone is counted is pivotal to having a government representative of its population.

The U.S Census determines the number of seats for each state in the U.S. House of Representatives. Census results are used to draw congressional and state legislative districts and distribute more than \$675 billion in federal funds across the nation. Earlier this year, the Supreme Court blocked the administration from asking people about their citizenship status in the 2020 Census. In my own home, my family considered not participating had the question been included

While this court decision marked a win for our communities, California's digital divide remains a big issue given that next year's Census will be digital for the first time. This digitalization threatens our Latino communities because we are the population least connected to the internet. Failure to acknowledge this gap could result in

an undercount of the Latino population, loss of resources and investments needed for our economic development in the next decade.

Next year, the 2020 Census questionnaire will be available online, through paper forms, and by phone. A person will have the option to respond online through a computer, tablet, or smartphone. According to Adán Chávez, Regional Campaign Manager in the Inland Empire for the NALEO Educational Fund, members of the Latino community are unaware that this will be the first-ever digital Census. He aims to increase awareness of the different ways to respond and to engage the youth who will play a critical role in filling out the questionnaire for parents who lack digital or literacy skills. According to a survey from the California Emerging Technology Fund, 18 percent of Latinos are only connected to the internet through a smartphone - an aspect of the digital divide many don't think about; hence while a smartphone is no substitute for home broadband, it's better than nothing, so informing the community of this alternative can be a viable option for those without a computer at home.

Governor Gavin Newsom committed \$187 million dollars in census outreach efforts, his administration along with community-based organizations must strategize to ensure adequate funding for regions where high percentages of Latinos lack internet access. For example, In San Bernardino County, 34 percent of the current population lives in hard-to-count neighborhoods and, as of the middle of this decade, 96,801 households had either no home internet subscription or dial up-only. The Inland Empire is also the region least connected to the internet and therefore 2020 Census outreach campaigns must target those households. Undercounting traditionally hard-to-count populations because of the digital divide could shift representation and funding away from poorer areas with larger communities of color and toward wealthier and less racially and ethnically diverse parts of the state.

As 2020 approaches, let's share with our families, friends, and community the importance of being counted and make next year's census one of our historic years by making our presence known and felt in California and throughout the nation

Digitalization versus an accurate count

How the 2020 Census will invite everyone to respond



Every household will have the option of responding online, by mail, or by phone.

Nearly every household will receive an invitation to participate in the 2020 Census from either a postal worker or a census worker.

95% of households will receive their census invitation in the mail.

Almost 5% of households will receive their census invitation when a census taker drops it off. In these areas, the majority of households may not receive mail at their home's physical location (like households that use PO boxes or areas recently affected by natural disasters).

Less than 1% of households will be counted in person by a census taker, instead of being invited to respond on their own. We do this in very remote areas like parts of northern Maine, remote Alaska, and in select American Indian areas that ask to be counted in person.

Why Government Loans?

For-profit lenders are reluctant to issue loans to anyone who does not have a strong credit report balance. These loans can be applied to a number of uses, such as:

- Purchase of new equipment, machinery, parts, supplies, etc.
- Financing leasehold improvements
- Commercial mortgage on buildings
- Refinance existing debt
- Establishing a line of credit

Government small business loans benefit both small businesses and the lending agency. For small businesses, it is beneficial because this is money & capital they may not have access too. For banks, the loan's risk is decreased due to the loan being backed by the SBA.

Different SBA Government Loans

The SBA extends financial help through various lending programs it has to offer. Some of the more popular loans are:

- 7(a) Loan Guarantee Program: aimed primarily in helping a small business start or expand its services. The maximum size of such a loan is \$5 million.
- MicroLoan Program: mostly used for shortterm purposes, such as purchase of goods, office furniture, transportation, computers, etc. The maximum amount is fixed at \$50,000.
 - 504 Fixed Asset Program: featuring fixed-rate and long-term financing, these loans are aimed at applicants whose business model will benefit their


