The latest data from the US Census Bureau has given us fresh insight into the landscape of employer businesses, revealing that, among the approximately 5.9 million employer firms in 2021, a significant portion were owned by veterans, women, and minorities.

Looking deeper into these statistics reveals an interesting trend: Veteran-owned businesses are outperforming their counterparts in several metrics by significant amounts.

#### **Gleaning Meaningful Information From the Data**

The performance of a business can be gauged in various ways, from revenue generation to employee satisfaction.

When comparing one business to another, it can be useful to observe how much they are able to

produce (receipts) using how much employee labor (number of employees), and how well that labor is compensated, as it can reveal exploitable trends

Through this lens, a business owned by a veteran will, on average, drive higher revenues using fewer employees who each take home significantly more than a business in any of the other categories.

Regarding revenue per employee, veteranowned businesses take the lead, driving nearly \$280,000 annually, indicating veterans tend to get greater performance per employee.

Furthermore, in examining payrolls, these businesses also offer higher salaries to their employees, with an average of \$54,520 per year. This figure is a significant 14.6% higher than the runner-up category: women-owned businesses.

#### Reasons Veteran-Owned Businesses Perform Well

Why do veteran-owned businesses perform so exceptionally well? A plausible reason lies in the rigorous military training veterans undergo. This training isn't just about physical endurance; it equips them with skills directly transferable to the business world.

The strategic planning, logistical expertise, risk management, leadership, and impeccable execution learned in military contexts often translate into business acumen, resulting in efficient and profitable operations.

In comparison, while women-owned businesses contribute substantially to the economy, they tend to generate lower annual revenue per employee, at an average of \$200,000. Their payroll figures are also lower, averaging \$47,560 per employee per year.

Despite these lower metrics, it's essential to recognize the sheer number of women-owned businesses as driving at least part of that divergence.

They significantly contribute to bigger-picture employment opportunities, albeit with lower average wages.

Moving beyond the statistics, it's imperative to discuss avenues where these businesses, especially minority and veteran-owned, can thrive even more. One such avenue is commercial real estate (CRE).

#### Commercial Real Estate: An Untapped Opportunity for Diverse Business Owners

The commercial real estate landscape is evolving, with an increasing recognition of the value of diversity. Historically, CRE has been a domain with limited representation from minorities and veterans.

However, with the industry beginning to acknowledge the richness, innovation, and problem-solving capabilities that diverse perspectives bring, doors are quickly opening.

Success stories of individuals from diverse backgrounds in CRE are starting to emerge, emphasizing the immense potential for minority and veteran-owned businesses in this field.

For instance, there have been accounts of Black American women making significant strides in CRE, navigating through the challenges and setting benchmarks for others to follow.

However, the journey toward inclusivity in CRE is far from over. Even as momentum builds, there's a need to further diversify the industry. The advantages of doing so are multi-fold, and

## At APEC, Governor Newsom Highlights California's Low-Carbon, Green Growth Economy

Governor Gavin Newsom and First Partner Jennifer Siebel Newsom met with world leaders at the Asia-Pacific Economic Cooperation (APEC) summit in San Francisco to promote economic development and trade, as well as advance climate action and strengthen ties between California and the broader Asia-Pacific region.

Leaders from APEC's 21 member economies have descended on San Francisco this week for a pivotal summit focused on trade and economic development. At a welcome reception hosted by San Francisco Mayor London Breed, the Governor joined President Biden in welcoming world leaders to California

Australia: Governor Newsom and First Partner Siebel Newsom met with Australian Prime Minister Anthony Albanese and The Honorable Dr. Kevin Rudd AC, Australia's Ambassador to the United States. The Governor and the Australian delegation adopted a work plan for the Memorandum of Understanding (MOU) signed by California and Australia earlier this year and discussed priorities for year one of the partnership and ways to keep the momentum going on climate action and collaboration.

Canada: The Governor and First Partner caught up with Canadian Prime Minister Justin Trudeau to talk about progress made on the climate partnership California and Canada launched last year. Specifically, the Governor and Prime Minister discussed implementation of the 2022 climate Memorandum of Cooperation (MOC), which has focused on several priority areas: ZEVs, methane, carbon capture, wildfire and forest resilience, and green shipping and aviation. They also discussed California and Canada's strong economic and trade relationship.

**Singapore**: Governor Newsom and the California delegation participated in a bilateral meeting with Singapore Prime Minister Lee Hsien Loong. The meeting centered on advancing bilateral relations, including on trade, economic development, and climate cooperation.

**United Kingdom**: Governor Newsom and First Partner Siebel Newsom met with UK's Secretary

### We Need to Talk about Nonprofit Job Quality More

"When I was a nonprofit Executive Director in San Francisco in 2017 I made \$80,000. Raising my salary wasn't a priority for me; it would mean more fundraising and funds were better spent elsewhere. But that also meant I wasn't prioritizing others' salaries. Two brilliant staff, a BIPOC woman and gender-expansive folk who I hoped would eventually lead the organization were facing a promotion without appropriate compensation. What's more, those staff had been participants in our programs years before. They embodied leadership with lived experience. I was not only wronging those staff, but our mission, as we were funneling our youth into a trap: mission-driven values-aligned work that would not pay their bills and allow financial autonomy in adulthood." — Pui Ling Tam

The nonprofit starvation cycle threatens organizational sustainability and indirectly constrains the sector's impact. But it also hurts the very people who make nonprofits run.

Too many nonprofit jobs lack family-sustaining wages, necessary benefits, worker protections, and advancement opportunities. Instead of enabling economic security, for many, a nonprofit job means sacrificing personal economic security and, in some cases, physical and mental well-being.

This is self-defeating for philanthropy. As a sector we endorse greater support for other essential occupations like healthcare workers and teachers, yet we are silent when it comes to nonprofit workers. We need to start talking. No matter your philanthropic strategy — from economic justice to climate change to the arts — your work depends on the well-being of nonprofit workers.

#### Here's why it matters:

#### It's about racial and gender equity

In the Bay Area alone, the nonprofit sector employs close to 800,000 workers, who are predominantly people of color. In San Francisco, 75% of nonprofit workers are people of color and low-wage nonprofit workers are dispro-

portionately Black or African-American. Nonprofit jobs remain some of the most accessible to people of color; yet unlike public sector jobs with strong unionization, nonprofit jobs do not provide a path to economic mobility. To the contrary, under-compensation of nonprofit jobs perpetuates racial and gender inequity.

### The nonprofit sector needs to recruit and retain talent

Nonprofits take on monumental tasks, like repairing centuries of harms inflicted on people of color, women, and gender expansive people. This work is deeply personal, often relying on individual workers' hard-earned wisdom gained from decades of experience. It is also hard, under-resourced, and surprisingly thankless. At the same time, organizing wins are driving job quality improvements in other sectors, threatening to widen the gap between private sector and nonprofit employment. This forces brilliant young people and nonprofit professionals alike to choose jobs that pay a living wage over working for social good. With turnover in nonprofits almost double that of other sectors and leaders reporting an acute shortage of talent, this limits organizational capacity and nonprofit (and thus philanthropic) impact. If we want the best and

brightest in our communities to join or stay in the nonprofit sector, we must stop expecting people to either have generational wealth that can subsidize their nonprofit career, or that the (often, but not always) rewarding nature of nonprofit work justifies struggling to make ends meet.

#### The massive sector needs to focus on quality jobs

For some workforce development funders, quality jobs are the name of the game. As foundations, we fund a long list of tools that tend to focus on job access in key sectors. But that work seldom focuses on nonprofits, despite the fact that the sector is the country's third largest and contributes \$1.5 trillion to the economy.

Conversations and early pilots to increase job quality are underway, but progress is not linear. Wage compression, or the decrease in the difference between higher salaries and lower salaries, can leave more senior staff feeling undercompensated. In addition, when one philanthropic funder or stream of government funding raises wages, it can lead to the same role having two different salaries based on funding source alone, eroding equity across the organization.

# Leadership in Tech: Here are 4 pathways to getting more women to the top

Gender balance within functional tech leadership remains an unfulfilled promise, heightening the challenges of chief technology officer (CTO) and chief information officer (CIO) succession planning for chief executive officers (CEOs) and chief human resource officers (CHROs). Depending on which data set you use, typical female representation within functional tech leadership sits in the 15-25% range. While it has been moving in the right direction, it has been slow and needs much improvement.

Considering that women effectively control roughly \$31.8 trillion in annual consumer spending, and with that figure set to increase as more women enter the workforce globally, the need for balanced gender leadership is even more apparent.

As technology evolves, companies without a diverse tech leadership will lose ground to competitors, including their attractiveness as a destination for women in tech. So, what can forward-looking organizations do to find female talent for their CTO and CIO roles? My advice: think about functional tech executive hiring in a less conventional way.

#### Grow talent internally

Executive succession planning is fundamental to achieving gender balance, and CTO and CIO positions demand particular focus.

TrustRadius's 2021 Women in Tech report found that women face additional barriers to promotion in tech, including the lack of clear career paths, coaching and mentors within their companies. You can start to change that in your organization by sponsoring female talent onto tech leadership pathways.

Building confidence in candidates is key as it can be lacking among women in tech roles, causing them to undervalue their skills and overlook themselves for promotion. Coaching can help develop self-belief from the start of their careers, setting them up for senior tech roles.

Diversity targets for the technical function are useful, but with a disparity of gender balance in science, technology, engineering and mathematics (STEM) subjects, talent development needs to start before women reach the workplace. Sending women tech leaders into schools, universities and sponsoring schemes that promote tech careers to female students can encourage girls to pursue STEM careers and step onto the ladder towards CTO or CIO.

How we're moving from words to action

These are real challenges, but addressing big problems is what this sector does. Here's some initial steps we're taking to address them with real action in support of nonprofit well-being:

At Irvine, in Better Careers' updated strategy, our support of direct-service organiza-

tions focuses on those who are led-by and accountable to the communities they serve and who use workforce development as a tool for repair. We are beginning a yearlong listening process to understand from leaders and staff what we can do to support better quality jobs. We fully expect that this means our grants will have to be larger and that we will have to choose fewer grantees

and potentially serve fewer people in the near-term as a result. We believe the tradeoff is worth it.

At ReWork the Bay, a community-led funder collaborative, our funder partners learn from community-centered, participatory grantmaking practices through our ReWork Philanthropy initiative. ReWork the Bay is also partnering with Irvine on a

participatory research and capacity building effort to advance philanthropy's understanding of the needs of client-facing nonprofit staff related to job quality and professional development, and identify and share practical strategies to better address those needs

Once opened, aim to keep the pipeline flowing by fuelling the drivers of female talent retention, such as flexible scheduling, flatter management hierarchies, equal parental leave and creating a supportive structure to allow those who choose to have children to thrive.

Building a pipeline of female talent is a core strand of a succession planning strategy, which creates contingencies for different contexts and time horizons. Doing so includes long-term planning to develop multiple generations of diverse leadership pools, continuous mapping of external talent with leadership potential and succession planning for emergencies.

#### Hire for hybrid roles

Across technology, digital and data, we're seeing a trend for hybrid leadership roles, such as "chief product and technology officer" and "chief digital and information officer.'

These compound roles are typically less technically focused and are far more transformative and strategic due to the breadth of responsibility. They require strong collaborative skills and empathy for customers and colleagues, often an innate skill of women leaders. Forming such hybrid roles will let you consider an expanded slate of diverse candidates

### Nela Park may add residential

#### Vision evolves for ex-General Electric Lighting HO

Many Greater Clevelanders have at least some familiarity with a place that could soon become home to many Greater Clevelanders. The owner of the former General Electric Lighting headquarters, 1975 Noble Rd. in East Cleveland, is preparing plans to convert several office buildings within the 94-acre Nela Park Campus into apartments and make those intentions known at a meeting of local stakeholders, possibly as early as this month, according to a source familiar with the project.

Milwaukee-based Phoenix Investors, which owns more than 80 industrial and commercial properties totaling 73 million square feet across 29 states, acquired the Nela Park Campus last year for a mere \$5 million, Cuyahoga County records show. The campus, with more than 26 buildings and over 1 million square feet of space, was built over a span of nearly 50 years, from 1911-1960 and once had more than 1,000 General Electric employees. Tunnels connect the buildings primarily as utility conduits but

GE employees sometimes used them to escape had weather.

Although Phoenix Investors focuses on rejuvenating large commercial properties for industrial and new commercial uses, it has noted in its marketing materials that some of the 26 buildings totaling 1 million square feet of space at the Nela Park Campus could be repurposed for new uses. Only three buildings on the campus that total about 182,000 square feet have existing tenants, according to Phoenix Investors. The current market for offices is depressed by the rise in remote working.

'The Historic Nela Park Campus offers a variety of options for new occupants and users including: abundant modern office areas with high-end finishes, state-of-the-art lab/R&D space, a large recently renovated conference & events center. a former school building with classrooms, and industrial/manufacturing buildings," Investors noted on LoopNet. "Other buildings could be redeveloped for other uses including housing or hospitality."
