
Innovations in Small Business Lending

Talent tensions ahead: A CEO briefing

Looming imbalances in global labor pools could make it harder for some companies to find enough skilled workers and for some lessskilled workers to find jobs.

Technological advances, industrialization, and liberalized trade have created a staggering 900 million nonfarm jobs in developing countries since 1980, lifting hundreds of millions of people out of poverty. As global companies have tapped (and helped fuel the growth of) low-cost labor sources, they also have created high-wage jobs for more than 50 million high-skill workers, while boosting productivity in developed and emerging markets alike.

This virtuous cycle appears to be reaching its limits, however, and there is a growing sense that something has gone wrong with the machinery that, for decades, delivered GDP growth, higher productivity, rising wages, and better standards of living. Indeed, new research from the McKinsey Global Institute (MGI) suggests that by 2020, the world could have 40 million too few college-educated workers and that developing economies may face a shortfall of 45 million workers with secondary-school educations and vocational training. In advanced economies, up to 95 million workers could lack the skills needed for employment.1

The projected gaps we identified are notional, and global labor markets will adjust in response to them. But their consequences would be serious: higher levels of unemployment (even as companies struggle to fill select vacancies), rising income inequality, and heightened social tensions testing political stability in countries around the world.

Senior executives and policy makers should study these imbalances closely because together they outline where dangers and opportunities will arise, and they provide a framework that business leaders and policy makers can use to guide their decisions. In this article, we'll look at the most significant labor imbalances by geography and then discuss the moves companies can begin making now to prepare

A new world for work

To better understand the evolving global labor market, we analyzed 70 countries, representing 87 percent of global population and 96 percent of GDP. Segmenting these countries by educational achievement (a rough proxy for skill), median age, and GDP per capita highlighted clusters of countries sharing similar attributes (Exhibit 1). Using these clusters as a starting-off point, we modeled a "momenbase case that combines current trajectories in demographics, GDP, educational attainment, and the supply of and demand for labor by skill level, all with the intention of highlighting potential labor imbalances that companies around the world might soon face. Four areas deserve close scrutiny from senior executives.

China's high-skill gap

In recent decades, China's industrialization has moved hundreds of millions of workers from farms into urban manufacturing and services. These changes boosted the country's GDP per capita and productivity, while providing the developed world with a massive source of low-cost labor. More recently, China has expanded beyond its role as "workshop to the world" and become a vital growth market for global companies operating there.

Yet a confluence of factors—including China's aging population, the rapid growth of the country's service sectors, and the move into more skill-intensive manufacturing—means that by 2020 the economy will probably need 23 million more college-educated workers than it can supply (Exhibit 2). This gap, equivalent to 16 percent of estimated labor demand, will probably emerge despite massive investments, already made or planned, in education. (China, for example, is already on track to add more than 50 million workers with a college education by 2020.) The implications of the gap are huge, as an adequate supply of highly educated workers will be critical to securing the growth of higher-value-added industries and the productivity gains needed to sustain China's GDP trajectory, not to mention realizing the growth aspirations of companies around the world.

First Electronic Metro ExpressLanes Display Message Boards go Live

14-miles of the I-10 San Bernardino Freeway set to Debut in early 2013

Following on the heels of the successful opening of 11-miles of Metro ExpressLanes along the Harbor Freeway and with more than 50,000 Fastrak® ExpressLanes transponders issued, motorists this week will begin seeing messages on the giant display message boards along the I-10 San Bernardino Freeway in preparation for the opening of the ExpressLanes along this stretch of freeway in early 2013.

The large electronic digital ExpressLane message boards will display information regarding the program. No date has been set for the official opening of the ExpressLanes along the 10 San Bernardino Freeway but work is progressing for a possible late January/early February opening.

"We encourage San Gabriel Valley commuters to get their FasTrak transponders now so they will be ready to enjoy all the benefits of the ExpressLanes when the lanes open on the 10 freeway next year," said Duarte Mayor and Metro Board Member John Fasana. "With the successful opening of the I-110 ExpressLanes, we look forward to seeing how the I-10 ExpressLanes will reduce traffic congestion in the San Gabriel Valley."

Metro, in partnership with Caltrans, is embarking on a one-year demonstration program that converts 11 miles of HOV (High Occupancy Vehicle) lanes on the I-110 (Harbor Freeway Transitway) between the 91 Freeway and Adams Boulevard near downtown Los Angeles and 14 miles on the I-10 San Bernardino Freeway between Union Station/Alameda Street and the I-605

Freeway to HOT (High Occupany Toll) lanes that allow solo drivers to use the lanes for a toll. The Harbor Freeway ExpressLanes opened to the public on Saturday, Nov. 10.

The ExpressLanes program seeks to reduce congestion by improving travel choices in the two corridors. Carpools, vanpools, and motorcycles will travel toll free. All will need a FasTrak® transponder to travel in the ExpressLanes.

When the I-10 ExpressLanes open next year, the rules for carpools on the I-10 freeway will stay the same as they are today. Carpools are three or more people traveling during peak travel times of 5 a.m. to 9 a.m. and 4 p.m. to 7 p.m. Monday to Friday, with holidays excluded. During peak travel times, carpools of just two people can travel in the I-10 San Bernardino ExpressLanes for a toll. All other times, they will travel toll-free in the Expresslanes.

At all times on both freeways, the general purpose lanes are not tolled. Net toll revenues will be reinvested in the corridor where they are generated for transportation improvements. To prevent backups in the ExpressLanes, the tolls will be adjusted from .25 cents a mile to a maximum of \$1.40 a mile and will increase as the number of vehicles in the ExpressLanes increase.

Construction workers have been busy over the last year installing a host of power and utility support units needed for the operation of the dynamic message signs (DMS) along the I-10 San Bernardino Freeway corridor. These signs will begin their testing phase this week displaying information regarding the ExpressLanes program. 

Boosting the share of college graduates in the labor force would help—it currently stands at 11 percent—but that will be tough. Getting to 17 percent by 2020 would require more than 85 percent of China's secondary-school graduates to complete a college education, compared with about 50 percent at present.

India's missing middle

India is a much younger country than China, and its shift out of agriculture and up the value curve is proceeding more slowly. From 2000 to 2010, India created just enough nonfarm jobs (about 67 million) to keep pace with the growth of its labor force, but not enough to move workers out of agriculture in substantial numbers. Consequently, India faces a unique set of labor market imbalances. In fact, it could be among the few countries with a surplus of highly skilled workers: in our momentum case, 36 million college graduates will join its labor force in the coming decade, about 6 million more than its domestic industries can employ.

Nonetheless, the share of India's working-age population with a secondary education is less than half that of China and many other developing economies. Further, India's relatively low secondary-school graduation rate could mean a shortage of medium-skill workers, such as plumbers and welders, to fill the jobs created by the country's burgeoning construction, manufacturing, retail- and wholesale-trade, and service sectors. All told, we project a gap in medium-skill workers of 13 million, or about 10 percent of demand in 2020 (Exhibit 3). India already faces a shortage of medium-skill workers, a fact reflected in high wage growth for vocationally trained people in sectors such as construction and mining.

Finally, if current population and education trends persist, India could have 27 million too many low-skill workers by 2020. This growing surplus of low-skill workers

implies adverse social outcomes: millions of people trapped in low-productivity, low-income jobs. India would need an unprecedented increase in job creation and education levels (including vocational education) to address these labor market challenges.2

From surplus to shortage

As China's labor force growth slows in coming decades, the young developing countries we studied, a group that includes Bangladesh, Kenya, Morocco, and Nigeria,3 will contribute about one-third of the growth in the global labor force. Today, these countries have ample numbers of college-educated workers—often more than their industries are ready to employ. In North African countries, for example, unemployment among highly educated workers is 20 percent, which is worse than the 8 percent rate for workers with only a primary education. (This difference reflects the fact that lower-skill workers engage in subsistence activities to survive in the absence of social safety nets.)

The labor surplus many of these countries have won't last forever, because their economies are growing much faster than those of the developed world and represent important markets for multinational companies. African countries, in particular, have garnered significant attention in recent years as destinations for investment, and new research from MGI finds the continent has large untapped job potential in agriculture, manufacturing, and the retail and hospitality industries.4

Nonetheless, if current growth, population, and education trends persist, we conservatively project that the countries of sub-Saharan Africa and South Asia (excluding India) could have a shortage of 31 million workers with a secondary education by 2030 (Exhibit 4). Furthermore, young developing countries will need to find work for about 30 million low-skill

workers with no education or only primary schooling. By 2020, the surpluses will represent 14 percent of the supply of such workers in these countries.

High-skill shortage, low-skill surplus

Advanced economies, including those in Europe and North America,5 face daunting challenges, too. Trends in educational attainment and projected employment needs indicate that employers there will require 16 million to 18 million more college-educated workers than will be available in 2020, a gap representing 11 percent of demand (Exhibit 5).

The skill gap will be widest in Southern Europe, where educational attainment is lowest and populations are relatively old. These countries could have 3.5 million too few college graduates in 2020. Other advanced economies with high median ages—such as Germany—could face a shortage of college-educated workers equivalent to 10 to 11 percent of demand, despite relatively high college completion rates. In the United States, a demographically younger economy, the gaps will be less severe: perhaps 1.5 million too few workers with college or graduate degrees by 2020.

Protect your data now — before the holiday rush begins

The holiday season is an exciting time for business owners, who expect to make their largest sales toward the end of the year.

But data thieves look forward to the holidays, too. They count on business owners and their employees to be too over whelmed with sales to guard against unexpected attacks. Here's

- Increased holiday volume and larger amounts are more attractive to thieves
- · Less experienced temporary staff are easier prey
- Small businesses are often more vulnerable than large corporations, because they're less likely to consistently follow Payment Card Industry (PCI) compliance guidelines
- · Business owners are more concerned with making holiday sales goals than checking for skimming devices or monitoring logs for unauthorized access

According to the 2011 Symantec U.S. Cost of a Data Breach Report, negligence caused 39 % of data breaches, and malicious attacks caused 37 % of data breaches — an increase of 6 % from the previous year. Malicious or criminal attacks are the most costly: averaging \$222 per compromised record. Multiply that by the number of customers you have to understand your potential risk.

The 2012 Verizon Data Breach Investigations Report found that most victims of data theft were targeted because of ease of opportunity. Thieves were able to exploit an obvious weakness, and they could succeed with very little effort.

Most attacks were directed against small businesses and most data breaches could have been prevented with a few fairly easy and inexpensive procedures.

Don't make it easy for thieves. Take action now to help protect your business and your customer data by following these simple steps before the holidays begin.

Important steps you can take before the holiday rush:

- By following PCI Best Practices and using basic common sense — you can help keep your sensitive information secure and prevent data breaches. Review your compliance guidelines, have a meeting with your staff, and put your procedures into place before the holidays.
- Next, get certified. Complete your PCI Compliance certification now by validating your PCI compliance. You may want to use a PCI certification company like Trustwave. This will help you keep your customer information secure.
- Regularly change your administrative passwords on all Point of Sale (POS) systems.
- Install a firewall and access control list for remote access and administrative functions.
- Install the latest version of your virus protection software on all your equipment.
- Inspect your POS terminals regularly to be sure no new wires or skimming devices have been attached to your equipment. Take photos of your terminals as a record for compari-

- Review your computer log each day to check for unauthorized activity. A third of criminal attacks involve malicious
- Educate your employees about data protection procedures, and make it a daily part of their jobs. Share the article on holiday fraud on page 4 of this issue.
- Ask your vendor if your POS is a Payment Application Data Security Standard (PA-DSS) compliant application.
- If a third-party vendor maintains your POS system, ask them to document the data loss prevention procedures that have been put into place.
- Never use any part of your POS system to browse the inter-
- Important: your wireless devices need extra security. Be sure your laptops, tablets, and phones are encrypted and use passwords, to reduce risk if lost or stolen. For an overview of special requirements for wireless equipment, review the Payment Card Industry Data Security Standard (PCI DSS) Wireless Guidelines now, before the holiday season begins.

Get started early. You'll feel good about taking care of these important issues now, before the holiday season begins. Knowing that you're doing your best to keep your business data and your customers' information safe will help you to focus on serving your customers during this important time of year.

Save time and money when you guard against common holiday fraud and scams

A big sale may be exciting — but you still need to follow procedures to be sure that the purchaser is the legitimate owner of the card. Knowing the warning signs of a suspicious transaction and training your staff will help reduce fraud losses. Here are some examples of common scams, and action you can take:

Fraudulent use of a lost or stolen card

Use best practices to verify the legitimacy of the card and cardholder:

- · Verify expiration date and security features (hologram and magnetic stripe)
- Check that signature is present and matches the signature on the
- When any card is declined, never swipe it a second time ask for another means of payment
- If doing business online, ensure that the 3-4 digit security code and billing address match what's on file with the bank

Employee fraud and theft of customer card data

- Make background checks before hiring temporary/seasonal employees
- Minimize opportunities for employees to take cards out of sight
- Keep a data access log and track which employees make which sales
- Have managers approve high-risk transactions, such as credit returns

Fraudulent "declined transactions" — using a closed or expired card

When a transaction is declined, the fraudster offers to call the card company from their cell phone to clear it up. Instead of calling the bank, they call an accomplice, and the accomplice gives a fake authorization code to the merchant to complete the

· If declined once, never swipe it again; ask for another means of payment

- Always get a valid authorization before shipping anything
- If the delivery address and billing address don't match and you suspect fraud, ask the customer for more details about their order
- · Handle rush delivery requests and large orders with caution Source: Wells Fargo Merchant Connect

AVS and CSC can help prevent fraud

Address Verification Service (AVS) is an important fraud prevention tool for card-not-present internet transactions. Plus, using AVS can help you qualify for lower interchange fees. AVS checks the address and zip code used for the purchase against the address and zip code used for

credit card billing. You're responsible for ensuring that your AVS

appropriate for the level of risk for your type of business. Note that you may not use the information collected for AVS to create marketing lists. AVS is intended to help prevent fraud, not for marketing purposes. If you have questions about using AVS, please review the VISA AVS Guide.

The Card Security Code (CSC, also known as CVV2, CVC2, or CID) is the 3 or 4 digit code printed on the card front or back, depending on the type of card. It's an extra level of security to request during a sale which can help indicate that the purchaser has the physical card in his possession.
