## California Awarded Up to \$1.2 Billion to Advance Hydrogen Roadmap and Meet Climate and Clean Energy Goals

In a historic announcement, California has been awarded up to \$1.2 billion from the United States Department of Energy (DOE) to build and expand projects focused on clean energy and creating green jobs with the ultimate goal of achieving a net-zero carbon economy by 2045.

California is one of seven awardees of the DOE's Regional Clean Hydrogen Hubs (H2Hubs), which will kickstart a national network of clean hydrogen producers, consumers, and connective infrastructure while supporting the production, storage, delivery, and end-use of clean hydrogen. The H2Hubs are expected to collectively produce three million metric tons of hydrogen annually, reaching nearly a

Together, they will also reduce 25 million metric tons of carbon dioxide (CO2) emissions from end-uses each year—an amount roughly equivalent to combined annual emissions of 5.5 million gasoline-powered cars—and create and retain tens of thousands of good-paying jobs across the country while supporting healthier communities

California submitted an application in April through the Alliance for Renewable Clean Hydrogen Energy Systems (ARCHES), a statewide public-private partnership designed to accelerate renewable hydrogen's (H2) contribution to decarbonizing the state's economy and build on California's long-standing H2 and renewable energy leadership. The Governor's Office of Business and Economic

Development (GO-Biz) has joined with the University of California, Lawrence Berkeley National Laboratory, state agencies, elected leaders, organized labor, and non-profit organizations to build the framework for California's renewable, clean hydrogen hub.

"Unlocking the full potential of hydrogen—a versatile fuel that can be made from almost any energy resource in virtually every part of the country—is crucial to achieving President Biden's goal of American industry powered by American clean energy, ensuring less volatility and more affordable clean energy options for American families and businesses," said U.S. Secretary of Energy Jennifer M. Granholm. "With this historic investment, the Biden-Harris Administration is laying the foundation for a new, American-led industry that will propel the global clean energy transition while creating

## Hispanic Entrepreneurship at the Forefront of American Business Boom

The Biden-Harris administration and U.S. Small Business Administration Administrator Isabella Casillas Guzman are committed to the success of Hispanic communities. More Hispanics than ever before are seizing the opportunity to create new businesses which enhance our cities and neighborhoods. Data shows that the five million Latino-owned businesses contribute \$800 billion each year to our economy. In the past decade, Latino entrepreneur growth rates have risen 10 times faster than non-Latino businesses. Within SBA's Region 10, Hispanic businesses employ thousands of workers and contribute millions of dollars to local economies. The number of Hispanic-owned businesses are impressive: nearly 3,000 in Alaska; more than 9,000 in Idaho; over 23,000 in Oregon; and more than 36,000 in Washington State.

Both President Biden and Administrator Guzman – the highest-ranking Latina in the President's administration – have made strengthen-

ing Hispanic-owned small businesses a priority. Over the last 33 months we have seen the fastest creation rate of Hispanic-owned businesses in over a decade, which was more than 20% faster than pre-pandemic levels. The president made a goal of increasing by 50% the amount of federal contracting dollars going to small, disadvantaged businesses by 2025, which translates to an additional \$100 billion for minority-owned and other underserved businesses and will help more Americans realize their entrepreneurial dreams.

President Biden directed the development of an ambitious, government-wide interagency plan to advance equity, justice and opportunity for Latino communities. The SBA established four equity goals that focus on direct assistance including:

GOAL 1. Improve access to capital for underserved communities, including Hispanic small business owners. SBA is investing in additional technology to match underserved borrowers with Community Financial Institutions including Community Development Financial Institu-

tions. For borrowers, application requirements will be simplified, data will integrate automatically, a high-quality customer service support system will be available and the process will be mobile-friendly.

GOAL 2. Expand access to federal procurement and contracting opportunities. SBA will enroll more small, disadvantaged businesses into its business development and contracting programs including the 8(a) Business Development program, HUBZone program and Economically Disadvantaged Women-Owned Small Business certification program. The goal is to strengthen those businesses' capabilities to compete and perform on contracts.

**GOAL 3.** Provide support and expanded access to disaster assistance. SBA will work with its field and program offices to develop a systematic and formal process with its resource partners to assist minority-owned businesses with disaster loans including application completion, reconsiderations, credit repair and managerial and technical services.

GOAL 4. Increase access to business counseling, training and services. SBA will investigate innovative approaches for reaching Hispanic and immigrant clients through its Community Navigators Pilot Program, Women's Business Centers, Small Business Development Centers, SCORE and Procurement Technical Assistance Centers.

This equity plan is in addition to the legislative successes over the last three years including the American Rescue Plan, the Bipartisan Infrastructure Investment and Jobs Act, and the Inflation Reduction Act of 2022 which makes urgent investments that will bring down costs, level the playing field and open historic opportunities for America's 33 million small businesses and innovative startups — especially those businesses owned by minorities, women and veterans.

## Breaking Barriers: Why Black Entrepreneurship Is On The Rise

Rates of new business openings have surged in recent years, as more people decide they would rather take a risk and work for themselves than stick with traditional employment.

#### The Contours of Black Entrepreneurship

Black business ownership has experienced positive gains and setbacks, largely due to the pandemic.

Black businesses were disproportionately impacted by the pandemic and closed at twice the rate of other businesses. These businesses initially also had more challenges accessing the massive influx of federal aid made available through mechanisms like the Paycheck Protection Program (PPP). They were more likely to be denied bank loans from small or mid-sized banks where lending determinations often were more subjective, according to the National Bureau of Economic Research.

But there is another side to the story of Black entrepreneurship. Black business ownership was already growing before the pandemic, but surged during this period — increasing 28% by the third quarter of 2021 compared to before the public health crisis. Some experts argue Black business ownership rose during this time because Black workers were disproportionately affected by layoffs. Four out of the five occupations that employ the largest number of Black workers — retail sales, cashiers, cooks, and waiters and

waitresses — experienced the highest rate of job losses at the beginning of the pandemic. With limited options in these industries, it is not surprising that some workers decided to redeploy their skills, start their own businesses, and try to control their own destinies.

### Bank On CLE Awarded Fellowship to Expand Banking Access in Cleveland

Millions of Americans across the country are outside of the stabilizing financial mainstream, without a safe banking account to manage their money and build towards a stronger financial future. Across the country, Bank On coalitions work to connect residents to safe, affordable accounts – and Bank On CLE just received a new grant to supercharge these efforts.

The City of Cleveland and national nonprofit the Cities for Financial Empowerment Fund (CFE Fund) announced that Cleveland has been selected to receive a grant to support a Bank On Fellow for a two-year term to advance banking access efforts at scale, including through identifying opportunities to connect access to safe accounts to programs and payments.

Now in its fourth Wells Fargo Foundation-supported cohort, the national Bank On Fellowship Program provides funding to six Bank On coalitions to support a full-time staff position for two years — a "Fellow" — to lead coalition activities. Launched in 2017 with generous support from the Wells Fargo Foundation, it is the first national initiative focused on building experienced banking access leaders across the country, equipping them with the training, tools, and resources to make significant advancements in local banking access efforts while at the same time generating best practices for other coalitions. Dedicated local leadership is critical to moving beyond general education and literacy efforts into identifying systemic integration points – from unemployment insurance to tax refunds to other program and payment streams - to connect unbanked people to safe, affordable accounts at scale.
