How Construction Companies Can Overcome Barriers to Adopt AI & Robotics

The pace of change in the construction industry is accelerating quickly. That requires knowing where the market is going and frequently examining business practices accordingly. While that presents a challenge, it also presents a chance to position oneself well for the work ahead. There are expected to be an additional 2 billion people on Earth by 2050. To meet those needs, humanity will need to build approximately 13,000 structures every day for 30 years.

Such a boom means unprecedented opportunities for AI and robotics to transform construction methods. The combined power of robotics with AI and machine learning data analysis and process automation has the potential to make construction much faster, less expensive, and less wasteful while making human jobs safer and less physically debilitating. Yet how should construction companies mired in the economic realities of today gear up for the fast-paced demands of tomorrow?

MassRobotics, a Boston innovation hub for robotics/automation start-ups, launched more than five years ago to accelerate and scale the visions of robotics entrepreneurs. It now has more than 50 companies in residence at its shared office/lab space, fosters a cluster of 350 robotics companies on the East Coast, and has expanded to work with start-ups around the world. On November 12, 2020, MassRobotics, in collaboration with Autodesk Technology Centers, held the Robotics In Construction virtual summit to outline the state of construction technology innovation, pinpoint the needs of construction companies in the field today and showcase some new solutions coming from some of the most promising construction technology start-ups. This confluence of industry knowledge suggested several ways for construction companies to break the barriers to AI and robotics adoptions, as well as ways for the technology providers to help them do it.

Mayor Eric Garcetti launched LA Optimized, an initiative to help local small businesses recover from the pandemic by expanding their e-commerce capabilities and growing their online presence. The project will be overseen by the Mayor's newly appointed 2021 Entrepreneur-in-Residence (EIR), Roberto Martinez.

Through the help of dedicated partners, the Mayor's Office plans to allocate over \$1.5 million to help provide these services.

This program will also partner with the ArtCenter College of Design and verynice to deliver up to \$500,000 in total to vetted creative professionals to provide \$500 worth of business and digital content services including branding, video, photography, and graphic design to struggling small businesses. In its first year, up to 1,000 small businesses will be able to access these services to increase their online visibility and engagement, and help them adapt to digital marketing platforms in the wake of pandemic-related challenges.

While the pandemic has accelerated the surge of online sales this year, small and medium businesses have long faced digital challenges to compete with larger corporations. This year, California's small business revenue dropped by 29.3%, and a September 2020 report found that Los Angeles has seen 15,000 closures, half of which are permanent.

LA Optimized will be open to active small businesses in the City of Los Angeles, with priority given to brick-and-mortar establishments located in or serving residents of low income communities. Businesses can enroll at Coronavirus.LACity.org/LAOptimized.

Governor Newsom Announces Immediate Assistance for Businesses Impacted by COVID-19 Including Temporary Tax Relief and \$500 Million in Grants

Billions in immediate, temporary tax relief will support businesses impacted by COVID-19, including an automatic threemonth extension for taxpayers filing less than \$1 million in sales tax and interest-free payment agreements to larger companies with up to \$5 million in sales tax and expanded interest-free payment options for larger businesses particularly affected by significant restrictions on operations based on COVID-19 transmissions.

In partnership with the Legislature, California will provide \$500 million in new COV-ID-19 Relief Grant funding for small businesses.

Additional \$12.5 million added to the California Rebuilding Fund launched last week

As the federal government fails to provide additional financial stimulus support to main street businesses, Governor Gavin Newsom today announced that California will provide temporary tax relief for eligible businesses impacted by COVID-19 restrictions. The temporary tax relief entails an automatic threemonth income tax extension for taxpayers filing less than \$1 million in sales tax, extends the availability of existing interest and penalty-free payment agreements to companies with up to \$5 million in taxable sales and provides expanded interest free payment options for larger businesses particularly affected by significant restrictions on operations based on COVID-19 transmissions. The total tax relief, if fully utilized, is estimated to have billions in impact. These efforts are informed by recommendations made by the Governor's Task Force on Business and Jobs Recovery.

"California's small businesses embody the best of the California Dream and we can't let this pandemic take that away," said Governor Newsom. "We have to lead with health to reopen our economy safely and sustainably while doing all we can to keep our small businesses afloat. With this financial assistance

and tax relief, California is stepping up where the federal government isn't. By providing potentially billions in immediate relief and support, our small businesses can weather the next month as we continue partnering with the Legislature to secure additional funding and investments in small businesses in the new year."

Small businesses are drivers of economic growth – creating two-thirds of new jobs and employing nearly half of all private sector employees. California is home to 4.1 million small businesses, representing 99.8 percent of all businesses in the state and employing 7.2 million workers in California, or 48.5 percent of the state's total workforce.

The COVID-19 pandemic has presented a significant challenge to small businesses, employers and employees. An August Small Business Majority survey data found that 44% of small businesses are at risk of shutting down. Data released through the Census Current Population Survey found that minority-owned businesses are disproportionately impacted: the number of active businesses owned by African-Americans dropped by 41%, Latinx by 32%, Asians by 25%, and immigrants by 36%.

'California's small businesses continue to struggle as a result of COVID-19, and this latest round of action at the state level will help bridge the financial gaps that are vexing our state's mom-and-pop business owners and nonprofits while we wait for congressional action, and as we prepare for additional legislative action at the start of the year," said Senate President pro Tempore Toni G. Atkins (D-San Diego). "From widening access to grants, lowinterest loans, and tax deferrals, to modifying fees incurred by restaurants and bars, these are critical supports for the small businesses and services that keep our communities going. Now, we need our federal partners to do their part and pass a federal stimulus so these businesses and nonprofits can survive 2020 and the vear to come.

"While we wait for Congress and the White House to approve an economic relief package that responds to the current surge, California has a chance to help nonprofits, small businesses, and communities now," said Assembly Speaker Anthony Rendon (D-Lakewood). "I thank the Governor and the Senate for their partnership."

The announcements build on the state's ongoing business support throughout the pandemic, including the Main Street Hiring Tax Credit, which authorizes \$100 million in hiring tax credit for qualified small businesses. The credit is equal to \$1,000 per qualified employee, up to \$100,000 for each small business employer.

Building on the state's ongoing support throughout the pandemic, which can be found here, the Governor announced the following immediate support and relief:

Tax Relief for Businesses Impacted by COVID-19

In April 2020, the Governor, through Executive Order, allowed taxpayers to apply for penalty and interest relief for 90 days for any taxpayer reporting less than \$1 million in sales on their tax return. Through November 22nd, some 9,287 plans with almost \$149 million in tax relief have taken advantage of this program.

The Governor will direct the California Department of Tax and Fee Administration to do the following:

- Provide an automatic three-month extension for taxpayers filing less than \$1 million in sales tax on the return and extend the availability existing interest and penalty free payment agreements to companies (with up to \$5 million in taxable sales)
- Broaden opportunities for more businesses to enter into interest-free payment arrangements.
- Expand interest-free payment options for larger businesses particularly affected

by significant restrictions on operations based on COVID-19 transmissions.

\$500 Million for New COVID Relief Grant for Small Business

The Governor announced the creation of a \$500 million COVID Relief Grant administered by the California Office of the Small Business Advocate (CalOSBA) at the Governor's Office of Business and Economic Development for small businesses that have been impacted by COVID and the health and safety restrictions. Funds would be awarded to selected intermediaries with established networks of Community Development Financial Institutions to distribute relief through grants of up to \$25,000 to underserved micro and small businesses throughout the state by early 2021. Non-profits would also be eligible for these grants. CalOSBA is establishing the program and will make it available to small businesses as soon as possible - for updates on availability visit here.

Increase Funding for the California Rebuilding Fund by \$12.5 million.

Last week, the Governor announced the opening of the California Rebuilding Fund which makes available \$25 million to help impacted small businesses rebuild from the economic crisis and keep local economies strong. This program is built to be a resource in the market for the next year as businesses pivot and recover.

An increase of \$12.5 million would allow the Fund to be fully capitalized. The additional funding will help the 3rd party administrator of the fund raise \$125 million to make more low-interest loans to small businesses with less access to loans from traditional banking institutions.

Whether you're a veteran looking to launch a brand-new business, buy an existing company, or expand the one you already own, there are many financing options available through the Small Business Administration (SBA).

The Small Business Administration generally doesn't make loans directly- with the exception of loans within the Disaster Loan program. Instead, it guarantees loans made by lenders. SBA loans are designed to help small businesses that would have otherwise have trouble securing affordable access to capital. Here are SBA loan programs to consider:

Military Reservist Economic Injury Disaster Loan (MREIDL)

The MREIDL program falls under the SBA's Disaster Loan program. It provides a working capital loan of up to \$2 million to help the eligible small business meet its ordinary and necessary operating expenses that it could have met, but it

is unable to meet, because an essential employee was called-up to active duty in their role as a military reservist. MREIDLs are loans, not grants, and they carry low interest rates and repayment periods of up to 30 years.

There are some important guidelines to know. Collateral is required for loans above \$50,000 and borrowers will need to pledge available collateral, including home equity in some circumstances. Borrowers will be required to have appropriate insurance as well. The business must not be able to get similar funding elsewhere (this is often referred to as the "credit elsewhere" test). Don't let that discourage you from applying, though; the SBA finds that over 90% of disaster loan applicants don't have the resources to recover without this help.

Unlike most SBA loans, MREIDLs are not available through lenders. Instead, you apply for one of these loans through the SBA's Disaster Assistance portal.

Economic Injury Disaster Loans

Most business owners hadn't heard of the Economic Injury Disaster Loan (EIDL) until the coronavirus crisis, even though this program has been around for a number of years. That's because these loans are made available to businesses located within a federally declared disaster which means they are often limited in availability. But the COVID-19 crisis is a national disaster that has made these loans available to qualified businesses negatively impacted by coronavirus across the U.S. or its territories.

How to Find and Apply for SBA Loans for Veterans Businesses?

EIDLs for businesses impacted by COVID-19 are attractive as far as business financing goes. They carry an interest rate of 3.75% (2.75% for nonprofits) and an SBA loan payment period of up to 30 years.

In addition, the CARES Act added an EIDL grant (advance) of up to \$10,000 that does not have to be repaid. The grant has been administered as \$1000 per employee.

Collateral is required for loans of \$25,000 or more, and a personal guarantee is required for

financing of \$200,000 or more. There will be a personal credit check for all loans, and a business credit check for loans above \$20,000, and borrowers must have acceptable credit.

EIDLs are not available through lenders. Like MREIDLs, you apply for one of these loans through the SBA's Disaster Assistance portal. (Note that currently the portal for COVID-19 EIDLs is closed to new loan applications except for certain agricultural businesses. The SBA is processing existing applications on a first-come, first-served basis.)

However, if your business is located in a federally declared disaster area (unrelated to CO-VID-19), you may be eligible for a Disaster Loan or EIDL. Disaster loans may cover physical damage to the business. You'll find helpful information on SBA.gov, or your local Small Business Development Center (SBDC), Veteran Business Outreach Center (VBOC), or SCORE chapter can provide assistance to help you understand disaster loan programs available to your business.

digital marketing tools and strategies to scale diverse small businesses and organizations — bridging the digital divide and providing businesses owned or run by people of color with the ability to compete against the titans of industry. As Google's Digital Coach for the Los Angeles metropolitan area, Martinez enlists some of the city's most accomplished business minds to build stronger industries across the City.

"I am honored and privileged to be the next Entrepreneur-in-Residence for the City of

L.A.," said Martinez. "Now more than ever there is a need to bridge the digital divide to help small businesses. How Construction Companies Can Overcome Barriers to Adopt AI & Robotics

Regardless of a firm's size, a construction company wanting to take its first steps into AI and robotics can start with some of the more mature technologies that are available. For example, using drones for aerial inspection of roofs, pipes, and more has become somewhat typical according to Jay Connolly, President and CEO of the construction management, developer, and planning and design company Connolly Brothers, and a speaker at the Robotics In Construction event. Although Connolly calls it a small company, Connolly Brothers has operated for 140 years in the industry, in part for its willingness to adapt over time, he says.

Another event speaker, Dan Linscott, Field Division Manager of the Boston-area commercial real estate company Cummings Properties, calls drone inspections a "game changer" for inspections. "You can get them in places you could never get a helicopter," he says.

A second opportunity is to adopt the offsite prefabrication of pieces to be installed on the jobsite, which can save time and cost, as well as increase worker safety because the prefabrication takes place in a controlled environment. In the Robotics In Construction keynote, Jim Lynch, Vice President & General Manager of Autodesk Construction Solutions, explained that this is part of the "industrialization of construction," which applies advanced manufacturing techniques to creating built environment elements. As such, it takes advantage of the efficiencies, precision, and data collection of robotics from technologies such as additive manufacturing and automating tasks like welding.

Construction firms can also use the Autodesk Construction Cloud to digitize, integrate, and optimize processes, Lynch says, and bring together workflows from designing and planning to building and operation. Doing so enables the platform's cloud computing AI to perform predictive analytics and risk mitigation.

The Strategic Approach to AI

Skanska and Suffolk Construction, the two largest construction firms represented at the Robotics In Construction event, have enacted strategies to identify and evaluate robotics, AI, and other technology solutions, as well how best to implement them.

Skanska is a global construction management and development company headquartered in Sweden. Event speaker Mike Zeppieri, Director of Innovation Services, Skanska USA, works in the group that brought BIM and VDC (virtual design and construction) to Skanska as part its effort to drive the company's digitalization strategy. Zeppieri's group now explores all the various technologies disrupting construction, such as data analytics, reality capture, industrialized construction, drones and robotics. He says they are particularly interested in robotics that can enforce some of Skanska's core values, such as safety, care-forlife, and sustainability. These would include for example exoskeletons and any other robotics that would not replace workers, but rather enhance their expertise and abilities by decreasing the physical toll on their bodies.

Raja Ghawa, Investment Associate of Suffolk Construction, a \$4 billion general contractor headquartered in Boston, explained that the company explores new technologies through several branches they call "pillars of innovation." The first of these, Suffolk CoLabs, has seven directors in seven cities across the US who collaborate with operational staff at more than 100 jobsites to find out their pain points and consider possible solutions to them. Suffolk CoLabs is tracking more than 60 technological solutions many of them in the robotics and AI space quantifying their results and measuring which of them will scale.

Suffolk's process with CoLabs has given the company enough practical insight to start Suffolk Technology, a corporate venture capital practice that by the end of 2020 will have invested in nine companies providing construction technology as a way for Suffolk to have "skin in the game" and share in the upside of some of the best solutions that Suffolk CoLabs has identified. For its latest effort, called Boost, Suffolk solicited applications from ConTech start-ups who wanted their most urgent challenge solved and chose five finalist companies to work with a Suffolk senior operational leader for a months to solve that problem. Those companies included Canvas, which uses robotics to automate drywall finishes, and Diamond Age, a robotic construction company that 3D prints homes.

Connect and Collaborate

Construction companies that are interested in robotics and AI but don't like what they see in the marketplace can also try just asking for what they'd rather have. Virtually all the parties involved at the Robotics In Construction event encouraged increased dialog between construction companies, robotics companies, and software providers like Autodesk to pinpoint how robotics and AI solutions can best address the specific needs of the construction industry, so that these automated systems are not "technology in search of a problem," as Zeppieri put it.

He and Ghawa both cited a strong ROI position as a major factor holding up the adoption of robotics and AI in construction. Robotics creators could begin to alleviate that concern by making specialized construction systems. For example, instead of offering to put robots on scissor lifts, which Zeppieri said are part of the safety problem, why not replace the scissor lifts altogether with a rail system and many smaller robots swarming along the rails performing tasks?

Linscott also presented several very specific opportunities for jobsite robots, such as a ro-

bot for auto-welding corrugated metal decking for roofs and floors, a slab saw cutting machine, a line painter for parking lots, and a robot washer for exterior facade glass.

In general, Connolly recommended that ConTech companies break down all the disparate processes of construction, such as site work, concrete, steel, drywall, plumbing, electrical, etc. and look for ways to standardize and improve the process for safety, efficiency, cost reduction, and ease of labor. He says that has already worked for subcontractors in the concrete foundation industry, a field formerly very entrenched in old methods that now is roboticized and takes a fraction of the time to complete.

Connolly encouraged ConTech firms to work with companies like his on their ideas. In fact, Connolly Brothers already collaborates with one of the many start-ups that presented their technology at Robotics In Construction: Human Dynamics, which makes tele-operated Drobot drones for accessing any high places and performing gripping and manipulation tasks.

The other presenting start-ups are also pursuing human-enhancing or task-specific applications for construction sites:

- Ascend Robotics makes autonomous precision coating and spray painting systems.
- Dephy makes industrial exoskeletons for assisting repetitive lifting and power tool operation.
- FLX Solutions' snake-like, one inch in diameter FLX BOT is designed to access spaces that people and other robots cannot to perform customizable actions and inspections.
- Hyperion Robotics provides automated concrete 3D printing with an eye toward sustainability.
- NeXtera Robotics created an operating system for industrial robots, as well as construction robots for panelization, dry wall installation, and laser scanning and layout.
- Vita Inclinata's Load Stability System (LSS) gives crane operators safe, adaptive, and self-contained rotational and swing control of all types of suspended loads, even in adverse weather conditions.
- Watertower Robotics aims to save wasted water with its soft robots that inspect water pipes.

With the continued cooperation and collaboration between the start-up community, construction companies, and software developers, the construction industry can continue to take advantage of the massive potential of AI and robotics where it's needed most.

5 AI Trends Profoundly Benefiting Business Bottom Lines

Expert cites machine learning advancements creating immediate, actionable value to drive data literacy, elevate cognitive insights and increase profitability in kind

In today's tumultuous business-scape amid increasingly intricate, and often vexing, marketplace conditions, curating and mining data to drive analytics-based decision making is just no longer enough. For competing with maximum, sustained impact and mitigated opportunity loss, it's rapidly monetizing data that's now the name of the game—particularly when spurred by artificial intelligence (AI). Indeed, emerging AI methodologies are helping forward-thinking companies achieve and sustain true agility, fuel growth and compete far more aggressively than ever before.

AI is critical as a means toward those ends and also certainly with respect to aptly predicting, preparing and responding to prospective crises as with the COVID-19 pandemic the globe is currently immersed in. In fact, Gartner recently cited the need for "smarter, faster, more responsible AI" as its No. 1 top trend that data and analytics leaders should focus on—particularly those looking to "make essential investments to prepare for a postpandemic reset." Novel coronavirus matters aside, Gartner underscored just how impactful AI will become, predicting that, "by the end of 2024, 75% of enterprises will shift from piloting to operationalizing AI, driving a 5X increase in streaming data and analytics infrastructures."

"To innovate their way beyond the post-COV-ID-19 world, data and analytics leaders require an ever-increasing velocity and scale of analysis in terms of processing and access to succeed in the face of unprecedented market shifts," said Rita Sallam, Distinguished VP Analyst, Gartner.

However, employing AI techniques like machine learning (ML) and natural language processing (NLP) to glean insights and render projections is simply no longer "enough" to get the job done especially for organizations seeking to compete efficiently on a national, multi-national or global scale. Today's organizations must endeavor toward a culture of AI-driven data literacy that directly and positively influences their top and bottom lines.

"To help data monetization-minded enterprises better future-proof their operations and assetamplify their data value chain, there are a few key ways to implement and elevate machine intelligence so that it's far smarter, faster and more accountable than protocols past," said Microsoft alum Irfan Khan, founder and CEO of CLOUD-SUFI—an AI solutions firm automating data supply chains to propel and actualize data monetization.

Below, Khan details five benefits of leveraging AI data-driven insights and technology in a way that will create actual and actionable value right now—the kind of insights that enable new and evolved business models and empower companies to increase both revenue and profitability.

Manifesting new market opportunities

Today's machine learning capabilities allow people to sift through data that previously could not be accessed, all at speeds faster than ever before. Present technology offers the opportunity to wholly analyze image, spoken or written inputs rather than just numerical, helping companies better find connections across these diverse data sets. This generates and maximizes value in a number of ways. Relative to the bottom and top lines, not only can it significantly reduce expenses, but it can also create new market opportunities. With COVID-19 as one recent example, algorithms speedily sifted through an extraordinary amount of data to identify diseases and potential cures that presented as similar, which allowed those methodologies to be readily tested against the coronavirus.

Machine learning advancements also help companies better monetize their data and establish new revenue streams. In the above example, of course patient information would not be shared or sold in any way, but other highly valuable data points can be gleaned. This includes determining that a certain drug is only effective on woman between certain ages—critical insights for pharmaceutical developers and physicians.

Emerging AI data processing protocols are far more rapid than prior iterations of machine learning technology, as are the resulting solutions, discoveries and profit-producing results thereof.

Reconcile emotions with actualities

Data generates value, which leads to the generation of money. It's that simple. Previously, it was difficult, if not humanly impossible, to sift through mass amounts of data and pinpoint relationships. There existed very rudimentary tools like regression and correlation, but today's analytics call for gaining a true understanding of what extracted data actually means. How do you convert data into a story you can actually tell? Often, decisions are made based on emotional foundations. Leaders are using data to either validate their gut or disagree with their instincts. Now, they are getting quicker insights that decisively validate or invalidate their thinking, while also prompting them to ask new questions. So, garnering meaning out of a company's own data provides tremendous advantages.

"Human nature is such that unless we can see it touch it feel it, it's hard to understand it," Khan says. "We as data scientists haven't done a really great job of explaining AI-driven data technology in simple terms. Telling a story with data or demonstrating actual results is where real power and understanding lies."

Scale statistical models for actionable models

We often separate our data as factuals, asserting "this is what happened." Neural networks connect the "human decision-making process" to those factuals—a simulation practice that helps us make better decisions. Previously, we would look at data sets like demographics, customer behaviors and such in silos. But when these multiple data sets are connected, it becomes quite evident that no two humans—or customers—are exactly alike.

Technology is now allowing us to understand trends on a factual level and then project outward. In the health realm, some companies are using this key learning to project whether or not a person is likely to suffer a certain affliction. It's also allowing for far more efficacious "if this then what?" scenarios. If a diabetic person takes insulin controls, then their diet the treatment protocol will change. This is enabling highly personalized medicine. But the same processes, principles and benefits hold true in non-health categories as well encompassing all industries, across the board. Future-proof, anti-fragile data supply chains

From data connectors to pipelines; data lakes to statistical models; AI to Quantum; visual storyboards to data driven automation; ML to NLP to Neural Networks and more, there are highly effective methods for future-proofing your data value chain. The data supply chain is quite complex and, to make it future-proof and non-fragile, it requires thoughtful processing from the point of creation to the point of consumption of actionable insights.

It starts with data acquisition-garnering a wide variety and volume of data from a number of internal and external sources where data is being generated by the millisecond. Once the data is identified and ingested, it needs to brought to a central point where it can be explored, cleansed, transformed, augmented and enriched and finally modelled for use toward a purpose. Then comes statistical and heuristic modeling. These models can be of different types using different algorithms vielding different levels of accuracy in different scenarios. Models then need to be tuned and provided and environment for continuous feedback. learning and monitoring. Finally, is the visualization of outcomes-an explanation demonstrated by drawing cause-effect relationships that highlight where the most impact happens. This leads to a conclusion on how a set of problems can be solved or opportunities uncovered.

"Most organizations have some data and drive different levels of business process improvement and strategic decisions with it," Khan notes. "However, few use data to the fullest. The right approach to data valuation and monetization can uncover limitless possibilities, including customer centricity, operational efficiency, competitive advantage, strategic partnerships, efficient operations, improved profitability and new revenue streams."

Multimedia monetization

Up to now, we have been able to write algorithms, generate immense amounts of numerical or written data and make sense of it. However, there is a significant amount of data that comes as images or voice, which has not been easy to process and manage until recent developments. The applications for the processing of visual and auditory inputs are endless. In fact, retail and finance industries have been early adopters of this technology—and with good reason. They've seen costs go down, engagement go up, sales increase and benefitted from other highly substantial points of monetization.

Now, a large department store can digitize their video data every night and determine that "X" amount of people saw "X" number of jeans, but they had to walk further to get to it. As a result, the department store can put those items closer to the door and walkways to determine if sales increase in kind.

Even the education realm is tapping AI-driven data. The technology is tracking retina movement to discern if kids are engaged amid the remote learning paradigm ushered in by the pandemic. They're exploring how to measure the retina to determine whether or not a child is actually engaged in the lesson.

In radiology, they are starting to convert visual data and track it to gain a deeper understanding of digital images and video. MRIs are better able to track brain tumors—whether they are growing or shrinking and at what rate and if they are getting darker or lighter in terms of the regions. This kind of AI-driven learning is helping doctors better detect cancer and treat it more rapidly. Video data processing of the human eye can also be used to determine if a person is drunk, fatigued or even has a disease. Voice machine learning has also keenly evolved. Originally, voice recognition was being utilized to discern if a person was actually suicidal, which could be accurately predicted by inflection points in a person's voice. Now, if that person can be captured on video, it is deemed to be about 20 times more accurate.

"All of this possibly had previously demanded a hefty price tag using systems and solutions of yore," Khan notes. "Today, integrating multiple processes across hybrid multi-cloud environments has made data processing and analytics much more accessible and outsourceable. This negates the need for companies to purchase cost-prohibitive servers and other machine hardware."

As one of the world's leading experts on building transparency into supply chains, Khan doesn't just talk the talk, he's walked the walk. As a revered marketplace change agent, he's known for driving business transformation and customercentric turnaround growth strategies in a multitude of environments. In addition to engineering partnerships with MIT, Khan has successfully led organizational changes and process improvement in markets across the Americas, Europe, Middle East and Asia.

"New AI solutions and trends will eliminate patchwork processes that cause data, and interpretations thereof, to get lost in translation or, even worse, remain entirely undiscovered," Khan says. "Next-Gen platforms are solving such problems by executing all functions required to create and govern AI products— single-source systems that pull data, transform, model, tunes and recommend actions with cause-effect transparency."

For niche players, today's leading-edge AI technology also aptly provides for vertical industry specialization. "Emerging solutions enable common data models, compliance and interoperability requirements that, in turn, accelerate model validation, refinement and implementation that's specific to a given sector or marketplace," notes Khan. "All of this ultimately drives speed to insights on previously unsolved problems, which reveals untapped opportunities and automates workflow integrated cognitive solutions."

"Overall, AI is ushering in a new and more sophisticated era of data literacy," he continues. "It's a new paradigm founded on automated, comprehensive and holistic data discovery, which is fostering elevated cognitive insights and actionable strategies that positively impact the top and bottom line."

Perhaps the future mandate for AI should not only focus on becoming smarter, faster and more accountable than predecessors, but actually bridge the gap between human intuition and data-backed decisions. Doing so will assuredly advance an organization's ability to transact with utmost trust.
