# How tech tackled the construction industry's inefficiency in 2017

The year 2017 may be remembered for many things in technology, such as Amazon's big push into offline retail, milestone moments in autonomous vehicles, or major breakthroughs in artificial intelligence (AI).

But for every jaw-dropping story that hits the tech press, there are broader microtrends that meander under the mainstream radar. And in 2017, one of those related to the construction and real estate industries.

### **Efficiency**

A few days back, database technology giant Oracle announced it was buying Aconex, an Australian company that builds team collaboration software for the construction industry, for a cool \$1.2 billion.

Aconex was founded more than 15 years ago, but Oracle's move to buy the company comes at a time when investment in the construction and real estate realm seems to be entering overdrive.

"Delivering projects on time and on budget are the highest strategic imperatives for any construction and engineering organization," noted Mike Sicilia, SVP and GM for Oracle's construction and engineering global business unit. "With the addition of Aconex, we significantly advance our vision of offering the most comprehensive cloud-based project management solution for this \$14 trillion industry."

Reports actually peg the construction industry at closer to \$10 trillion, though consultancy firm McKinsey notes that the global figure could

# **Thriving While Black:** The Top 10 Cities For Black **Businesses In The U.S.**

If you're a Black entrepreneur and you don't live in one of the following 10 cities, you may want to consider relocating. Blacktech Week used data from the U.S. Census Bureau to update its list from 2015 of cities where Black entrepreneurs thrive. The same cities made this new list that was previously published by NerdWallet, only they were ranked differently this time around, HuffPost reported.

The top ten cities, defined as areas with more than 100,000 residents, follow:

1. Memphis, Tennessee (previously ranked third): Memphis has the lowest unemployment rate of the top ten cities, a Black Business Association and a higher percentage of Black-owned businesses than Atlanta, the city commonly

thought of as the best place for Black entrepreneurship.

2. Montgomery, Alabama: What's boast-worthy about Montgomery is that it has "the highest percentage of black businesses nationwide," according to HuffPost. Black business-owners there can also consult the Alabama State Black Chamber of Commerce and Montgomery's Chamber of Commerce Minority Business **Development Task Force** for support.

3. Atlanta/ Sandy Springs/ Marietta Georgia (down from first place): The top city for Black businesses in 2015, still has the "highest number of businesses per 100 habitants," an unemployment rate that has decreased from 6 percent

# An Open Letter to the Next **Mayor of San Francisco: Confront Gentrification**

The sad, sudden death of Mayor Ed Lee shocked not only San Franciscans, but people all over the Bay Area. As a person, Lee was almost universally liked. His low-key, gentle style came as a relief after the flamboyant personalities of Gavin Newsom and Willie Brown. His policies proved more controversial, but whatever one thinks of specific decisions, there can be no doubt that during Lee's tenure. San Francisco gentrification went from being a concern to a full-blown crisis. As a 24-year city resident, I feel compelled to offer a few thoughts to the next mayor of San Francisco:

## Dear Mayor,

I don't know your name yet, or your politics or your platform, but it doesn't matter. Whether our

next full-term mayor turns out to be current Acting Mayor London Breed or one of the at least half-dozen other potential candidates being talked about, you need to recognize that our city is in crisis. That crisis can be summed up in one image from an event I attended downtown: Heading out of the Montgomery Street BART station, I saw a homeless man, an older African American, huddled on the sidewalk with his few belongs, ignored by the well-dressed professionals zipping by. On the street, a gleaming, brand-new Tesla zoomed past. And another. And another.

Welcome to the City of Income Inequality, and the next mayor of San Francisco must face the fact that we have reached a state of emergency. Earlier

Other advantages include loyalty from customers who choose to do business only with companies whose business practices are socially responsible.

### **Job Promotion**

The importance of workplace diversity cannot be overstated when it comes to an organization's ability to reach markets in foreign countries. The appeal of global markets creates two kinds of opportunities for employees: opportunities for promotion and employee development. reach \$14 trillion by 2025. Regardless of the actual dollar figure today, construction is a lucrative business. However, construction is not renowned for its efficiency, with some reports suggesting that the industry is among the lowest in terms of productivity — and this is partly due to the lack of digitization.

According to McKinsey, some construction companies are adopting new digital tools to enhance their productivity, including 5D modeling and data capture from drones, but they tend to be the exception to the rule. "Most companies, however, have legacy systems and unique requirements for budgets, planning, and operations, so change is difficult," the report found.

Still, we saw a number of startups and investors push to tackle this perceived lack of efficiency in 2017.

Just last week, Navitas Capital, a VC fund focused entirely on construction and real estate investments, closed its second fund at \$60 million, with plans to invest in "high-growth" companies across a number of construction tech areas, including financial services, marketplaces, smart buildings, machine learning, and workflow solutions.

A quick peek back through 2017 reveals a number of tech investments across the construction spectrum.

## Investments

Last month, Nashville-based Built Technologies raised \$21 million to "bring construction lending into the digital age." A week later, Palo Altobased Buildup raised \$7 million for its crossplatform software aimed at helping contractors, developers, and property managers identify and fix tasks and issues related to a job — it's ultimately about bringing handwritten lists and

printed documents into a central cloud-based location.

"The construction industry lags behind other markets in the overall productivity of its workers," said Buildup investor TLV Partners' managing partner Eitan Bek. "Buildup addresses the longest phase of a construction project: building."

Elsewhere this year, "Airbnb for construction" startup EquipmentShare raised \$20 million to grow its marketplace for selling and lending equipment; Emagispace raised \$4.2 million for its modular building block technology; Belgian startup Aproplan raised around \$6 million for its "Salesforce for construction" platform; and BuildingConnected raised \$22 million to grow its bid procurement platform for building contractors.

Drones too have emerged as key tools in the construction industry, serving to automate, capture, and process imagery from sites using unmanned aerial vehicles (UAVs). Menlo Park-based industrial drone company Kespry raised \$33 million last month from notable names such as Cisco Investments, Shell Technology Ventures, and Lightspeed Venture Partners.

And targeting the post-construction phase of building work, Zillow Group — the company behind a number of online real estate sites, including Trulia and Zillow — acquired New Home Feed to help builders market newly constructed properties.

When a lucrative business opportunity crosses paths with inefficiency, the landscape is often ripe for innovation and investment. In 2017, we saw some signs that the technology industry was pushing for its piece of the \$10 trillion pie.

# Ivanka Trump calls for ensuring access to capital for women entrepreneurs

US President Donald Trump's daughter and his advisor Ivanka Trump called for closing the gender gap in workforce by providing women better access to capital and ensuring better representation in high-value industries. (Live updates)

She underlined the need for more progressive policies to address the stagnation which set in a decade ago in closing the gender gap. She also noted that women dominate those sectors of the economy which are undervalued financially.

Ivanka Trump was speaking at a session on the second day of Global Entrepreneurship Summit A(GES) on Wednesday.

The session on 'We can do it! Innovations in workforce development ad skills training' had Cherie Blair, Founder, Cherie Blair Foundation

for Women; Chanda Kochhar, Managing Director and CEO, ICICI Bank and Karen Quintos, Chief Customer Officer, Dell EMC as other panelists.

Telangana's Minister for Information Technology, Industries and Commerce KT Rama Rao was the moderator.

The speakers were unanimous that women need to be empowered through education, skill development and access to capital.

Ivanka Trump spoke about the inadequate representation of women in higher education fields in the US. Only 13 per cent of engineers and 20 per cent computer science professionals are women.

The White House advisor listed out the steps being taken by the Trump administration to help close the gender gap in fields of Science, Technology, Engineering and Math (STEM). Another initiative encourages successful entrepreneurs to mentor young men and women.

Describing technology as a greater driver of entrepreneurship, she said it was reducing barriers to start business and creating flexibility. "Technology offers tremendous opportunities to women entrepreneurs," she said.

Cherie Blair said inadequate access to capital is the biggest problem faced by women entrepreneurs. She also stressed the need for giving options to women and the support required in terms of policies and eco-system.

Chanda Kochhar was of the opinion that women should have confidence in their capabilities. She said women do not need special policies but only required to be given an opportunity to prove themselves

She explained how ICICI Bank is helping the women workers, especially young mothers and those who need to take care of their elderly parents by allowing them to work from home.

Referring to the strides India is making in women empowerment, she said there is no other country in the world where 40 per cent of banking sector is headed by women.

Quintos said while more women were joining the workforce, the numbers were not changing fast. She believes the environment was still conducive to women.

to 4.5 percent and the **Atlanta Metropolitan Black Chamber of Commerce.** 

- 4. Washington/Arlington and Alexandria, Virginia: The "urrea" touted the highest median income for Black residents nationwide, the highest growth rate of startups (measured by number of employees) over the last five years and the support of "National Black Chamber of Commerce, the Northern Virginia Black Chamber of Commerce and BizLaunch, an entrepreneurship program."
- 5. **Savannah, Georgia (up from sixth place):** Savannah's rich jazz legacy attracts tourism, which has bolstered much of the Black business ownership in the oceanside city.
- 6. Baton Rouge, Louisiana (up from seventh place): Baton Rouge's petrochemical industry has driven much of its business, as it has the "4th largest refinery in the US and 10th largest in the world."
- 7. **Durham, North Carolina (down from fifth place):** "Several accelerators, co-working spaces, and entrepreneurial convening places" boosted Durham's thriving Black business communi-

ty, which has contributed to the city's significant decrease in unemployment (from 6.1 percent to 3.8 percent).

- **8. Baltimore/ Towson, Maryland:** Although the city took a financial hit with the loss of many manufacturing jobs, the survival of small businesses has increased in the last five years.
- 9. Miami/ Fort Lauderdale/ Pompano Beach, Florida (up from 10th place): The trifecta that keeps this metro area in the top ten included an increase in median annual income (\$16,091 to \$23,309), a decrease in the cost of living and a decrease in unemployment (5.7 percent to 4.2 percent).
- 10. Richmond, Virginia (down from ninth place): With the "2nd highest average annual revenues for black-owned businesses," Richmond's history of Black entrepreneurship secured its inclusion on the updated list. position. "The Jackson Ward neighborhood is commonly referred as 'the birthplace of Black capitalism' and is considered the second 'Black Wall Street,' after the Greenwood district in Tulsa, Oklahoma." HuffPo wrote.

# An Open Letter to the Next Mayor of San Francisco: Confront Gentrification

this year, Bloomberg crunched the numbers and found that the income gap between the richest and poorest San Franciscans was the highest of any city in the country.

The rent for a one bedroom apartment in San Francisco now averages a breathtaking \$3,390 per month – meaning that a \$40,000 annual income won't even cover the cost of housing, much less buy food, pay PG&E, etc. At that level of gentrification, it's effectively impossible for an artist, an entry-level nonprofit worker or a single mom working in retail to live in this city. Even people with what should be good jobs, like nurses and teachers, struggle to keep a roof over their heads.

City officials have pushed to increase housing construction, with some success. According to a recent report, as of last month over 5,000 units were under construction, with some 64,000 "in the pipeline." Of course, there's no guarantee all those pipeline units will actually get built. Worse, that 64,000 unit total includes only 5,600 affordable rentals – and again, we're a long way from knowing they'll all get built.

The gentrification crisis has accelerated the decline of San Francisco's Black population, which dropped from 13.4 percent of city residents in 1970 to just six percent in 2016. The city is losing Latinos too, at the rate of about 1,700 per year, even as our overall population increases.

The next mayor of San Francisco must confront the reality that the very character of our city is at risk. This famously diverse and eccentric place – that once spurred comments like, "North America used to be tilted, and everything loose rolled to

San Francisco"—can't be that if only people with incomes well into six figures can afford to live here. We need aggressive, creative strategies to get more affordable housing and save what we're losing, and quickly.

But San Francisco's crisis goes beyond just housing. That river of tech money that sent housing costs soaring somehow hasn't found its way into the city treasury. Astonishingly, "emergency" fee increases at city parks and other facilities, implemented seven or eight years ago to cope with recession-induced revenue losses, have never come back down. For example, the cost for an adult to swim in a city pool was \$4 in 2009. Now it's \$6, a 50 percent increase. Fees for kids, low-income residents, and monthly passes are lower, but have also risen, as have fees at all sorts of city facilities.

\$6 may not sound like much, but for that single mom trying to make do on \$40,000 a year, it's prohibitive.

San Francisco has come to epitomize the opening of Dickens' A Tale of Two Cities: "It was the best of times, it was the worst of times." San Francisco is awash in personal and corporate wealth, but while that mass of cash has fueled rampant displacement and gentrification, it mostly hasn't trickled down to the city services on which working families depend. We urgently need a serious rethinking of the city's tax structure to tap into that wealth and put it to work for those without high-paying tech jobs.

The next mayor of San Francisco must recognize the magnitude of this crisis, and that business as usual cannot be an acceptable option.
