SBA Administrator Karen Mills Announces Her Departure

SBA Administrator Karen Mills today announced her departure. Following is the note that was sent to SBA staff.

Dear SBA Team:

After four years as Administrator of the SBA, I have let President Obama know that I will not be staying for a second term. I will stay on until my successor is confirmed to ensure a smooth and seamless transition.

Serving as SBA Administrator, and seeing this Agency rise to meet the economic challenges we faced when I arrived four years ago, has been both a privilege and an honor.

As I have said to President Obama, and leaders in Congress, "We are a small agency with a big mission." We advocate for 28 million small businesses. We are responsible for the individuals who create two of every three net new jobs in our economy. And I cannot think of a better team to support these job creators. I want to take this opportunity to thank everyone across the SBA for the work you have done to help America's entrepreneurs and small business owners during this critical juncture in our nation's history.

Four years ago, when I arrived at the SBA, America's small businesses and entrepreneurs were struggling in the face of the worst economic environment since the Great Depression – and a banking sector that was frozen.

Together, we rolled up our sleeves and went to work. And from day one, each of you stepped up and fulfilled the mission of what the Agency was created to do. And you should be proud because our accomplishments are significant.

Together, we got capital into the hands of small business owners and entrepreneurs when they needed it most. We streamlined and simplified SBA programs, in some cases taking more than one hundred pages of paperwork out of the applications for some of our loan products. We brought more than 1,000 community banks back to SBA lending, opened our loan products to more mission-based lenders to reach communities hardest hit and secured a \$20 billion commitment from 13 banks to increase their small business lending over a three-year time frame.

Over the last four years, SBA supported more than \$106 billion in lending to more than 193,000 small businesses and entrepreneurs. This includes two record years of delivering over \$30 billion annually in loan guarantees. And today we are using our streamlined lending programs and products to get capital to communities that are still struggling and to fill market gaps.

We helped increase American competitiveness through an aggressive push around high growth entrepreneurship. We launched Start-Up America, passed a long-term reauthorization of the Small Business Innovation Research (SBIR) program and completely transformed and streamlined our Small Business Investment Company (SBIC) program. As a result, the SBIC program just had its third consecutive record-breaking year in FY12. Today, the SBA is the place where venture capital firms, startups and high growth entrepreneurs turn for proven tools and counseling to scale their operations and reach new markets in the U.S. and abroad.

We've transformed our Office of Disaster Assistance. A hallmark of these efforts is our streamlined disaster loan application. During Hurricane Katrina, it took almost 77 days to get a disaster loan turned around. Today, following important reforms, over 50 percent of the Sandy

applications are coming in on-line and being turned around within 21 days. I have seen the impact of your work during my recent travels and you should be proud of the role that you are playing, across the Agency, to help those affected rebuild their lives and their businesses.

Together, we've made selling to the federal government easier and more efficient. We've taken a zero tolerance stance on fraud, waste and abuse in federal contracting, created an Administration-wide emphasis on the importance of small businesses to apply for federal contracts and to get paid quickly once they win contracts. As a result, in the last three years of reporting, small businesses have accessed more than \$286.3 billion dollars in federal contracts. That is \$32 billion more than the previous three years, even as overall contract spending decreased during those years.


Working with our resource partner network, we've improved the delivery of our counseling and mentoring services. Today, our SBA "bone structure" includes a national network of Agency field offices, more than 900 Small Business Development Centers, 300 chapters of SCORE and more than 100 Women's Business Centers with over 14,000 members. This network is more integrated and coordinated than at any time in SBA's history. And we are using it to meet entrepreneurs where they are—whether that's on-line, one-on-one or in the classroom.

Because of your hard work, the SBA has established itself as the voice of small business and entrepreneurship both in Washington and across the country. We have a seat at the table because President Obama knows the important role that small businesses play in our economic growth and global competitiveness. And he understands that the SBA has the tools and the team to take America's small businesses to that next level, so that they can drive energy and momentum into the economy. That's why the President elevated my position to his Cabinet, so we can make sure that small businesses and entrepreneurs are a centerpiece of America's growth agenda.

And because of the work you have done the SBA has become the place that small businesses and entrepreneurs turn for trusted and reliable information on legislative issues and changes to the tax code and regulations that will affect their businesses. It is because of your work that we were able to pass the Small Business Jobs Act of 2010, the most comprehensive piece of small business legislation in over a decade.

The SBA is in a strong place. We are mission driven. Under the leadership of our Deputy Administrator Marie Johns, we just signed the first new master agreement with our employees' union in over a decade. We have strong leaders in place across the Agency who are poised to achieve great things.

Small businesses are now ready to go on the offensive. They are ready to expand to new markets, to scale their operations and to hire new workers. And I am confident that the SBA will be a driving force in their success for **Continued on page 3**





Mayor Lee Celebrates Positive Impact of Community Benefit Districts

New Economic Analysis Shows Positive Impact of Community Benefit Districts on Improving Neighborhoods, Program to Expand to Three New Neighborhoods

Mayor Edwin M. Lee announced the results of the Office of Economic and Workforce Development's (OEWD) Impact Analysis of San Francisco's Community Benefit Districts (CBDs). The evaluation was conducted to measure the success of existing districts in meeting strategic goals set forth for the CBD program including the improvement of the public realm, cleanliness and public safety and the creation of economically viable neighborhood business districts.

"Community Benefit Districts are a prime example of successful public-private partnerships," said Mayor Lee. "This new OEWD Impact Analysis demonstrates the positive and measurable impacts that CBD service and investment have on our City's commercial neighborhood corridors. More importantly, as each neighborhood takes an economic step forward, so does our City."

"CBDs are key partners in our efforts to keep our neighborhoods safe, clean, and vibrant," said District 8 Supervisor Scott Wiener. "They perform critical work in the neighborhoods and are effective eyes and ears, since their staff is physically present every day. CBDs can quickly alert city agencies of issues that need to be addressed. I work closely with the CBDs in my district to ensure good management of our neighborhood public spaces. I'm grateful for their work."

Due to the successes seen in existing areas, several new CBDs are in the planning and formation process. The Broadway, Embarcadero, Image credit: Google Image

and Rincon Hill commercial districts are all in the formation process. Several other commercial districts are starting to form steering committees to jumpstart the formation process.

The new Impact Analysis focused on 11 locally managed property and business improvement districts that are based on specific geographic areas within San Francisco in operation as of 2012. These 11 CBDs/BIDs cover nearly 3 percent of San Francisco by land area, sustain more than 60 full-time jobs and invested \$9.9 million investment in the 2011-2012 fiscal year to improve their mixed use neighborhood commercial areas.

The Impact Analysis demonstrated that on average, CBD-maintained streets were found to be cleaner than similar commercial streets located in the same Supervisorial district, suggesting that supplementary CBD street cleaning services have a measurable impact on public realm cleanliness. Additionally, the Impact Analysis shows that CBDs were insulated from the effect of the 2007-2009 economic recession. Specifically, CBDs retained more value in their properties, experienced less significant reduction in sales tax revenues, and maintained lower commercial vacancy rates than what was experienced across the City.

The Impact Analysis also highlights physical environment investments yielded since 1999, some of which include 36 unique public art installations, creation and or improvement of 25 public open spaces and 337 new street trees planted.

"The data analyzed in the CBD/BID impact report verifies the positive results we have seen in Noe Valley; our property owners, merchants and neighborhood residents have benefitted greatly from the presence of our Community Benefit District and its' partnership with the City," said Noe Valley Association CBD Executive Director Debra Niemann.

Community Benefit Districts are publicprivate partnerships in which property and/ or business owners elect to make a collective contribution to the maintenance, development, and promotion of their mixed use neighborhood though a special assessment to the property or business.

Community Benefit Districts emerged San Francisco in 1999 with the founding of the original Union Square Business Improvement Districts (BID). The program has grown rapidly following the creation of OEWD's technical assistance program, which is designed to incubate this innovative economic development strategy in 2004. Today there are 13 San Francisco-based CBD/BID districts that represent the diversity of the City's vibrant neighborhood commercial corridors, including Greater Union Square, North Market/Tenderloin, Fisherman's Wharf Landside & Portside CBDs, Noe Valley, Castro/Upper Market, 2500 Block Mission, Central Market, Yerba Buena, Ocean Avenue, Civic Center, Moscone Expansion District and Tourism Improvement District, a Citywide CBD.

Workmans Comp: What New Business Owners Should Know

New start-ups happen everyday, and many times it is the first private venture for the owner. All successful businesses take time to grow. As demand increases, the the owner will eventually need more employees to maintain the growth pattern. There are many laws that pertain to the operation of a company, and one of the most important laws is compensation protection for workers that are injured on the job. The laws are in place for particular reasons. The workman's compensation laws protect both the employee and employer in most cases, depending on the severity of the employee injuries.

State Law Matters

Most states are completely inclusive in required participation, meaning that a company with a single worker is required to carry workman's compensation insurance on that individual. This total also includes the owner. Normally, this expense is not optional. Reviewing state regulations concerning employee insurance should be a significant part of any business feasibility study, even though many self-employed individuals do not establish themselves as a private contracting company. A worker is considered an employee by virtue of the compensation insurance coverage. Temporary staffing companies are a prime example of this condition, as they are required to carry the compensation insurance for each person employed that they contract.

Which Injuries are Covered

It is important for the owner to understand that coverage is only extended to those who are injured on the job. Also, there are statutory limitations to the insurance protection and the injury must be endured for at least seven days. If the injury still prevents the employee from working after the initial period, then the coverage is retroactive to the original date of the injury. This is part of the reason for requirement of documented injury reports. These requirements are the same whether your company chooses to use Liberty Mutual workers comp or another company for coverage.

Owner Liability Beyond Compensation

The injury report serves as a beginning point for any liability. Additionally, workman's compensation insurance coverage level is only determined for lost wages. The insurance company is not liable for punitive damages if the injury is severe. Business owner liability that exceeds compensatory damages must be addressed as a civil tort claim in the proper local court of jurisdiction. It is important for companies that perform dangerous duties to complete a thorough evaluation of adequate coverage. This can be provided by purchasing other insurance protections, for those employed and for the company as well. A good working knowledge of the business trade is essential.

Workman's Compensation as an Expense

Workman's compensation costs are a serious concern for all businesses, from local stores to major corporations. Many spend upwards of 25% of there operational funds on this line item. This should be calculated into any prices or contract bids. Insurance rates vary according to the risk level of the business operation. The total cost of compensation protection can be intimidating for the new owner, but it is an investment when the protection works as the statutes intend.

Any prospective business owner should consult with an experienced attorney who is knowledgeable of new business establishment, such as registering the company as a limited liability company. This prevents the actual business from being liable for income taxes and passes responsibility along to the owner. A LLC is not a corporation. It is a pass-through business structure that operates according to agreement among the partners or the policies of a single owner. New business owners should always include workman's compensation insurance protection as a legitimate and significant component of any new business.

Business Loans and Intoxicating Circumstances

Small businesses are the backbone of the American economy, and their success often depends on whether or not an owner can secure a small business loan when necessary. Personal Background Statement

Most places that offer loans are going to require a personal background statement; this is definitely true for any loan guaranteed by the United States Small Business Administration (SBA). These background statements have a section where applicants must list prior criminal convictions. A DUI conviction will likely make the guarantor think twice about the risk associated with offering the loan.

Civil Actions Against Defendant

DUI verdicts can also lead to financial issues that will affect a person's credit score. There are obviously penalties, fines and further costs related with it (ie. taking alcohol treatment classes), but if a person causes an accident while intoxicated, they face much higher civil penalties.

The cost of paying off civil judgments to people who are injured or whose property is damaged during an alcohol related crash can financially cripple a person and ruin their credit rating. This reduction in credit score will definitely lead to loan denials or the ability to only secure high-risk loans with excessively high interest rates.

How a Small Business Owner Can Avoid DUI Consequences

Many people simply choose to plead no contest when faced with a DUI charge because they believe their conviction is a foregone conclusion. Sadly for these people, most individuals do actually have a chance at having such a charge reduced or thrown out altogether. While it's possible to defend oneself against a DUI, it's usually a better idea to hire a legal professional who knows all local laws. In fact, the severe consequences that small business owner's face usually necessitates the hiring of an attorney.

DUI charges can often be thrown out altogether if it can be proven that police made a mistake during or even prior to the arrest. If an individual is pulled over with no reasonable cause, for instance, it is usually considered an illegal stop and any evidence gained after that stop is inadmissible. There are also problems that could occur with a breathalyzer machine or mistakes that police can make during a field sobriety test that can warrant having charges dropped.

Can a DUI be Expunged?

A person who has a criminal record expunged basically erases it from existence

for most matters. Unfortunately, many states don't allow a DUI to be expunged if the person was convicted. This type of charge, however, if dropped, reduced or thrown out, can be expunged and permanently removed from that individual's record. Laws will vary state by state and even between counties, so it's important to find legal help or become acquainted with local laws if arrested.

The majority of people realize that there are some harsh consequences related to a DUI conviction, but few comprehend the fact that a small business owner's company can actually be affected. It is imperative for any small business owner or future hopeful to understand these consequences and react accordingly if charged with a DUI. Their future dreams literally rely on this.

Therefore, retaining a lawyer could be paramount when a person's livelihood is at stake – every measure should be taken to help secure ones present and future endeavors


