

SFMTA DBE Disparity Study

Executive Summary (ES)

A. Purpose of the DBE Availability, Utilization, and Disparity Study

San Francisco Municipal Transportation Agency (SFMTA) is a recipient of U.S. Department of Transportation (USDOT) funds for transportation projects, including Federal Transit Administration (FTA) funds. As a recipient of FTA funds, SFMTA must implement the Federal Disadvantaged Business Enterprise (DBE) Program in accordance with 49 Code of Federal Regulations Part 26 (49 CFR Part 26 or Part 26) and applicable statutory and constitutional law. The USDOT also provides guidance to recipients to assist them in implementing the Federal DBE Program.

SFMTA adopted its current race-neutral Small Business Enterprise (SBE) Program for FTAfunded contracts1 on August 1, 2006 to comply with the requirements of 49 CFR Part 26 and in response to the Western States Paving Co. v. Washington State Dept. of Transportation, 407 F.3d 983 (9th Cir. 2005) (Western States) decision.2 The SBE Program includes construction, professional services, and goods and other contracts. The purpose of this Disadvantaged Business Enterprise Utilization, Availability, and Disparity Study (the Study) is to determine if substantial disparities exist in SFMTA's utilization of DBEs in federally assisted contracts funded by the FTA and, if so, what is the appropriate level of participation by DBEs. SFMTA must set an overall DBE goal every three years for DBE participation in its FTA-funded contracts3, and examine whether the overall DBE goal can be attained solely through neutral measures or whether race- or gender-based measures are needed. The results of this Study are intended to assist SFMTA in implementing its DBE Program in the future.

SFMTA retained Rosales Business Partners LLC and Exstare Federal Services Group, LLC, in association with BBC Research & Consulting; JLM Management Group; Merriwether & Williams Insurance Services; and Chinese for Affirmative Action (collectively the Study Team), to conduct the Study.

s B. Study Scope

The Study Scope examined whether there are disparities between utilization of minority-owned business enterprises (MBEs) and woman-owned business enterprises (WBEs),4 and what contract participation might be expected based on their availability for FTA-funded transportation contracts. Utilization and availability results reported for MBEs and WBEs combine (a) firms certified as DBEs, (b) potential DBEs5; and (c) minorityand woman-owned firms that may have graduated from the Federal DBE Program or are otherwise too large to be certified as DBEs.

The Study Scope encompasses SFMTA FTA-funded construction and professional services contracts awarded during FFYs 2009 through the third quarter (Q3) of FFY 20156 (Study Period).

To perform the Study Scope, several analyses were conducted:

Market Area Analysis. The Study Team identified the relevant "geographic market area" in which SFMTA spent the substantial majority of its FTA-funded contracting dollars during the Study Period and where the substantial majority of interested contractors, subcontractors, and other goods and services suppliers that seek to do business with the SFMTA are located. 7 The Study Team used SFMTA contracting data and its lists of interested firms to help determine the market areas. Different market areas were determined based on the transportation-related construction and professional services contract opportunities (including goods and supplies) awarded during the Study Period.

DBE Availability, Utilization, and Disparity Study for the SFMTA

For construction, 74 percent of SFMTA's FTA-funded contracts were awarded to prime contractors and subcontractors located in San Francisco, Alameda, San Mateo, Santa Clara and Los Angeles Counties. The majority of interested firms seeking opportunities with SFM-TA are also located in these market areas. These counties were therefore identified as the relevant geographic market area for SFMTA's transportation-related construction contracts.

For professional services, 92 percent of SFMTA FTA-funded contracts were awarded to prime contractors and subcontractors located in San Francisco, Alameda, San Mateo, and Santa Clara Counties. The substantial majority of interested firms seeking opportunities with SFMTA are also located in these market areas. These counties were therefore identified as the relevant geographic market area for SFMTA's professional services contracts.

Availability Analysis. Relevant data relating to the availability of capable and qualified contractors was collected and evaluated consistent with evidence gathering efforts approved by the federal courts. The Study Team engaged in an extensive effort to identify all firms in the relevant geographic market areas that are "ready, willing and able" to participate in SFMTA's FTA-funded contracts.

The Study Team used a custom census approach to estimate the availability of MBE/ WBEs and majority-owned businesses for the transportation-related construction and professional services prime contracts and subcontracts that SFMTA awarded during the Study Period. Figure ES-1 presents overall dollar-weighted availability estimates by MBE/WBE group for those contracts.

Overall, MBE/WBE availability for SFMTA transportation contracts is 17.6 percent. Hispanic American-owned businesses (6.7%), non-Hispanic white woman-owned businesses (5.0%), and Asian Pacific American-owned businesses (3.9%) exhibited the highest availability

percentages among all MBE/WBE groups.

Utilization Analysis. To determine SFMTA's utilization of MBE and WBE firms, the Study Team ascertained the dollar values of FTA-funded transportation-related construction contracts and professional services contracts (including goods and other services) awarded by SFMTA during the Study Period, as well as the total dollar value of all FTA-funded

contracts awarded (including subcontracts). This task required in-depth review and analysis of SFMTA contract data, as well as a determination of the utilization of MBEs, WBEs, DBEs and majority-owned firms in FTA-funded contracts. The type of contract and the total dollar value of contracts awarded to MBE and WBE controlled businesses as prime contractors, subcontractors, suppliers and consultants were also determined.

As shown in Figure ES-2, MBE/WBEs received 18.3 percent of SFMTA's transportationrelated construction and professional services dollars during the Study Period. MBEs received 15.9 percent and WBEs received 2.5 percent of these contract dollars.

Asian Pacific American-owned businesses (utilization of 7.6%) and Hispanic Americanowned businesses (utilization of 5.6%) received the most contract dollars of any MBE/WBE group. Black American-owned businesses (utilization of 2.0%), Native American-owned businesses (utilization of 0.0%), Subcontinent Asian American-owned businesses (utilization of 0.6%), and non-Hispanic white woman-owned businesses (utilization of 2.5%) all received substantially less of SFMTA's contract dollars. Results for DBEs by race, ethnicity, and gender are similar to the MBE/WBE results.

Disparity Analysis. The availability and utilization data was evaluated to identify substantial statistical disparities, if any, between actual MBE and WBE utilization on SFMTA contracts and MBE/WBE firms' availability in the rel-

evant geographic market areas.

Substantial disparities were found for non-Hispanic white woman-owned businesses, which only received 50 percent of the contract dollars that they were expected to receive based on their availability. Other disparity analysis results of note include: Black American-owned businesses showed a substantial disparity on SFMTA construction contracts overall, receiving only 64 percent of the contract dollars expected given their availability; and four MBE/WBE groups showed substantial disparities on small prime contracts: non-Hispanic white woman-owned businesses, Black American-owned businesses, Subcontinent Asian American-owned businesses.

Native American-owned businesses did not receive any contract dollars. This may be due, in part, to the relatively small number of firms owned by Native Americans. Hispanic American-owned businesses also showed a disparity, though it was not substantial, as explained further in Chapter V.

Marketplace Conditions and Anecdotal Evidence. The Study Team conducted quantitative and qualitative analyses of conditions in SFMTA's local marketplace to examine whether barriers exist in SFMTA's marketplace in the construction and engineering industries for minorities, women, and for MBE/WBEs, and whether such barriers affect the utilization and availability of MBE/WBEs for SFMTA contracting.

The Study Team's quantitative analyses show barriers in SFMTA's local marketplace for certain minority groups, women, and minorityand woman-owned businesses in the areas of entry and advancement, business ownership, access to capital, and success of businesses. Evidence presented in other relevant disparity studies that covered SFMTA's local marketplace support that conclusion and also demonstrate substantial disparities in the utilization of MBE/ WBEs in transportation-related construction and professional services contracting. The anecdotal evidence of discrimination was gathered through public hearings, surveys, and one-on-one interviews. Some of the recurring concerns that emerged from this body of information include:

- Complaints that SBE/DBEs are listed on successful bids and contracts but are not utilized after the contract award stage;
- Prime contractor accepting subcontractor bids for work, winning the contract, and subsequently reversing the decision post contract award or not honoring the scope of the accepted subcontractor's bid;
- SFMTA contracting for work, with SBE work starting late in the project; and
- Setting qualification criteria higher than necessary, such as insurance or bonding requirements.

Assessment of Procurement Policies, Procedures and Practices. The Study Team assessed SFMTA's procurement policies, procedures and practices to identify and determine the effectiveness of current race or gender-neutral techniques and whether discrimination or other barriers exist in SFMTA's implementation and enforcement of these policies, practices and processes. The Study Team's assessment is that SFMTA has done a good job, and its policies, procedures and practices did not create barriers to MBE/WBE/ DBE participation during the Study Period.

Business Owners (SBO). This data revealed that business ownership in our nation is mirroring our increasingly diverse population. The number of minority-owned firms in the U.S. rose from 5.8 million in 2007 to 8 million in 2012, and contributed \$1.4 trillion to our economy. From 2007 to 2012, the percentage of minority-owned firms increased from 22 percent to 29 percent of the total number of U.S. firms.

That's positive news for minority business owners and the nation, but there's still more work to be done to grow all minority businesses. I challenge each of us to collectively use our resources to not only identify opportunities in this new economy, but to also create them for others in the minority business community. We must work together to export our products, diversify our corporate ranks, leverage data such as the SBO results and lend our full support to businesses that support minority communities.

Change will not occur overnight but it will occur through strategic action from minority business entrepreneurs, the federal government and the nation. Each of us plays a part.





Abraham Lincoln Civil Rights Activist, U.S. Representative, U.S. President, Lawyer (1809–1865)

Abraham Lincoln was the 16th president of the United States. He preserved the Union during the U.S. Civil War and brought about the emancipation of slaves.



Cassius Marcellus Clay Activist (1810-1903)

Cassius Marcellus Clay was born in Kentucky to a slave-holding family, but became a major figure in the abolitionist movement. Nicknamed The Lion of White Hall, was a Kentucky planter and politician who worked for abolition of slavery.

He was appointed by President Abraham Lincoln as the American minister to Russia during the American Civil War, and is credited with gaining Russian support for the Union.



Solomon Northup Journalist (1808–c. 1863)

Solomon Northup was an African-American farmer and musician who was taken hostage and sold into slavery in 1841; his story is told in the film 12 Years a Slave.



Susan B. Anthony Publisher, Civil Rights Activist, Editor, Women's Rights Activist, Journalist (1820–1906)


Susan B. Anthony was a suffragist, abolitionist, author and speaker who was the president of the National American Woman Suffrage Association.

Born around 1758, in Africa, Jean-Jacques Dessalines was enslaved in the French colony of Saint-Domingue. He served as a lieutenant under Toussaint L'Ouverture after the 1791 slave revolt and later eliminated French rule. Dessalines renamed the colony Haiti in 1804 and declared himself emperor. Despised for his brutality, yet honored as one of Haiti's founding fathers, he was killed in a revolt on October 17, 1806, in Pont Rouge, near Port-au-Prince, Haiti.




Frederick Douglass Author, Government Official, Journalist, Civil Rights Activist (c. 1818-1895)

On Dec.15, 2015, the U.S. Census Bureau's released the final results of the 2012 Survey of Business Owners (SBO). This data revealed that business ownership in our nation is mirroring our increasingly diverse population. 

Executive Summary -Disparities in Capital Access between Minority and Non-Minority Businesses

This report was developed under a contract with the U.S. Department of Commerce's Minority Business Development Agency, and contains information and analysis that was reviewed and edited by officials of the Minority Business Development Agency.

Preface

Capital access remains the most important factor limiting the establishment, expansion and growth of minority-owned businesses. Given this well established constraint, the current financial environment has placed a greater burden on minority entrepreneurs who are trying to keep their businesses thriving in today's economy.

In this study, Dr. Robert W. Fairlie and Dr. Alicia Robb provide an in-depth review and analysis of the barriers to capital access experienced by minority entrepreneurs, and the consequences that limited financial sources are placing on expanding minority-owned firms.

Unknown ObjectMinority-owned businesses have been growing in number of firms, gross receipts, and paid employment, at a faster pace than non-minority firms. If it were not for the employment growth created by minority firms, American firms, excluding publicly-held firms, would have experienced a greater job loss between 1997 and 2002. While paid employment grew by 4 percent among minority-owned firms, it declined by 7 percent among non-minority firms during this period.

Minority-owned businesses continue to be the engine of employment in emerging and minority communities. Their business growth depends on a variety of capital, from seed funding to establish new firms, to working capital and business loans to expand their businesses, to private equity for



acquiring and merging with other firms.

Without adequate capital minority-owned firms will fail to realize their full potential. In 2002 there were 4 million minority-owned firms, grossing \$661 billion in receipts and employing 4.7 million workers. If minority-owned firms would have reached parity with the representation of minorities in the U.S. population, these firms would have employed over 16.1 million workers, grossed over \$2.5 trillion in receipts, and numbered 6.5 million firms. Increasing the flow of capital for minority-owned businesses must be a national priority to re-energize the U.S. economy and increase competitiveness in the global marketplace.

Minority business enterprises (MBEs) make a substantial contribution to the U.S. economy, gen-

erating \$661 billion in total gross receipts in 2002. Minority-owned firms also employed 4.7 million people with an annual payroll totaling \$115 billion. The growth rates in the total number of firms, employment and gross receipts of minority-owned businesses far outpaced non-minority-owned businesses between 1997 and 2002. Had minorityowned businesses reached economic parity, the U.S. economy would have recorded higher levels of key economic activity estimated at \$2.5 trillion in gross receipts and 16.1 million employees. As defined by the Minority Business Development Agency, economic parity is achieved when the level of business activity of a business group is proportional to that group's representation in the U.S. adult population.1

Minority-owned firms are an engine of employment, with young firms creating jobs at similar rates as young non-minority firms. Greater capital access for minority-owned firms is essential to sustain their growth, reduce national unemployment levels, and in particular the high rate of unemployment in minority communities.

At the very time that broad economic productivity is critical to strengthening the economic foundation of the nation, the growth potential of minorityowned businesses is being severely hampered. Across the nation minority-owned businesses face the obstacles of access to capital, access to markets and access to social networks, all of which are essential for any business to increase in size and scale.

4 Tips for Getting a Business Loan

1. Get your financial house (and documentation) in order.

Typically, a business needs to have been profitable for the past three years in order to qualify for a bank or SBA loan. Since most lenders will look closely at your credit history prior to making a decision, keep an eye on your credit score and anything in your credit report that might be a red flag.

Remember, most banks will require that you personally guarantee the loan, but if you have sufficient collateral within your business to cover the loan principal, they shouldn't require a lien on your home.

2. Tell your company's story.

"In my prior experience as the co-founder of a lending company, one of the most basic errors made by loan applicants was not telling me why their company needs the money. And they wouldn't reveal why we should approve the loan even though their company doesn't meet

our minimum standards," says Walter.

Is your industry experiencing growth? Are you scheduled to partner with a major retailer? What's your story?

"Don't just say you want a loan, turn in your documentation, and expect the loan officer to rubberstamp your request," adds Walter. "Fine-tune your business pitch to include your future prospects--not just highlight past successes."

3. Go local.

A national bank is less likely to hear you out if your business hasn't been profitable for the last three years. It is also likely that your company will be passed over if you are lacking sufficient collateral to secure a loan.

"Visit a community bank and also inquire about SBA loan programs," suggests Ross. "Since up to 80 percent of a business loan can be guaranteed by the government under the SBA program, some banks may be more lenient. The downside to this route, of course, is the lengthy paperwork and delay in securing financing due to bureaucracy."

4. Look at alternative financing for short-term needs.

Alternative financing is on the rise as historically profitable or growth-stage companies face shortfalls in cash flow.

"Asset-based lending and factoring are good bridge financing avenues for many small businesses," says Ross.

With factoring, a company sells its accounts receivable to receive a short-term loan of up to 80 percent of its value. Asset-based lending is more comparable to the traditional loan process, where a lender will evaluate accounts receivable, inventory values, and fixed assets to determine creditworthiness, and issue a line of credit. If you don't qualify for traditional bank financing, look at these alternatives, but expect interest rates on these types of loans to be at least double what you'd pay for a traditional loan.
