Senate Democrats Offer \$1 Trillion Infrastructure Plan

Responding to President Trump's insistence he will present Congress with a \$1 trillion infrastructure investment proposal this spring, the Senate Democrats proposed an infrastructure plan of their own.

Senate Minority Leader Chuck Schumer (D-N.Y.) on Jan. 24 unveiled a blueprint aimed at modernizing the country's transportation network over 10 years, claiming the measure would create about 15 million jobs.

Specifically, the plan would authorize \$210 billion to projects for roads and bridges, \$180 billion for transit programs, \$110 billion for water infrastructure systems, and \$50 billion for railways. Speaking to reporters, Schumer did not specify on the measure's funding structure. He did, however, emphasize the measure did not provide tax credits for developers.

A plan President Trump's advisers promoted in October called for providing \$137 billion in tax credits for the private sector to achieve a \$1 trillion investment in infrastructure over 10 years.

"This bill would mean three things for this country: jobs, jobs, and more jobs. And good paying jobs to boot," Schumer said. "As this bill hopefully moves forward, Democrats are going to fight for environmental and labor protections. We will not support tax credits for developers. We will insist that labor and raw materials come from America."

Republicans in control of Congress are unlikely to advance the Democrats' infrastructure measure. Senate Majority Leader Mitch McConnell (R-Ky.) has indicated he would oppose an infrastructure package that is not paid for, and contributes to the national debt.

The national association representing roadbuilders applauded the Democrats but called for bipartisanship.

"Addressing the nation's critical transportation needs in a meaningful way will require real, recurring, dedicated revenue streams that are complemented by private investment," said Pete Ruane, president and CEO of the American Road and Transportation Builders Association. "For that rea-

One local contractor poised for the future

Often in life, the best way to see how you got to where you are today, and where you're going in the future, is to look at where you've been in the past. Such is the case for Derrick Amos and New Vision Commercial Builders, the company of which he is CEO and president.

A third-generation contractor—Amos' father was a contractor, as was his maternal grandfather—Amos grew up learning all aspect of the trade at his father's side — from foundation to roofing and everything in between, including drywall, electrical, framing, painting, etc.

In 1997, he started doing commercial construction as New Vision Commercial Construction, a sole proprietorship. In 1999 he received his General B license, after which he also received his A Engineering and C21 licenses. Since 1999 New Vision has done heavy commercial, including schools, high-end residential, banking or financial institutions, as well as doing other craftwork, concrete framing, drywall, etc. In 2015, Amos incorporated the business, at which time he also changed the name to New Vision Commercial Builders, Inc.

New Vision Commercial Builders is a small, family-owned and -operated business, that is both DBE (Disadvantaged Business Enterprise) and SBE (Small Business Enterprise) certified. It is also a licensed, bonded and insured general contractor firm, whose focus has been commercial/ TI, retail, schools and municipalities. They offer concrete placement, interior/exterior restoration, and a full range of rough and finish carpentry services.

In the 20 years that they've been in business, New Vision has also built something you can't go to a trade school for, or get a license to do: and that is building a lasting relationship with clients and a solid reputation for excellence, quality, attention to detail, integrity and trustworthiness.

Everywhere you turn in California there is construction taking place, running the gamut between residential, commercial, federal, civil, military, and local government contracting. While New Vision

used to do residential work, it's not something they do anymore, choosing instead to focus more on commercial. New Vision now wants to take their experience and reputation to yet another level.

"A building is a building is a building," says Amos, but the construction industry trend in recent years has been to add civil and government (local, state and federal) contracting to one's professional repertoire, something Amos says they are ready for. "It's an atmosphere where there's plenty of work, so my background is the foundation for us to transition to the federal or public sector."

There are several reasons for that, Amos says, not the least of which is that the projects are larger, the payment is guaranteed, there is a fairly quick-turnaround, and there is so much work everywhere. "We're seeing upwards of \$100 billion worth of federal funds being spent over the next 15 years and it's suspected that number could go even higher. With that volume of work being available, there is no sense in chasing our tail doing residential when we can find our place, our sweet spot, if you will, under some much larger contractors who are getting \$500 million or more contracts, and their requirement is to hire smaller contractors in order to reach their (small business enterprise or local business enterprise) goal, or requirement. Having all of our certifications and licenses puts us

in a great position to be able to do federal work."

One of the major projects they're hoping to work on is the \$4 billion to \$5.5. billion Los Angeles International Airport (LAX) and Los Angeles World Airports (LAWA) modernization project, estimated to begin in early 2018. That project, though long-discussed, is finally coming to fruition, and with it, come tremendous opportunities for contractors of all sizes. Dubbed LAMP, the acronym for Landside Access Modernization Program, the project includes a 2.25-mile long Automated People Mover, or train, to move passengers between a new offsite check-in facility and a Consolidated Rent-a-Car Center (otherwise known as ConRAC).

Dragados is part of the lead contractor team for the airport project and Amos and his wife Lisa, who is also the vice president of business development for New Vision, will soon meet with someone from Dragados to see about not only working with them, but being mentored by them, as well. In fact, it's possible that Dragados may have some work that New Vision could partner with them on even before the airport project gets underway in the next year or so.

"There have been somethings tossed around already that Dragados has going on that we may be

SFMTA will hold a public hearing to discuss how the contracting process will change on SFM-TA contracts that contain federal funds. There will now be African American owned business goals on Construction contracts and Women owned business goals on Professional Services and Construction contracts.

SFMTA is required to use Race-Conscious and Race-Neutral methods to meet an overall, annual 15% DBE participation goal. This goal applies to all contracts: construction and professional services. DBEs are businesses owned by women and businesses owned by non-Caucasians.

The San Francisco Municipal Transportation Agency conducted a Disparity Study (see below for more details) that indicated ONLY African American CONSTRUCTION firms did not receive their fair share of contracts with SFMTA. The Disparity Study also indicated that white women-owned firms did not receive their fair share of CONSTRUCTION and PROFESSIONAL SERVICES contracts. The SFMTA ask the U.S. Secretary of Transportation in the Obama Administration whether SFMTA could place African American-owned business and Women-owned business (all women, regardless of ethnicity) goals on CONSTRUCTION projects. SFMTA also asked whether SFMTA could place Women-owned business (all women, regardless of ethnicity) goals on PROFESSIONAL SERVICES contracts. Former Secretary Anthony Foxx agreed.

Mayor Garcetti announces winners of Great Streets Challenge

Mayor Eric Garcetti today announced the winners of the Great Streets Challenge, a program that will award a total of \$2 million to community-driven initiatives to re-imagine Los Angeles' iconic commercial corridors. The seven selected projects span from Panorama City to Watts, and from the Westside to Boyle Heights.

"Our streets belong to the people who use them every day, and the Great Streets Challenge empowers Angelenos to reimagine public spaces in their own neighborhoods," said Mayor Eric Garcetti. "These grants will allow community groups to bring a vision to life — transforming streets across Los Angeles into vibrant, walkable spaces that reflect the unique character of their communities."

Each community partner will receive up to \$13,000 for community outreach, and will be supported by technical consultants and City staff in implementing transportation, economic, and cultural projects.

Four of the Challenge Grant projects will create temporary pop-up projects, while the other three will use the funds to make permanent

street improvements.

"These grants will not only enhance the quality of our neighborhoods, but will also spur our local economy by increasing foot traffic along our busiest boulevards," said Los Angeles City Council President Herb J. Wesson, Jr. who represents the 10th Council District. "The long-term benefits of these projects will not only provide for the residents of the tenth council district, but will serve Angelenos citywide for years to come."

Female entrepreneurs launch XXcelerate Fund to help women-led startups access capital

This female founders' story starts in a kitchen — but the women weren't there to cook.

Portland business leaders Mara Zepeda, Paige Hendrix Buckner, and Genevieve LeMarchal were sitting around the kitchen table discussing a familiar topic. They met regularly to talk about sales strategies for growing their companies. The conversation always came back to funding and how a lack of access often prevented women from becoming entrepreneurs. Despite their success in business, women kept facing rejection from venture capital firms and lenders.

"The women decided that they could do something about it," said Robin Klemm, a longtime angel investor and technology consultant.

Shortly after that meeting in the kitchen, the entrepreneurs approached Klemm with their idea: They wanted to start a fund that would help women get access to critical debt financing and they wanted Klemm to be executive director.

Together, with fellow entrepreneurs Astrid Scholz and Jill Nelson, they launched XXcelerate Fund to help female founders access the capital they need to get their businesses off the ground.

"Women receive only 3 percent of venture capital and 5 percent of small business loans," said Klemm. "Yet, this gap in access to capital is happening at a time when we see continuing proof points of the effectiveness of women business leaders. Men continue to have loads of options when starting a business. It is time to extend equal opportunities to capital for women entrepreneurs."

XXcelerate is currently seeking capital in the form of loan funds and grants through government entities, foundations, businesses, and individuals. The

fund has already secured capacity-building cash from the Portland Development Commission. Once the fund reaches its initial goal of \$500,000, XXcelerate will name its first recipient.

XXcelerate will also help recipients of its loans with financial education, sales guidance, mentorship, and peer support.

The fund is now accepting applications from Oregon businesses, led by women, with a demonstrated market fit and established customer base.

"The XXcelerate Fund board imagines a world where funding women entrepreneurs is the norm, not the exception, and where more women-owned businesses are bankable, investable, or independent," said Klemm. "We have to start somewhere and a fund dedicated to women is a good place to focus."

This startup helps Latino businesses get funding

The two founded Camino Financial, an online lending web site that helps connect small business owners who are first-time borrowers or who are having a hard time getting a loan connect with banks and other lenders.

Sean Salas said the idea came to he and his brother when they were getting their MBAs at Harvard Business School. They remembered how their mother had to close her El Mexicano restaurant chain in Southern California because she didn't have sufficient funding or access to capital.

The closures forced the family to leave Los Angeles, where the two brothers had lived since they were born. So at age 12, they moved to their mother's hometown in Mexico.

These types of stories are common among Latino entrepreneurs.

Often, a lack of credit history or sufficient collateral to secure a loan keeps Latino businesses from getting the funding they need.

According to a recent survey from Stanford University released late last year, only 6% of Latino-owned businesses had used commercial loans. And less than 1% had received venture capital funding, the researchers noted.

But Salas said his mother's circumstances, and that of many Latinos, goes beyond access to financing.

"Capital is not what closed my mother's business," Salas said. "It was a combination of lack of resources, 'know how' and affordable capital to grow the business sustainably."

Community banks used to lead the way in lending to small business, but many of them closed since the Great Recession, said Salas. "Traditional

banks... aren't incentivized to lend to Hispanic business owners."

This has forced many Latino business owners to turn to predatory lenders, which can charge interest rates of as high as 80%, he said.

Through Camino Financial, Salas and his brother not only want to help Latino entrepreneurs qualify for more affordable loans, but offer them advice and ongoing credit monitoring to help sustain their business.

Here's how it works: Camino doesn't finance the loans itself. Rather it pre-qualifies borrowers through its website then connects them with one of its 14 lending partners and takes a commission of 2.5% of the resulting loan's principal.

"The commission is 100% paid by our lending partners, and in most cases, our services come at no additional cost to the borrower," Salas said.

Since many Latino business owners often have little to no credit history, Camino Financial looks at multiple sources of information to determine their creditworthiness.

The company's credit scoring system not only takes into account a borrower's credit score and tax information, but it may also look at other public filings, bank statements and even social media data (with the borrower's permission). On average, borrowers that get approved for loans have at least one year of business, \$100,000 in annual sales and a 600+ FICO score, Salas said.

Depending on a borrower's financials, Camino's lending partners typically charge rates of between 8% and 40%. Although rates typically don't go above 25%, Salas said.

Camino also underwrites the loan, which not only gives lenders extra peace of mind about taking on a riskier borrower but also opens the door for more Latino business owners.

That's because Latino businesses tend to ask for smaller loans -- around \$50,000 -- and banks are reluctant to take on the cost of underwriting the loan. "It costs a bank just as much to underwrite a \$1 million dollar loan as a \$100,000 loan," he said.

Since it launched in 2014, Camino Financial has helped finance \$1.3 million worth of small loans to 33 small businesses, according to Salas.

"We believe we can originate \$1 billion in loans by year five," Salas said. "Our alternative lending competitors have been growing that fast and if you have the right management team it's how fast it can grow."

But a lot will also depend on Camino's own finances.

The firm is one of the only 1% of venture capital-funded companies that are Latino-owned.

Salas says Camino Financial has raised \$750,000 -- and now the company is seeking another round of financing. Last weekend, they were busy pitching themselves to potential investors at Village Capital's 2016 Fintech Showcase at the South by Southwest festival in Austin.

"We're a venture-backed Latino business. We take that with a very strong degree of responsibility," Salas said. "There's also a mission-driven aspect of our business. We want to help Latino businesses to grow."

Slavery to Capitalism

The Incomplete List of US Companies & Universities That Benefited From Black Slavery

Americans tend to think that only the South or only slave traders and slave owners benefited from slavery.

But it was not that simple. Slaves and land were the main forms of wealth in the US before 1860. Therefore slaves figured in insurance policies and bank loans. Therefore universities turned to slave owners and slave traders to raise money. Industry in the North and in Britain made money processing slave-grown tobacco, cotton and sugar from the South and the Caribbean. Railway companies used slave labour. The most profitable activity on Wall Street was – the slave trade.



AIG – bought American General Financial which owns US Life Insurance Company. US Life used to insure the lives of slaves.



Aetna – insured the lives of slaves in the 1850s.



Bank of America – grew in part out of the Bank of Metropolis, which accepted slaves as collateral.



Brooks Brothers – got its start making clothes for slaves!

BROWN == BROTHERS HARRIMAN

Brown Brothers Harriman – a Wall Street bank that owned hundreds of slaves and lent millions to Southern planters, merchants and cotton traders.




Brown University – named for the Brown brothers who gave money to the university. Two were slave traders, another ran a factory that used slave-grown cotton. University Hall was built in part by slave labour.



CSX – rented slaves to build rail lines.



Fleet Boston – grew out of Providence Bank, founded by one of the Brown brothers (see Brown University above), a slave trader who owned slave ships. The bank made money from the slave trade. Providence, Rhode Island was the home port for many slave ships.



Harvard Law School – endowed with money from Isaac Royall, an Antiguan slave owner and sugar grower.

JPMorganChase

JP Morgan Chase – made a fortune from the slave trade. Predecessor banks (Citizens Bank, Canal Bank in Louisiana) accepted slaves as collateral, taking possession of 1,250 slaves from owners who defaulted on loans.



New York Life – insured slaves. Of its first 1,000 insurance polices, 339 were policies on slaves.



Norfolk Southern – the Mobile & Girard, now part of Norfolk Southern, rented slaves to work on the railroad. Central of Georgia, also now part of the company, owned slaves.



Princeton – raised money and recruited students from rich, slave-owning families in the South and the Caribbean. Princeton was not alone in hitting up slave owners and traders for money and students. So did:

- Harvard,
- Yale,
- Penn,
- Columbia,
- Rutgers,
- Brown,
- Dartmouth
- University of Delaware

By the middle 1700s, most Princeton students were the sons of slave owners. Many of Columbia's students were sons of slave traders.

Tiffany's – founded with profits from a cotton mill in Connecticut that processed slave-grown cotton.

able to help them with," says Amos. "They're looking to get us and going right away."

It wouldn't be their first partnership and mentorship with a larger, more well-known firm. In 2016 they began dealing with Skanska. "They had a boot camp that we went through that was a few months' long. We got a certification saying that we know how to do business with them," says Amos. "So, we're talking directly with the people who, not only can we service, but who can get the additional benefit of using local hire, and we have all the necessary qualifications and certifications, plus we'll give them quality work."

Of course, with business change or growth comes new challenges. Lisa says they first experienced challenges when they got away from doing residential construction, but at the same time those challenges can be positives: "When you're doing residential, you learn that people have a tendency to hold their money very closely, almost like holding their payments hostage. They frequently ask for a little more and a little more, literally keeping you there until they get every little bit more they want. But transitioning into commercial, the projects are very specific. You know exactly what's expected of you and when it's done, you're done. That makes for a better working relationship and we're better able to do our scheduling and we know payment will soon follow."

On the downside, she said, because they love working with people, they have lost some of that personal or one-on-one connection. "When we were doing single projects for individuals, we were able to offer a very boutique-type service. But, it's all a part of the growth, I guess. But, when you make changes like that, you have to trust that you're made the best decision for your business. When you're good at your craft, you're good at your craft. And now that we're moving in a different direction, we will still find something that makes us stand out."

Lisa has this to say about what makes them stand out from their competitors: "There are great tradesmen out there. But the thing that really differentiates us is that not only are we great tradesmen, but we have the L, M, N, O, Ps that say to (government entities or large contractors), we are certified, we are a true small business, we have this breadth of experience and we have the educational background of successfully running a business to complement our skills," she explains. "Derrick and I both have MBAs, and Derrick has his PMP (Project Management Professional), so we have not only invested in ourselves in the trade, but in our education, as well. When everything went crazy in the economic downtown of 2009 and 2010, many people just waited for things to pass.



Launch With The Right Plan In Place

We knew it wasn't going to be like that all the time and that when we would come out of that slump, but we wanted to make good use of our time. So, we continued our education, learning the business from an academic and business standpoint, not just a tradesman standpoint."

"We retooled ourselves on the other side. We already were licensed as a General B contractor. We went back and got an A Civil Engineering license, and a C21 (Building Moving/Demolition Contractor) certification. There was a plethora of things that we shored up to make sure that we would be valuable when things did turn around," Amos adds. "So not only do we have the hands-on practical experience, but we have the other side to where we can manage a project from beginning to end, and from ground to ceiling. There's no level of a project that we can't do from a management standpoint – from concept to physically getting it done."



Meet Project Milestones

"There was a place for us before the economic downturn. If things got slow, I could get a job as a project or construction manager quite easily. But when the economic downturn came, everything also shifted down. So, vice presidents became project managers; project managers became construction managers; construction managers became superintendents; so on and so forth. Everybody was trying to save their own skin by taking every position that they could. It was like everyone grappling for a few crumbs. We realized during that time that talent was not enough. There had to be something more than talent that we had to offer, so that when the economy turned around we had more to offer to customers. So, we invested in ourselves and came out a much better contractor on all levels," Amos continues, adding that he can now understand the depth and nuances of a project that before he could not. "Having retooled ourselves in this way, we believe, gives us a leg up on our competition, and we're very happy to be in this position



Finish On Time
And Under Budget

Some might have fears about taking such a big step. But Lisa says they've been preparing for this for a long time; in fact, she says her husband has been preparing for it for his whole life. With the fears removed, all they feel now is excitement and anticipation about the future: "We are so prepared and so ready to let Dragados (and others) know where we are in the process. We're looking forward not only to do a quality job for Dragados, but to be a helpmate with their projects. Plus, by entering this public sector of the business, we're also able to leave a different footprint than we've been able to leave in the residential sector. To be able to point to the airport and tell grandchildren that we worked on it, or to look at the rail system and tell others that we worked on it, or the 405-Freeway, whatever it may be, is a footprint that we'll be able to be very proud of in years to come. Houses may come and go, but those major public structures will likely always be there."

The City received 37 applications from 99 partner organizations. An external panel selected the winning teams based on the strength of their community outreach strategy, and alignment with the City's health, mobility, and economic development goals.

Six of the seven project areas fall outside of the 15 Great Streets corridors announced in 2014 — a first for the Great Streets Challenge.

"I am thrilled the Mayor selected Robertson Boulevard as a recipient of the Great Streets Challenge grant," said Councilmember Paul Koretz of the 5th District. "I've been working with the South Robertson Neighborhoods Council to come up with creative ways to turn this major north/south thoroughfare into a safer, more walkable, artistic and vibrant center for ev-

eryone. The grant money will allow us to further our goals of creating, attracting, and providing more community access, reducing commercial vacancies, improving parking while enhancing safety for those by car, foot, transit or bike."

The Great Streets Challenge builds on a series of neighborhood enhancement projects launched in recent months by Mayor Garcetti's Great Streets Initiative. Most recently, Mayor Garcetti unveiled safety improvements along a stretch of Van Nuys Boulevard.

About the Great Streets Initiative

Mayor Eric Garcetti launched the Great Streets Initiative in October 2013 to transform streets across the city into more vibrant public spaces. A Great Street is a street that serves as the center of a neighborhood, where people can walk, meet, learn, and play on a daily basis. The
