

SBA Expands its Emerging Leaders Initiative Helping Small Businesses to Thrive

#### Recruitment now underway to help increase small business development in underserved communities

The U.S. Small Business Administration announced the launch of the 2017 Emerging Leaders Initiative, a seven-month executive-level training series targeting small businesses with high-growth potential in underserved cities across the nation. This year, three new cities have been added, bringing the number of participating communities to 55.

Local recruitment for the 2017 training cycle has begun and is ongoing at designated SBA district offices. Classes are scheduled to begin in April, and interested small business owners can learn more on eligibility and how to apply at the SBA's website: www.sba.gov/emergingleaders.

The SBA's Emerging Leaders Initiative delivers entrepreneurship education and training focused on small, poised-for-growth companies that are potential job creators. This intensive executive entrepreneurship series includes nearly 100 hours of classroom time per participant and provides the opportunity for small business owners to work with experienced coaches and mentors, attend workshops, and develop connections with their peers, local city leaders and the financial community.

This year, there are three new locations being added to the initiative for the first time, expanding availability of the SBA's Emerging Leaders Initiative to entrepreneurs in Mobile, Ala., Albany, N.Y., and the U.S. Virgin Islands.

The SBA's Emerging Leaders Initiative has trained more than 4,000 small business owners in underserved communities since its inception in 2008, and its impact continues to expand. SBA's Emerging Leaders continues to be a catalyst for expanded opportunities in underserved communities. Emerging Leaders graduates reported that nearly 70 percent achieved revenue growth and over 80 percent created new jobs or retained all existing jobs. Graduates also secured federal, state, local and tribal contract awards of over \$700 million. SBA's Emerging Leaders graduated 775 small business owners in 2016, representing the largest graduating class.

# U.S. Infrastructure Gets Near Flunking Grade From Engineers

The report card is in, and U.S. infrastructure is almost flunking.

The American Society of Civil Engineers on Thursday assigned a grade of "D+" to the quality of U.S. roads, bridges and other infrastructure in a closely-watched assessment that the group publishes every four years. The group said an additional \$2 trillion in funding is needed to raise the standards.

The findings could reinforce President Donald Trump's initiative to steer as much as \$1 trillion in public and private funds to U.S. infrastructure over the coming years. Trump met with privatesector leaders on Wednesday to discuss his plan and said he wants states to be ready to start projects within 90 days of receiving funding, the White House said.

"We need our elected leaders – those who pledged to rebuild our infrastructure while on the campaign trail – to follow through on those promises with investment and innovative solutions that will ensure our infrastructure is built for the future," Norma Jean Mattei, ASCE president, said in a statement.

## Los Angeles Mayor Wins Re-Election in Landslide

Los Angeles Mayor Eric Garcetti, facing 10 little-known opponents, was gliding to a second term Tuesday in an election that tested his clout as Los Angeles voters weighed a sweeping anti-development measure that he fought to defeat, according to early returns.

With less than 5 percent of the vote counted, Garcetti declared victory in remarks to cheering supporters in Pico-Union.

Eight City Council seats were also at stake in Tuesday's primary, with incumbents across the city all taking an early lead over their challengers.

In a season when Donald Trump's tumultuous presidency has dominated politics worldwide, it has been hard for Garcetti and others on the L.A. ballot to capture the public's attention.

Garcetti spent more than \$3 million trying to burnish his image for an election he stood little chance of losing. His goal was to win not just another term, but also a solid affirmation of hometown support that could strengthen his standing to run for statewide office. He governs a city of nearly 4 million people, but is barely known outside Southern California.

In his campaign, Garcetti stressed his record raising the minimum wage, cutting business taxes and backing ballot measures to expand public transit and house the homeless.

The recent surge in homelessness and an uptick in crime threatened to dampen Garcetti's support, even if he was widely expected to win the majority vote that he needs to avoid a May 16 runoff.

Public anxiety over explosive growth of development in Hollywood and other neighborhoods fueled support for Measure S, which would hinder some major real estate projects. Passage of the measure would be a blow to the pro-development mayor, but preliminary returns showed it losing by a wide margin.

A liberal Democrat, Garcetti also faced criticism from immigrant rights advocates who accused him of failing to speak out forcefully enough against Trump, a charge he denied. They criticized him for resisting labeling Los Angeles a "sanctuary city" for immigrants in the U.S. illegally.

On Tuesday night, scores of protesters gathered outside Garcetti's election celebration at the Pico-Union office of Laborers International Union of North America Local 300.

"Sanctuary is our demand, Mayor Garcetti take a stand," they chanted.

Garcetti has sought to raise his national profile in recent weeks by denouncing Trump's immigration policies in television news interviews.



The property does not include the residential portion of the mixed-use development.

The Fillmore Heritage Center, one of the last projects from the Western Addition redevelopment program, was developed as a multi-use facility whose goal was both to revitalize the commercial corridor and to honor the cultural heritage of the neighborhood, which prior to "Urban Renew-al" was considered the "Harlem of the West" for its sizable community of African American residents and African American-owned businesses, many of them music venues.

# What Crowdfunding and 'Democratizing Capital' Could **Mean for Minority Entrepreneurs**

Data supports the notion that institutional prejudice is widespread and affecting the overall quality of life for minorities across the country, primarily through startup capital acquisition and employment. The darker we are, the harder it is to live a quality life; however, this goes directly against the American Dream ideals the Founding Fathers' rooted in our Constitution. All men and women are created equal with the right to life, liberty and the pursuit of happiness. The power to alter the course of institutional discrimination is possessed by the diverse makeup of 320 million Americans--the crowd.

Small businesses and startups in America are a dreary topic and we usually hear about their high rate of failure or exits as a billion-dollar unicorn. Starting up a business in America has a lot of friction involved, most notably raising capital. The SEC's finalization of the JOBS Act in mid-2016 brought the business startup process into light for everyone, but the masses are slow to learn and adopt these new regulations...and their unique benefits to minority groups. How are minority leaders using crowdfunding to level the playing field with large institutions?

#### Reward and Donation Crowdfunding, Infantile Equity

The digital crowdfunding trend in America started in 2003 when ArtistShare launched as the world's first donation crowdfunding platform for creative artists. The most notable crowdfunding platforms today, Indiegogo and Kickstarter, launched a few years later with a reward model in 2008 and 2009, respectively. In this time, Kickstarter has launched an astounding 340,559 projects, raising \$2.9 billion since launch, giving grassroots a whole new channel of exposure. Reward and donation crowdfunding are similar, but reward campaigns will offer a perk for contributions while donation campaigns do not. Crowdfunding has surely stimulated the national and global economy over the years, but equity crowdfunding is a federally regulated tool with the ability to shift power from large, robust institutions to the individual entrepreneur and investor.

#### Crowdfunding and Community Building

Prior to the JOBS Act, entrepreneurs turned to friends and family when raising funds. In order to expand fundraising to new potential investors after exhausting the previous option, they hire securities lawyers. The startup then learns the bad news: they cannot raise capital from anyone with whom they do not have a substantial pre-existing relationship. Otherwise it would violate the prohibition against general solicitation. The JOBS Act changed this by classifying 240 million citizens as non-accredited (or retail) investors and allowing general solicitation to the public. Entrepreneurs can now go to their friends, family, AND communities.

Equity crowdfunding acts as a catalyst for individuals to collectively combat institutional dis-crimination along with the very real wealth and unemployment disparity between races in the country. Any American adult can hire an attorney and file their offering with the SEC under Reg CF or A+ and, after approval, can begin raising capital from their crowd in exchange for equity shares of their company. While organizing a crowdfunding campaign strategy is complex in nature, leaders

across the country are working hard to make this crowdfunding easier and more accessible to every-

While the equity crowdfunding space is off to a very slow start with only 26,000 Reg CF investments made in the last nine months, leaders in the community are already advocating for equal opportunity and diversity among entrepreneurs. Devin Thorpe, Champion of Social Good- Journalist, author, and avid speaker on a mission to solve some of the world's biggest problems before 2045 by championing the work of change agents who will do it.

Lynn Da, Buy The Block- Advocate for minority investment education and access to real estate crowdfunding investments. Platform set to launch April, 2017.

StartingFive Partners and General Catalyst Partners, FundLatinos - These two groups came together to develop this donation crowdfunding platform to



bring together with the vision to build the tools, technology and partnerships needed to foster a trusted environment for Latinos to raise money for personal and community causes that matter.

Charlie Jackson, CEO at Texas Diversity Fund-Equity crowdfunding platform with a focus on encouraging diversity in entrepreneurship.

Financial education is another big issue facing the entire Fintech space and a determining factor when enrolling investors. Startup investing is extremely risky and investors should know there is the potential that they lose their investment capital. This is a call to action for other leaders with a global mindset to stand up and use your power to include minority groups and break down barriers. Crowdfunding is just a tool of democratized finance, we choose whether or not to use it collectively to make a true difference in our local communities onto the rest of the globe.

## U.S. Infrastructure Gets Near Flunking Grade From Engineers

#### Continued from page 1

The ASCE evaluated 16 categories of infrastructure in its 2017 report card, with grades ranging from a "B" for rail to a "D-" for transit. Engineers assessed data and reports and consulted with technical and industry experts to assign grades, the group said. The criteria included whether capacity meets current and future demands, infrastructure condition and the current level of funding.

The group defined the "D+" grade as infrastructure that is "in fair to poor condition and mostly below standard, with many elements approaching the end of their service life."

While the overall grade was unchanged from 2013, there were some improvements: hazardous waste management, inland waterways and locks, levees, ports, rail, schools and wastewater treatment, according to the report. Grades fell for parks, solid waste management and transit. They stayed the same for aviation, bridges, dams, drinking water, energy and roads.

The group estimated that there's a gap of more than \$2 trillion between projected current funding and the \$4.59 trillion it would take to improve U.S. infrastructure to a "B" grade by 2025, according to the report.

The ASCE says it represents more than 150,000 members in 177 countries who plan, design, construct and operate infrastructure. In a 2016 report, the group estimated that a failure to close the gap in infrastructure investment would result in \$3.9 trillion in losses to the U.S. economy by 2025.

Trump has yet to provide details for his plan, including what kinds of infrastructure would be included and how it would be funded. He has said it will be "financed through both public and private capital," including with public-private partnerships.

The administration convened a meeting on March 2 with 15 cabinet members and agency leaders to discuss funding, projects, and possible changes in policy, regulations and statutes to speed the process. Trump met on Wednesday with representatives from the private sector, including billionaire Elon Musk, to discuss ways to encourage public-private partnerships, the White House said.

During the meeting, Trump asked for more details about Musk's Hyperloop project that would use small vehicles to transport people and goods through low-pressure tubes at high speeds, the White House said. The details of the meeting were reported earlier by the Wall Street Journal.

The president also expressed interest in both new high-speed railroads and auctioning the broadcast spectrum to wireless carriers, and he suggested giving states 90 days to start projects to encourage them to accelerate permitting the way he is trying to do at the federal level.

Officials with the U.S. Chamber of Commerce and the American Association of State Highway and Transportation Officials testified on Wednesday before the Senate Subcommittee on Transportation that while a variety of funding and financing tools are needed, there must be more public investment and that existing funding mechanisms to get dollars to states should be used.

"The needs are great, and the resources are limited," said Ed Mortimer, the chamber's executive director for transportation infrastructure. "This is a once-in-a-generation opportunity to modernize America's infrastructure."

## Los Angeles Mayor Wins Re-Election in Landslide

"He's out there defending the cause," Romario Ortiz, 27, the son of immigrants from Guatemala and El Salvador, said Tuesday after voting for Garcetti at an Echo Park polling station.

Only one of Garcetti's challengers, Democratic political operative Mitchell Schwartz, posed at least a minimal threat. Schwartz spent nearly \$700,000 on the contest, much of it for final-week mailings to voters. It has been many decades since that kind of small-scale campaign has succeeded in an L.A. mayor's race.

The other two citywide elected officials, Controller Ron Galperin and City Attorney Mike Feuer, were running unopposed Tuesday, as was Councilman Bob Blumenfield in the West Valley.

But City Councilmen Gil Cedillo, Paul Koretz, Curren Price, Mike Bonin, Mitch O'Farrell and Joe Buscaino were all facing challengers. In the East Valley, 20 candidates were vying for the open council seat last held by Felipe Fuentes.

Cedillo, who served 14 years as a state lawmaker before winning his council seat four years ago, was facing one of the most serious challenges, from bike activist Joe Bray-Ali. But the first round of election returns found that even Cedillo stood a chance of winning a majority and avoiding a runoff.

One sign of concern among Cedillo supporters was a late \$80,000 expenditure by a Los Angeles Area Chamber of Commerce committee on Spanish-language radio ads promoting the Eastside councilman. The ads focused on his work supporting immigrants in the country illegally.

At Cedillo's party Tuesday night in Highland Park, former Mayor Antonio Villaraigosa, said a runoff looked unlikely.

"He's a fighter and I think the people recognize that," said Villaraigosa, now a candidate for governor.

Price, one of three blacks on the council, was trying to fend off two Latino challengers in his district just south of downtown. The district has become a test of black political power in recent years as the Latino population has steadily risen. Initial returns showed Price easily avoiding a runoff.

Koretz, Bonin, O'Farrell and Buscaino were each defeating their opponents handily in early returns. In the open East Valley district, early returns showed Karo Torossian and Monica Rodriguez best positioned to make a May runoff.

The trickle of voters at city polling stations captured the city's prevailing attitude toward the election: indifference.

"Four people in line at my polling place is four more people than I thought would be at my polling place, so that's something," University of Southern California graduate student Alex Amadeo wrote on Twitter.

The city's elected officials normally serve fouryear terms. But because of a shift in the election calendar, winners of this year's elections will serve 5{ years. Starting in 2020, city elections will coincide with state and federal elections.
