# As MBDA Celebrates Its 47th Year, a Look Back At March 1969

## **Historical Highlights**

1969 President Nixon signs Executive Order 11458 creating OMBE and the Advisory Council for Minority Business Enterprise. OMBE and the Advisory Council partner with the U.S. Census Bureau to conduct the first Survey of Minority-Owned Business Enterprises.

In the early morning of March 5, 1969, President Richard M. Nixon emerged from the private residence of The White House and received his daily schedule. As usual, it was packed with ceremonial events and meetings concerning governance.

Tucked between a 7am breakfast with NSA Assistant Director Henry Kissinger, and a lunchhour meeting with Urban Affairs Assistant, Daniel Patrick Moynihan, President Nixon had an event with a very long title:

"Creation of the Office of Minority Business Enterprise and [signing] the Executive Order, 'Pre-scribing Arrangements for developing and coordinating a National Program for Minority Business Enterprise."

In the Cabinet Room of the White House, President Nixon signed Executive Order 11458 establishing a U.S. Department of Commerce division now known as the Minority Business Development Agency.

About 40 guests were invited, including representatives from minority chambers of commerce from across the nation, as well as several cabinet officials, including:

- U.S. Secretary of Commerce, Maurice H. Stans
- Hilary Sandoval, Administrator, Small Business Administration

197 President Nixon signs Executive Order 11625 and expands the scope of MBDA and its minority business programs by authorizing grants to public and private organizations to provide technical and management assistance to minority business enterprises (MBEs).

- George Romney, Secretary of Housing and Urban Development
- Walter Hamilton, Deputy Assistant Secretary for Business Policy.

The formation of the Office of Minority Business Enterprise happened during a period of social and political turmoil in many American cities.

While the Voting Rights Act and the Civil Rights Act had been signed into law by President Lyndon B. Johnson earlier in the 1960s, by the end of the decade, President Nixon acknowledged that the Federal Government needed to do more.

During the signing ceremony, Nixon's statement reflected the economic imperative of establishing a Federal agency that promotes the establishment and growth of businesses owned and operated by minority entrepreneurs:

I have today issued an Executive Order directing the Secretary of Commerce to coordinate Federal programs related to the strengthening of minority business enterprise, and authorizing him to take the necessary steps to do so effectively.

The President continued: This is not a substitute for the many other efforts that continue to be needed if we are to make headway against the ravages of poverty. It is a supplement, dealing with a special but vital part of the broader effort to bring the members of our minority groups into full par-ticipation in the American society and economy.

981 The Minority Business Development Center program was established and became the MBDA's primary method for delivering technical and management services to MBEs. MBDA served ninetyfour Metropolitan Statistical Areas and an Information Center was created, which collected, published, and disseminated data and information pertinent to MBEs.

1983 President Ronald Reagan signed Executive Order 12432 giving the Department of Commerce and the U.S. Small Business Administration, in consultation with the Cabinet Council on Commerce and Trade, broad authority to oversee the establishment, preservation and strengthening of federal minority business enterprise programs. President Ronald Reagan also signed a Presidential Proclamation designating the first week of October as Minority Enterprise Development Week (MED Week).

Its success will be measured by tangible results, not by the volume of studies.

Nearly five decades later, the Minority Business Development Agency has made great strides toward accomplishing the goals laid out by President Nixon.

For example, in FY 2014, MBDA supported the creation and retention of nearly 31,000 jobs by assisting minority-owned businesses in obtaining access to nearly \$6.9 billion in contracts and capital-exceeding the previous year's record level by 45%. Job creation and retention by MBDA clients has increased 55% since 2012.

As MBDA approaches a half-century, MBDA National Director Alejandra Y. Castillo salutes the Agency for more than four decades of service to our nation's minority-owned businesses.





1996 MBDA focused on relationships with the private sector with an emphasis on strategic partnerships to assist the growth of minority businesses. There was also an emphasis on international trade and franchising.

## 2013 In fis-

cal year 2013, through **MDBA's nationwide** network of Business Centers, we have assisted clients in securing more than \$4.8 billion in contract and capital. This led to the creation and

than 25,000 U.S. jobs. Return on taxpayer investment, the Agency's primary measure of internal operating efficiency, was 174x in fiscal year 2013.

## **Change Orders Could Add Hundreds of Millions** of Dollars to First 29 Miles of CA Bullet Train

The California rail authority is facing hundreds of millions of dollars in potential change orders and other prospective cost increases on the first 29 miles of the bullet train system, state and private contractor documents show.

The change orders and other claims are coming from construction firms, utilities and railroads involved in that first segment, according to the documents.

Several of the biggest claims and change orders could cost 10% to more than 30% above original estimates for the segment, which is to run between Madera and Fresno. Scores of smaller claims could mean additional spending.

Higher costs for the first construction phase of the project would carry implications for the entire \$64-billion system.

The rail authority has repeatedly asserted that Central Valley contracts were signed for below budget amounts. If claims submitted after those contracts were signed send costs above budget, they will call into question the rail authority's cost projections for the full system.

The contractor team on the first segment has sent the rail authority a log that includes more than 300 pending change orders and notices, about 200 of which do not yet include cost estimates. The team, led by Sylmar -based Tutor Perini, won a \$1-billion contract in 2013 for the first segment. The Times obtained a copy of the log dated last November and a subsequent update in January.

Asked about the notices, state officials said the documents are not yet official claims or demands, and should not be considered final.

"The fact that the contractor will submit change orders or claims to us is really just the start of the process," rail authority Chairman Dan Richard said in an interview. "It is not a self-executing process."

The requests will be audited by the authority to see "if the costs they claim really did happen," Richard said. "After that there will be the process of what really caused those and who has the responsibility."

He noted that the process also works in the other direction. "We will have claims against the contractor for not being ready to do things they should have been ready to do." Ron Tutor , chief executive of Tutor Perini, did not return a call requesting comment.

The rail authority has approved about \$14 million in change orders, and the logs from Tutor Perini include an additional \$51.7 million that the company has estimated.

Among the unpriced change orders is a potentially large claim Tutor Perini is preparing against the state for project delays. The firm cited the state's failure to deliver land parcels over a two-year period after the contract was awarded.

The state had virtually none of the land acquired in 2013 when it awarded the Tutor Perini contract, and limited construction did not begin until July 2015

Tutor Perini believes the state owes it \$65 million for a 17-month delay, according to company documents obtained by The Times . A second delay of sev-en months could be priced at \$30 million , according to experts who have looked at the computations.

Rail authority spokeswoman Lisa Marie Alley said the authority has not received a formal claim from Tutor Perini about the delays.

It will take time for the state and contractors to decide on the costs of change orders. But construction industry experts who reviewed the logs said those changes could be costly. Several estimated they could exceed \$400 million on the initial contract.

They based their estimates on the large volume of change orders, lengthy delays and the significant revisions of the original plans.

"If you award a contract and promise to make the land available and it isn't there, it can have consequences," said William Ibbs , a UC Berkeley civil engineering professor who has consulted on high-speed rail projects around the world. "Delay claims occur all the time.'

The Tutor Perini computed costs include idleequipment charges, overhead, higher prices for materials and additional insurance, among other items. The company parked dozens of pieces of heavy construction equipment in yards near the Fresno project.

The rail authority has set aside a \$160-million contingency fund for potential cost overruns on the segment, which, including work by utilities, is estimated to cost \$1.2 billion to \$1.8 billion .

But project chief Gary Griggs of Parsons Brinckerhoff , the state's lead consultant, last month warned the authority board that it might have to increase that contingency fund by an additional \$150 million .

In addition to problems raised by Tutor, potential costs have risen for utilities, highway relocations and freight railroad issues.

This month, a report by rail authority staff warned that a \$150-million cost increase was projected for just two companies, communications giant AT&T and utility provider PG&E .

Alley said the increased costs relate to design issues and "a better understanding of utility impacts." Part of the problem involves what construction managers call "unexpected conditions," in which the lines are not where blueprints show.

"The state did research with PG&E to find gas and electrical locations, but those lines are not always where you think they are or as deep as you think they are," said Fresno public works director Scott Mozier . Fresno has no direct role in the matter, except handling its own water and sewer pipes.

Railroads are discussing tens of millions of dollars in compensation for impacts on their operations, including relocation of their tracks, barriers separating their lines from future bullet train tracks and other uses of their property.

The two freight railroads did not respond to requests for comment.

One of the major unpriced change orders on the Tutor Perini log involves the relocation of a one-mile stretch of Golden State Avenue in Fresno,

#### a major north-south four-lane highway.

The contract originally would move the road by about 25 feet, but business owners protested to Fresno Mayor Ashley Swearengin , saying it would damage their operations. Swearengin negotiated a new plan to relocate the highway by about 400 feet around the back of the businesses, said Mozier, the public works director.

The work includes relocating a flood retention basin, moving utilities, gutters and much more, at a cost likely to get into the high tens of millions of dollars, according to one engineer close to the project. Alley said the agency is negotiating a price for the change and would not speculate about the cost.

"This change was important to us because [it] resulted in fewer impacts to property owners, which is a key element of this program," Alley said.

The Golden State realignment concerns some Fresno leaders, though the project still has the strong support of Swearengin.

"Right here in the first mile in Fresno , you have a major change," said Steve Brandau , a city councilman whose district includes the realignment section. "How many times is this going to happen by the time they get to Los Angeles ?"

Brandau said he is worried that Fresno could be left torn up if the project stumbles, adding that rail authority officials routinely disregard his requests for information on construction plans in his own district.

Lawson Rock & Oil Inc., the state's largest hauler of crude oil, has a large truck yard on Golden State Boulevard that was among the affected businesses. Owner John Lawson , a member of the Fresno County planning commission and a former member of the California Transportation Commission, said the rail authority made a major error in awarding the Tutor Perini contract when it had such little property in hand.

"When they awarded Tutor the contract, the state owned three or four pieces of property," Lawson said. "That was pretty stupid. If they can build this for [ \$64 billion ] like the liars say, I say build it. But when it gets to \$150 billion they are going to be in deep trouble."

Higher costs for the first 29 miles could be just part of broader increases affecting the entire 118 miles of construction in the Central Valley .

A detailed analysis of the bullet train project by Elizabeth Alexis , a private investment manager and cofounder of a Bay Area group critical of the project, asserts that the Central Valley construction segment from Madera to near Bakersfield is now about \$1.2 billion above the 2012 budget of \$5.8 billion -- a 21% jump. A spreadsheet that details the changes was submitted to the Legislature and the rail authority.

"Their plans change all the time, so it is hard to track on an apples-to-apples basis how their costs have changed," she said. "None of their documents allow this direct comparison."

In a report this month, the Legislative Analyst's Office concluded that the amount, schedule and cost of work in the Central Valley have changed over time, making it "difficult to determine how well the high speed rail authority is adhering to the budget for that segment."

## These Are The Best Cities For Minority-Owned Businesses



The recession turned out to be a boom time for starting new businesses. That's when the U.S. economy lost more than 8 million jobs starting in late 2007, and the convergence of unemployed workers with no alternative job offerings created the most fertile environment for entrepreneurship in more than a decade, according to analysis of Census and Bureau of Labor Statistics data published in the Journal of Economics and Management Strategy.

A second trend that emerged post-recession is the rise of minority entrepreneurship. According to the most recent government data, 2.2 million non-white Americans started their own businesses in the aftermath of the economic downturn—growing 38% between 2007 and 2012. That's more than triple the population growth of minorities, government data show.

But being a minority business owner has its challenges. Even though they now make up 29% of all U.S. firms, up from 22% in 2007, minority-owned businesses still only account for 4% of all business revenue in the U.S. Additionally, a recent report from the Minority Business Development Agency found that despite this growth, the average gross receipts for those firms dropped by 16%.

That's due in part to the fact that minorities—like women—have less access to capital. For example, according to CB Insights report in 2015, only 1% of venture-backed founders were black, while the census shows they make up the largest racial minority, or about 14.3% of Americans.

There are some areas across the country that have proven to be more favorable toward minority business owners. Nerdwallet, a financial advice and tools site, analyzed government data to fine the best places for minority entrepreneurs to start and run their businesses.

To do this, they first pulled together 178 metropolitan areas with populations of 250,000 or higher, then factored in the business climate from the Census Bureau's Survey of Business Owners that comprised 55% of the overall score. They then looked at the health of the local economy based on three metrics from the Census Bureau's American Community Survey for 20% of the score. Finally, access to financing that rounded out the remaining 25% of the score was garnered from data from the Small Business Administration (SBA) and the American Community Survey.

NerdWallet's data analyst Jonathan Todd points out that it was important to look beyond areas with high concentrations of minority-owned businesses. If they had, only five states would be represented. Judging by overall favorable conditions still has some states such as California well represented, but others such as Utah with a rising population rate of Hispanics, and Fayetteville, Arkansas; Anchorage, Alaska; and Cedar Rapids, Iowa.

Other common favorability factors shared among the top 10 cities for minority entrepreneurs are employment rates and the number of SBA loans. Each city showed a stronger recovery than the rest of the country in the last three years, with unemployment averaging at 4.7% from 2013 through 2015, compared with 6.2% nationally. All top 10 cities additionally ranked in the top 25% based on SBA loan amounts per 100,000 residents.

#### When Diversity Efforts Work

The case of Cedar Rapids mirrors a current diversity issue running through the tech industry right now. Attracting underrepresented minorities is only one part of a diversity effort. Like Intel, which made a massive investment in its initiatives to recruit more diverse talent, Cedar Rapids business leaders founded Diversity Focus in 2005 to change the face of a community that was 95.5% white. Like Intel, companies in the metro area were having a hard time getting minority employees to stay.

Their efforts achieved some success. Cedar Rapids's white population has fallen to 91.2% white, but alongside this, SBA loans to minority businesses in the area increased by 111% from 2007 through 2012, according to NerdWallet. Todd notes that part of the bump was due to the 2008 flood, which boosted the number of government-backed loans to area businesses.

Other metro areas such as No. 6 ranked San Francisco-Oakland-Hayward, California, have support systems such as Pacific Community Ventures, a nonprofit social enterprise that pairs founders with local business mentors, or No. 7 Santa Rosa, California's minority business support groups such as the Hispanic Chamber of Commerce of Sonoma County. Utah's burgeoning ethnic populations are bolstered by No. 9 ranked Salt Lake City's chambers of commerce for Native American, Asian, and Hispanic communities, and Utah Diversity Connections.

#### Where The Future Population Is Trending Now

San Jose, California, provides a snapshot of what the future demographic makeup of the country is. In 2013, the metropolitan area's minorities outpaced the white population for the first time—48.3% white compared with 51.3% the previous year, according to Census Bureau data. San Jose also clinched the No. 1 spot by having the highest minority median income—\$83,406 in 2014.

Coming in at No. 2 is an area that is also impacted by an influx of minorities. Fayetteville-Springdale-Rogers, which crosses from Arkansas into Missouri, has a fast growing economy thanks to being home to Walmart, Tyson Foods, and J.B. Hunt Transport. The NerdWallet report quoted analysis from the Federal Reserve Bank of St. Louis, which revealed, "Nearly 30% of residents in Springdale and Rogers are Hispanic or Latino, about twice the national rate. More than 10% of the firms in each of these cities are Hispanic-owned."

#### Women Emerge As More Entrepreneurial

Among these minority-owned businesses, a large cohort are owned by women. A separate, recent report issued by the National Women's Business Council (NWBC), based on the most recent data set (2012) from the census, revealed that of all African-American businesses, the majority (58.9%) are women-owned. That's more than 1.5 million businesses across the U.S., and the rate of growth represents a 67.5% increase.

Additionally, there are 1.48 million Hispanic women-owned businesses in the U.S., an 87.3% increase since 2007. In comparison, the number of businesses owned by Hispanic men grew just 39.3%. The same holds true between Asian men and women. There are 754,874 Asian-American women-owned businesses, up 44.3% from 2007. That is less than the five years prior (54%), but still better than growth in businesses owned by Asian men, which capped out at 25.1%.

Fast Company recently reported on NerdWallet's best cities for female entrepreneurs. Overall though, NWBC's chairwoman Carla Harris chalked such growth up to a "perfect storm" of historically low interest rates, inflation, record amounts of cash on corporate balance sheets, an increasing presence of women on boards of directors, and female degree holders. "It could not be a better time to start and scale," she said.

## Loan Options and Advantages for Minorities Running a Small Business



Loan Options and Advantages for Minorities Running a Small Business

Are you a minority who is starting or growing a business? If so, you're definitely in good company, and there are many minority business loan options and loan alternatives available when you need funds. State and local agencies, as well as private organizations assist minority owned enterprises in a variety of ways including with minority business loans. There are also Small Business Association (SBA) backed loans that are available to all business owners including minorities. In fact, a recent study has shown that SBA-backed loans are three to five times more likely to be made to minority businesses than those made by banks.

There has definitely been an increased focus on providing loans to minorities and for good reason. The number of minority-owned businesses jumped nearly 50% from 2002 to 2007 – more than double the 17.9 percent increase for US businesses as a whole. Revenues of minority-owned businesses increased 55 percent to \$1.0 trillion over the same five year period. This is compared to a 33 percent increase for all businesses nationwide. The three states with the largest number of minority-owned firms are California, Texas, and Florida. In Los Angeles County alone, nearly 45% of all businesses are minority-owned.

With more minorities than ever launching businesses, the need for minority loan options is increasing. And, lenders are seeing this as an opportunity to reach out to them with a variety of new lending opportunities. The following offers some of the best options for minorities who want financing for their business venture.

### The Minority Business Development Agency (MBDA)

A great place to start when investigating minority business loans is the Minority Business Development Agency which is part of the US Department of Commerce. This government agency offers technical assistance and access to capital, contract opportunities, and new markets with the purpose of fueling job growth.

On the MBDA website, there is information about a variety of financing options for minorities including how to apply for a minority business loan, availability of grants, and private equity and venture capital sourcing. The agency offers oneon-one financial counseling for minority business owners and can even help with getting documentation together for a loan application.

#### The Small Business Administration (SBA)

While the SBA does not offer specific any specific minority business loan program, it is one of the largest loan guarantors in the United States. This gives businesses the opportunity to apply to certified commercial lenders for loans backed by the government. The SBA does not offer any preferential status for any group, and as such doesn't provide funding specific to a demographic. But, many certified lenders do have special programs to award loans to minority businesses.

### The SBA offers a variety of loan programs including:

General Small Business Loans – For general small business loans, the SBA has the 7(a) Loan Program which provides loans to businesses to assist in the acquisition, operation, or expansion of an existing business. These loans have a maximum amount of \$5 million. The average 7(a) loan in 2012 was \$337,730.

<u>Microloans</u> – The SBA's Microloan program loans up to \$50,000 to help small businesses and some not-for-profit childcare centers expand or start up. The average amount of this type of loan is \$13,000. The SBA works with designated intermediary lenders which are nonprofit communitybased organizations with experience in lending, management, and technical assistance. These lenders each have their own lending and credit requirements, and some offer special programs for minority business owners.

Microloans can be used for working capital, inventory, supplies, furniture, fixtures, machinery, or equipment. However, SBA microloan proceeds cannot be used to pay off existing debt or to purchase real estate. The payment term for an SBA microloan is six years, and the interest rate typically ranges from eight to 13 percent.

To apply for a microloan, you will need to work through one of the affiliated nonprofit, community-based organizations, and typically business training is one of the requirements of obtaining this type of funding.



The SBA 8(a) Business Development Program

While not a loan program, the 8(a) program helps qualifying minority-owned businesses growth through one-to-one counseling, training workshops, and management and technical guidance. The 8(a) program also gives minority businesses access to government contracting opportunities to enable them to compete in the federal marketplace.

Minority groups are presumed by the SBA to be socially and economically disadvantaged and can qualify for the 8(a) program. These groups include African Americans, Hispanic Americans, Native Americans, Asian Pacific Americans, and Subcontinent Asian Americans. Business owners who are not members for one or more of these groups can be considered for the 8(a) program if they can provide substantial evidence and documentation that shows they have been subjected to bias or discrimination and are economically disadvantaged.

Minority business owners who are interested in the 8(a) program should contact their local SBA district office.

### State and Local Funding for Minority Business Loans

It's definitely a good idea to investigate state and local sources of funding when looking for a minority business loan. There are a variety of regionallyfocused redevelopment agencies and other organizations that can help.

Operation Hope is one such organization that is helping people in low-wealth communities who want to grow businesses. Their Small Business Empowerment Program provides business training, as well as assistance with loan packaging, access to direct lenders, SBA loan program financing, and lines of credit.

Many states offer specific minority business loan programs. For example, the State of Ohio offers a Minority Direct Loan Program which provides fixed, low-interest rate loans to certified minority-owned businesses that are purchasing or improving fixed assets or creating or retaining jobs. Eligibility for the program is determined by a number of factors including the number of jobs created or retained as a result of the State's investment, the extent of participation by the business and a lender in the project, and demonstrated need for the funds. The minimum amount for this loan program is \$45,000 with a maximum amount being \$450,000.

#### Private Lenders

Both community and national lending institutions offer minority business loans. These loans typically have competitive interest rates, more flexible underwriting, and generally less restrictive lending options. Banks generally use the minority definitions set forth by the Equal Employment Opportunity Commission. And, a minority must own and manage at least 51 percent of the business.

Most commercial banks with active small business portfolios or SBA lending programs have programs for minorities. For example, Wells Fargo had recently set a goal of lending \$5 billion to Asian American businesses owners as part of its Asian Business Services division. KeyBank runs a minority and women's business enterprise program, and Bank of America and UPS Capital have both committed to helping minorities with lending programs.

#### Other Forms of Funding for Minorities

Minority business loans are definitely an option for minorities looking for working capital to fund their businesses. But, there are other options for acquiring cash including peer-to-peer microlending sites and non-traditional lenders of working capital like Kabbage. Kabbage offers fast flexible funding for purchasing inventory, hiring help, or buying equipment, and advances are available quickly – typically in less than seven minutes.

Of course, many minorities obtain loans through friends and family, and even angel investors who are willing to invest in a portion of a business in the infancy stage with the hope that they will be able to make a profit as the business grows.
