# Investing in women entrepreneurs nets a huge return on investment

Linda McMahon, the president's nominee to lead the Small Business Administration, made a point during her confirmation hearing saying that she wants to grow women's entrepreneurship.

She's not alone.

Momentum on women's issues has reached a fever pitch, making this the perfect time to empower McMahon, if confirmed, to make good on that goal by giving her the tools she needs to harness the entrepreneurial energy of our nation's 10 million women business owners. We urge the president and Congress to join her in helping women business owners and the economy prosper.

Our organizations, which represent microbusinesses and women entrepreneurs, propose the government make a significant investment in women-owned businesses. This investment would increase business training services, prioritize gender parity in access to capital, and increase federal contracting opportunities—giving women entrepreneurs the coaching, capital and connections to markets they need to grow and thrive.

The SBA invests \$17 million in Women's Business Centers; these 106 centers reach 100,000 women business owners with coaching and training—just 1 percent of the 10 million womenowned businesses in the U.S. This work is crucial, as McMahon knows from her support of WBCs in her home state of Connecticut. When a business owner receives training, she is 80 percent more likely to still be in business three years later and will create two additional jobs, according to the Aspen Institute's Field Program.

Imagine if we increased funding to \$100 million. More than a five-fold increase would allow WBCs to serve 500,000 women entrepreneurs. Let's say 80 percent start their own business. The return on investment would include 1.2 million jobs and \$20 billion in revenues generated at a conservative \$50,000 per business. Studies from Civic Economics find that \$20 billion from locally-owned businesses will circulate at least three times more in their local economies than money from big chains do, creating a total value of \$60

billion. That's a huge return on investment, in terms of new jobs, greater revenues, and stronger local economies.

Take Lidia Mendez who went from strawberry picker to café owner of Taqueria Lidia in Watsonville, Calif. She supports her family, takes her special needs child to work with her, and is free from back breaking work. Jessica McGinty started Jessicurl, a curly hair care product line, out of her Arcata, Calif., kitchen and now sells around the country and employs eight. Rebecca Weston went from massage therapist to owner of Sacred Mountain Spa in Mount Shasta, Calif., and has four employees. None of them did it in a vacuum – they all received support from a Women's Business Center.

If President Trump is serious about creating jobs and stoking America's economic fire, he should make women business owners' access to capital needs a top priority, as well. Women entrepreneurs lag woefully behind their male counterparts when it comes to their ability to get a loan. Only 3 percent of venture capital funding goes to women, and women entrepreneurs receive a paltry 4 percent of commercial loan dollars. What's more, a 2016 Fundera study found that on average, those dollars come with a higher interest rate and must be paid back sooner.

Another way the federal government can help women business owners is to open up federal contracting opportunities. WIPP released a report in 2016 that found women-owned small businesses have limited opportunities to win some of the federal government's most sought-after contracts, despite a proven ability to deliver innovative goods and services across the globe.

Despite these challenges, women have been tremendously successful in business. Between 1997 and 2015, the number of women-owned

businesses grew by 74 percent—a rate that's 1.5 times the national average, according to the State of Women-Owned Businesses Report by American Express. Women of color are starting businesses at three times the rate. Today, women-owned businesses generate more than \$1.4 trillion in revenues and employ 8.4 million people.

### We propose the following agenda for President Trump and McMahon's first 100 days:

- Increase funding for Women's Business Centers to \$100 million;
- Re-authorize legislation for SBA's Women's Business Centers;
- Target women-owned businesses to obtain the capital they need from the SBA and other agencies such as Treasury and USDA;
- Open the door to women on large, multi-year government contracts.

Investing in women is as important as investing in big infrastructure projects. Women are a crucial part of the economic and social fabric of our communities. President Trump and, if confirmed, McMahon have the opportunity to make a meaningful investment in our nation's future. It's an opportunity not to be missed.

# Diversity in the Workforce

### Why It's Still So Difficult to Hire a **Diverse Team**

More and more businesses are making a conscious effort to understand and promote the business benefits of diversity and inclusion. Their value does not lack external validation -- a recent McKinsey study shows that, "Companies in the top quartile for racial and ethnic diversity are 35 percent more likely to have financial returns above their respective national industry medians." And numerous other respected organizations around the world -- from Gallup to Credit Suisse ESG to PwC -- all provide strong evidence that link diversity to improved financial performance.

So, once we accept that the connection is clear, how do we start to improve corporate diversity? The first step is examining how we attract and hire diverse talent.

Often our greatest obstacle to embracing diversity and inclusion is not the proof of their value, but resistance to change -- both consciously and unconsciously. Tackling the obvious biases of others involves braving corporate and political turmoil and challenging the "status quo." Typically, our organizational decision-making processes follow the way things have always been done.

Another part of the problem is bias -- we hold implicit notions about the kind of person who would make an ideal candidate and/or leader, and we hire and promote accordingly. The need to think differently is critical if we want to harness the power and strength of a more diverse talent pool. According to a recent New York Times article, women make up only 20 percent of the total workforce in Silicon Valley. Additionally, a recent global study by Oxford Economics and SAP, Leaders 2020, stated that diversity has increased substantially among the general workforce over the past three years, but change has been slower to come to mid-level management, and even less evident among senior executives and corporate boards. We can and we must -- do better!

Sadly, impediments to recruiting diverse candidates exist in all of us. We need to stop tiptoeing around the issue of bias -- both conscious and unconscious -- and accept it. In order to directly combat both forms of bias, organizations need to re-examine their processes and redesign how they recruit, interview and hire candidates. By recognizing, identifying and working to reduce bias, companies will begin to reap the benefits of a diverse and inclusive workplace.

Here are three ways your company might be facilitating bias and without even knowing it:

### 1. The job description

The lack of diversity within today's workforce starts with a job posting. Certain words or phrases tend to attract male candidates versus female candidates, and vice versa, whether intentional or not. According to recent a Huffington Post article, the term "ninja" is usually skewed towards male stereotypes, attracting more male candidates to apply instead of females. While companies may not be doing this intentionally, unconscious bias is directly affecting the types of candidates who apply for the job. In order to combat unconscious bias in job postings, nextgen technology, like machine learning, can as-

Machine learning enables the company to analyze its past job postings for gender-biased language, which might have discouraged some applicants, and offers suggestions to help future postings be more gender neutral, increasing the number of female applicants who get past the initial screenings. Recently, SAP SuccessFactors announced machine learning-based sentiment analysis of job descriptions within SAP to not only identify potentially biased language in job descriptions, but also recommend alternative language to ensure the descriptions are genderneutral. By starting with the screening process,

# Three Ways Women Can Overcome The Gender Gap In Small Business Financing

### **By Rohit Arora**

In past nine years, women-owned firms have increased by 45 percent, and employment by these companies has increased by 18 percent since the Great Recession. Additionally, business revenues among women-owned companies have increased by more than one-third since 2007. Today, there are estimated to be more than 11 million women-owned companies that generate more than \$1.6 trillion in revenue.

Biz2Credit's newly released study of women-owned businesses identified that annual revenues, earnings, credit scores and even loan sizes have gradually increased in a year-to-year comparison. Average annual revenues (\$210,000) of women-owned businesses increased 47 percent in 2016, while average annual earnings (\$117,064) jumped 61 percent last year.

Despite this, women still significantly lag behind their male counterparts as it relates to financials, confirming that a gender gap still exists, according to Biz2Credit's new study of more than 25,000 companies. Businesses owned by men generated about 52 percent more revenue (\$363,414) on average than women-owned businesses. Meanwhile, male-owned firms averaged \$195,574 in earnings, accounting for a \$78,510 differential between the genders.

Further, credit scores of women-owned firms (595) were 17 points lower than companies owned by men.

Among the encouraging findings of the study were the average sizes of loans of women-owned businesses. Female entrepreneurs' average loan size was more than 28 percent higher than that of companies owned by men, an indication that they are investing more money in their firms. Women also started businesses at a faster rate than men with the average age of their business just under three years (35 months) with male-owned companies averaging 44 months.

A strong overall economy and low interest rates spurred women business owners to apply for credit. Women have been able to borrow larger sums of money to grow their businesses than ever before. Online lending portals have made it easier for borrowers to reach banks, marketplace lenders, institutional investors, micro lenders and other financial institutions willing to lend to women-owned companies.

Here are three elements that women entrepreneurs can leverage to build upon their success:

### 1. Continuously look for new opportunities

Mary Engelbreit, a graphic artist and children's book illustrator once said, "If you don't like something, change it. If you can't change it, change the way you think about it." This lesson can easily be applied to small business ownership.

In a country of opportunity, American entrepreneurs have many resources to succeed. Do some investigation. Learn about specific resources available for women entrepreneurs. For instance, the SBA highly encourages women-owned businesses to apply to be government contractors.

SBA Administrator Linda McMahon, the former CEO of WWE, also has a track record of empowering women entrepreneurs as co-founder of Women's Leadership LIVE. The firm educates and inspires women through business ownership, career advancement, and pursuit of leadership opportunities in public service. Women entrepreneurs especially should have confidence

in the support system of the government moving forward.

### 2. Know Your Numbers

When it comes to running an operationally sound company, perhaps the most vital part to your success is knowing and understanding your financials. Money talks. After all, consider why you are in business in the first place -- to make money. Know what it takes for your company to thrive and survive and develop a plan to serve as a guide.

"There are three key financial components entrepreneurs should must fully understand in order to run an operationally sound company – their net income statement, the balance sheet, and statement of cash flows," writes Dawn Fotopulos, a serial entrepreneur and author of Accounting for the Numberphobic: A Survival Guide for Small Business Owners.

If you want to expand your business, try to improve your credit score by continuously paying bills on time and in full when possible. The benchmark is about 600, but it will improve your odds of securing financing if you can raise it. Building a history of timely payments is an important first step. Any creditor will want to know if you can pay the money back.

### 3. Ask Your Accounting Pro

Entrepreneurs are blessed with a vision and industry skills to succeed. When it comes to running a successful business, the last thing on their mind is to make sure the financial statements are in order and that the financials are up-to-date. Falling behind on financials and taxes can be catastrophic for a company.

Rely on your accounting professional. As an small business owner, it is important to understand that you cannot be an expert at everything. Many accountants offer their clients financial advice. If you already have a relationship built on trust with your accountant, you've already ahead of the game.

companies will take the initial step toward greater equality.

### 2. The interview

In today's society, perception is reality. Being confident and successful are considered positive and desirable traits during the interview process, but there can be a thin line between "confident" and "bossy" -- especially for women.

Research has shown that a male candidate is already more likely to get hired than a female of equal qualification, and what may be seen as confidence in a man can across as "pushy" in a woman. Companies need to reevaluate and restructure the interview process, in order to avoid favoring candidates based on gender. Iris Bohnet, author of What Works: Gender Equality by Design, and a behavioral economist and professor at Harvard Kennedy School, shared in a recent Harvard Business Review article, "work-sample tests, structured interviews and comparative evaluation allow companies to hire the best talent instead of those who look the part." By rethinking how companies interview candidates, female and male candidates will be equally vetted on their skillset.

### 3. The salary negotiation

According to the American Association for Women, in 2015, women working full-time in the United States typically were paid just 80 percent of what men were paid. While the number has gone up year over year, the increase was extremely small. While gender equality continues to be a hot topic, the pay gap between men and women still exists. Companies need to take a proactive approach to understand salary discrepancy numbers in an effort to attach and retain female employees. In December, the White House announced that a total of 100 employers signed the White House's Equal Pay Pledge, committing themselves to take action to advance equal pay. In addition, recently, SAP America worked with a third-party firm to complete a pay equity report, which found that 99 percent of its male and female employees in the U.S. were paid equally. Where disparity did exist, the gap was corrected. By addressing the pay equity issue in the salary negotiation process, companies will motivate the workforce and retain the best talent.

The first step to creating a more diverse and inclusive workforce is looking at ourselves -- and recognizing that we all have bias, conscious and unconscious. By understanding and accepting this, organizations can then proactively work to take corrective action that will enable them to attract and hire the best talent -- whomever they might be! -- and begin the journey toward a truly diverse, inclusive workplace.


