# 9th Circuit upholds Caltrans' preferences on contracts for ethnic groups, women

A state Transportation Department contracts program that gives preferential treatment to firms owned by members of disadvantaged ethnic groups and women does not run afoul of the U.S. Constitution, a federal appellate court ruled Tuesday.

U.S. District Judge John A. Mendez of Sacramento got it right in 2011 when he rejected a constitutional challenge to the program by the Associated General Contractors of America,

a three-judge panel of the 9th U.S. Circuit of Appeals declared.

The circuit panel dismissed an appeal by the contractors' association of Mendez's decision, saying the association "did not identify any of its members who have suffered or will suffer harm ... and therefore (the association) has not established that it has ... standing to bring suit."

But, the three judges added, even if the Associated General Contractors had legal

standing, its appeal would fail because there is strong "evidence of discrimination within the California transportation contracting industry" and the Caltrans program is "narrowly tailored to benefit only those groups that actually suffered discrimination."

That finding echoes Mendez's conclusions two years ago in the lower court.

The contractors claim the program, begun in 2009, unlawfully provides race- and sex-based preferences on certain contracts to firms owned by African Americans, American Indians, Asian Pacific Americans and women.

Not so, said Mendez, holding that the agency's statistical and anecdotal evidence shows the four groups have been subjected to discrimination in the transportation construction industry and the Caltrans program benefits only those groups.

Attorney Ralph Kasarda, who represents AGC, said Tuesday that he and his client are disappointed they got the same reception at the appellate court.

"Such a preference is unconstitutional because it can never be narrowly tailored on both construction and engineering contracts in such a large and diverse state as California," Kasarda said in an email response to a request for comment.

"For instance," he added, "prime contractors must favor subcontractors who trace their heritage to China, Japan, or South America, but disfavor male subcontractors whose national origins are from Pakistan, India, Bangladesh, Maldives, Nepal and Sri Lanka. The Caltrans program offends all notions of equality and fairness."

# **New High Tech Businesses Rely More Than Other Firms on Bank Loans**

# Advocacy Study Shows Women and Minority-owned Businesses Operate on Less Financing

In the current financial climate, new high-tech businesses rely more than other firms on outside loans and investments, while non-technology businesses owned by African Americans, Latinos, and women simply operate on less capital, says a report issued today by the U.S. Small Business Administration (SBA) Office of Advocacy. The report, called Access to Capital among Young Firms, Minority-owned Firms, Women-owned Firms, and High-tech Firms looks at how the changing financial environment affects new firms.

"We know that startup businesses with access to financing drive innovation, job creation, and economic growth," said Dr. Winslow Sargeant, Chief Counsel for Advocacy. "Policies that help close the financing gaps for minorities and women and for high-tech startups will benefit the whole economy."

The author, Alicia Robb, finds that minority firms in particular rely more on their own funds—and have less capital to start up and grow. High-tech businesses that rely on patents, copyrights, and trademarks also faced bank financing hurdles, possibly because their products rely on knowledge, which is harder for banks to assess than physical assets.

The report uses data from the Kauffman Firm Survey to look at new businesses' access to capital during the 2004-2010 period. African American and Latino owners of young firms are less likely than others with similar credit scores to have access to bank financing. During the financial crisis, women and minority owners of new startups were less likely to apply for credit, fearing loan denial.

## 9th Circuit upholds Caltrans' preferences

Kasarda said he and his client are discussing "the possibility of filing a petition for rehearing" before an enlarged circuit panel or seeking review of the matter by the U.S. Supreme Court.

The opinion was authored by Senior Circuit Judge Jerome Farris, with Circuit Judges Sidney R. Thomas and N. Randy Smith concurring.

They cited a 2005 federal statute enabling states that receive federal transportation funds to set up a program like California's "in response to pervasive and ongoing discrimination." The act mandates that 10 percent of federal funds distributed to participating states and municipalities be "expended on disadvantaged business enterprises." Those firms are

defined as small businesses owned or controlled by socially and economically disadvantaged individuals."

Caltrans receives up to \$3 billion annually from the federal government for transportation projects.


While the contractors' appeal was pending, Caltrans commissioned a new disparity study to update its preference program as required by federal regulations. The agency then submitted a modified program that is nearly identical to the 2009 program, except it now includes Latinos and sets an overall goal of 12.5 percent of its contract expenditures going to disadvantaged persons' companies.



### SF Unemployment **Rate Dropping to Six Percent**

Mayor Edwin M. Lee today issued the following statement on San Francisco's unemployment rate dropping to six percent in April for San Francisco, based on preliminary unemployment numbers released by the California Employment Development Department (EDD):

"San Francisco's steady economic recovery is putting our residents back to work. When I first came into office in January 2011, our unemployment rate was 9.5 percent, and today it stands at a fiveyear low of six percent. I will continue my focus on job creation, workforce training and education to continue to make sure San Franciscans are ready for the jobs and demands of the 21st Century economy. And, I will continue to work every day with every business sector in our City to support successful policies that grow our economy, create jobs and put San Franciscans back to work."

San Francisco registered the third lowest unemployment rate among California's 58 counties. Jobs located in San Francisco increased by 3.6 percent on a year-over as of September 2012, according to the Bureau of Labor Statistics. That ranks San Francisco 17th in performance out of the 329 largest counties in the nation, compared to 1.6 percent nationally and 2.8 percent in California. Between March of 2012 and March of 2013 with a drop of 1.8 percent, San Francisco experienced the largest oneyear drop in the unemployment rate in more than two decades.

# Making tracks to the Westside



Metro's rail operations chief, Bruce Shelburne, says bike ridership on the trains has gone "sky high."

# Bruce Shelburne is hoping for the best. But he's bracing for "a learning experience."

As Metro's executive director for rail operations, Shelburne will have his hands full this Sunday, when the hugely popular CicLAvia winds its way for the first time from downtown Los Angeles to Venice, promising to pack the rail system with riders headed to points along the 15-mile route. At the same time, the Los Angeles Times. Festival of Books and the Grand Prix of Long Beach will also be feeding crowds onto the rail lines.

Still, Shelburne, a 26-year Metro veteran, says he's learned not to get overly stressed by the logistics and pitfalls of his job. "I'm learning to let go a little bit," he says. "Otherwise you're going to find yourself on the wrong end of a shovel, six-feet under."

Shelburne expects one major CicLAvia hotspot to be the new Expo Line's Culver City station, which, for now, is the closest stop to the sea. That end-of-the-line location will make it a major—and potentially clogged—entrance and exit point for people interested in traveling only along the route's western end. Culver City's elevated station might also complicate things because cyclists will have to carry bikes up and down stairs or crowd into elevators.

Increasing the potential congestion, CicLAvia has placed one of its "hubs" there to provide water, restrooms, and bike repairs, while Culver City and its businesses are planning a variety of entertainment options, including free massages and live music to complement food and shopping deals. A bike valet will help people make sure their wheels are secure while they browse the area.

Throughout Metro's rapidly expanding rail system, Shelburne and his staff will also have to grapple with the reality that many CicLAvia passengers will be riding the rails for the first time and are unfamiliar with the agency's TAP Card system, which can be confusing to the uninitiated.

"Trust me," Shelburne says, "if that becomes a bottleneck, we'll undo that real quick. We'll address it with any means necessary to get people moving."

Shelburne says that he sees CicLAvia and other major seam-stretching L.A. events as laboratories for lessons that can be applied in the future. For example, based on past CicLAvias, Shelburne says he's doubling the number of trains on some lines. And while bikes are normally limited to two per train, Shelburne says, "we tend to look the other way on this kind of day." In fact, Metro staffers will try to devote one car or maybe more per train to cyclists.

"It's not all about the bikes," Shelburne says. "We can't take all the seats out. We have 100 million riders boarding the system annually and the majority of them don't use bikes...The advantage is that bicyclists, especially the experienced ones, tend to work well with each other."

(On Thursday, the regional rail service Metrolink announced it would be putting all 17 of its specially-outfitted "bike cars" into service on Sunday to serve the CicLAvia crowds. More information is here.)

While Shelburne is modest about his team's successes managing past events, he's particularly proud of one of his personal contributions—deploying Metro staffers to help people navigate the system and provide a human face to agency. Humor helps, too, he says. "If you're not afraid to make a joke at your own expense, it goes a long way."

On the future of bikes and trains in general, Shelburne sees a growing challenge and the need for a new relationship between cyclists and other passengers. "It seems like our bicycle ridership has really gone sky high," he says.

Metro has already removed seats from older rail cars, and new cars will include additional accommodations for bicycles. But in the long term, Shelburne says, Metro will need to look at additional measures, such as arranging seats around the edges of cars to open more floor space.

While Shelburne admits he's not one to jump on a bike very often, he does spend a plenty of time on the rails each day. He commutes from his home Oxnard to Union Station in downtown L.A.—a 70-mile trip that takes more than 90 minutes each way. On the way home, it's a chance to catch up with work. But in the morning, he says, the smooth ride is the perfect opportunity for a pre-office nap.

"What rail buys," he says, "is peace of mind and consistency. It just calms you down and you don't have to worry about some of the idiots on the road."

# No deficit of good news in this budget

Just three years ago, in the thick of the Great Recession, Los Angeles County officials proposed a budget to the Board of Supervisors with a deficit of more than \$490 million, prompting an extraordinary belt-tightening that forced some county departments to slash spending by more than 30 percent.

Back then, Chief Executive Officer William T Fujioka put the best spin possible on the gloomy situation. Despite the gaping shortfall, he said, the county had not been forced to significantly reduce services or lay off workers, who' d agreed to forgo raises until the crisis had passed.

It looks like that day may have come.

On Monday, CEO Fujioka offered a \$24.7 billion spending plan for board approval that, for the first time in five years, has no deficit and no proposed cuts. This year, there'll be no raiding reserves or other one-time funding solutions.

"This is unheard of, not only here within the county but throughout the state of California," Fujioka said of the county's proposed zero-deficit budget, which will be financed entirely by ongoing revenue sources. Departmental cutbacks, efficiency initiatives and rising property and sales tax revenues were central to the budget turnaround, Fujioka said. But the county could not have weathered the economic storm, he stressed, without the fiscal discipline of the Board of Supervisors and the cooperation of employee unions.

Unlike City of Los Angeles workers, whose raises have been blamed for the city's dire finances, county workers haven't received a cost-of-living raise in five years—a savings of hundreds of millions of dollars that has helped preserve programs and save jobs. The unions agreed to the arrangement so long as the money would begin to flow once the county's finances were back on track. Union leaders are wasting no time holding the county to its word; Fujioka said his office already has begun negotiating with public safety unions.

Jim Adams of the CEO's office, who's been negotiating with the unions for a little more than a month, says he expects there'll be "some kind of pay increase." Citing the confidentiality of the talks, he declined to be more specific but cautioned that every 1-percent increase in the county workforce's payroll amounts to close to \$40 million, not including benefits. "We'll be sweeping the budget corners," looking for ways to fund raises, he said.

Adams and others said they expect a chunk of that to come from rising property tax revenues, which are likely to exceed the Assessor's conservative forecast of 2.88 percent for fiscal year 2013-2014.

For the most part, the new spending plan holds the line on departmental budgets that have been pared back during the past five years, recommending only small spending increases or none at all. "We're not going to quickly and blindly restore people" to departments without a specific need, Fujioka said during a morning news conference. He cited, for example, a reduction in the number of clerical workers in the treasurer's office to process property tax payments. As a result, the payments took an extra day or two to deposit in the bank, Fujioka

said, costing the county "a lot of money" in interest.

The CEO says he is, however, recommending that new funding be used to enact a series of reforms urged last year by the Citizens' Commission on Jail Violence, which investigated alleged deputy brutality within the county's lockup. Among other things, Fujioka said he's proposing that \$5 million be set aside each year for the soon-to-be-created Office of the Inspector General, which will oversee and monitor sheriff operations in the jail and on the streets.

Fujioka also cautioned that unforeseen budget pressures could arise from the full

implementation next year of the Affordable Care Act, as well as the continuing implementation of a massive transfer of responsibilities from the state to the county for supervision of ex-California prison inmates.

Still, despite such uncertainties, Fujioka's press briefing had the feel of a victory lap as he praised the leadership shown by the five members of the Board of Supervisors, who'll begin public hearings on the budget in May.

"You probably think it's easy for a guy like me to say something like that because they're the people I work for," Fujioka said. "But it's the absolute truth."

# Access to Capital among Young Firms, Minority-owned Firms, Women-owned Firms, and High-tech Firms

By Alicia Robb, Marin Consulting, LLC

#### **Purpose**

The availability of capital is crucial for small business startup, survival, and growth. This study investigates how the youngest small firms operated and were financed during the evolving financial environment of the recent Great Recession, especially high-tech firms and firms owned by women and minorities.

#### **Background**

The major constraint limiting the growth, expansion, and wealth creation of small firms—especially women- and minority-owned businesses—is inadequate capital. Because of their size, these small firms typically have almost no access to external funds from public markets and are bank dependent. Small firms have little or no collateral and, as relatively young firms, lack an extensive history from which future firm or management performance can be surmised, even though the firm may have high growth potential. Research also shows that bank lending is adversely affected by a tightening of monetary policy, regulatory changes that tighten capital requirements, and bank capital

Studies indicate that women entrepreneurs have less access to financial capital or make less use of it than male entrepreneurs. Research shows that the characteristics of women-owned firms may help explain why women obtain smaller loans, pay higher interest rates, must put up higher collateral, and are dissatisfied with the bank loan process.

For instance, younger and smaller businesses, as womenowned businesses typically are, tend to be less favored by bankers, regardless of the gender of the owner.

On the equity side, women typically have limited social interaction with venture capital firms, and are under-represented among fast-growth and high-tech businesses. They also rely more on informal funding methods and self-financing. These characteristics may help explain the gender disparity in access to capital.

For many minorities, starting out at lower wealth levels also acts as a barrier to entrepreneurship.

#### **Policy Implications**

- Skill development and training have a critical role in improving the economic performance of women and minority entrepreneurs; targeted initiatives might help them build more viable businesses
- Encouraging enrollment in science, technology, engineering, and math disciplines is another option for women and minority
- Developing and expanding networks can help women and minority business owners access needed resources such as financial capital.

#### **Overall Findings**

High tech firms had higher levels of financial capital; surprisingly, they were more dependent on formal debt financing than were similar firms that were not high tech firms at the start-up phase and in subsequent years before and during the

Both women- and minority-owned businesses (African American- and Hispanic-owned firms) showed some similar disparities in their capital structure relative to firms owned by men and nonminorities. They used a different mix of equity and debt capital and were more reliant on owner equity investments. The average women- or minority- owned business operated with much less financial capital, even after controlling for other factors including credit score.

During the financial crisis period, many women and minority entrepreneurs of new startups were less likely to apply for a loan, fearing denial. The researchers controlled for some characteristics that were likely to affect bank borrowing, including legal form of organization, credit score, and type of business.

The evidence showed that, compared with nonminority owners, minority owners of young firms were significantly less likely to have their loan applications approved.

#### Scope and Methodology

This study uses data from the Kauffman Firm Survey (KFS) to examine the financing patterns of young, minority-owned, women-owned, and high-tech firms. The KFS is a cohort of businesses that began operations in 2004 and were followed through 2010. The author used owner demographics at the firm level to define the gender and minority status of the primary owner. For firms with multiple owners, the primary owner was indicated by the largest equity share, and where there were two or more owners with equal shares, hours worked, along with other variables, were rank-ordered to identify a primary owner.

Both univariate and multivariate tests were used to examine the financial environment and capital access of these firms. Three models using logistic regression estimated separately the probability of (1) applying for a loan, (2) not applying for a loan when credit is needed for fear of loan denial, and (3) receiving a loan. Several control variables were utilized.
