US DOT provides billions of dollars a year to states and municipalities for the con-struction and maintenance of highways and mass transit systems on the condition that small businesses, owned and operated by disadvantaged individuals, receive a fair share of these federal funds. In Pennsylvania, Penn DOT and SEPTA receive these funds and they require contractors to award a percentage of their subcontracts to eligible DBEs.

According to the U.S. Department of Transportation, this scheme, which lasted for over 15 years and involved over \$136 million in government contracts, is the largest reported Disadvantaged Business Enterprise (DBE) fraud in the nation's history

Schemes to defraud the Department of Transportation's Disadvantaged Business Enterprise program cheat not only the government and taxpayers, but also cheat those small, minority-owned businesses that the program is intended to help," said Special Agent in Charge George C. Venizelos of the Philadelphia Division of the FBI. "This longterm joint investigation, culminating in the conviction announced here today, shows our



Gross Receipts Tax

Definition:

A gross receipts tax is a state tax on the gross receipts (sales) of a business; usually a state will impose a gross receipts tax instead of a corporate income tax. Sometimes referred to as a gross excise tax, this tax is passed through to the consumer. Some states allow some deductions from the gross receipts tax and some types of businesses may be exempt from these taxes. Check your state's department of revenue for more information about your state.

States which impose some sort of gross receipts tax include:

- · Washington
- Arizona
- Delaware
- Hawaii
- Illinois
- Mississippi
- New Mexico
- Ohio

Also Known As: Gross Excise Tax Examples:

Delaware's Division of Revenue imposes a gross receipts tax on the "total receipts of a business received from goods sold and services rendered in the State. There are no deductions for the cost of goods or property sold, labor costs, interest expense, discount paid, delivery costs, state or federal taxes, or any other expenses allowed."

Paying Your Business Property (Real Estate) Taxes

If your business owns real property, you must pay property tax on this property. In the same way as individuals pay property tax on the assessed value of their homes, businesses pay property tax on the assessed value of their real estate (land and buildings). If real estate is sold, the tax for the year is distributed between the previous and new owners, based on how much of the year they owned the property.

Property taxes are assessed by local entities - towns, cities, counties, villages - for local purposes, such as schools, roads, improvements in infrastructure.

When you purchase real estate for your business, the property will be registered with the appropriate taxing authority and you will receive information on the changes in your assessed value and the amount of tax you owe

each year.

Check with your local taxing authority for more information on real estate taxes on your business property. Since property taxes are specific to each state, you might also go to Google and type in "property taxes [state]" for more information.

What Form Do I Use to Report and Pay

Question: When are Excise Taxes Due and Reportable?

Answer: Excise taxes are taxes on certain products and activities used or engaged in by businesses

What products must I pay excise taxes on?

Businesses must pay excise taxes on:

- Environmental products, such as domestic petroleum oil spills and ozone-depleting chemicals.
- Communications and air transportation taxes
- Fuels used in business

• Purchase of trucks, trailers, semi-trailers (at a For a complete list of products and services subject to federal excise taxes, see IRS Form 720.

When are Federal Excise Taxes Due?

- You must file Form 720 quarterly, one month after end of the quarter:
- Quarter end March file by April 30
- Quarter end June July 31
- Quarter end Sept. Oct 31
- Quarter end December January 31

Fresno Construction Career Awareness Day Breaks Records





transform travel in America. The announcement is one of a number of job initiatives the President will lay out in the coming weeks that follow up on the continued commitment to job creation he discussed in last night's State of the Union Address. A full list of the awards can be viewed HERE.

"Through the Recovery Act, we are making the largest investment in infrastructure since the Interstate Highway System was created, putting Americans to work rebuilding our roads, bridges, and waterways for the future," said President Obama. "That investment is how we can break ground across the country, putting people to work building high-speed rail lines, because there's no reason why Europe or China should have the fastest trains when we can build them right here in America."

"By investing in high speed rail, we're doing so many good things for our country at the same time," said Vice President Biden. We're creating good construction and manufacturing jobs in the near-term; we're spurring economic development in the future; we're making our communities more livable—and we're doing it all while decreasing America's environmental impact and increasing America's ability to compete in the world."

Today's awards will serve as a downpayment on developing or laying the groundwork for 13 new, large-scale high-speed rail corridors across the country. The major corridors are part of a total of 31 states receiving investments, including smaller projects and planning work that will help lay the groundwork for future high-speed intercity rail ser-The grants are not only expected to vice. have an up-front job and economic impact, but help spur economic growth in communities across the country, provide faster and more energy-efficient means of travel, and establish a new industry in the U.S. that provides stable, well-paid jobs.

This historic \$8 billion investment is expected to create or save tens of thousands of jobs over time in areas like track-laying, manufacturing, planning and engineering, and rail maintenance and operations. Over 30 rail manufacturers, both domestic and foreign, have agreed to establish or expand their base of operations in the United States if they are hired to build America's next generation high-speed rail lines – a commitment the Administration secured to help ensure new jobs are created here at home.

"The President's bold vision for high-speed rail is a game changer," said Transportation Secretary Ray LaHood. "It's not only going to create good jobs and reinvigorate our manufacturing base, it's also going to reduce our dependence on fossil fuels and help create livable communities. I have no doubt that building the next generation of rail service in this country will help change our society for the better."

The majority of the dollars announced today will go toward developing new, largescale high-speed rail programs. This includes projects in Florida, which is receiving up to \$1.25 billion to develop a new high-speed rail corridor between Tampa and Orlando with trains running up to 168 miles per hour, and in California, which is receiving up to \$2.25 billion for its planned project to connect Los Angeles to San Francisco and points in between with trains running up to 220 miles per hour. In April 2009, the Administration released a long-term plan for high speed rail in America. In addition to the \$8 billion awarded today, the plan also included \$1 billion a year for five years in the federal budget as a down payment to jump-start the program. Applicants submitted over \$55 billion in project proposals for the initial \$8 billion in funds awarded today.

Obama Administration officials are traveling across the country this week to announce funding for the high speed rail projects and discuss how this investment will create local jobs and rebuild the economy. Today, EPA Administrator Lisa P. Jackson will travel to Durham, North Carolina, Secretary of Labor Hilda L. Solis will visit Columbus, Ohio and Housing and Urban Development Secretary Shaun Donovan will be in Milwaukee, Wisconsin, Secretary of Transportation Ray LaHood will hold an event in Washington, DC, Executive Director of the White House Council on Auto Communities and Workers Ed Montgomery will visit St. Louis, Missouri and Federal Railroad Administrator Joseph C. Szabo will be in Philadelphia, Pennsylvania. On Friday, a senior Department of Transportation official will travel to California and FRA Administrator Szabo will hold an event in Chicago, Illinois.

Sales Tax Requirements for Your E-Business

Whether your operations are in one location or multiple states, sales taxes are something you are dealing with already on some level. However, if you are also selling online you may not realize the scope of responsibilities your company already has in this regard – or those it may be taking on in the near future.

How Nexus is Determined

If you are selling within the state in which you are licensed (this is your nexus), then you already have a sales tax identification and are collecting, reporting and remitting taxes collected from your customers. You will want to update any changes in your company information to avoid potential duplication from the tax office. If you relocate to another state be sure to complete the deregistration process, or it could become an administrative nightmare.

On the other hand, if your nexus hasn't changed but you are selling online to remote consumers, you may also be responsible for collecting taxes for other states. Though nexus is technically defined as a "tangible" physical presence, a particular state may narrow the line further. If you have salespeople or employees working in any other state – or you are housing inventory or leasing property outside your own nexus – then you may need to register and collect sales taxes there as well.

Location, Location, Location

If you're selling within your own nexus, a tax tables booklet may be sufficient – but then again, maybe not. Sales and use taxes are charged according to physical locations, not just zip codes – and even zip+4 codes are not always accurate. Keep in mind that zip codes can change randomly and are only assigned to addresses deliverable by the U.S. Post Office.

Aside from state and county lines there are city borders, special use districts, transit districts, and more. Tax rates can vary within these areas, even though the zip code is the same for them all! There are also tax exemptions of some products and organizations to consider, as well as sales tax variations within certain industries; software, food, digital goods, services and medical equipment to name a few.

The Best Attempt at Getting It Right

In 2000 Congress adopted the Streamlined Sales Tax Project, allowing voluntary registration and attempting to reduce the bookkeeping and expenses a company would incur from the collection of state and local sales taxes. Its registration is handled with the SSUTA (Streamlined Sales and Use Tax Agreement). Another function of the SSTP is to certify sales tax administration software for use in businesses. There are 2 types of software, CSP and CAS; both having unique benefits.

1. Certified Service Provider (CSP)

CSP software determines which products and services are taxable, and at what rate; it can integrate with your accounting system and shopping cart, file the tax return and pay the sales taxes on your behalf. Each CSP company is certified by, and under contract with, the SSTP's governing board to provide these administrative tax services.

2. Certified Automated System (CAS)

This system is used by a business that prefers to have its sales tax functions remain inside of its own firewall. Per the SSUTA, it must "calculate the taxes, determine the amount to remit to the appropriate state, and maintain a record of the transaction." The CAS can also integrate with your accounting application. If you use this system, your business remains responsible for the proper filing of returns and timely remitting of the collected taxes.

Though there are two new bills in front of Congress that could alter the SSTP, it currently is the "gold standard" for at least the 25 states that have joined its ranks thus far. The political sparring of 2011's Main Street Fairness Act and Marketplace Equity Act may continue indefinitely – meanwhile the SSTP is your best bet for accurate compliance.

This can be done by creating a "national restitution fund" that would share in the fines, penalties and restitution. The "national restitution fund" would become a conduit for low interest loan guarantees, bonding, entrepreneur training and workforce development. The United States Attorney's Office for the Middle District of Pennsylvania announced today that Joseph W. Nagle, of Deerfield Beach, Florida, was convicted after a four-week jury trial before Senior United States District Court Judge Sylvia H. Rambo in Harrisburg.

Late Thursday, the jury returned a verdict of guilty on 26 of 30 charges in the indictment including conspiracy to defraud the United States Department of Transportation (USDOT) and commit wire and mail fraud, 11 counts of wire fraud, six counts of mail fraud, conspiracy to commit money laundering, and 11 counts of money laundering.

According to the U.S. Department of Transportation, this scheme, which lasted for over 15 years and involved over \$136 million in government contracts, is the largest reported Disadvantaged Business Enterprise (DBE) fraud in the nation's history.

According to United States Attorney Peter J. Smith, Mr. Nagle faces up to five years' imprisonment on the conspiracy count; up to 20 years' imprisonment on each of the wire and mail fraud counts; up to 10 years' imprisonment on the money laundering conspiracy and each of the money laundering counts of conviction; and \$250,000 in fines and mandatory restitution on each of the convictions. Nagle was acquitted on four counts of wire fraud. No date has been set for sentencing.

Mr. Nagle was president, chief executive fficer and partowner of Schuylkill Products Inc. (SPI) and its wholly-owned subsidiary CDS Engineers Inc. (CDS) until April 2009, when SPI was sold. SPI was based in Cressona, Pennsylvania and manufactured concrete bridge beams used on highway construction projects in Pennsylvania and surrounding states. CDS was SPI's erection division and installed SPI's bridge beams, as well as other suppliers' products, on highways in Pennsylvania and surrounding states. Mr. Nagle was convicted of joining an on-going 15-year conspiracy to defraud USDOT, the Pennsylvania Department of Transportation (PennDOT), and the Southeastern Pennsylvania Transportation Authority (SEPTA) in connection with the federal government's DBE program when he became president in April 2004.

USDOT provides billions of dollars a year to states and municipalities for the construction and maintenance of highways and mass transit systems on the condition that small businesses, owned and operated by disadvantaged individuals, receive a fair share of these federal funds. In Pennsylvania, PennDOT and SEPTA receive these funds and they require contractors to award a percentage of their subcontracts to eligible DBEs.

Mr. Nagle was convicted of participating in the scheme, which ran from 1993 to 2008, where he and other executives at SPI diverted over 300 PennDOT and SEPTA construction contracts to SPI and CDS that were reserved for DBEs. Mr. Nagle and his co-conspirators executed the scheme by using a small Connecticut highway construction firm known as Marikina Construction Corporation as a front company to obtain these lucrative government contracts.

Marikina was owned by Romeo P. Cruz, of West Haven, Connecticut, a naturalized American citizen born in the Philippines. Marikina was certified by PennDOT and SEPTA as a DBE. Although Marikina received the DBE contracts on paper, all the work was performed by SPI and CDS personnel, and SPI and CDS received all the profits. In exchange for letting SPI and CDS use its name, Marikina was paid a small fixed-fee, set by SPI.

The scheme was carried out for over 15 years because of the numerous fraudulent steps the co-conspirators took to conceal the scheme. SPI and CDS personnel routinely pretended to be Marikina employees by using Marikina business cards, e-mail addresses, stationery, and signature stamps, as well as using magnetic placards and decals bearing the Marikina logo to cover up SPI and CDS logos on SPI and CDS vehicles.

Previously, four former executives associated with SPI, CDS, and Marikina entered guilty pleas for their roles in the scheme:

Romeo P. Cruz, the former owner of Marikina, pleaded guilty to conspiracy and tax fraud charges in 2008 and 2009. Ernest G. Fink, of Orwigsburg, Pennsylvania, SPI's former vice-president, chief operating officer, and owner, pleaded guilty to conspiracy in 2010. Timothy G. Hubler, of Ashland, Pennsylvania, CDS' former vice-president in charge of field operations, pleaded guilty to conspiracy and tax fraud charges in 2008. Dennis F. Campbell, of Orwigsburg, Pennsylvania, SPI's former vice-president in charge of sales and marketing pleaded guilty to conspiracy charges in 2008. All four testified during the Nagle trial and await sentencing.

"Preventing and detecting DBE fraud are priorities for the Secretary of Transportation and the USDOT Office of Inspector General," said Doug Shoemaker, OIG Regional Special Agent in Charge. "This significant conviction, in what is the largest reported DBE fraud case in USDOT history, will serve as a clear signal that severe penalties await those who would attempt to subvert USDOT laws and regulations. Prime contractors and subcontractors are cautioned not to engage in fraudulent DBE activity and are encouraged to report any suspected DBE fraud to the USDOT-OIG. Our agents will continue to work with the Secretary of Transportation, the Administrators of the Federal Highway and Transit Administrations, and our law enforcement and prosecutorial colleagues to expose and shut down DBE fraud schemes throughout Pennsylvania and the United States."

"Schemes to defraud the Department of Transportation's Disadvantaged Business Enterprise program cheat not only the government and taxpayers, but also cheat those small, minority-owned businesses that the program is intended to help," said Special Agent in Charge George C. Venizelos of the Philadelphia Division of the FBI. "This long-term joint investigation, culminating in the conviction announced here today, shows our determination to work together with our partners to safeguard the taxpayer dollars that support these important programs."

The investigation was conducted by the FBI, the U.S. Department of Transportation Inspector General's Office, the U.S. Department of Labor Inspector General's Office, and the Criminal Investigation Division of the IRS. Senior Litigation Counsel Bruce Brandler and Assistant United States Attorney Kim Douglas Daniel handled the prosecution.

Bovis Lend Lease fined \$56 million for fraud

A U.S. subsidiary of the Australia's Lend Lease Construction has admitted to a 10-year overbilling scheme on New York area projects and will pay \$56 million in fines and victim restitution, prosecutors said on Tuesday.

Bovis Lend Lease, as the subsidiary was previously known, has its largest U.S. office in New York City, where it employs more than 1,000 people and has worked on projects such as the September 11 Memorial in Lower Manhattan and the Citi Field baseball stadium in Queens.

Federal prosecutors in Brooklyn said the company pleaded guilty to criminal charges 'systematic practice" between 1999 it had a and 2009 of billing clients -- often government agencies -- for hours its workers had never worked.

"Today's proceedings mark the culmination of a three-year investigation into a systematic pattern of audacious fraud by one of the world's largest construction firms," FBI Assistant Director in Charge Janice Fedarcyk said in a statement.

Prosecutors said that the former head of Bovis' New York office, James Abadie, 55, pleaded guilty earlier on Tuesday to charges of conspiracy to commit mail and wire fraud.

Abadie faces up to 20 years in prison. An attorney for Abadie, Stephen Kaufman, did not immediately return a call seeking comment.

Bovis agreed to pay \$56 million in penalties and victim restitution as part of a deferred prosecution agreement made public on Tuesday.

The agreement showed Bovis had accepted responsibility for the fraud and was cooperating with investigators. As part of the agreement, the company would put in place new internal controls to prevent any future misconduct.

"Lend Lease takes corporate governance very seriously and is committed to the highest levels of ethical standards," Robert McNamara, the chief executive of Lend Lease in the Americas, said in a statement. "We accept responsibility for what happened in the past and have agreed to continue to make restitution to the affected clients.'

Bovis agreed to pay \$40.5 million in penalties as well as \$13.6 million and \$2.5 million to victims of different sets of schemes, the deferred prosecution agreement showed.

In one scheme, Bovis lied about employing construction companies owned by women and minorities to qualify for public projects in New York and New Jersey, court documents said

The Bovis overbilling scheme concerned projects such as the construction of a criminal court in the Bronx, as well as work on the Brooklyn federal courthouse, the very building in which Boyis was charged.

The cases are U.S. v. James Abadie and U.S. v. Lend Lease (US) Construction LMB, U.S. District Court for the Eastern District of New York, No. 12-274 and 12-288

Missed the Income Tax Deadline -**IRS Offers Help for Taxpayers**

Now that the federal tax return deadline of April 17 is past, there may be taxpayers who missed filing their returns on time. The IRS has some advice for those taxpayers who missed the deadline.

We want taxpavers to understand that there are still options for those who missed the filing deadline," said IRS spokesman David Tucker II. "The important thing is for them to take action to remedy their situation.'

- Don't panic but file as soon as possible. If you owe money the quicker you file your return, the less penalties and interest you will have to pay. Even if you have to mail us your return, the sooner we receive it, the better.
- E-file is still your best option. IRS e-file programs are available for most taxpayers through the extension deadline - October 15, 2012.
- Free File is still available. Check out IRS Free File at www.irs.gov/freefile. Taxpayers whose income is \$57,000 or less will qualify to file their return for free through IRS Free File. For people who make more than \$57,000 and who are comfortable preparing their own tax return, the IRS offers Free File Fillable Forms. There is no software assistance with Free File Fillable Forms, but it does the basic math calculations for you.
- Pay as much as you are able. Taxpayers who owe tax should pay as much as they can when they file their tax return, even if it isn't the total amount due, and then apply for an installment agreement to pay the remaining balance.

- Installment Agreements are available. Request a payment agreement with the IRS. File Form 9465, Installment Agreement Request or apply online using the IRS Online Payment Agreement Application available at www.irs.gov.
- Penalties and interest may be due. Taxpayers who missed the filing deadline may be charged a penalty for filing after due date. Filing as soon as possible will keep this penalty to a minimum. And, taxpayers who did not pay their entire tax bill by the due date may be charged a late payment penalty. The best way to keep this penalty to a minimum is to pay as much as possible, as soon as possible. Although it cannot waive interest charges, the IRS will consider reductions in these penalties if you can establish a reasonable cause for the late filing and payment. Information about penalties and interest can be found at Avoiding Penalties and the Tax Gap
- Refunds may be waiting. Taxpayers should file as soon as possible to get their refunds. Even if your income is below the normal filing requirement, you may be entitled to a refund of taxes that were withheld from your wages, quarterly estimated payments or other special credits. You will not be charged any penalties or interest for filing after the due date, but if your return is not filed within three years you could forfeit your right to the refund.
