MBDA and Walker's Legacy Partner to Support Minority Women Entrepreneurs

In 1910 Madam C.J. Walker opened her Madam C.J. Walker Manufacturing Company in Indianapolis to manufacture her hugely successful line of hair and beauty products for African-Americans. She would go on to become the first self-made woman millionaire in the nation and a trailblazer in the minority business community. More than 100 years later, her spirit of entrepreneurship and innovation is touching a new generation of minority entrepreneurs, specifically through a partnership between the Minority Business Development Agency (MBDA) and the Walker's Legacy Organization.

Inspired by the legendary life of Madam C.J. Walker, CEO and Founder Natalie Cofield

created Walker's Legacy in 2009 as "a professional collective that promotes the career advancement, skill sets and networks of women in business, and female entrepreneurs." The organization's core programing consists of a series of educational forums designed to inform, engage and empower women of color. Many of which, MBDA staff have supported as panelists and speakers.

This week, members of MBDA and Walker's Legacy gathered at the Department of Commerce in Washington, D.C., to sign a memorandum of understanding (MOU). This agreement enables Walker's Legacy and MBDA to work together to provide specialized business development programs and resources, such

Black Construction: It's Legacy and Future

One of the richest legacies of African descendents is construction. From the pyramids of Egypt to the building of America, Blacks have been involved in this industry that will survive the times. We will always build. Even when we demolish existing structures it is because we are about to build something new to replace it. Yes, construction has a certain future. It is a producer of many jobs and can provide not only a living for the laborers in the business but wealth for entrepreneurs to be handed down generation by generation.

African slaves were brought to this continent in the early 1500's to build New York (New Amsterdam at the time), Philadelphia, Baltimore, Washington, DC and the entire Southeastern territories. The craftsmanship that was learned through this action gave freed slaves an advan-

tage as we slowly approached the Industrial Revolution. America relied on the crafts learned by Blacks during slavery and passed along to offspring from generation to generation. Even "Chicken George's" son in the Roots documentary owned a lumber yard to sell supplies to the local black craftsmen who were the builders of the community.

As I grew up in Ventura County, CA, it was marvelous to admire the parents of my friends. The Gaston's, from east Texas, were masters at drywall. The Drayton's, from Louisiana, could lay masonry like no one else. The Gordon's, from Georgia, were expert hod carriers. No one could build a spiral staircase like Frank Williams, from Louisiana. He was so good that the wealthy would fly him to Australia, Japan, etc. to build spiral staircases for custom designed man-

Treasurer José Cisneros And Supervisor Jane Kim Advance First In The Nation Effort To Alleviate The Inequitable Burden Of Fees And Fines On Low Income Communities And People Of Color

Treasurer José Cisneros and Supervisor Jane Kim today released the recommendations of the Fees and Fines Task Force. The Task Force was created by the Board of Supervisors, and led by the Financial Justice Project in the Office of the Treasurer, to recommend reforms to reduce disparate impact of fees and fines on low-income communities.

"I launched the nation's first Financial Justice Project because I believe we can right-size fines and fees so they don't disproportionately impact poor people and people of color, while protecting our City's financial health," said Treasurer José Cisneros. "It is only fitting that the City that provides free MUNI, champions universal healthcare, and provides free City College is now the first to champion these types of reforms. We need consequences for breaking the law, but one ticket shouldn't cost someone their job, wreck their credit, or hurt their ability to find a job or a place to live."

"San Francisco should not be in the business of impoverishing poor and working class families. We are impoverishing poor and working class families because they made a mistake," said Supervisor Jane Kim, the sponsor of the Fees and Fines Task Force legislation. "Our heavy fines have become the difference between paying for rent and being evicted for many San Francisco families and often lead to driver license suspension, incarceration or bad credit ratings because they cannot afford to pay."

"We are grateful for San Francisco's leadership on these issues, starting with Debt Free SF's great organizing. San Franciscans have been calling for reform, and we are eager to see the Board of Supervisors fully implement the Task Force's recommendations." Elisa Della-Piana, Legal Director of the Lawyers' Committee for Civil Rights of the San Francisco Bay Area.

The Board of Supervisors held a hearing in 2016 to listen to diverse perspectives on how fines, fees, tickets, and financial penalties impact low-income San Franciscans. Following the hearing, Supervisors Kim and Avalos created the Fees and Fines Task Force with leaders from the City and community organizations. The task force was coordinated by Anne Stuhldreher, the Direc-



tor of Financial Justice in the Office of the Treasurer and Tax Collector.

The Task Force finds that and fees are spreading when people can least afford them. A recent Federal Reserve study found that nearly half of Americans would be unable to cover a \$400 emergency expense. In California, traffic fines and fees are among the highest in the country. Uncollected court-ordered debt for traffic and criminal offenses add up to an estimated \$12.3 billion, according to the California Legislative Analyst's Office.

In San Francisco, the burden of these fines and fees falls heavily on the African-American Community. In San Francisco, African-Americans make up less than 6 percent of the population, but over HALF of people who are in the County jail, and 45 percent of people arrested for a "failure to pay/appear" traffic court warrant.

"Steep fines and fees can be a "lose-lose", for citizens and for government," said Stuhldreher. "Research shows that fines and fees levied on people with modest incomes are often high pain-hitting poor people particularly hard--but low gain, bringing in less revenue than expected."

The Task Force developed recommendations to:

 Base fine and fee amounts on an individual's ability to pay, to ensure consequences do not place an inequitable burden on low income San Franciscans. Specific recommendations include: offering options including community service for people who have a complete inability to pay, offering flexible payment plans, allowing individuals to verify inability to pay by showing enrollment in public benefits, and using the same process across all City/County/Court proceedings.

2. End the practice of **suspending people's driver's licenses** when they are unable to pay traffic citations.

Specific recommendations include: making permanent the San Francisco Superior Court's policy to not refer failures to pay to the Department of Motor Vehicles, supporting and advocating to pass SB185, which would eliminate this process statewide, and to create an ability to pay process throughout the traffic court proceedings.

3. Ensure that **Quality of Life citations** do not punish people for being poor or create barriers to employment and housing for people struggling with homelessness.

Specific recommendations include: to stop adding a \$300 civil assessment fee to quality of life violations, streamline the process to allow individuals who receive these citations to resolve them through receiving social services, and to prioritize writ-

ten admonishments rather than citations when possible.

4. Ensure consequences for transportation violations hold people accountable but do not pose an inequitable burden for low income San Franciscans.

Specific recommendations include: expanding community service and payment plan options and making them more accessible; lowering fare evasion tickets and options to clear them; expanding towing and boot fine relief; and adding information about alternative payment options to the initial citation.

5. Reform our local system of bail to ensure decisions to keep someone in jail are based on the risk they pose to the community, not the amount of money in their bank account.

Recommendations include: exploring the creation of a community revolving bail fund, increasing oversight of the local bail bond industry, increasing the use of current alternatives such as the Pretrial Diversion Project, and engaging in statewide advocacy for reform.

 Relieve the inequitable burden of child support debt owed to the government by low income parents when they cannot afford to pay.

Specific recommendations include: developing and piloting a program to erase delinquent child support debt owed to the state if they can pay a portion of the delinquent debt, increasing referrals to nonmonetary payment options, and to continue to seek realistic child support orders that allow parents to make manageable payments.

The findings of the Fees and Fines Task Force will be presented at a hearing of the Government Audits and Oversight Committee of the San Francisco Board of Supervisors on May 17th, 2017.

Why Latino Small Businesses Thrive in California, Texas, Florida and New York

If you're thinking about opening up shop in one of these states — California, Texas, Florida, and New York — here's a glimpse at the benefits that await Hispanic business owners getting started.

Last year, the Stanford Latino Entrepreneurship Initiative released the State of Latino Entrepreneurship 2016 report that included key findings on the high growth of Latino-owned firms in the United States. One of the most interesting discoveries was uncovering the states where the majority of these firms do business. Nearly 60 percent of Latino firms are located in California, Texas, Florida and New York. Runner-up states include North Carolina, Georgia, Arizona, South Carolina and Illinois.

While the four core states where these firms thrive are also well-known for their large Latino populations, each state provides plenty of opportunities for entrepreneurs looking to get their startups off the ground. If you're thinking about opening up shop in one of these states — California, Texas, Florida and New York here's a glimpse at the benefits that await Hispanic business owners getting started.

The State of Latino Entrepreneurship report notes that in California, 22 percent of Latino firms call the West Coast home, particularly in the city of Los Angeles where 2.1 percent of these firms are based. This is great news for the city, which leads the nation in startups according

to the Los Angeles Business Journal.

While it's true that California is an expensive state to start a business, the flood of new firms has brought with it major financial assistance. In 2016, the U.S. Small Business Administration (SBA) approved more than \$5 billion in small business loans for California companies. 2017 has great plans in store for entrepreneurs as well. 12 months of economic development are on the horizon including the major lending initiative, Partnerships for Lending in Underserved Markets or PLUM. A combined effort from the SBA and Milken Institute, this initiative plans to provide minority-owned businesses with enhanced capital access and increased lending for those in underserved markets.

2. Texas

Texas is home to two cities where one in nine Latino firms can be found: San Antonio (2.4 percent) and Austin (1.6 percent). The state is one of the fastest growing for Hispanic entrepreneurial activity and credits that action to the Latino population and overall economic growth.

The Lone Star State is also extremely small business friendly. Residents pay no personal income tax and receive access to loans with lower business taxes than most states offer. With so many benefits, it's hardly a surprise that the Greater Austin Hispanic Chamber of Commerce (GAHCC) has the city on track to be the home

sions. He spent most of his local time doing it for homes in Hollywood and Beverly Hills. He raised 18 children from the profits of his craft. There were many more transplanted craftsmen in my Southern California home and they were barely literate and uneducated but they mastered their crafts.

Due to the Jim Crow laws of the South, there were many Black southern craftsmen who would travel to perform their skills. Many would go to places like New York, Philadelphia, Detroit, etc. and would out compete local white contractors who could not perform as well as they did and could not settle for their affordable pricing. It was because of this, that construction unions in the North were formed to block out Black crews from coming into communities and providing a better service for a cheaper price. Soon after the unions were formed they set in motion the Davis-Bacon Act (named for two New York congressmen). This act set up arbitrary labor wage scales so that Black craftsmen could no longer under price their white counter parts. They all had to pay a certain price, prevailing wage, at a minimum and competition became no more. With the price competition out of the way, the whites moved in through political favor and blatant racism. This would be followed with Project Labor Agreements which meant some projects would be declared "Union Only". With the construction unions discriminating against Blacks, PLA's would also mean "Whites Only"

Construction unions have made it rough for Black laborers and downright lethal for Black owned

construction companies. However, some of the best have made it through the years. Almost all of the longstanding Black construction companies have Southern roots. Let's look at three of the largest. Powers & Sons, SR Smoot and Russell began their businesses in Mississippi, West Virginia and Georgia respectively. The founders stressed education on their children and today the second generation is bearing the fruits of that education (Purdue, Michigan St. and Tuskegee respectively) and yielding great dividends. The third generation is settling in and they aren't just getting college degrees in engineering. The degrees are coupled with Construction Management, Architecture, Law, MBA, etc.

It is not just craftsmanship any longer. It is construction management, program management, urban development, design and build to order, etc. The construction industry demands political clout and the arrival of Black political power is right on time as city councils, school boards and mayoral offices have courageous leaders who happen to be of the same background as our Black contractors. The new generation in construction is something we can all be proud of. A new and better era is about to fully evolve.

Of course, racism still exists as well as conspiring unions and anti-affirmative action zealots who believe it is the destiny of Blacks

to fail at business and not be considered a part of this economy. We will defeat them. In fact, we love to fight them at every corner as we have a rising inventory of great entrepreneurs who have derived from the craftsmanship that actually built this nation and empires from Timbuktu to Ramses II. A family tradition continues!

3. Florida

Seeking a grant for your Latino firm? Head over to the Sunshine State — as an extra incentive, your small business won't have to worry about personal income or state tax. Florida is known for having the second-highest density of startups in the country and offers up small business grants and programs for qualifying startups. Two of our favorites include the Miami Mom & Pop Small Business Grant for Miami-based local businesses and the Orlando Downtown Facade & Building Stabilization Program for businesses based out of Orlando looking to improve the appearance of their buildings.

4. New York

Inside this concrete jungle where dreams are made of are a whole lot of entrepreneurs looking to make their mark. The SBA noted in 2014 that 99% of all New York businesses are made up of small businesses. Of the 60 percent of Latino firms scattered throughout the four main states, 6 percent are in New York with 3.6 percent of that percentage based in New York City.

While the entire state offers plenty of small business opportunities, there are several New York City-centric small business grants that are definitely worth looking into for new and established entrepreneurs alike. • Limited Liability Company: Disadvantaged individuals must own at least 51% of each class of member interest. 13 CFR § 124.105(c)

• Corporations:

- Disadvantaged individuals must own at least 51% of each classof voting stock and at least 51% of the aggregate of all outstanding stock. (13 CFR §124.105(d))
- Stock option plans for nondisadvantaged individuals will be viewed as if they have been exercised. (13 CFR §124.105(e))

SBA will look at the:

- stock certificates and ledger;
- IRS 1040 Schedule C, if single mbr. LLC.;
- IRS 1040 Schedule E, if applicable;
- Firm's tax returns.

Control and Management

- Partnerships: Agreements must reflect unconditional management by disadvantaged partner(s). DVD individual(s) must be named as the General Partner(s). 13 CFR §124.106(b)
- SBA will examine the partnership agreement, and any amendments.
- Limited Liability Company: One or more disadvantaged individuals must serve as management members with unconditional control. 13 CFR §124.106(c)

SBA will examine the LLC's operating agreement, and any amendments.

Corporations: How control is established. 13 CFR \$124.106(d)

SBA will examine the corporation's articles, by-laws, and meeting minutes, among other things.

A. Disadvantaged directors of the board must control the board by actual number of votes and must be able to establish a quorum without the presence of nondisadvantaged directors.

OR

B. Control without considering the board of directors:

- 1. A single disadvantaged individual owns 100% of the voting stock.
- 2. A single disadvantaged individual owns at least 51% of the voting stock, is on the board of directors and no supermajority* voting requirements exist. If a supermajority requirement exists, the disadvantaged individual must own at least the percentage of voting stock necessary to overcome any supermajority requirements.
- 3. If more than one disadvantaged individual, each disadvantaged individual is on the Board of Director and together own at least 51% of the voting stock and no supermajority voting requirements exist, and there are enforceable agreements of the shareholders permitting one of them to vote all stock as a block without a shareholders meeting. If a supermajority requirement exists, the disadvantaged individuals must own at least the percentage of voting stock necessary to overcome any supermajority requirements.



* A supermajority is a percentage of votes required by shareholders to make decisions on behalf of the concern. For example, if a 2/3 vote is required to approve a bylaw change, disadvantaged individuals must have at least 2/3 of the votes necessary to control the concern.

What constitutes Control?

A Disadvantaged Individual must:

- Hold the position of President or Chief Executive Officer, Managing/ General Partner, or LLC Managing Member;
- Be physically located in the U.S.;
- Be the highest compensated individual;
- Have the ability to Hire and Fire;
- Set Policies;
- · Have the ability to commit firm to contracts;
- Have the ability to the control Budget and Financial Disbursement;

Does a disadvantaged indiv. control the Operations?

Tests:

- Does a disadvantaged individual or individuals devote full-time to the business?
- Does a disadvantaged individual have sufficient managerial experience to run the concern?
- Does a disadvantaged individual have ultimate managerial control over individuals with technical expertise and/or critical licenses?

Do Non-disadvantaged Individuals have the Ability to Control the firm?

TESTS

- Do contractual arrangements exists that allow a nondisadvantaged individual to control the firm?
- Is the nondisadvantaged individual a previous employer or supervisor?
- Does a nondisadvantaged individual:

- hold the critical license and have an equity interest in the applicant concern;
- provide the necessary licenses or bonding;
- have unlimited access to the business bank accounts;
- provide critical financing;
- control through business loan arrangements; and/or
- receive excessive compensation.

Some phrases to look for:

- "unanimous consent of..." w/o regard for the ownership of the disadvantaged individual(s);
- "consent of all..." w/o regard for the ownership of the disadvantaged individual(s);
- "supermajority"
- Terms and other clauses that restrict the actions the disadvantaged individual(s) may take;

Potential for Success

- Financial capability: sufficient capitalization, financial performance, bonding capacity, manageable debts.
- Managerial and Technical capability: performance on previous contracts, firm has the necessary personnel, licenses, certifications, facilities, prior experience.
- Management capability: Education, experience and training of CEO and other managers, magnitude and complexity of past/current jobs, management systems.
- Qualifications for ability to perform on Federal contracts: relevant contracting experience, ability to meet Federal procurement policies.

Ineligible Businesses & Individual Disqualification

 Ineligible businesses: brokers *; debarred or suspended persons or concerns; nonprofit organizations. Franchises may be allowed contingent upon SBA's review of the franchise agreement.

- A business may participate only once. Even if ownership and control has completely changed, firm may not re-apply.
- Any person who has used his/her disadvantaged status to qualify another firm shall be regarded as non disadvantaged.
- * A broker is a concern that adds no material value to an item being supplied to procuring activity or which does not take ownership or possession of or handle the item being

Good Character

What shows lack of good character?

- Adverse information regarding possible criminal conduct by the applicant or its principals.
- · Violations of any SBA regulations.
- · Debarred or suspended individuals or firms.
- Applicant firms and principals that lack business integrity as shown by an indictment, guilty plea, or civil judgment.
- Any principal who is incarcerated or on parole or probation.
- Evidence that the firm knowingly submitted false information during the application process.
- Any firm or any of its principals that fail to pay financial obligations to the Federal Government.

Waiver of the Two Year Rule

Factors considered:

- Your firm must demonstrate potential for success by showing two years in business. Please note that if the business concern has not yet generated revenues you will be unable to waive the two year rule.
- If the business has not generated revenues for the preceding two years, as verified by revenues reported on business tax returns, you will need to request the Two-Year Waiver.
