Why the Suburbs Are Where **Innovation Will Happen**

It was back in 1997 when Harvard Professor Clayton Christensen coined the phrase "disruptive innovation" to describe a process that transforms an industry in which expensive and complicated processes have been the norm. Disruptive innovations introduce simplicity, convenience, accessibility and affordability. Today we face another period of disruption as technologies like the Internet of Things and artificial intelligence spread.

This time of transformative technological change is already having significant impact on all facets of government. What will economicdevelopment strategies look like in an Internet of Things economy? How will first responders and social-services caseworkers harness data to deal with some of our communities' most pressing social ills? How will public infrastructure evolve to meet the needs of the disruptive innovation

that is occurring in transportation? How will local governments learn to adapt to the pace of disruptive innovation that is occurring all around

Some answers can be found in what might seem an unlikely place: the suburbs. Much has been written about the decline of the suburbs, the rise of the cities and the millennial generation's distaste for the suburban lifestyle. The popular concept of a suburb is often one of a bedroom community that is myopically focused on catering only to the needs of the family. Many might think that the suburbs would be the most resistant to change and adaptation. I disagree.

According to the Urban Land Institute, suburbs account for 79 percent of the population of the 50 largest U.S. metro areas. Employment opportunities in the suburbs are rising: Between 2010 and 2014, the number of suburban jobs increased

The U.S. Has Forgotten How to Do Infrastructure

As Vox's Matthew Yglesias points out, the problem with high infrastructure costs is that they force us to debate the wrong things. If costs were reasonable, even skeptics would probably agree to fix roads and build better trains. But when the price of maintaining high-quality infrastructure is ridiculously high, the issue gets divided into two camps -- a pro-building contingent that advocates biting the bullet and overspending to maintain transportation networks, and an antibuilding group that throws up its hands at the price tag. When this is the debate, the country loses either way, because it ends up either spending too much money or living with potholed roads and trains that never arrive.

The U.S. is in the grips of exactly this sort of dilemma. For some mysterious reason, the same mile of road or train track costs a lot more to

build in the U.S. than in other rich countries like France or Japan. When it comes to trains, the disparity is particularly egregious. During the past few years, people who pay attention to this problem have catalogued a list of potential culprits. But none of these is really satisfying.

One popular villain is union labor. The Davis-Bacon Act, passed in 1931, mandates that infrastructure workers get paid locally prevailing wages, which usually means the wages that union members would receive. Some studies have claimed that this law and other unionfriendly policies drive up costs in the U.S.

But unions probably don't help explain the yawning gap between the U.S. and other rich countries. The reason is that places like France have some of the strongest unions in the world.

Mayor Lee to Name Jason Elliott as New Chief of Staff

He is a tireless worker and an effective communicator, and I know that he will bring a determined enthusiasm and commitment to this position every day.'

Elliott served as the Mayor's Liaison to the Board of Supervisors and Director of Government Affairs from 2011 to 2014. From 2009 to 2011, he was a Policy Advisor for Mayor Gavin Newsom

"I'm excited about this opportunity and I look forward to addressing the many important issues facing our City today," said Elliott. "I know that I have big shoes to fill, but I'm fortunate to be able to rely on the support of so many talented colleagues and department heads. Together, we are ready to carry out the vision of the Mayor and work to make San Francisco a better place for all."

Kawa served under Mayors Lee, Newsom and Brown, and began his career at the City and County of San Francisco in 1991, working as a Legislative Aide to former Supervisor Tom Hsieh. Kawa helped guide San Francisco through challenging times such as the Great Recession and the aftermath of 9/11, and through historic achievements including marriage equality and universal healthcare access. He also helped oversee unprecedented investments in affordable housing and infrastructure projects.

"Steve has helped shape the policies and the values of this City for the better," said Mayor Lee. "He has worked tirelessly on the City's emergency disaster responses to ensure all residents are safe, led countless labor negotiations, and ensured the long-term financial stability of the City through pension reform. Steve was the calm amongst many storms. We are lucky to have had such a compassionate and brave public servant."

5 Ways Small Business Owners Can Grow In 2017

In the world of business it is all about growth. Coach Lou Hotlz famously said, "in this world you're either growing or you're dying, so get in motion and grow." As a result, here are five surefire ways to grow your business in 2017.

1. Get Better At Search Engine Optimization

In the words of Bill Gates, "there will be only two kinds of businesses, those with an internet presence, and those with no business at all." This one statement effectively illustrates the modern business landscape. People go to the internet for almost all information. What kind of internet presence does your small business have? Today you can't just have a sexy website, instead you need to have a means for attracting visitors in the first place. This is where SEO comes in. With roughly 644 million active websites on the net, it is becoming very challenging to be discovered online. SEO involves a series of rules and protocols that helps bring your business out of the background and into the virtual highway. When someone is searching the web after a hailstorm for "Cleveland roofing service," you want your business to be one of the first pages on Google. If you rank high enough organically, that's free advertising. The easiest way to get better at SEO is to simply hire someone. Although that might be the best option for companies with a big enough budget, others might not be so fortunate.



If you're strapped for cash, I have two important recommendations First there is a free website that teaches small business owners how to optimize their websites for Local SEO. I can't recommend this resource highly enough. Second, there is a book titled The Ultimate Guide to Link Building. This is an incredible resource to help people understand how to do SEO the right way.

2. Understand Lean Operations

A key element to running a business is organization and prioritization. Do not allow your business organization to disintegrate into an array of convoluted finger-pointing when it comes to operations. A good book to reference regarding lean business operations is Good to Great by Jim Collins. Good to Great evaluates the qualities of companies that not only grew but also maintained success beyond their growth periods. The book discusses the importance of simplification in business operations. Collins and his associates found that great businesses comply with three major operational components: level five leaders, the right staff and confronting brutal facts.

Once businesses understand the intersection of those three components, the managers continue to optimize and simplify operations. What are bare bones to your small business? More importantly, what activities give you 80% of the value for 20% of the time? Those are the things you need to optimize and mistake-proof. As an additional resource, read The Lean Start-Up by Eric Ries. This book helps new business owners create a culture of lean operations from the first day.

3. Focus On Free Cash Flow

A small business needs to define their free cash flow. Businesses typically calculate free cash flow based on what is left over after all necessary financing expenditures are paid and noncash items are adjusted on the net income. When a small business owner starts to think about business decisions from a free cash flow vantage point, new opportunities and perspectives are gained. More specifically, growth opportunities become more apparent. Where many business owners lose sight of this important consideration is when they make huge capital investments into infrastructure that has large depreciation costs and little long-term value is created. Having a balance sheet full of stagnant assets that add little long-term value creates a financially inefficient company. This is one of the reasons Warren Buffett and Charlie Munger have been so successful through the years; they have always

Strikes by rail workers are commonplace. Yet France's trains cost much less.

Japan is another counterexample. The median salary for a Japanese construction worker in 2014 was about 4 million yen a year, which at current exchange rates is roughly \$36,000. Construction workers in the U.S. make about the same -- an average of \$37,890 in 2016. Now, it's possible that the average Japanese worker is capable of building much more in an hour than the average American worker, meaning U.S. laborers could still be overpaid in the relative sense. But it seems unlikely that the difference is that huge. The numbers are pretty clear -- high wages

aren't the big culprit in U.S. costs.

Another bogeyman is land-acquisition costs. People think of China's authoritarian government forcing millions of people to move in order to build dams and highways, and assume this must be why it can get things done so much more cheaply than in the democratic U.S

But this is also probably a red herring. As transit blogger Alon Levy notes, land-acquisition costs are much higher in Japan, where eminent domain laws are weaker. So much for the U.S. being the land of property rights! And yet, somehow, Japan still lays train track much more cheaply.

Explanations based on geography -- the U.S. is too spread out, or New York City is too dense

-- also fail to stand up to scrutiny. Cumbersome environmental impact reviews are a possible culprit, but it's hard to believe that countries such as France would be so willing to pave over their natural beauty and slaughter endangered species that their trains would cost only half as much as America's as a result.

There is reason to suspect that high U.S. costs are part of a deeper problem. For example, construction seems to take a lot longer in the U.S. than in other countries. In China, a 30-story building can be completed in only 15 days. In Japan, giant sinkholes get fully repaired in one week. Even in the U.S. of a century ago, construction was pretty fast -- the Empire State Building went up in 410 days.

Yet today, it takes the U.S. many years to spend the money that Congress allocates for infrastructure. New buildings seem to linger half-built for months or years, with construction workers often nowhere to be found. Subways can take decades. Even in the private sector, there are problems -- productivity in the homebuilding sector has fallen in recent decades.

That suggests that U.S. costs are high due to general inefficiency -- inefficient project management, an inefficient government contracting process, and inefficient regulation. It suggests that construction, like health care or asset management or education, is an area where Americans have simply ponied up more and more cash over

Where To Find Small Business Loans Online

Small businesses have more choices and options for loans and financing than ever. And the good news is you have access to a wide range of resources at your fingertips, without leaving your office -- all through the Internet.

Online lending marketplaces and alternative funding sources make getting financing so much easier today than a decade ago.

In this article, I cover some of the common financing and loan options existing today and where to find them online. You can do much of your research online, and even apply directly online for a loan or funds in many instances.

As you research options, keep in mind the terminology is evolving. Often the definitions of financing type vary from source to source. Some financing sources today simply call everything "small business loans" even if the financing really takes the form of a cash advance or line of credit or something else.

Here are some options:

SBA Loans

SBA Loans are loans that are backed by guarantees from the U.S. Small Business Administration. They are issued through private lenders authorized to make SBA loans.

An efficient way to get started with SBA loans is at the SBA.gov website. While you can't apply directly online for an SBA loan, you can do a lot of the research and preliminary steps online:

- Research the different types of SBA loans.
- Learn the information you need to gather.
- Find SBA lenders. The SBA Linc website helps connect small businesses with SBA lenders.

Lines of Credit and Traditional Loans

If you need money for day-to-day cash flow, a line of credit could be the solution. Small business lines of credit are an excellent choice because you draw on them only as needed, and you only pay interest on the portion you use.

A loan, on the other hand, delivers the funds in a lump sum and you repay the loan with interest, usually in monthly payments.

Today an extremely efficient option is to visit an online financing marketplace, such as Biz2Credit.com, Lendio.com or Fundera.com. Such fi-

nancing marketplaces match up businesses to lenders. You can apply directly online at such marketplaces, saving time and getting access to multiple funding sources in one place.

Microloans

Microloans are loans for small businesses, in small amounts. If you're concerned that your business is too small or too young to interest a bank, a microloan may be for you.

Accion.org provides microloans, starting at \$500 on up. First time borrowers can apply directly online at the Accion website.

The SBA also has a microloan program, in amounts up to \$50,000, with the average amount being \$13,000. Start your research for SBA microloans here.

Business Credit Cards and Charge Cards

If you need credit for smaller or routine purchases, such as for travel expenses or online software licenses, then a business credit card is useful. Charge cards are similar to credit cards, except that you have to pay off the balance monthly.

Don't rely on personal credit cards. Rather, apply for a business card so that you establish credit in your business name and so as not to max out personal credit cards

You can go to the website of a card provider such as American Express or Discover, or to a bank such as Chase or Capital One, and apply directly online.

Cash Advances and/or Merchant Advances

Cash advances are a form of financing made against your future receivables or credit card receipts. Like any type of financing there are pros and cons. Cash advances may not require a credit check, minimize paperwork, and often the money is available quickly (in minutes or hours). However, the fees and interest can be expensive.

Kabbage.com is a unique funding source for alternative financing because the Kabbage platform connects to a number of services used for commerce transactions, such as QuickBooks, Etsy, Amazon or Stripe. Kabbage quickly verifies the business's information through direct connection with the transaction service.

Why the Suburbs Are Where **Innovation Will Happen**

by 9 percent, compared to 6 percent in urban areas. Employment growth produces more tax revenue, providing suburban governments with greater flexibility to adapt to disruptive innova-

Suburbs have other advantages as well. Less bureaucracy allows for more nimble adaptation of policies and regulations, and suburban communities typically have far less internal red tape to navigate than larger cities, so suburban governments can pivot more quickly as technology

Like many communities, our Indianapolis suburb of Fishers has come face-to-face with technological disruption, requiring us to innovate to compete. Three industries of particular importance to Indiana, manufacturing, agriculture and logistics, are all beginning to see major disruption from the Internet of Things. In preparing for that, the city of Fishers has partnered with local leaders in technology, entrepreneurship and higher education to launch Indiana's first Internet of Things lab. Companies will be able to take up residence, temporarily or permanently, in IoT Lab-Fishers for an annual membership fee.

The lab will be dedicated to bringing together the four key components to IoT solutions: "ideation," cloud data, leading-edge hardware and software development. Such support for industry-driven innovation initiatives is a key focus area of Indiana Gov. Eric Holcomb's Next Level Legislative Agenda, which proposes investing \$1 billion over the next 10 years to make the state a global hub for innovation and entrepreneurship.

The advantages that suburbs have for adapting to disruptive innovation should not be a rationale for their complacency. Adaptation needs to be nurtured; it won't happen automatically. Suburbs have an opportunity and, more importantly, an obligation to develop proofs of concept and to share those lessons with other governmental

That means that the narrative of suburban versus urban must change. With open lines of communication between suburbs and cities, suburbs have a chance to redefine themselves as entrepreneurial laboratories of innovation -- and perhaps to cause some disruption of their own.

looked at the free cash flow of their own business and any new opportunities for growth. To learn more about this idea, I would recommend reading the Berkshire Hathaway Shareholder letters. You can get access to them for free with the previous link, or you can buy a hardcopy online.

4. It's All About The Customers

Small businesses have a fundamental advantage over large corporations. Small businesses can interact with customers at a much more personal level. This is not to say that large corporations do not care about the customers, but it's more challenging to put the CEO or other high-ranking executives face to face with new customers. Small businesses are local and can customize their services to their specific population. Take for example this dental practice in Albuquerque, New Mexico. Recently, I talked to one of the partners at this practice and he told me how important customer interactions were to their overall business model. For him, there was nothing more important than ensuring each customer had a satisfactory visit. Although this might seem like common sense for most busi-

ness interactions, many companies get customer fatigue and complacency. Culture and focus on individual customer interactions is something that many small businesses take for granted and fail to realize the long-term importance. Stephen Covey's The 7 Habits of Highly Effective People demonstrates the value of placing the customer first. One pivotal element to focusing on the customer involves Covey's rule of "seeking first to understand before being understood." We live in an era of complete customization, from social media profiles to iPhone cases. People want what they want. Make sure you understand your customer or client, then you can cater to their specific desires. Additionally, billionaire Tony Hsieh wrote a book titled, Delivering Happiness, and it talks about how an online shoe company uses its customer service to create a competitive advantage over other retailers. Whether you're running a local dental clinic or a large online shoe store, focus on the customer and treat each interaction as a vital source of future growth. This habit is the lifeblood of any great business.

5. Invest The Retained Earnings Intelligently

Your business runs well. You understand the balance sheet, and you want to explore other opportunities. You can reinvest your retained earnings back into the operational business, or you can choose to invest in external assets that are non-operational subsidiaries. What is the right decision? Well that's the hard decision. I guess my point for bringing this discussion into the fold is to simply make the reader aware of the idea Too often business owners think they need to reinvest retained earnings into the organic business. In many cases this is the right decision, but in some instances they aren't doing the hard math. In fact, many business owners that have had successful companies in the first 10 years take the retained earnings and invest in another operational business. The failure comes when the overconfidence from the first success overshadows the realism in the second venture. New ventures that have low odds of success and huge upfront costs could mean the death of both businesses. Instead of taking low-probability choices with huge sums of money, a better choice might be to invest in non-operational assets (either private or public). An interesting book that captures this exact topic is Outsiders by William Thorndike. In Thorndike's research, he finds that business owners that consider a very wide array of investment options - beyond their operational

business model - tend to have the best growth. One must first master their original business, but once that is achieved and retained earnings are being added to the balance sheet, the compounding and optimization of those earnings is what differentiates professionals from amateurs. In short, business owners must become great investors too. Warren Buffett is famous for saving. "I'm a better investor because I'm a businessman, and I'm a better businessman because I'm an investor." For many people, they might see these activities as being the same thing, but for Buffett, investing and operational leadership are different skills that both need mastered.

Small businesses face challenges, and these five ways of growing your small business can differentiate your business from the others. Do not get distracted with spreading operations thin across a multitude of unnecessary platforms. Focus on simplification, customization and understanding your free cash flow. Once you accomplish those vital tasks, learning to invest the retained earnings may be the most challenging task of all, but in business, we call that a good problem.

the years while ignoring the fact that they were getting less and less for their money. To fix the problems choking U.S. construction, reformers are going to have to go through the system and rip out the inefficiencies root and branch.

Unfortunately, this is going to be hard, given all the vested interests and institutional inertia blocking deep reform of the construction sector. As Yglesias ruefully notes, a study by the Government Accountability Office looking into the problem of high train-construction costs was recently killed by Congress, with no explanation given.

Shenanigans like this can only delay the day of reckoning. The U.S. construction sector is sick, and the disease must be diagnosed. Otherwise, infrastructure debates will continue to seesaw between those who are willing to spend too much and those who are willing to let the system crumble because it costs too much to repair.
