Applauds SBA Administrator Maria Contreras-Sweet

Policy experts at The Greenlining Institute applauded Small Business Administration chief Maria Contreras-Sweet's priorities announced today in remarks at the Center for American Progress.

After strongly supporting Administrator Contreras-Sweet's nomination, the Greenlining Institute and its coalition published an open letter with recommendations for what she could accomplish within her first 100 days of taking office. These recommendations included suggestions about building small business capacity, increasing access to capital for small businesses, improving small business data, championing diversity and prioritizing supplier diversity.

Contreras-Sweet's remarks today aligned with many of Greenlining's suggestions, drawing praise from Executive Director Orson Aguilar. "From government contracting opportunities to expanding SBA lending to diverse entrepreneurs, the Administrator is showing that she understands the importance of growing businesses rooted in communities of color," said Aguilar. "As our nation becomes increasingly diverse, our economic prosperity will depend more than ever on the success of small businesses of color. These businesses often act as neighborhood anchors, with higher rates of job creation than their white counterparts.'

In her remarks, Contreras-Sweet noted that "capital is not reaching small business owners equitably" and focused on expanding access to core SBA programs known as "three Cs" - capital, consultation and contracting. "The face of entre-preneurship is changing in America, "said Contreras-Sweet. "More of those faces today belong to women, Latinos, African Americans, Asian Americans, Native Americans, veterans, seniors, and business owners who are socially and economically disadvantaged. Too many in these groups cannot access the requisite expansion capital. Your gender, your race, your age, or your neighborhood should never impact whether you can get a small business loan. Only your creditworthiness should."

Contreras-Sweet also remarked on the importance of cutting through red tape to increase access to capital for business owners from "all walks of life," and emphasized improving government contracting opportunities for small businesses.

"We look forward to a continuing dialogue with the Small Business Administration as the agency works to revitalize this critical sector of our economy," Aguilar said.

Ruby Dee dead at 91: Legendary stage and screen actress and Civil Rights leader

Stage and screen legend Ruby Dee, who personified grace, grit and progress at a time when African-American women were given little space in movies and on stage, died Wednesday in New Rochelle, N.Y. She was 91.

The death was confirmed Thursday by a family member, who declined to answer any questions pending the release of a statement.

"She died late (Wednesday) with her whole family around her," family friend Latifah Salahudin told the Daily News. "All three kids and seven grandkids were there, surrounding her with so much love. She went peacefully from natural causes. We should all be so lucky."

"She was so full of life and so strong. Such a powerful woman. We're all going to miss her," Salahudin added.

The Cleveland-born, New York-raised actress and activist — winner of an Emmy, a Grammy and a Screen Actors Guild award, among others — not only starred on Broadway ("Take It From the Top!" "Two Hah Hahs and a Homeboy"), film (Spike Lee's "Do the Right Thing" and "Jungle Fever"), and TV ("All God's Children," "Feast of All Saints"), but, with her husband and collaborator Ossie Davis, was a major figure in the Civil Rights movement.

Dee's first film role came in 1949, in the musical drama "That Man of Mine." She played Rachel Robinson in "The Jackie Robinson Story" in 1950, and costarred opposite Nat King Cole, Eartha Kitt and Cab Calloway in "St. Louis Blues" (1958).

She appeared in the 1979 TV movie "Roots: The Next Generations," and costarred with Davis in their own short-lived 1980-81 show, "Ossie and Ruby!"

The two played contentious neighbors who embodied, and recalled, the social unrest of the '60s in Lee's "Do the Right Thing" (1989). She earned her sole Academy Award nomination, for Best Supporting Actress, for "American Gangster" (2007).

Her final film was the still-in-production crime drama "King Dog," opposite Ice-T.

Dee was a frequent presence on New York stages for four decades, since joining the American Negro Theatre in 1941 before her stage debut two years later in the Broadway drama "South Pacific."

In 1946 she costarred in the play "Jeb" with Davis, whom she married in 1948.

In 1953, Dee starred in the Broadway premiere of "A Raisin in the Sun," playing the wife of Sidney Poitier — and reprised that role in the film eight years later.

Dee's last Broadway performance was in the 1988 comedy "Checkmates," which marked the debut of Denzel Washington, who is currently on the boards in Poitier role in "A Raisin in the Sun."

Washington declined to comment: "Not today," a spokesperson said.

But the Rev. Al Sharpton issued a statement calling Dee "a phenomenally rare artist and a jewel to our nation and community."

California to Spend \$600 Million on Housing for Homeless Veterans

Currently, 25 percent (an estimated 19,000) of the nation's homeless veterans reside in California—making it the state with the highest rate of ex-servicemen without housing in the U.S.

However, this will soon change following the passage last week of Proposition 41.

The Veterans Housing and Homeless Prevention Bond Act of 2014 authorizes \$600 million in bonds to assist both homeless and at-risk veterans. The funding will be allocated toward housing as well as aid for those struggling with physical and

mental injuries, and substance abuse. It will also provide job training.

While the Veterans Bond Act (Proposition 12) was passed back in 2008, the \$900 million from it was never allocated. Additionally, \$200 million from Proposition 32 (another veterans housing bond) was never spent either.

Prop. 41 will be repurposing \$600 million from Prop. 12 for the aforementioned veteran needs, leaving \$500 million available for the original plan of purchasing single-family homes.

Following the passing of Prop. 41, campaign co-chair Burt McChesney released the following statement:

Is \$487K Too Little to Pay **Federal Contractors?**

The federal government has finalized a plan to expand compensation reimbursement caps to a large swath of its contracted employees, drawing the ire of its private industry partners.

Congress approved the expansion in the 2012 National Defense Authorization Act, applying the ceiling on reimbursable pay to all Defense Department, General Services Administration and NASA contract employees, rather than just the five highest paid executives. The law applied to all contracts signed on or after Dec. 31, 2011.

The contracting community took particular issue with the rule's requirement that the reimbursement cap's implementation take place retroactively to the end of 2011. Instead, the Professional Services Council said, the cap should only apply to contracts signed after June 26, 2013, when the Federal Acquisition Regulatory Council initially issued the interim rule to implement the change.

"As a result of the interim and final rules, covered contractors will have to unscramble their accounting to make this change in allowable compensation rates that were validly incurred during the 18 months it took the FAR Council to act, said Alan Chvotkin, PSC executive vice president. 'That is simply unacceptable.'

The FAR Council said in the final rule, however, it was only following the letter of the law.

The 2012 NDAA "explicitly states that the expanded reach of the compensation cap 'shall apply with respect to costs of compensation incurred after Jan. 1, 2012, under contracts entered into before, on, or after the date of the enactment of this Act' (which was Dec. 31, 2011)," the rule stated. "Therefore...the specified effective date for this rule is Jan. 1, 2012."

A separate proposed rule would apply the salary reimbursement cap to contracts awarded before Dec. 31, 2011, but for which costs were incurred in 2012 and beyond.

The budget deal reached at the end of 2013 set the maximum contractor reimbursement salary at \$487,000. The government has not yet issued a rule to implement that cap, though it is scheduled to take effect June 24 and will apply to all federal government contractors. At the time of the original Defense, GSA and NASA guidance, the cap was \$763,029, meaning contractors must retroactively ensure no employee in a post-2011 contract was compensated by government funds at more than that figure.

Adding to the confusion, Chvotkin said, is that in 2013 the maximum reimbursable salary jumped to \$952,308. Though he suspected very few employees were charging the government more than either of those figures, Chvotkin said determining how and how much to pay back in overcharges could create "quite a bit of administrative work

PSC said it opposes both the expansion of the maximum reimbursable salary provision and the "arbitrary caps" put in place by the budget deal. As the maximum reimbursable rate shrinks to \$487,000, "or gosh forbid lower," Chvotkin said, some companies -- especially smaller ones -- cannot afford to pay their employees more than what they receive from the government.

A commenter on the interim rule said the expansion will "reduce contractors' ability to attract and retain experienced and talented individuals and will jeopardize contractors' ability to support government mission critical requirements." FAR Council noted, however, just 0.4 percent of contractors would be affected by a cap set at the president's salary of \$400,000 -- almost half of the maximum in place at the time of the rule. It added citing the Ĝovernment Accountability Office -even if the cap were set at the vice president's salary of \$237,000, businesses would only be "minimally affected.

Going forward, Chvotkin said PSC will help agencies take advantage of a provision allowing them to exempt contracted employees in fields such as science, engineering and math from the

SBA Proposes Revisions to Size Standards

Size standards for Wholesale Trade and Retail Trade Industries to be reviewed.

The U. S, Small Business Administration (SBA) has proposed increasing small business size standards affecting businesses in 46 industries in North American Industry Classification System (NAICS) Sector 42, Wholesale Trade, and in one industry in Sector 44-45, Retail Trade. If they are adopted, nearly 4,000 more firms will become eligible for SBA's loan programs. The proposed rule was published in the Federal Register on May 19, 2014.

The proposed size standards would define the maximum number of employees a firm in these industries could have and still be a small business. The proposed revisions reflect changes in marketplace conditions.

SBA proposed to retain the current size standards for the remaining industries in those sectors. SBA reviewed all of the employee-based size standards for both sectors to determine whether the size standards should be revised or retained.

The SBA has also proposed to retain the current 500-employee size standard for federal

U.S. House Approves Transportation, Housing Measure

The GOP -controlled House on Tuesday passed a huge bill providing money for transportation and housing programs despite protests from Democrats that the \$105 billion measure shortchanges transit projects, Amtrak and rent subsidies for the poor.

The House passed the bill on a 229-192 vote, capping a busy day as lawmakers worked their way through the annual spending bills funding line-by-line agency budgets. It came hours after the Democratic-led Senate Appropriations Committee unveiled a \$158 billion measure funding the departments of Labor, Health and Human Services , and Education.

The Senate measure more than doubles, to \$1.9 billion , funding to care for the wave of unaccompanied immigrant children fleeing drug and gang violence in Central American countries like Guatemala and El Salvador . It also adds money for health research, Head Start and child care grants, as well as reviews of Social Security disability claims.

A Senate subcommittee approved the measure by voice vote, though Republicans oppose it for funding implementation of the new health care law. It rejects administration-sought cuts to heating aid and grants to nonprofit community action agencies that help the poor, and awards a sizable increase to community health centers.

And on Tuesday morning House panels gave back-to-back bipartisan approval to both a \$570

billion Pentagon spending bill and a \$34 billion measure funding the Energy Department , water projects and the Pentagon's nuclear weapons program. In approving the energy and water measure, lawmakers restored almost \$1 billion in cuts proposed by the Obama administration to Army Corps of Engineers projects. The GOP -led panel also pared back renewable energy programs backed by Obama and his Democratic allies while boosting spending to maintain the government's stockpile of nuclear weapons.

The defense funding measure backed up the Pentagon's efforts to retire the A-10 Warthog, the close air support aircraft that has a strong constituency in Congress . Rep. Jack Kingston , R- Ga. , had offered an amendment to save the plane, shifting \$339 million from other accounts to keep the aircraft operating. But the amendment failed by a 23-13 vote. The vote is far from the final word on the plane as the panel's actions put it at odds with the House Armed Services Committee and the Senate .

The frenzy of activity involves the approximately \$1.1 trillion portion of the federal budget that's funded annually through 12 appropriations bills. These so-called discretionary programs would essentially be frozen at current levels, but as a practical matter face cuts as lawmakers deal with a spike in costs to care for unaccompanied immigrant children, battle Western wildfires and provide health care for veterans. A nearly \$3 billion drop in Federal Housing Administration receipts —

which are used to pay for spending elsewhere in the transportation and housing bill — has created problems not just for that measure but is having ripple effects through each domestic bill.

While senior lawmakers like Senate Appropriations Committee Chairwoman Barbara Mikulski, D- Md., are promising to get the troubled appropriations process back on track this year, the challenges should not be discounted. Mikulski is employing accounting maneuvers to squeeze an additional several billion dollars into the measures, which is creating a mismatch between the House and Senate bills.

For instance, the spending increases in the Senate's labor, health, and education bill are paid for with \$2.4 billion in additional cuts to as-yet-unspecified programs. Such "changes in mandatory programs" often are a relatively pain-free way of squeezing money into spending bills and are typically met with skepticism from GOP budget banks.

The transportation and housing measure offers a vivid illustration of the gap between the GOP House and Democratic Senate . Obama's Senate Democratic allies have added \$2.4 billion on top of the House measure, providing \$550 million for a transportation grant program that dates to Obama's 2009 stimulus bill, additional funding for rent vouchers for the poor and full funding of Obama's \$950 million request for the HOME program, which helps state and local governments

build and rehabilitate affordable housing projects.

The House measure was opposed by most Democrats for shortchanging those programs. But the cuts were not as deep as last year, when the transportation and housing bill collapsed on the House floor.

procurement of supplies under its non-manufacturer rule because Wholesale Trade and Retail Trade NAICS codes and their small business size standards cannot be used for procurement of supplies. These proposed revisions primarily affect eligibility for SBA's financial assistance programs.

Comments can be submitted on this proposed rule on or before July 18, 2014, at www.regulations.gov, identified by the following RIN number: (RIN 3245-AG49). You may also mail comments to Khem R. Sharma, Chief, Office of Size Standards, 409 3rd St., SW, Mail Code 6530, Washington, DC 20416.

As part of an ongoing review of all size standards, SBA takes into account the structural characteristics of individual industries, including average firm size, startup cost and entry barriers, the degree of competition, and

small business share of federal government contracting dollars. This ensures that small business size definitions reflect current economic conditions and federal marketplace in those industries. Under the Small Business Jobs Act of 2010, SBA plans to continue its comprehensive review of all size standards for the next several years.

U.S. House Approves

"It provides inadequate funding for our country's highways and transportation infrastructure," said New York Rep. Nita Lowey, the top Democrat on the Appropriations Committee.

But Rep. Ed Pastor , D- Ariz. , said the measure "is the best we can do" given the budget constraints facing lawmakers.

In two days of debate, the House made no significant changes to the bill. On Tuesday, Republicans jammed through an amendment by Jeff Denham , R- Calif. , toughening a provision to block a controversial California high-speed rail projects. On Monday, Rep. Ted Poe , R- Texas , who represents a Houston district, backed off an attempt to strip out language by a crosstown rival, Rep. John Culberson, R- Texas, that effectively blocks construction of a light rail line on the city's west side.

A familiar bipartisan coalition emerged to protect money-losing Amtrak routes from a move by Rep. Pete Sessions, R- Texas, to cut off funding for several long-haul routes where operating costs are more than double revenues.

All the evidence is there that loan demand is poised to strengthen gradually. But banks and their investors are hungry for far more.

Six years after the meltdown, what they crave are blow-out, record-setting periods of loan growth, preferably at double-digit percentage rates.

That was clear at Morgan Stanley's Financials Conference in New York on Tuesday, when Betsy Graseck, one of the firm's banking analysts, asked the audience members what would cause them to increase their holdings of Wells Fargo (WFC). The winner of her multiple-choice question? Accelerated loan growth, which beat out such shareholder-friendly responses as increased dividends or stock buybacks.

Later, Graseck asked the crowd of investors what would drive Regions Financial's (RF) stock price this year. Same answer: loan growth.

"We have a theme from the conference," Graseck exclaimed. "Everyone wants loan growth!"

Whether that kind of growth is going to happen soon is anyone's guess. But banks seem desperate to deliver. Richard Davis, the chairman and chief executive at U.S. Bancorp (USB) in Minneapolis, said strong commercial demand could be the start of an turnaround that will result in loan growth of 9% to 10% a year, up from the company's current average of roughly 6%.

"That's what we had before. That won't be that hard," Davis said. Commercial and industrial borrowers are a "bellwether for informed opinion" on the economy, and they have been investing in their own businesses, he said.

Annual growth of 9% to 10% "isn't unreasonable when the world is back to some form of normalcy," Davis said, though he was unspecific about when he thought that would be.

Davis' optimism has some merit. The \$371 billion-asset company reported 1.3% loan growth in the first quarter, compared with the previous quarter, and 6% growth year over year. Wholesale banking and commercial real estate loans led the charge.

Banks from both coasts have also reported upward movement this year, from the \$23 billionasset Signature Bank (SBNY) in New York, to the \$29 billion-asset City National (CYN) in Los Angeles.

More broadly, the Federal Reserve's latest Beige Book economic survey said lending activity rose across the country, with two-thirds of Fed districts reporting rising demand. In a promising sign for community banks, construction-and-development loans, which had declined every quarter since the middle of 2008 before last year, have now grown each of the past four quarters, according to the Federal Deposit Insurance Corp.'s latest Quarterly Banking Profile.

Yet some are not convinced that the good times are here to stay. Less than a quarter of respondents in an informal American Banker poll believe the loan growth in the first quarter will have legs. Nearly 80% of the poll's responses said the momentum won't continue, or they're uncertain if it will.

Some bankers at the Morgan Stanley conference were more cautious than U.S. Bancorp's Davis; they suggested the loan growth will continue, albeit at a somewhat sluggish pace. The persistence of low interest rates continues to put a brake on overall growth.

"It's a tough time for us, because our model still does best in a high-interest-rate environment," said Christopher Carey, the chief financial officer at City National. "I don't know what normal will be anymore, but I think it will be a great story as rates move up."

Karen Parkhill, the CFO at Comerica (CMA) in Dallas, said that, with roughly 85% of the bank's book made up of floating-rate loans, a rise could help the bank hit its target of a 60% efficiency ratio, down from 67.38%.

"We're moving the ratio in the right direction by controlling what can be controlled," she said, but an "increase in rates will be necessary to help us ultimately achieve our goal."

A rise in rates would make deposits more valuable as a source of funding but also more expensive. Parkhill touted Comerica's strong deposit growth in Texas, where deposits have grown 31%, to \$10.2 billion, since 2011, but predicts that would be hard to sustain as rates rise.

Banks keep preparing for the turnaround, despite some of the nagging doubts.

The need for deposits to fund future loan growth has made U.S. Bancorp reluctant to shutter branches. The company this year agreed to buy RBS Citizens' Chicago branches and may do more branch acquisitions, Davis said.

"That core money may not be very valuable today or even the last five years, [but] to take a long view, it may well be the most important thing you'll ever have when rates move up," Davis said.

Regions has projected loan growth this year of between 3% and 5%. But the \$118 billion-asset Birmingham, Ala., company believes reluctance by small businesses to borrow is holding back those figures from getting any stronger.

"Where we really want to see more demand is the small-business, lower end of the middle market, which is just not demanding credit like we would like," said David Turner, chief financial officer

"If we can get that group to start demanding credit, using all our products and services, we've got a very different answer for you, in terms of 3 to 5%," Turner said.

The SBA's Plan to Boost Loans to Minority Entrepreneurs

The Small Business Administration has a size problem. To help Main Street businesses recover from the Great Recession, the agency increased the size of the loans it was willing to guarantee. That helped boost the dollar amount of loans it backstopped last year by 40 percent from 2009 levels, to \$29.6 billion.

The big boost to loan volume wasn't matched by a similar increase in the number of SBA-backed loans. As a result, the size of the average SBA loan

increased, to \$547,000 last year from \$372,000 in 2009.

That shift is good for lenders because it takes a comparable amount of time and effort to underwrite a loan for \$1 million and a loan for \$100,000; larger loans generate more revenue from interest. It's bad for the smallest U.S. businesses, including those owned by minority entrepreneurs who already face an uphill battle getting credit.

To help those business owners, the SBA is trying to promote smaller loans. In October, it waived a 2 percent fee for loans of less than \$150,000—a move the agency says has already led to a 15 per-

cent increase in small loans. And today, SBA chief Maria Contreras-Sweet said the agency would speed up approvals for loans of \$350,000 or less, relying more heavily on credit-scoring processes that the agency has been developing for more than a decade.

"We're making these changes, knowing it will simplify and streamline the lending process and get more small loans into the hands of entrepreneurs, especially the underserved," Contreras-Sweet said today in a speech hosted by the Center for American Progress, a Washington think tank. That should help minority-owned businesses in particular, she said, because 80 percent of SBA

loan applications from black and Hispanic business owners are for \$150,000 or less.

Speeding up the approval process for small loans may also prevent more business owners of any race from taking on expensive debt from merchant cash-advance providers and other nonbank lenders. Those loans, often marketed as being approved quickly, can carry annualized interest rates in excess of 100 percent, many times more than the single-digit interest rates typical of loans backed by the SBA.

U.S. Mid-Size Companies are Turning to International Markets for Financial Success

Wells Fargo launches International Business Indicator Survey

The global marketplace is no longer the exclusive domain of large corporations as mid-sized U.S. companies focus on doing business internationally in order to be financially successful. According to a new survey released today from Wells Fargo's International Group, part of Wells Fargo & Company (NYSE: WFC), among 250 U.S. companies with \$50 million or more in annual revenue, 69 percent of mid-sized companies plan to increase international business over the next year – and more than half expect an increase in revenue and profits from their international activity. The Wells Fargo International Business Indicator (PDF)* was launched to track the outlook and activity of companies that conduct at least some international business.

"U.S. companies are bullish on international business (PDF)*," said Sanjiv Sanghvi, head of Wells Fargo's Global Banking Group. "They view international markets as growth opportunities for their products, services and supply chains. The results of our inaugural International Business Indicator provide insights into the 'why, how and where' of the international strategies for these U.S. companies."

The Why

"It's going to become increasingly important for companies to have operations overseas. There are tremendous growth opportunities overseas and we're seeing that the margins are a lot higher there as well." - Food Production, Vice President

In the face of a tough competitive environment and current economic conditions, companies are looking outside the U.S. to grow their businesses. Seventy nine percent of companies said a competitive marketplace is driving their international plans, with 77 percent citing global economic conditions, and 73 percent saying labor costs. While companies continue to expand their international activity, companies said they are concerned that political stability and regulations - both at home and abroad – may negatively impact their international business.

The How

"Our international customers are growing internationally and taking us with them." - Lodging/Personal Services/ Business Services, Managing Director

When developing their international strategy, companies can turn to a number of different sources for information. The most valued source, by a wide margin, is feedback from customers and suppliers, which was cited by 55 percent of companies. Fewer than half as many look to government agencies (20 percent) or industry and trade resources (17 percent) to help with decisions about international business.

The Where

"We're looking to expand into South America, certainly into Brazil. It's a huge market, especially with the World Cup and the Olympic Games coming there over the next couple of years. That's really been a goal of ours for 2014." – Manufacturing, C-Suite

Companies looking to expand internationally say they are more focused on U.S. neighbors, with Latin America and Canada leading the list of regions where they plan to increase business activity. Fifty-six percent of companies plan to increase activity in Latin America (including Mexico) followed by 49 percent in Canada and 48 percent in Asia Pacific (excluding China). U.S. businesses are also planning to increase activity in China (41 percent) and Western Europe (35 percent) while they are currently less focused on Middle East and Africa (28 percent) and Central and Eastern Europe (23 percent).

"We want to better understand the global business climate as well as the challenges and opportuni-ties facing decision makers at these mid-market and large corporate companies," said Sanghvi. "We believe the indicator studies will be valuable tools for tracking and analyzing the sentiments, intentions and strategies of U.S. companies so that we can best help them succeed in today's global marketplace."

In the short run, bankers made it clear they will stick to their recent formula of taking steps to cover their revenue gaps while preparing for their visions of a rosier future. That formula has included cutting costs, rolling out niche, fee-based products and buying branches to load up on deposits.

KeyCorp (KEY), in Cleveland, plans to close 18 branches in the second quarter and reduce its overall real estate by 17% by 2017, said Don Kimble, chief financial officer.

Others discussed expansion plans.

Huntington Bancshares (HBAN), in Columbus, Ohio, may look to securitize some of its auto loans as early as 2014, said Mac McCullough, chief financial officer.

Huntington bought branches recently in Michigan to serve as a complement to some areas where it only had an in-store branch at a grocery store, McCullough said. Further, Huntington still sees some value in branches, he said.

"We still think that branch banking is a good business in terms of customer acquisition and being able to offer advice and the types of products that the customers like to ... get advice on in person." he said.

Davis seeks to boost U.S. Bancorp's corporate trusts and payments businesses, which he also wants to expand in the European and Latin American markets. He expects payments to eventually account for 35% of the company's total revenue, from 28% currently.

Executives are also dealing with regulatory products that sometimes complicate attempts at innovation.

Regions plans to develop new products to replace the deposit-advance loan product that it was forced to discontinue, Turner said. Regions ended its deposit-advance loans on regulators' crackdown on products that resemble payday loans.



The new policy, which takes effect next month, will pare by as much as 50 percent the time it takes to originate an SBA loan by eliminating the need for certain financial analyses, according to the Wall Street Journal.

There's a flip side to easing the approval process. Earlier this year, the SBA drew fire from Senator Jeff Sessions, an Alabama Republican who worried that government guarantees and lax oversight were leading banks to make bad lending decisions. "The lender still makes a profit while taxpayers shoulder the cost of the default," wrote Sessions in an April letter to Contreras-Sweet. Along those lines, simplifying the approval process for small loans sounds like a good thing for small business owners—unless it encourages banks to make loans that business owners can't afford.
