History of Juneteenth

Juneteenth is the oldest known celebration commemorating the ending of slavery in the United States. Dating back to 1865, it was on June 19th that the Union soldiers, led by Major General Gordon Granger, landed at Galveston, Texas with news that the war had ended and that the enslaved were now free. Note that this was two and a half years after President Lincoln's Emancipation Proclamation - which had become official January 1, 1863. The Emancipation Proclamation had little impact on the Texans due to the minimal number of Union troops to enforce the new Executive Order. However, with the surrender of General Lee in April of 1865, and the arrival of General Granger's regiment, the forces were finally strong enough to influence and overcome the resistance.

Later attempts to explain this two and a half year delay in the receipt of this important news have yielded several versions that have been handed down through the years. Often told is the story of a messenger who was murdered on his way to Texas with the news of freedom. Another, is that the news was deliberately withheld by the enslavers to maintain the labor force on the plantations. And still another, is that federal troops actually waited for the slave owners to reap the benefits of one last cotton harvest before going to Texas to enforce the Emancipation Proclamation. All of which, or neither of these version could be true. Certainly, for some, President Lincoln's authority over the rebellious states was in question For whatever the reasons,

Oakland Groups Launch "No Uber Oakland" Campaign

Faced with unprecedented threats to Oakland's diversity and affordability, The Greenlining Institute joined other Oakland advocates to launch No Uber Oakland. The campaign seeks to roll out the unwelcome mat for Uber, which has acquired the former Sears building on Broadway, until and unless the controversial company agrees to work with the community to preserve and enhance Oakland as a diverse, vibrant community for people of all income levels.

"It would be bad enough if Uber was just a horrible company with a record of ignoring laws, condoning sexual harassment, cheating drivers and cozying up to Donald Trump," said Greenlining Institute President Orson Aguilar. "But Uber also represents a growing wave of tech-driven gentrification that's already drowning San Francisco and threatens to do the same here. The Oakland community has come together to say, 'No. We're not willing to let Oakland become a city that only people with six-figure incomes can afford.'"

Already endorsed by eight community and advocacy organizations, No Uber Oakland has put forth a 10 point platform designed to mitigate a wide variety of the company's expected impacts. Issues covered include Oakland's af-



fordability crisis for residents, nonprofits and artists, jobs and training for local workers; contracts for small and minority-owned businesses, treatment of drivers, working with and not undermining the East Bay's mass transit network, and creation of a community advisory board to ensure that the voices of Oakland residents guide the development of specific plans.

"Uber's plans for the building it calls Uptown Station look a lot like Gentrification Station to us," Aguilar said. "We need Uber to set a responsible precedent for other wealthy corporations coming into Oakland, and we need our city government to stand with Oaklanders to hold these companies accountable."

Please continue to show your support for increasing diversity in insurer supplier procurement and governing boards by sending a support letter for SB 488 by Tuesday, June 13th, 2017!

As you may be aware, Insurance Commissioner Dave Jones and Equality California are sponsoring a critical diversity bill introduced by Senator Steven Bradford: Senate Bill 488. As state and federal law requires Californians to purchase many types of insurance, such as automobile, health, and workers' compensation insurance, insurers collect \$288 billion a year in premiums in California, but have only scratched the surface when it comes to procuring goods and services from diverse businesses, or having governing boards that mirror the diversity of California policy holders.

An extension of the original insurance supplier diversity bill AB 53, Senate Bill 488 does three main things:

- Extends the insurance supplier diversity survey to 2025, as current statute ends the survey soon
- Expands the diverse supplier categories to include LGBT and veteran-owned businesses
- Codifies the governing board diversity survey

Fact Sheet: SB 488 - Insurance: Diversity.



SUMMARY

Senate Bill 488 (Bradford) would codify the successful supplier diversity and governing board diversity initiatives of the California Department of Insurance. Only part of this program is in current statute. SB 488 adds LGBT-owned and veteran-owned businesses, a governing board diversity survey, and extend the sunset through 2025.

BACKGROUND

State and Federal law requires Californians to purchase many types of insurance, such as automobile, health, and workers' compensation insurance.

But, the more than 200 insurance companies that collect \$100 million or more each year from Californians have only scratched the surface when it comes to procuring goods and services from diverse businesses, or having governing boards that mirror the diversity of California.

The Insurance Diversity Initiative (IDI) has three major components:

- Surveys of insurance company supplier diversity and governing board diversity;
- A first in the nation Annual Diversity Summit which facilitates business matchmaking to increase contracts for California's diverse businesses with the nation's leading insurers and awards insurance industry leaders and stakeholders for achievements in diversity; and

- An Insurance Diversity Task Force comprised of industry leaders.

In 2011, Insurance Commissioner Jones asked insurance companies to participate in a voluntary survey regarding supplier diversity and governing board diversity, but only 29% of companies responded.

In 2012, Assembly Bill 53 (Solorio) was enacted to codify the insurer supplier diversity survey so that future Commissioners would implement it as well. It required each insurance company that collects more than \$100 million annually in premium from Californians to report on the company's supplier diversity efforts in odd-numbered years. Specifically, California Insurance Code Section 927 requires insurance companies and groups to report on procurement efforts (the extent to which insurance companies are buying goods and services) from minority-, women-, and disabled veteran-owned businesses.

Insurance Commissioner Dave Jones continued to implement the supplier diversity and governing board diversity surveys, and in 2016 California partnered with other states (District of Columbia, Minnesota, New York, Oregon, and Washington) to launch a national insurance supplier and governing board diversity survey called the Multistate Insurance Diversity Survey (MIDS).

The initiative focuses on transparency, as "what gets measured, gets done."

SOLUTION

SB 488 Continues the successful insurance supplier diversity and governing board diversity efforts through 2025 and expands the statute to include LGBT and veterans and businesses and codifies the government broad diversity survey.

12 Tips on Raising Venture Capital for Your Startup

1.) You Have to Decide: High Impact or Small Business Entrepreneur?

Yes -- you call yourself an entrepreneur. But hold the phone -- because unless you have a pretty clear idea going in what your aspirations are; you could find yourself flailing around like a ship without a rudder.

As Jones explains it; "You have to know going in what you really want; because you can't have it both ways. If you go into high impact venture-backed entrepreneurship; you're trying to build a business that's going to scale and make people wealthy. And you're not going to be your own boss for long. Whereas a small business entrepreneur wants salary security and to be their own boss. So you really need to ask yourself which world you're trying to be in. Are you trying to be a business owner who's well respected in the community; has a nice income and runs his own shop or are you trying to create the next Microsoft or Twitter? You have to choose because these are two very different rides."

2.) You May Have to Move

Did you pick the high impact entrepreneur road? Awesome. But brace yourself -- because unless you already live in Silicon Valley; you may have to move.

Jones puts it frankly; "No one ever said life is fair and I've written and told people that if raising money at the best valuation fast is your sole objective in life -- you probably need to move to Silicon Valley."

3.) Get On The Team -- Even if You Sit the Bench For Awhile

Never been an entrepreneur before and have zero experience? Have no fear. You can still get in the high impact entrepreneur game.

As Jones explains; "Put yourself in an environment where you can get exposure to good deals and successful entrepreneurs. There's an incredible training ground out there. Go to conferences with pitches by entrepreneurs. Find a place to work where the company works with high impact entrepreneurs. You have to be willing to go and do it and realize you're not going to get a

big paycheck -- but at least you're in the game."

4.) Focus on Your Own Team

Now that you're on the path to superstardom; are you interested in the most important thing for you to work on? According to Jones -- it's your team.

"Money follows people. The majority of VCs I've worked with over the years would say the most important thing is the team. Also, in my experience, the proximate cause of most startup failures is because the team is not up to the next task. It's usually at those various pivot points where a team proves dysfunctional under stress and implodes because of it. So your team is of paramount importance."

5.) Get a Mentor -- But Choose Wisely

One of the smartest players you can find for your team as an entrepreneur is a mentor, coach or counselor.

Jones told me this; "Get counsel and be very careful about who it is. Not to confuse the fact that someone who can run a billion dollar cor-

poration does not necessarily mean they're a good adviser for your startup. So really find people who have experience and wisdom in the trenches of the kind of thing you're trying to do. The CEO of some Fortune 500 company is not a great person to be an adviser. They might be a great person to leverage for money -- but they're probably not going to have a lot to tell you about the realities of building your high tech business on a shoestring."

6.) Treat It Like A Game

Too many entrepreneurs aren't having any fun with their businesses. I see it all the time. But Jones has some good wisdom for you:

"I used to say when I was an entrepreneur that what I'm doing is a game. I want to win and I play really hard. You follow the rules but at the end of the day, going to work is like going to play golf. Pure fun. And as I say, if you want to be the best golfer in the world, one thing you can say about Tiger Woods is he hits an incredible number of practice shots. If you want to be the best pianist in the world, you're going to practice a lot."

7.) Failure is Acceptable

Think you're going to hit grand slams every time at bat? Think again.

According to Jones; "One of the great things about being an entrepreneur -- and I used to say this about even being a venture investor too: You're supposed to strike out a bunch. You have to be one of those people who realize that if you're going to hit 714 home runs, you're prob-

ably going to strike out over 1,300 times like Babe Ruth did."

8.) Learn the Lingo and Know What's Going On

You have the team put together and are ready to play the game -- but you don't know the rules. Not good. According to Jones, not understanding the terminology and what's going on in the world of venture capital is a real deal killer.

"Take some time with the lingo and figure out what's going on. How do venture deals work?

What is the real valuation? I mean most of the entrepreneurs I run into these days, they just don't know what the valuations are in the market and when they do, they will compare themselves to an entrepreneur in Silicon Valley. But by the way -- that person has made a half billion dollars for themselves and his investors. What have you done? So I think a lot of it is just learn the lingo. Know what convertible preferred stock is. Know that you don't go to a venture investor and give him some high valuation number. You're a

startup with no prior experience in the venture world. That's just a reality."

9.) No Cold Calling Investors

Pouring in from all points across the globe to angels, VCs and investors are unsolicited requests for funding. Business plans not even opened and sitting at the bottom of the trash can. Don't let yours be one of them. Jones put it this way when I asked him one of the major things not to do

History of Juneteenth

conditions in Texas remained status quo well beyond what was statutory.

General Order Number 3

One of General Granger's first orders of business was to read to the people of Texas, General Order Number 3 which began most significantly with:

"The people of Texas are informed that in accordance with a Proclamation from the Executive of the United States, all slaves are free. This involves an absolute equality of rights and rights of property between former masters and slaves, and the connection heretofore existing between them becomes that between employer and free laborer."

The reactions to this profound news ranged from pure shock to immediate jubilation. While many lingered to learn of this new employer to employee relationship, many left before these offers were completely off the lips of their former 'masters' - attesting to the varying conditions on the plantations and the realization of freedom. Even with nowhere to go, many felt that leaving the plantation would be their first grasp of freedom. North was a logical destination and for many it represented true freedom, while the desire to reach family members in neighboring states drove the some into Louisiana, Arkansas and Oklahoma. Settling into these new areas as free men and women brought on new realities and the challenges of establishing a heretofore non-existent status for black people in America. Recounting the memories of that great day in June of 1865 and its festivities would serve as motivation as well as a release from the growing pressures encountered in their new territory. The celebration of June 19th was coined "Juneteenth" and grew with more participation from descendants. The Juneteenth celebration was a time for reassuring each other, for praying and for gathering remaining family members. Juneteenth continued to be highly revered in Texas decades later, with many former slaves and descendants making an annual pilgrimage back to Galveston on this date.

Juneteenth Festivities and Food

A range of activities were provided to entertain the masses, many of which continue in tradition today. Rodeos, fishing, barbecuing and baseball are just a few of the typical Juneteenth activities you may witness today. Juneteenth almost always focused on education and self improvement. Thus, often guest speakers are brought in and the elders are called upon to recount the events of the past. Prayer services were also a major part of these celebrations.

Certain foods became popular and subsequently synonymous with Juneteenth celebrations such as strawberry soda-pop. More traditional and just as popular was the barbecuing, through which Juneteenth participants could share in the spirit and aromas that their ancestors - the newly emancipated African Americans, would have experienced during their ceremonies. Hence, the barbecue pit is often established as the center of attention at Juneteenth celebrations.

Food was abundant because everyone prepared a special dish. Meats such as lamb, pork and beef which not available everyday were brought on this special occasion. A true Juneteenth celebra-

tions left visitors well satisfied and with enough conversation to last until the next.

Dress was also an important element in early Juneteenth customs and is often still taken seriously, particularly by the direct descendants who can make the connection to this tradition's roots. During slavery there were laws on the books in many areas that prohibited or limited the dressing of the enslaved. During the initial days of the emancipation celebrations, there are accounts of former slaves tossing their ragged garments into the creeks and rivers to adorn clothing taken from the plantations belonging to their former 'masters'.

Juneteenth and Society

In the early years, little interest existed outside the African American community in participation in the celebrations. In some cases, there was outwardly exhibited resistance by barring the use of public property for the festivities. Most of the festivities found themselves out in rural areas around rivers and creeks that could provide for additional activities such as fishing, horseback riding and barbecues. Often the church grounds was the site for such activities. Eventually, as African Americans became land owners, land was donated and dedicated for these festivities. One of the earliest documented land purchases in the name of Juneteenth was organized by Rev. Jack Yates. This fund-raising effort yielded \$1000 and the purchase of Emancipation Park in Houston, Texas. In Mexia, the local Juneteenth organization purchased Booker T. Washington Park, which had become the Juneteenth celebration site in 1898. There are accounts of Juneteenth activities being interrupted and halted by white landowners demanding that their laborers return to work. However, it seems most allowed their workers the day off and some even made donations of food and money. For decades these annual celebrations flourished, growing continuously with each passing year. In Booker T. Washington Park, as many as 20,000 African Americans once flowed through during the course of a week, making the celebration one of the state's largest.

Juneteenth Celebrations Decline

Economic and cultural forces provided for a decline in Juneteenth activities and participants beginning in the early 1900's. Classroom and textbook education in lieu of traditional home and family-taught practices stifled the interest of the youth due to less emphasis and detail on the activities of former slaves. Classroom text books proclaimed Lincoln's Emancipation Proclamation of January 1, 1863 as the date signaling the ending of slavery - and little or nothing on the impact of General Granger's arrival on June 19th.

The Depression forced many people off the farms and into the cities to find work. In these urban environments, employers were less eager to grant leaves to celebrate this date. Thus, unless June 19th fell on a weekend or holiday, there were very few participants available. July 4th was the already established Independence holiday and a rise in patriotism steered more toward this celebration.
