Advocacy Brings Small Business Issues Back to Washington, D.C.

Chief Counsel for Advocacy The Office of Advocacy continues exercising its unique role within government to give voice to small business issues and con-

cerns. The past few months have seen Advocacy engage with widely diverse small business groups. From meeting with the Plumbing

diverse small business groups. From meeting with the Plumbing, Heating, and Cooling Contractors Association in Washington, D.C., to universities and high tech startups in Michigan and Ohio, America's entrepreneurs and innovators continue to seek ways to work with government in growing our economy.

Advocacy is fortunate to have a talented crew of professionals who are in tune with the small business community. Small businesses are also encouraged that the Obama Administration has issued a number of executive orders (E.O 13563, 13579, 13609, and 13610) that direct agencies to consider business size at all stages of the regulatory process. These actions are important for entrepreneurs and small business owners because they free them to focus on what they do best, which is to innovate and create jobs.

Small businesses want government to be effective. Political gridlock only leads to uncertainty. Public/private partnerships have shown that they can work. In Michigan, I met with small business owners who shared with me how pleased they are that the automobile industry is growing again. Manufacturing jobs are coming back! For our economy to grow and add jobs, we will need to build things domestically and access international markets. Entrepreneurs and small business are ready to go.

Many business owners, however, need access to capital to expand their operations and to add additional staff. This sentiment was expressed in a meeting I had at Automation Alley, Michigan's largest technology association. The lack of accessible capital for startups and small businesses remains a challenge. We know that it takes money to make money. Advocacy's annual small business lending study lists by state the banks that are lending to small businesses. This information has been invaluable to those who may not know where to turn after a financial institution has turned them down. An update of our lending study is due this summer.

In Cleveland, my visit to the Council of Smaller Enterprises (COSE) and a local incubator that focused on innovative manufacturing added to an informative trip. The Manufacturing Advocacy and Growth Network (MAGNET), funded by the Department of Commerce's National Institute of Standards and Technology (NIST) provides business consulting and engineering services for advanced manufacturing companies. As an engineer myself, I was pleased to see the array of startup companies using resins, polymers, and ferrous and nonferrous materials to make products that reduce energy use and make manufacturing processes leaner. The MAGNET incubator, located adjacent to Cleveland State University, is helping to make Ohio's manufacturing sector more globally competitive.

There are a number of positive developments taking place in Michigan and Ohio. Small businesses are again looking to drive the local economy. The public/private relationship is crucial for small businesses to innovate and grow. The small business sector, our engine of economic growth, will need to have a workforce that is globally competitive. Making sure that we train U.S. workers for these jobs—as well as making sure the United States remains a beacon for the best and the brightest from around the world—should be priorities in this public/ private partnership. Advocacy is encouraged that the U.S. Citizen and Immigration Services is looking at ways to streamline visa processes for individuals, students, and entrepreneurs in technical fields.

Advocacy continues to bring the small business viewpoint to discussions of these issues at the highest levels of government. Significant strides at reducing barriers— supporting entrepreneurs and small businesses—continue. It is good to know that small business is being heard. **Continued on page 4**

CDFI Fund Seeks Additional Public Comment on Reporting Requirements for the Capital Magnet Fund

The U.S. Department of the Treasury, as part of its continuing effort to reduce paperwork and respondent burden, invites the general public and other Federal agencies to take this opportunity to comment on proposed and/or continuing information collections, as required by the Paperwork Reduction Act of 1995, Pub. L. No. 104-13 (44 U.S.C. 3506(c)(2)(A)). Currently, the Community Development Financial Institutions Fund (CDFI Fund), an office within the Department of the Treasury, is soliciting comments concerning the reporting and record retention requirements for the Capital Magnet Fund. The request for comment was published in the Federal Register on June 8, 2012.

This request for comment on reporting and record retention for the Capital Magnet Fund builds from the first request dated September 17, 2010. The CDFI Fund is reissuing the reporting and record retention request to fulfill changed administrative needs. The revised Capital Magnet Fund Awardee Data Collection Memo has been updated based on comments provided from the September 17, 2010 request as well as program policy decisions that have been made since the implementation of the Capital Magnet Fund program.

The Capital Magnet Fund will use an annual report to collect data points from Capital Magnet Fund Awardees. This







Obama Administration Launches \$26 Million Multi-Agency Competition to Strengthen Advanced Manufacturing Clusters Across the Nation

Fourteen Federal Agencies Collaborate to Enhance Global Competitiveness of U.S. Manufacturers and Create Jobs

The Obama Administration today announced a \$26 million multi-agency Advanced Manufacturing Jobs and Innovation Accelerator Challenge to foster innovation-fueled job creation through public-private partnerships. These coordinated investments will help catalyze and leverage private capital, build an entrepreneurial ecosystem, and promote cluster-based development in regions across the United States. This is the third round of the Jobs Accelerator competition, which is being funded by the U.S. Department of Commerce's Economic Development Administration (EDA) and National Institute of Standards and Technology (NIST); the U.S. Department of Energy; the U.S. Department of Labor's Employment and Training Administration; the Small Business Administration; and the National Science Foundation (NSF).

"This \$26 million Accelerator Challenge is yet another example of the Obama Administration's commitment to supporting American manufacturers in building things here and selling them everywhere," said U.S. Commerce Secretary John Bryson. "We are so pleased to join with our federal agency partners to further strengthen the American manufacturing sector, which creates high quality, good paying jobs. "The Accelerator Challenge is one way the federal government is helping to support the manufacturing industry, a vital source of middle-class jobs," said Secretary of Labor Hilda L. Solis. "The innovative products developed as a result of this federal grant program will help our economy maintain its global competitive advantage, while also creating jobs at home."

Manufacturing accounts for 70 percent of private-sector R&D and 60 percent of U.S. exports-including a record \$1.2 trillion in goods exported in 2011. Over the past 25 months,

manufacturers have created nearly half a million jobs-the best streak since 1995. The Jobs Accelerator Challenge is designed to assist the development and implementation of regionally-driven economic development strategies that will support advanced manufacturing and cluster development. The goal is to create jobs, grow the economy, and enhance the competitiveness of U.S. manufacturers in the global marketplace.

"Made in America' is making a comeback," said SBA Administrator Karen Mills. "The Advanced Manufacturing Jobs Accelerator is an opportunity to build on the momentum we're seeing in U.S. manufacturing and to support small businesses and local economies through regional innovation clusters. 

What to do when your credit card company increases your APR?

When your credit card company increases the APR on your credit card without you changing your habits, or missing a payment – this is known as rate jacking. Even though this practice has become much more prevalent, there is something you can do about it.

Step 1 – Change your credit card provider!

This might seem overly simple, but the ditch and switch option is often the very best for anybody carrying a balance on their cards. There are a plethora of balance transfer deals available at 0% APR, with nominal or no fees for the transfer itself.

The issue here is your credit scoring and history; these deals are often only available to those with the strongest credit histories.

Step 2 – Did you miss a payment and lose the promotional rate?

If you missed a payment whilst on a 0% deal, often the credit card companies will move you immediately to their standard rate, which is not likely to be competitive.

Call your provider and explain to them that this is a one off, and you want to remain one of their customers and politely request that the promotional rate is extended.

If you have no luck, move to step 3

Step 3 – Force your credit card provider to stop the increase

The first thing to do is to call your provider and ask them if they are willing to offer the debt at the existing rate when no additional debt is added. They should say yes – if they refuse run through the following checklist:

• Was your increase within the first 12 months of owning the card?

Has there been a rise within the last 6 months

- Was the increase in APR explained to you?
- Are you in financial hardship?
- Have you been given 30 days notice?
- Have you been given the option of repaying the debt in full at the existing rate within a reasonable time period?

If the answer is no to any of these questions, write to your provider, indicating your belief that they have acted improperly under the codes of practice set down by the UK Cards Association and you would like your case to be reviewed.

Step 4 - Go to the Ombudsman

If the card company does not agree to review your case, and you still believe you have been treated unfairly, you should contact the Ombudsman.

Whenever the Ombudsman is involved the likelihood is that the company will settle directly, as it doesn't want to risk setting a precedent for future cases on the basis of the points raised in your complaint. The less information about a particular complaint that is made public the happier the companies will be.


Step 5 – Seek Help

If you are struggling to repay your debts you should seek dent counselling immediately. Look out for the not-for-profit agencies as these are more likely to act on your behalf with no hidden motives or agendas.
