The Federal Government Lost 40,000 More Employees Than It Gained Last Year



Federal agencies hired nearly half the number of employees in fiscal 2013 as they did four years prior, and the gap between employees leaving and joining federal service continued to grow.

The federal government hired about 77,000 new employees in fiscal 2013, according to a Partnership for Public Service analysis of Office of Personnel Management data, a 14 percent drop off from the previous year. The number of separating employees, meanwhile, remained steady over the last two years at more than 115,000 annually. New hires represented 4.2 percent of the federal workforce last year.

An overwhelming majority of employees hired last year -- four out of every five -- were from defense and security-related agencies, PPS found. One-third of all new hires came from the Veterans Affairs Department, while 36 percent came from Defense Department agencies. Here is a full breakdown of hires by agency:

Agencies saw a dramatic uptick in STEMM (scientific, technology, engineering, mathematics and medical) jobs and veterans hiring. About 39 percent of new hires went to STEMM positions, while 45 percent were veterans. Both figures were up 10 percent over the last five years.

Uncle Sam is hiring fewer young people, however. Just 24 percent of new hires were less than 30 years old, down from 2005 through 2009, when employees younger than 30 made up more than 30 percent of new hires.

"The federal government needs to develop a strategy to recruit and retain a greater percentage of younger workers to build a pipeline for the future," PPS wrote in its report.

Instead, with the exception of a Coast Guard building that opened last year, the grounds remain entirely undeveloped, with the occasional deer grazing amid the vacant Gothic Revival-style structures. The budget has ballooned to \$4.5 billion, with completion pushed back to 2026.

Lack of funding is a key reason for the perpetual stall in the project. A spokesperson for the General Services Administration told the Post, "GSA and DHS haven't received the appropriations that this project needs to keep it on its original schedule. Construction is a commodity market, and costs increase with delays."

In addition to financial woes, there is also the history of St. Elizabeths, the psychiatric hospital grounds on which the renovations are planned. Consider:

Almost from the beginning, assassins and would-be assassins were confined at St. Elizabeths. The man who tried to shoot President Andrew Jackson, the man who did shoot President Theodore Roosevelt and, of course, the man who grievously wounded President Ronald Reagan all ended up there.

Could some sort of ancient evil buried directly below the site, coursing through the earth's crust, be affecting construction?
