How Public Pensions Are Getting Smart About Infrastructure

While American politicians talk about changing public policy to increase investment in U.S. infrastructure, America's public pension funds are investing their money in infrastructure overseas.

The largest U.S. public pension fund, the California Public Employees' Retirement System (CalPERS), recently announced a \$1 billion deal with Queensland Investment Corp. (QIC), an Australian pension fund, to invest in Australian and Asian Pacific infrastructure.

At first glance, this would seem to be bad news, especially when you consider that 11 other U.S. public pension funds have deployed an additional \$5 billion to overseas infrastructure investments over the past five years while collectively investing less than \$800 million in domestic infrastructure.

It is bad news that other countries have figured out how to make infrastructure investing attractive to pension funds while, clearly, the United States has not. But looking closer, CalPERS may be leading a new way to finance American infrastructure while earning a rate of return consistent with other competing investments.

What's remarkable about the CalPERS deal is that instead of hiring expensive middlemen to make infrastructure investments with its money -- as was done with the previously deployed \$5 billion and is done regularly with the bulk of the \$5.3 trillion of U.S. public pension capital -- CalPERS is acquiring the capacity make such investments on its own. That reflects a trend among cost-conscious pension plans around the world that have eschewed the intermediary approach.

Pension funds in Australia and Canada did so long ago. Today, they are forceful market players instead of captive customers. Once they bypassed the intermediaries to harness the influence of the

large pools of capital they control, they leveraged that power to form pension-owned infrastructure investment platforms such as Australia's Industry Funds Management and Canada's Borealis. These platforms have collectively deployed more than \$50 billion of pension capital into infrastructure investments around the world, and they have realized returns above the 7 percent that U.S. pension funds need to fund future liabilities.

The United Kingdom and Switzerland have now followed their lead. The British government launched policy initiatives in 2011 that led to eight U.K. pension funds pooling their capital for the purpose of making direct in-country infrastructure investments. To date, they have deployed a half-billion dollars of capital. And nine Swiss pension funds came together last May, also for the purpose of making direct investments in local infrastructure. They now are structuring their third such investment.

CalPERS' deal with QIC will enable the California fund to tap into the Australian pension fund's experience in developing internal skill to manage assets as owners. This capacity was best demonstrated last year when QIC made a profit of

Glory Days: A different perspective on neighborhood change in Harlem

A few weeks ago an old-timer whom I'll call Bill struck up a conversation with me on a bench outside a laundromat on 116th street. According to him, the neighborhood is "gone" and will never be the same.

It's the type of comment you hear a lot these days in rapidly changing places like Harlem, Brooklyn, San Francisco, and Oakland.

But Bill wasn't talking about the new lux apartments and throngs of moneyed and increasingly white restaurant-goers on Frederick Douglass Boulevard. For Bill, the glory days ended definitively some 55 years ago.

In an exchange that began with some unsolicited advice on how to correctly hold my baby daughter, Bill revealed that he had spent the formative portion of his 73 years just a block from

where we were sitting. The father of nine children, he had lived around the world as an adult and only recently returned to an apartment building on 116th.

When he was growing up, he said, people used to go out dancing on Friday and Saturday and not come home until Sunday morning. They were so well dressed that you couldn't tell who was coming back from an all-night party, and who was going to church. In those days, people walked on different sides of the street depending on whether they were going uptown or down.

"People aren't the same now," he said. "They don't take care with their appearance." (In keeping with new times, perhaps, Bill himself was wearing a rumpled polo shirt, athletic shorts, and a baseball cap.) He gestured lankily toward the Canaan Baptist Church of Christ across the street. "That used to be a movie theater," he said. "And that one, too." He pointed to the big church on

Senator Roth's Proposal to Protect Small Businesses, Ensure ADA Compliance Approved by Assembly Judiciary Committee

Senator Richard D. Roth's (D-Riverside) proposal to protect California's small businesses and the disabled community was approved by the Assembly Judiciary Committee today on a bipartisan, unanimous vote of 10-0.

"I thank my colleagues for supporting this common-sense, balanced measure to protect the disabled community and small businesses," said Senator Roth. "Senate Bill 251 is a critical step in guaranteeing access for disabled Californians by providing small businesses with the tools and resources necessary to comply with state and federal disability access laws."

Due to a lack of education and resources, many businesses throughout California have found

themselves out of compliance with state and federal disability access laws. This situation has prevented Californians in the disability community from having full and equal access to facilities and

The Legislature has attempted to reform ADA access laws and regulations over the past decade, with the most recent and substantial measure being Senate Bill 1186 (2012) by former Senate President pro Tem Darrell Steinberg (D-Sacramento) and former Senator Robert Dutton (R-Rancho Cucamonga). While SB 1186 created important policies regarding Certified Access Specialists (CASPs) and compliance notification, there remain significant barriers to ensuring small

businesses have the resources and tools necessary to maintain compliance with state and federal disability access laws. As a result, many businesses throughout California have found themselves out of compliance with the law. This situation has prevented Californians in the disability community from having full and equal access to facilities and services.

Supported by the California Chamber of Commerce as a "job creator," SB 251 is a narrowly crafted provision to provide businesses with much needed disability access education, resources and training, and allows small businesses that have been proactive in identifying access issues a reasonable amount of time to fix any problems identified

before a lawsuit arises. SB 251 also provides tax incentives in an attempt to ensure full and fair access for all Californians.

As it passed the Senate, SB 251 allowed small businesses 90 days to proactively correct access violations. In continuing to work with stakeholders in the disability rights and business community, SB 251 now extends the period of time small businesses have to proactively correct access violations from 90 days to 120 days. Further, if a building permit is required, the business could have up to six months to make such corrections.

The Ins and Outs of Alternative Financing

After the recent financial crisis, traditional banks are more reluctant than ever to fund small businesses. Entrepreneurs need not be discouraged though, as a new trend has emerged in the world of finance: "alternative lending." What exactly is alternative lending and is it right for your business? Here are some resources to help demystify the latest options in small business financing.

"Alternative Lending" Defined

You may walk through open doors of your local bank only to hit a brick wall. According to this Alternative Lending e-guide, traditional banks decline up to 80% of small business loan applications

Enter the "alternative lenders," aka non-bank lenders. With faster underwriting and shorter decision processes, alternative funders have grown increasingly popular. They lent approximately \$3 billion in 2013, double the amount from 2012. Applying for online business loans requires less paperwork with a shorter wait period. You can often learn your fate in five minutes and receive funding in 24 to 48 hours. However, interest rates are often higher than those of traditional bank loans.

Sources of online financing include:

- Non-profit lenders
- Invoice financing
- Online business loans
- Loan matching sites or aggregators
- Crowdfunding

Get the Crowd Behind You

Another buzzword has hit the world of financing: "crowdfunding." This is the funding of a business or project by raising money from a large number of people. Individuals can commit as little as \$5 and receive a reward for their donation. Kickstarter and IndieGoGo are popular options, but the list of crowdfunding websites grows every day.

In the SCORE Small Business Success podcast on Crowdfunding, Maryann O'Neil and John Montelione, co-founders of a crowdfunding website called MsGenuity, detail the process. They explain the two types:

- Reward based crowdfunding: A person contributes money and receives a reward in exchange
- Equity based crowdfunding: A person contributes to become an investor of the business

Why is crowdfunding so popular now? The great recession and high unemployment rates inspired the Jobs Act of 2012. The new law encourages small business financing by relaxing securities regulation so entrepreneurs can raise money from the public.

Alternative financing may seem like the perfect answer for a small business owner, but every loan comes with risks. A SCORE mentor can help

weed through your financing options, so you can decide what's best for your small business; get connected today.



Organization

Countywide procurement is structured centralized and decentralized. Countywide contracts are administered by the Purchasing Division, under the General Services Department (GSD); whereas individual departments handle many of their own procurement functions.

Mission

The mission of the Purchasing Division is to maintain the continuity of services and supplies necessary to support the efforts of the various Yolo County Departments.

My first research project in physics was at the Princeton Plasma Physics Lab where I saw math come to life in the form of magnetic field lines in tokamak reactors, which were designed for renewable energy generation. I went on to get a Ph.D. in theoretical physics and do other things in my career. Kiverdi brought me back to my original interest in renewable energy. We have taken our business beyond energy and are now using innovations in biotech to make renewable materials.

What impact do you hope to make with your work?

I want to change the way materials are manufactured by making sustainably produced materials in a way that is profitable for the industry. At Kiverdi, we are commercializing a technology that converts CO2 and carbon waste into oil using microbes. This oil can be used to make renewable materials to replace their petroleum-derived counterparts. We call what we do carbon engineering and our goal is to create a sustainable world for our progeny.

What could improve diversity in the tech industry?

When I was in high school, I wanted to learn the programming language C, but there were no classes that were being offered. So I asked my math teacher to teach me and he did. He actually took his free period, where he'd normally be doing other things and taught me C programming every single day. So for those that didn't ask, that option wasn't available. And still today, there are many schools throughout our nation that don't offer things like programming and other tech courses.



How Public Pensions Are Getting Smart About Infrastructure

several billion dollars on the sale of the Queensland Motorways, a broken-down highway, bridge and tunnel network that the Queensland state government conveyed to QIC in 2011 to satisfy pension liabilities.

And CalPERS isn't the only U.S. public pension fund -- or even the only one in California -- tapping into overseas expertise relating to infrastructure financing. This spring, the California State Teachers Retirement System (CalSTRS) announced an investment partnership with a Dutch pension fund, Stichting Pensioenfonds ABP, that will allow CalSTRS to benefit from ABP's skill in negotiating with government project sponsors. This was evident in the 2012 N33 transportation project, which the Dutch government structured expressly to secure equity and debt financing from ABP and Holland's largest pension fund, PGGM.

It's great news that our two largest public pension funds have begun to take steps to acquire the capacity to invest their own money and to end an impoverishing reliance on intermediaries. What's more, they're doing this by forming partnerships with international peers who know how to make money in infrastructure.

Even the most sophisticated pension-fund investors, however, have not figured out how to make money in U.S. infrastructure, given the competition from low-cost capital through the municipal-bond market. It just doesn't seem to make sense for infrastructure-project sponsors to pay pension funds (or any other institutional investors) more for capital than they pay the muni-bond market, currently about 4 percent.

But while capital at 4 percent appears cheap, borrowing costs are only the starting point in public infrastructure projects. Other costs, such as for operations and maintenance, ought to be considered -- and too frequently aren't --- when taking on projects that might stretch out over 30 years. Governments and taxpayers would get far more value from investors willing and able to finance total lifecycle costs than they do from a simple bond issuance.

As the level of new municipal financings continues to decline, the U.S. will increasingly need investors, such as public pension funds, that can add value beyond what is currently available from the capital markets. Infrastructure project sponsors could realize additional value for taxpayers by raising the kind of patient public pension equity capital that is more interested in long-term dividends than up-front fees for advisory and/or construction services.

By working directly with state and local governments to structure pension-right, public-right infrastructure projects, U.S. public pensions could open the most coveted infrastructure market in the world to the global community of institutional investors. This would result in a win for public pension funds, state and local governments and, most importantly, taxpavers and retirees.

116th and Adam Clayton Powell with expansive posters on its walls promoting the Good News.

Harlem in those days was a big mix of people from the South and the Caribbean, he said. Blocks were sorted according to which state people originated from – there was the Georgia block, the South Carolina block, etc. There were a lot of Caribbean men married to Southern women, whom they liked "because they were so good at keeping homes." (I didn't get to find out more about Bill's background except that, like the vast majority of people who have grown up in Harlem in the last 80 years, he is Black.)

The jazz musicians used to practice in the little park (now A. Philip Randolph Square) on 117th and Adam Clayton Powell. Around the corner next to Minton's Playhouse was a big gray hotel where they all stayed. Across the street, the black doors on the side of historic Graham Court were once the entrance to the Central Park carriage horses' stables.

I wondered whether he had read Manchild in the Promised Land, which seemed to paint a much less rosy picture of Harlem in the 1950s. Was it accurate?

"Yes, I knew Claude!" Bill replied. "But who was even better was... Oh I'm forgetting his name. It'll come to me." He rubbed his temple.

"Did you ever read James Baldwin?" I asked.

"Yes! That's him," Bill said. "Baldwin wrote seven or eight books on Harlem. He really described the life. The writers all mixed with the kids in those days."

Everything changed in 1959, according to Bill, "when the Italians brought drugs in." (I assumed he meant the mafia.) "They were giving them to people. They'd pay musicians in drugs instead of money." Bill quoted Harlem population statistics

as he described how the Caribbean immigrants mostly moved to Brooklyn as the neighborhood deteriorated – and that's why the West Indian Day Parade is now on Eastern Parkway, rather than in Harlem, where it once was. People got forced out of their brownstones – "they used to own those homes!" The redlining, the neglectful landlords, everything conspired against Harlem.

I asked him if he would have said the same thing 15 years ago (before the current wave of gentrification gained energy). He frowned. For him, the glory days ended with the beginning of the 1960s.

Walking home, I looked around at a Harlem that over the last eight years I had come to love: a vibrant place where you could walk out and hear French and Wolof and Bambara and the muezzin's call but also Keith Sweat and Drake thumping from cars, where men crowded outside the barbershops to watch ball games through the windows, where you could stumble on a Somali restaurant, and where other places served high quality food from around the world at prices better than elsewhere in Manhattan. I couldn't accept that it wasn't now also a treasure, if drastically different from the one Bill grew up in. What's more, his nostalgia was for the pre-Civil Rights era – not for that aspect of the era as far as I knew, but for the neighborhood as it existed at a time when racism was far more deeply encoded in law, and more absolutely shaped where and how people lived.

The conversation was a fascinating window into a different time – a period and place that produced many famous artists, writers, and musicians. I appreciated the sweetness of Bill's memories, and the urgency with which he shared them with a complete stranger. But it was also something of a warning: nostalgia, the idolization of past Camelots, can hide from us the good of the contemporary.

Bank Regulators Flunk the Diversity Test

Some of the most important regulatory agencies just fumbled a major chance to start fixing a problem that ails our financial system. Fortunately, the story isn't quite over vet.

The 2008 financial crisis caused widespread hardship. But it particularly devastated communities of color, many of which had been targeted by predatory practices that stripped billions of dollars in wealth from those who could least afford to lose it. For several reasons, regulators and financial industry executives

alike seemed to have little idea of what was happening in these communities, leaving them ill-equipped to anticipate the crisis and reduce its impact. One such reason for these huge blind spots was, and continues to be, the financial industry's lack of diversity. It's a simple fact that people's lived experiences affect what they perceive and understand. When the experiences of people of color aren't represented in the people who serve them, important developments in those communities get missed.

To address this critical problem, members of the Congressional Black Caucus set out in 2010 to enact reforms that would help prevent similar injustices in the future. They succeeded in passing Section 342 of the Dodd-Frank Wall Street Reform and Consumer Protection Act, which created 20 Offices of Minority and Women Inclusion in the nation's most powerful financial regulatory agencies.

OMWIs were given the responsibility of creating standards that would diversify the financial sector's hiring and contracting opportunities. This represents a historic chance to improve connections between financial institutions and our nation's fastest-growing communities, potentially generating trillions of dollars in investment.

Such standards are clearly needed. Research conducted by the Greenlining Institute and the NAACP found that in 2012, some of the top banks did less than 6% of their discretionary contracting with minority-owned businesses, while less than 20% of bank managers were people of color.

This problem can be fixed. For example, look at what happened when California began requiring regulated utilities and telecommunications providers to report their level of contracting with diverse-owned

businesses. The simple act of creating transparency caused a boom in contracting with businesses owned by women, racial and ethnic minorities, and service-disabled veterans. So for the past five years, stake-holders have been advocating for the OMWIs and their agency leaders to seize this opportunity and issue strong workforce and supplier diversity standards for the 70,000-plus companies they regulate.

Recently, the OMWIs in the Office of the Comptroller of the Currency, Federal Reserve Board of Governors, Federal Deposit Insurance Corp., Securities and Exchange Commission, National Credit Union Administration and Consumer Financial Protection Bureau released their final joint standards as required by section 342. But to our shock, the "standards" aren't standards at all. Standards would have helped promote important policy objectives and helped financial companies understand an acceptable level of performance.

Unfortunately, regulators' proposed standards achieve none of these objectives. They set no criteria or expectations for diversity and inclusion and provide no benchmarks against which to measure progress. Instead of standards, the document is a collection of nice suggestions coupled with a choose-your-own-adventure reporting system.

That's no exaggeration. The "standards" encourage banks and other financial institutions to report diversity data, but leaves every important detail for the companies to decide: whether to report, what to report, how to present the data. It's a bit like your college professor letting you decide whether or not to take a final exam, and then write it and grade it yourself. The lack of standards leaves the public and advocates with no way to compare companies, practically inviting them to provide spin instead of substance.

Financial companies need direction and clarity to get things done, as regulators know too well. Unfortunately, they seem to be ignoring the lessons of the past.

Oddly, the agencies seem to have some doubts about their authority to impose clear, measureable reporting requirements. This is doubly puzzling because the key congressional architects of Sec. 342 specifically addressed this point, stating: "We believe it is necessary to achieve both the spirit and plain letter of Section 342 that the final standards include: (1) mandatory diversity assessments and disclosures from all regulated entities; (2) information on both workforce and supplier diversity practices and policies of the regulated entities; and (3) that the diversity data be made available to the public."

So why did the agencies ignore the clear intent of the law's authors? We can only speculate. But it's possible that regulators are worried holding the private sector accountable for its diversity would bring the agencies' own performance into the spotlight. Surprisingly, a 2013 Government Accountability Office study found that that the diversity record of federal financial regulators is even worse than the private sector entities these offices oversee.

For example, in 2012, one federal agency did as little as 3.8% of its total contractor spending with minority-owned businesses, while another had just 9% people of color in management.


