# **Top-100 Defense Contractors 2014**

U.S. Department of Defense Fiscal Year 2014

The following is a list of the Top-100 U.S. Department of Defense (DoD) Prime Contractors in Fiscal Year (FY) 2014 ranked by total contract funds awarded. In FY 2014, the DoD awarded a total of \$286.41 billion in defense contracts down 7.7% from \$310.23 billion in FY 2013. The DoD's share of total government contracts was 63.9% in FY14 down from 66.9% in FY13.

In FY 2014, top awardee Lockheed Martin received \$25.31 billion in prime contracts or 8.8% of total contract funds awarded by the DoD. Runner-up was Boeing with \$18.22 billion (6.4%) followed by General Dynamics in third place with \$13.62 billion (4.8%). Raytheon received \$11.92 billion (4.2%) followed by Northrop Grumman, United Technologies, L-3 Communications, BAE Systems, Huntington Ingalls, and SAIC/Leidos. BAE Systems, #8 on the list, was the largest foreign defense contractor in FY 2014.

# Small Business Loan Authorization Program Could Close Down

By Scott Hauge

I have seen first-hand the kind of struggle that today's small businesses face in order to survive in this economy, especially here in California. When looking for capital, many small businesses hear "no" and many banks run from small businesses as one of the riskiest investments in the market. That is why the survival of the Small Business Administration's (SBA) 7(a) loan program is critical as a job-creating access to capital program. However, the program is about to reach its authorized lending cap annually set by Congress and as a result, will most likely shut down sometime in early August, possibly sooner. Before Congress goes back to the districts over August recess, I ask you to join me in encouraging them to keep this important lifeline open to Main Street America.

The 7(a) program annually supports over 45,000 small businesses and over 500,000 jobs with partnerships from approximately 1,200 active participating private-sector lenders who drive this bottom-up small business financing. Roughly 20% of all 7(a) lending go to California small busi-

# **New Survey Shows** California Small Business Economic Sentiment in Unprecedented Geographic Detail

#### Broad Improvement Seen Over 2+ Years of Data Collected So Far Shows a Slow and Steady Recovery

Thumbtack.com released the Thumbtack Small Business Sentiment Survey, a first-of-its-kind survey that captures the economic sentiment of more than 10,000 small businesses nationwide on a monthly basis, including 14,766 responses over two years in California. Starting today, and released on a monthly basis going forward, the survey and accompanying visualization allow anyone to explore American small business economic sentiment at the national and local level. Designed with Bloomberg, all data will be housed and inte-

grated seamlessly into the economic functions of the Bloomberg Professional service.

The U.S. Economic Census shows that over 90% of small businesses in the United States have five employees or fewer. Thumbtack's survey is the first small business survey whose respondents reflect this specific demographic. While there are various indexes and surveys that seek to measure small business sentiment, there are no other surveys that have enough responses from businesses of this size to examine results at a state or city level.

Via its network of more than 150,000 active service professionals, Thumbtack has the unique capability to regularly survey this otherwise difficult-to-reach population. "We are excited to be able to share this new survey, which will capture the sentiment of thousands of small businesses nationwide on a monthly basis," said Jon Lieber, Chief Economist of Thumbtack. "Many of these business owners have few or no employees, and are often overlooked in other widely-tracked business surveys. We hope to offer new insights and a better understanding into what's happening in this critical segment of the nation's workforce and the American economy."

The inaugural version of the survey shows a slow and steady recovery among California's smallest businesses:

Economic sentiment for California small businesses has improved 5% over the past year. However, that is significantly below the national average of a 7% increase over the past year.

California's small businesses ranked #33 nationally for overall economic sentiment in both March and April, in the bottom 40% of all states.

The state's businesses reported slightly lower expectations for inflation in April versus March. Over the past year, however, their inflation expectations have risen 3% -- slightly higher than businesses nationally.

Just like business owners elsewhere in the country, California small business owners are overwhelmingly optimistic about the future, rating their expectations of their future financial condition consistently 25 to 30 points higher than their perceptions of their current financial situation.

Reported job openings stalled in April over March, declining 1.5% during that time period.

The full results for California include details on the relative sentiment of each state and city, how businesses in each area responded to survey questions, and hundreds of quotes from small business-



# 5 Years Later, Legacy Of Financial Overhaul Still Being Weighed

#### By John Ydstie

Five years ago Tuesday, President Obama signed into law the massive overhaul of U.S. financial regulations called Dodd-Frank. But there's still a battle over whether the law has helped stabilize the financial system or whether it has harmed the economy and should be rolled back.

Congress designed Dodd-Frank to fix excesses in financial markets and mortgage lending cesses that triggered the financial crisis and forced massive bailouts of Wall Street firms.

After five years, regulators have completed just two-thirds of the rules that Dodd-Frank mandated. But that's not a reason for concern, says Annette Nazareth, a partner at the law firm Davis Polk, which tracks the law's implementation on its website.

'The most significant rules — those that required the most work and were probably the most impactful coming out of Dodd-Frank, I would say have been adopted or there's been very serious progress," Nazareth said.


And one of the most difficult and contentious rules, the Volcker rule, takes full effect Tuesday. It bars banks that take government-insured deposits from making speculative investments like those that contributed to the financial crisis.

Dodd-Frank became law with almost no Republican support. Now that they control Congress, many Republicans want to repeal it or at least roll it back. Texas Rep. Jeb Hensarling is one of them. He calls Dodd-Frank Obamacare for the

"And just like Obamacare, Dodd-Frank has left us with fewer choices, higher costs and less freedom," Hensarling said. "It's evident that Dodd-Frank has made us less prosperous and less free. If

# **Bay Bridge Costs Trimmed, But No Wiggle Room for Contingencies**

#### **By Richard Rubin**

Chopping into the swelling cost estimates for finishing the final touches of the new Bay Bridge and razing the rest of the old one has worked, but a budget approved Monday includes no room for the kinds of unexpected costs that keep popping up.

The lack of contingency money bothered members of the bridge construction oversight committee on Monday as it approved a \$22 million fiscal year budget. Caltrans had previously proposed a \$32.5 million draft budget that was rejected by the Toll Bridge Oversight Committee .

Cost overruns have plagued the bridge construction, and two continuing program costs --demolition of the old bridge's underwater piers and what might be costly testing of suspect bridge bolts a panel of experts could recommend -- are unpredictable.

"If there's room to carve out a contingency fund, that would be a desirable thing," said Steve Heminger , chairman of the oversight panel. He has for months questioned the growing costs as the

Bay Bridge construction winds down.

He praised Caltrans for having found the savings it did, and he kept pressing for more at a Monday conference call meeting.

"I do appreciate" the budget cut, he said, but added, "I do think new paradigm means what it says. There are a couple of remnants of the old paradigm here."

He questioned Caltrans budgeting \$2 million for a number of full-time outside contract workers for a contract ending in 10 days.

"That's a lot of money to spend ... after the contract closes," he said to Caltrans Director Malcolm Dougherty .

"I don't know all that's included in that," Dougherty replied.

Heminger, who is executive director of the Metropolitan Transportation Commission , also questioned a one-to-one ratio of support workers for field workers.

Dougherty said a lot of details in the contracts were covered in the support staff category. "We will be looking at these to make sure we're doing the best we can do," he said.

A major savings was in cutting back the bridge work staffing from 34 full-time workers to 10, a \$5 million savings, said Dan McElhinney , a Caltrans chief deputy director.

"Reduction is the trend we need to see," said Heminger.

we want strong economic growth, more freedom, and an end to bailouts, it's time we commit to making sure this anniversary is Dodd-Frank's last anniversary."

Supporters argue that Dodd-Frank has improved regulation and made the U.S. financial system more stable, by among other things, requiring banks to hold more capital to absorb losses.

A recent report from the International Monetary Fund said U.S. banks appear healthier and stronger than they were five years ago.

Annette Nazareth agrees. "There's been very substantial progress in that area. I don't think there's any questions that the banks are far better capitalized than they were before," she said.

Also important, Nazareth says, is a requirement that banks produce something called a living will. That's a road map for how a bank can be wound down, without a government bailout, when it gets in trouble. Nazareth says that provision will help avoid future bailouts.

There is one area where Republicans and Democrats agree that Dodd-Frank has created problems. That's in the regulation of the nation's small community banks. At a recent hearing, Rep. Scott Tipton, R-Colo., described the problem for Janet Yellen, the chair of the Federal Reserve, which regulates community banks.

Tipton said he "sat down with community banks in my district. They feel that they are no longer working as a banker but they're working for the federal government. They're working just ... to be able to comply with regulations that are currently in place. And they don't feel that anyone is actually listening."

Yellen acknowledged there's a problem. "The regulatory burdens that they face have been really quite high and they're struggling with it," she said. Yellen said it would be helpful if some Dodd-Frank regulations could be adapted to provide relief. Nazareth says that's a good idea. But she fears community banks will be held hostage to politics as Democrats and Republicans argue about whether a broader overhaul of Dodd-Frank is necessary.

# **Small Business Loan Authorization Program Could Close Down**

nesses. In the past decade alone, over \$27 billion in small business lending has gone to over 93,000 California small businesses through this program. Not only does 7(a) lending directly support American jobs, but it also operates at no cost to the U.S. taxpayer, and in fact, has consistently returned money to the Treasury. As a result, the 7(a) program has become one of those rare programs that actually stimulates the private-sector economy to make investments that actually benefit local downtown communities.

Lending in the 7(a) program has been increasing exponentially, in large part because of two main factors: the current climate surrounding the private sector's financial institutions and the evolving status of small business needs. In this post-Dodd Frank and Basel III environment, banks are heavily regulated and avoid tying up their deposit base in long-term loans, creating a norm where the bulk of conventional loans are made for 3-year terms or less. This means that the majority of small businesses that typically need long-term, competitively priced loans can only find these terms through the 7(a) program, which offers loans up to a term of 25 years. Simultaneously, borrowers are just coming out of the shadows of the Recession, dramatically increasing the pool of 7(a) applicants.

Last year, Senate and House Small Business Committees, in conjunction with Senate and House FSGG Subcommittees on Appropriations, championed the passage of a \$1 billion supplemental increase in FY14 7(a) lending authority in the final weeks of FY14 – successfully avoiding a shutdown of the program. This allowed private sector lenders to make hundreds of millions of dollars in loans to meet the needs of small businesses just in the last week of September FY14;

loans that otherwise would not have been made.

Once again this year, FY15 is barreling toward the same circumstances as the 7(a) industry lends far above the expectations set by Congress more than a year ago. The program has an \$18.75B lending cap for FY15, and industry, SBA, and OMB all concur that the program will most likely need \$22.5B in lending authority. This is a good problem to have—it means that the private-sector is lending more and more to small businesses and stimulating local job creation. Congress needs to continue showing Main Street America that they are behind small businesses.

If Congress allows this program to shut down, the consequences will be most severely felt by the small businesses that rely on this source of access to capital. Thousands of small businesses will be told that the loan they believed would be available in September will not only be unavailable, but also that no one will be able to tell them when it will become available. If that small business was planning to hire new employees with 7(a) capital, it will have to tell those potential new hires that no jobs are available. If that small business has signed contracts with a construction crew to expand their business, they will need to find a way to halt expansion plans in order to avoid defaulting on the contract. In short, 7(a) program shutdown prevents job-providing small businesses from offering critical support to local communities.

We urge our policymakers to work as quickly as possible to increase the lending authority that capital for hard-working small business owners remains available. We need small businesses around California to contact their Member of Congress.

Of particular importance is contacting Leader Kevin McCarthy (R-CA-23), who represents California's 23rd District in the Bakersfield area. More

than \$246 million in small business loans have been made in the 23rd District in the past two decades and that small business support should never be discouraged. Leader McCarthy's office number is (202) 225-2915 and emails can be sent to kevin. mccarthy@mail.house.gov. Every voice helps!

It is important that we let California's elected officials in Washington know how important the 7(a) program is to California small businesses.

#### Survey methodology

Thumbtack.com has surveyed tens of thousands of small businesses quarterly since December 2012. The survey asked questions about how small businesses are feeling about the general economic environment and health of their business, such as:

How would you rate your company's financial situation today?

Have you attempted to fill any part-time or full-time positions over the past three months?

How do you expect the prices you charge to your clients or customers to change over the next three months?

Thumbtack.com and Bloomberg then used the survey responses to create a weighted index that demonstrates Small Business Economic Sentiment in one easy-to-understand number between 0 and 100 - an index score above 50 means sentiment is positive; an index score below 46 means sentiment is negative. # **Private Equity and Venture Capital Sourcing**

In recent years, crowdfunding has become a popular way to fund small business endeavors for those who aren't independently wealthy. But how does it work? Here's what you need to know about crowdfunding and how to get started if you want to start or fund a project.

#### What is crowdfunding?

Crowdfunding is the raising of money by multiple people for a project, usually a good, service, experience or cause. Essentially, a large group of people who don't necessarily know the project initiator can fund this person's business or project through a third-party crowdfunding organization. This allows the initiator to start their dream business, publish a book or even make potato salad [2].

# What is the contributors' incentive to help a crowdfunding project?

The benefits to the project initiator are obvious, but what do the donors get out of this? This depends on the type of crowdfunding. Popular types include:

- Rewards-based crowdfunding [3]: In rewards-based crowdfunding, the donors will get a product or service related to the project. The value this product or service holds will depend on the amount donated. For instance, a \$5 donation might get you a handwritten thank you card for helping to fund the project, while \$50 or \$100 might get you the product that will be made by the business venture being funded. Either way, the money donated is enough to cover the cost of the good or service, plus help pay for the project itself.
- Equity-based crowdfunding [4]: For equity-based crowdfunding, donors will receive shares in the company; the number is based on the amount of the contribution. Contributors choose to invest in companies they believe will be successful in the future, as the success of the company directly influences the return on investment donors will get from equity-based crowdfunding.
- <u>Credit-based crowdfunding:</u> You may have heard of credit-based crowdfunding on a per-

sonal, not business, level. It's often called "peer-to-peer lending [5]" and is essentially a loan at a reasonable rate funded by multiple investors. Rates will depend on the credit history of the person applying for the loan, but those with good credit can often get a better interest rate on a peer-to-peer loan than on a traditional bank loan. That said, investors can usually make a better return on investment than playing it safe in a mutual fund or bond.

Of course, there may be a touch of goodwill, but there are definitely quantifiable reasons for investors or lenders to participate in crowdfunding projects.

#### Should I use crowdfunding?

There are a few things you should consider before you try to start a crowdfunding project. These include:

- Your project: Ask yourself: Why would anyone care about this project? Does it provide a good or service that would make people's lives easier? Is it a cause close to the heart of many people? Whatever your project is, it's unlikely to be funded unless other people believe it's a project that matters. And while a potato salad did receive contributions in the high five figures, this isn't the norm.
- Your project plan: Will the amount you're asking for cover the expense of your project? Do you have a detailed plan on how to bring your project to fruition? Do you have a dedicated team to get your project up and running? You need to be a doer in addition to a dreamer, so make sure your project plan is realistic.
- Your video: This is arguably the best part of your project profile. You need to create a short video telling potential contributors your story. Explain the good or service, how it works and why it matters. If you don't have a person in your circle with mad videographer skills, you'll need to hire someone. This isn't the place to skimp people are unlikely to contribute to a project with a shaky iPhone video.
- Your network: Even an awesome project won't get funded if no one knows about it. And while people may come across it while browsing their favorite crowdfunding site, it helps to have a large network to spread the word. If you decide

to crowdfund, shyness needs to go out the window. Tell everyone in your life about it and ask them to spread the word on social media and offline. Funding your project will be much easier if you have a project others care about and a ton of people promoting it on your behalf. Get

ready to turn emailing people about your proj-

ect into a full-time job

- Your marketing plan: If your project is a winner, start local. Call television networks and reporters in your area a few weeks before your launch to see if they're interested in featuring your project in a story. Post on social media channels, back similar crowdfunding projects for exposure, engage with the crowdfunding organization's community, etc.
- Your rewards: Are the rewards you're offering appealing to your target audience? Whether it's a good or service or shares in your business venture, if they aren't appealing enough to your audience, people won't contribute.

**Bottom line:** Crowdfunding is a great way to get your project off the ground, as long as it's a project people care about and it's marketable. Check out the

available platforms above to choose a crowdfunding organization that's right for you and put together your business plan. Good luck!

# **Upstart Ex-Googlers Raise \$35 Million To Get Millennials More Access To Loans**

#### **By Alex Konrad**

At Google, a 25-year-old is a known quantity. Where young job candidates went to school, what they majored in, and many more data points help Google predict which are more likely to succeed in certain roles. But outside the Googleplex, those millennials are much less trusted, particularly when it comes to accessing credit to take out a major loan.

Dozens of startups are tackling lending practices in the U.S. today, but Dave Girouard didn't understand why no one was reaching millennials using Google's approach. An eight-year veteran of the tech giant who recently ran its enterprise business, Girouard saw a business opportunity in doing just that.

"People in the lending world were acting like there was none of this data," Girouard says. "There a real difference from companies that decide to lend money but don't have anything unique to their approach."

Girouard's startup, called Upstart, makes three-year personal loans to millennial borrowers the company believes it can predict will grow into a healthy financial situation. Most of them are to refinance credit cards, helping young professionals adjust their interest rates down from an average of 22% to Upstart's average of 11-12%. Many of those borrowers make more than \$100,000 in annual salary and 90% have college degrees. So far Upstart has issued almost 9,000 loans and collected 36,000 repayments. "These are very high quality borrowers, just ones without a lot of credit history," Girouard says.

To find the right applicants, however, Upstart's approach depends upon its new ways of analyzing data. So Girouard plans to add a handful of new scientists to his team of about 40 full-time employees and 25 contractors and find a larger office to fit them all in. Enter investors. Upstart announced Thursday that it had raised a \$35 million Series C round from Third Point Capital, the venture arm of billionaire Daniel Loeb's Third Point hedge fund. The money is distinct from the \$800 million issued in loans so far.

Upstart had raised a \$1.75 million seed round and \$6 million Series A round in the past several years for a slightly different approach, income shared agreements that charged borrowers a fraction of what they earned. 150 people signed up, too slow a rate of growth for Girouard and his early investors. According to Girouard, it was Josh

Kopelman at First Round Capital who played a key role in helping him realize the startup needed a change. The company's customer representatives noticed a difference right away. "We switched from hour-long discussions with potential borrowers to 30-second conversations," Girouard says.

Upstart claims its default rates are about half of those of LendingClub, which went public in December 2014 and has a market cap of about \$5.5 billion. "What we are doing is only risky in the sense that others haven't done this before," says Girouard. "They're like, I'll believe it when I see it. They'll see it."


