**Could Be A Boon For U.S. Businesses** 

**A Reopened Embassy In Havana** 

Minnesota Sen. Amy Klobuchar says U.S. embassies around the world are promoting American businesses, and she's hoping that once the U.S. embassy is reopened in Havana this month, American companies interested in doing business there will find a place to get advice.

"If they're not some big Fortune 500 company, they don't actually have personnel on staff to help them vet customers," Klobuchar says. "In fact, many of our small- and medium-sized businesses in Minnesota and across the country use the foreign commercial service. They have people in the embassy, so that they can actually call."

There's no foreign commercial service staff based at the U.S. diplomatic post in Havana yet to answer such a call, and a U.S. embargo is still on the books. Nevertheless, Klobuchar, a Democrat, is looking ahead.

"In order to really make this work, once you lift the trade embargo, you are going to have to have people that are working to help American businesses," she says. "Otherwise, just the big guys get all the business."

Minnesota already exports about \$20 million a year in agricultural products to Cuba under a humanitarian exemption to the embargo. Cuban-American attorney Pedro Freyre teaches a course at Columbia University's law school about the embargo, which he says has more holes than Swiss cheese.

"There's huge, huge loopholes in the embargo," Freyre says. "One of them has to do with the sale of agricultural products. The United States is one of the biggest trade partners that Cuba has. If you have a chicken cutlet in Havana, its likely to be a U.S. chicken."

Freyre, a partner with the law firm Akerman LLP, sees big potential for trade in pharmaceuticals and in telecommunications. He says the U.S. can also export certain construction materials and paint for private property owners and charitable institutions in Cuba.

Maybe it seems like just yesterday that you were storing away your holiday decorations.

Maybe it actually was yesterday because life gets busy and tasks get put off, and before you know it, half the year is over and you're scrambling to catch up.

So in case you have been too busy to pay close attention, here's what we now know about the just-ended half of this year's economy:

On Friday, the Labor Department provided another reasonably upbeat monthly jobs report — good enough to make 2015 a winner so far for workers.

In June, employers added 223,000 jobs, and it was the 64th straight month of private-sector job growth — the longest streak on record.

## **New NNPA Chair: 'We're Going to Flex Our Muscles'**

When America's first black newspaper was published on March 16, 1827, black people were still enslaved. Nearly two centuries later, the issues of Black America — though not as severe as human bondage — are still urgent and continue to belie America's promise of freedom and justice for all.

This is the reason that 21st century black newspapers remain focused on "pleading our own cause" as was expressed in the first editorial by abolitionists Samuel Cornish and John B. Russwurm in Freedom's Journal. The editorial concluded, "Too long has the public been deceived by misrepresentations, in things which concern us dearly."

In this regard, Denise Rolark Barnes, the new chair of the National Newspaper Publishers Association, says the federation of more than 200 black-owned newspapers will continue to not only thrive but grow as it begins its 75th year. With most newspapers in an economic struggle industry wide and black newspapers enthralled in a historic battle against advertising discrimination, Barnes says NNPA's new leadership team will encourage a keen focus on issues that continually plague black communities, while initiating strategies to expand.

"Housing, the large foreclosure rate, the issue of the lack of police-community relations, the unwarranted deaths of young black men at the hands of police, the big issue of black-on-black crime —We need to take responsible positions on all of these issues because this is what our community looks for, but this is also what I think our advertisers will be looking for. They want us to take a stand on these issues," says Barnes in an interview with the Trice Edney News Wire. "I'd just say look out because we're going to flex our muscles. And we're looking forward to doing our jobs on a broader scale and speaking stronger. And I know the publishers are prime for it." The flexed muscle of the Black Press recalls the powerful logo made famous by the historic Richmond Planet. The newspaper's banner carried a drawing of "a flexed, muscular black arm with lightning bolts radiating out of its clenched fist", as described by the National Endowment for the Humanities.

Barnes, publisher of the Washington Informer Newspaper for more than 20 years, was given the leadership charge by her fellow publishers in a June 19 election held during the NNPA Annual Convention in Detroit. As publisher, she follows in the footsteps of her father, the late Calvin Rolark, who was widely known as a business and community leader as well as publisher of the Informer, which was founded more than 50 years ago.

The executive committee elected alongside her also includes publishers who are well-entrenched leaders in various communities: First Vice Chair Karen Carter Richards, Houston Forward Times; Second Vice Chair Francis Page, Jr., Houston Style Magazine; Treasurer Janis Ware, Atlanta Voice and Secretary Shannon Williams, Indianapolis Recorder. "Many of us are second generation publishers. We're fairly young and are committed to the legacy that was left by those who started in this industry. We understand what our responsibilities are and we're looking forward to continuing to make a difference through the stories, the photographs, and the editorials that you'll find in black-owned newspapers," said Barnes.

She ticked off several initiatives foremost on her mind that the association must explore in coming months and years in order to expand and strengthen its membership. Among them are:

\*Since NNPA operates off of sponsorships and advertising, there must be new ways to help corporations understand the value of black newspapers. That will be a major effort now carried out by a national advertising sales team currently being es-

tablished. \*Increase, solidify and grow online presence in order to engage readers who may not readily pick up newspapers. Currently, the two NNPA websites are NNPA.org and BlackPressUSA.com. Most NNPA member newspapers also have their own individual websites. The NNPA Foundation, which includes the D.C.-based NNPA News Service and Blackpressusa.com, run by Editor-inchief George Curry, has a separate board chair.

\*Create genres through which readers can exchange opinions and thoughts surrounding the issues and articles in black newspapers.

\*Consider broadening the NNPA membership base to fully include those newspapers that only publish online as well as helping to bring back members that may have become defunct due to economic difficulties.

\*Provide greater support and service to newspapers that are evolving into multi-media companies.

\*Supporting the staff of the national office, also based in Washington, D.C., in order to maximize the success of the policies set by the board.

Barnes' term as chair is two years, after which she could run for a second two-year term. The executive committee heads a 22-member board of directors, including representatives of five regions. The board establishes policy and directives for the Washington, D.C. headquarters, which is led by NNPA President/CEO Benjamin Chavis.

Chavis' stature as a former member of the recently pardoned historic Wilmington 10 as well as his civil rights leadership as former NAACP executive director, has raised the visibility of the organization to a new level over the past several years. Barnes, who replaces former chair Cloves Campbell of the Arizona Informant, says she will build on the new growth that he established over the past four years.

"NNPA for so long didn't have a president and didn't have a staff; therefore, the publishers were actually involved in the day to day management of the association. Now, we have the benefit of both of those, the president, the staff and the National Office. And so, the board now can get back into the business of creating policy," she said.

The fact that the NNPA national office and chair are now both located in the nation's capital is an additional advantage from a standpoint of infrastructure, she said. Amidst the home of the federal government, the U. S. Congress, she says she will work the relationships garnered by her and her father over 50 years for the maximum benefits for NNPA.

"We serve as the voice for the black community; we speak truth to power, we influence legislation and I think when folks see that we're still an integral part of our community because of the positions that we take on behalf of our community, it will show that we have the kind of value that's worth investing in," Barnes says. "Some may not always appreciate the positions that we may take. But, it's not about liking what we do. It's being respected for what we do."

She concluded, "We give you stories about communities that are working hard to support their families, to build communities, to contribute to this nation and to the world and I don't ever see a day, to be honest with you, when the black press will not play that critical role in this country and across the world."





### So Far, So Good For The Economy. But What About The Second Half?

And the unmployment rate fell by twotenths of a point to 5.3 percent, the lowest level since April 2008. In January, unemployment was 5.7 percent, so the trend is encouraging. And the average monthly gain in payrolls for the year's first half was 208,000 — not a bad pace for a 6-year-old recovery.

But the June report also underscored problems that have plagued workers in 2015. For one thing, the pace of job creation cooled compared with the second half of 2014. In the back half of last year, monthly job growth averaged 281,000.

Here's another disappointment: In June, average hourly wages did not go up — not by even one penny.

Betsey Stevenson, a member of the White House Council of Council of Economic Advisers, shared her reaction with NPR's Scott Horsley: "Obviously, zero is a disappointing number."

To be fair, wages are up 2 percent from this time last year, but still, June's flat line suggests raises are losing momentum.

And there's this, too: The labor-force participation rate slipped to 62.6 percent, down from 62.9 percent. That marked the lowest level since 1977 — and may mean discouraged Americans aren't even trying to find jobs. So, on balance, the labor market is doing OK, but it could be a lot better.

As for the second half of 2015, economists are somewhat optimistic, expecting moderate economic growth of 2.5 percent. Among the positive factors: higher consumer spending and confidence, tied to cheaper energy.

"The national average gasoline price likely peaked for this year in mid-June at \$2.91 per gallon and the price is \$2.88 per gallon heading into the July 4 holiday weekend — much lower than \$3.73 per gallon at last year's July 4 weekend," PNC chief economist Stu Hoffman said in his written outlook. By Christmas, he expects gas to be down to \$2.40 a gallon — helping give consumers a spending boost even without raises.

Even though the outlook is generally upbeat, there are risks looming in the second half of the year. For example, the debt crisis in Greece could worsen and deeply rattle financial markets. The Federal Reserve could start raising interest rates in September and touch off a bad market reaction among investors. Congress could allow a debt-ceiling problem to spiral into a crisis this fall.

But there are always dangers. On balance, the last line of Hoffman's assessment probably best summed up the big picture.

"Havana is a city that is in dire need of a paint job, so I suspect you're going to see some opportunities there to get that type of material over to Cuba," he says.

Freyre's looking forward to the newly re-established embassy, though he's found that its becoming just as easy to work directly with Cuban officials as he takes his clients around Havana.

"Having the embassy, I think, is always helpful," he says. "It provides comfort, it provides support. Your government is there for you. But right now, I have to say that the direct communications with the Cuban officials have been opening up."

Freyre's own views about his homeland have changed too. He was always a staunch opponent of the Castro regime, but welcomes this new U.S. approach of engagement.

"The U.S. tried direct invasion, confrontation, blockade, guerrilla warfare, exploding cigars, an embargo, and none of it worked," he says.

Though he and other experts don't think Congress has the votes yet to formally lift the embargo, the push to open tourism is gaining momentum. Klobuchar says Congress shouldn't stop there.

"Well, if you just do that and you have Americans flocking to Cuba on vacation, they're going to be staying in Spanish hotels and eating food from Germany and China," she says. "At some point, if we wait too long to get American businesses in there, we're actually going to be losing enormous opportunities." Klobuchar has 17 co-sponsors on a bill to end the embargo, but faces opposition from some key Republicans, who accuse the White House of looking for legacy and overlooking human rights abuses in Cuba.



# The country's last black-owned banks are in a fight for their survival

#### **By Michael A. Fletcher**

Capital Savings Bank opened shop in Washington in 1888, making it the nation's first black-owned bank at a time when the mere notion of offering financial services to the African American community was a novel idea. Now black-run banks are in a fight for survival, even though many advocates argue that many African Americans remain starved for banking services.

The Federal Deposit Insurance Corp. counted 25 black-owned banks remaining in the country last year, down from 48 in 2001. That decrease came even as the overall number of minority-owned banks increased slightly, going from 164 to 174. In addition, the majority of black-owned banks that remain open are on shaky ground and struggling to hold on in the face of the economic devastation that has ravaged many of their customers. Analysts say 60 percent of black-run banks lost money in 2013.

"I would venture to say that [the vast majority of black banks] are in varying degrees of trouble," said Darrell Jackson, chief executive and president of Chicago's Seaway Bank, a blackowned bank celebrating its 50th anniversary.

Black-run banks have been struggling for years, as mainstream institutions increasingly picked off their best-heeled customers. The increased competition came amid what some call a string of strategic blunders. The banks, historically headquartered in the heart of traditional black communities such as Chicago's South Side, New York's Harlem and Washington, D.C.'s Shaw, failed to modernize their services. Few offered the branch networks, computerized banking and other automated services that have come to dominate the business. And many of the banks failed to follow the African American middle class to the suburbs.

Taken together, black banks control just \$5 billion in assets, a tiny fraction of the size of the nation's banking behemoths, such as Wells Fargo, which by itself has some \$1.7 trillion in assets. Black banks tend to be small even by the standard of minority owned banks, which as a group had some \$181 billion in assets at the end of 2013, according a FDIC report.

The trouble faced by black banks only deepened during the recession, and they have continued during the recovery. Just a handful of them were eligible for the federal bailout funds that sustained many large financial institutions through the crisis. Now they are challenged by the bleak economic prospects of their core customers. Not only were many black neighborhoods crippled by the mortgage crisis, but the recovery has been been slower in black communities than elsewhere. African Americans continue to lose wealth as their property values have lagged those elsewhere in the years since the financial downturn. Despite an extended period of job growth nationally, the black jobless rate remains above 10 percent.


The economic shock continues to ripple through the black community, upending black business and even churches, which historically have been the best customers for black banks. Meanwhile, many black-owned banks are left with a lot of toxic loans in their portfolios.

"This is such an extremely important sector of the banking community," said Michael A. Grant, president of the National Bankers Association, the lobbying group for black banks. "We were hit so hard during this sub-prime crisis, and they are having a hard time working their way back from that."

Others argue that many black-run banks planted the seeds for their own demise by failing to evolve with the times. William Michael Cunningham, an economist and entrepreneur, said many black banks do not do enough to modernize their businesses, and instead rely too heavily on political connections and old business alliances for deposits and customers.

"Being a black banker in a top-30 city in the U.S. is a very good job, mainly because you don't have to do much," Cunningham said. "Too often, if you are a black banker, your incentive is not to make loans."

Paul O'Connor, founder of Angkor Strategic Advisors, a Chicago-based banking consultancy, called black-run banks a victim of the larger progress of African Americans. Like

other institutions that thrived in the face of rampant discrimination, black banks now confront more and better financed competition for relatively affluent customers. Meanwhile, few banks see profits in banking the poor. At the same time, he noted, many black communities — particularly impoverished neighborhoods in which black-owned banks tend to be headquartered — remain in dire need of better banking options.

"The positive side of this is that the African American community has developed in a way that they don't need African American banks like they did 50 or 70 years ago," he said. "Also, they have a margin for error that is much smaller than most banks. At the end of the day, you are banking human beings and they are as good a credit risk as the last job they had. A lot of people these institutions banked are hurt economically."

Whatever the root cause of the problems of the problems of black banks, many analysts agree their demise is a net loss, since they disproportionately serve poor communities where banks are few, according to the FDIC."Often, black banks are the only bank, ore one of two, in the entire zip code," said Russell Kashian, an economist at the University of Wisconsin, Whitewater. "If they weren't there, there would be nothing."

Given that reality, many advocates say their survival should be a priority of both the government and the black community. Black bankers have been lobbying federal officials to relax regulations in a way that would make it less costly to do business. Others say there need to be better incentives and training and mentoring to help sustain the banks. "If we want these underserved neighborhoods served, either we have to make these communities wealthier, or provide some better incentives for these banks to exist," Kashian said.

The National Bankers Association's Grant added that more black consumers should make a priority of banking with institutions that served their communities when others would not. "The African American community itself is going to have to do more to support its businesses, which includes the banks," Grant said. "Why are we boycotting our own businesses? These are the banks that were there for us before integration. We should be there for them now."

## **The Freedman's Savings Bank:** Good Intentions Were Not Enough; A Noble Experiment Goes Awry

Like much else that came out of the Civil War, the Freedman's Savings Bank (officially the Freedman's Savings and Trust Company) began with a sense of high moral purpose. Its founders understood that the 13th Amendment to the Constitution, which abolished slavery, was only the start down the long road toward full participation in American society for former slaves. Simply to survive the transition to a system based on free labor, they would need food, clothing, shelter, and medical care. But in the longer term, if they were to have a meaningful chance to succeed in American society, they would also need education, legal services, financial services, and capital.

With these needs in mind, Congress on March 3, 1865, enacted legislation to establish the first-ofits-kind social services agency that became known as the Freedmen's Bureau, to administer a broad program of help and self-help. On the same day, it chartered the Freedman's Savings Bank, with the goal, as the African-American statesman Frederick Douglass put it, of instilling into the minds of the former slaves "lessons of sobriety, wisdom, and economy, and to show them how to rise in the world."

The need for the Bank's services was acute. Large numbers of slaves liberated by the Union Army had gone on its payroll. As this was the first bit of cash many of them had ever received, they needed a safe depository and basic financial education. The plan also called for the Bank to employ numbers of freedmen, giving them hands-on training and experience in the banker's skills.

At first, all went well. With the Freedman's Bureau helping to publicize it, the Bank attracted millions of dollars from tens of thousands of depositors. The accounts they established were poignantly small. The vast majority of them ranged between \$5 and \$50, but these small deposits were emblematic of the historic rise of a class of black property owners.

The Bank was quick—perhaps too quick—to acquire the tangible symbols of success. It established dozens of branches throughout the country, which attracted new deposits but also depleted its resources. It built a splendid headquarters in Washington, D.C., at the southeast corner of Lafayette Square where the Treasury Annex now stands. Its appearance filled Douglass's heart with pride. With its "magnificent brown stone front, its towering height, its perfect appointments, and the fine display it made in the transaction of its business," he wrote, "it was a sight I had never expected to see." But it had cost more than \$200,000 to construct and furnish—a dubious expenditure for an institution that, within a few years of its founding, was already experiencing problems.

Some of those problems stemmed from the volatile post-war economy, which saw decline, expansion, and then contraction again, culminating in the Panic of 1873. The contraction pushed down the yield on government securities, which formed a primary component of the Bank's investment portfolio and which reduced the return to depositors. It was ostensibly for their benefit that a new management team at the Bank urged Congress to liberalize the terms of its charter, permitting it to make loans backed by real estate. Congress went along. After all, access to finance for housing and related purposes, then as now, was a matter of compelling public policy. Unfortunately, history has repeatedly shown the error of expanding bank powers without providing a commensurate increase in official oversight and risk management.

Enter the Office of the Comptroller of the Currency (OCC). Created in 1863, just two years before the Freedman's Savings Bank, the Comptroller and his examiners were responsible for supervising the national banks it chartered, including several in the nation's capital. Under the national banking laws carried out by the OCC, real estate lending was explicitly forbidden—a prohibition enforced by the office's professional bank examiners.

The Freedman's Savings Bank's depositors had no such safeguards. Indeed, the Bank's charter explicitly subjected it not to the authority of the OCC, but to Congress itself. This oversight proved episodic, and what there was of it was often tainted by political considerations. That is why the Congress had seen fit to create the OCC as an independent agency funded not by appropriations, but by fees paid by the banks it supervised.

By 1873, as the national economy spiraled downward, the Bank's condition turned critical. Too late, Congress asked the OCC to assess its prospects, providing a special appropriation to conduct emergency examinations. In February 1873 and February 1874, OCC examiner Charles Meigs reported on the growing precariousness of Bank's position. In part because no one had been watching carefully over the Bank's affairs, its of-ficers had fallen victim to their own inexperience and to the machinations of the likes of Henry Cooke, who served on the Bank's board while also serving his family banking business, using the assets of the former to benefit the latter. In March 1874, Frederick Douglass was induced to take the reins of the Bank, a move that many hoped would steady the Bank in the eyes of its depositors, lest they withdraw their savings in a panic. But it was too late. On June 29, the Bank's trustees voted to shut it down.

The Bank's closing did more than shatter the dreams of Douglass and others with high hopes in its future. It left 61,144 depositors with losses of nearly \$3 million. After years of waiting, depositors only recouped a share of what was owed them. It was a bitter conclusion to a venture launched with great promise.




