## ACCA Commitment to Equity

The American Contract Compliance Association was established in 1986 as a nonprofit national organization dedicated to ensuring equitable employment and contracting practices within the public and private sectors. It started as the brainchild of members of the Minnesota based Inter-Governmental Compliance Institute (IGCI).

The thought was to foster a national organization which would provide training, standardization of practice, networking, and support to the many affirmative action, contract compliance, equal employment, and human rights workers across the country. In 1989, under the leadership of President Robert Harrison, Vice President Kerry Kirkland, and in association with Boston University School of Social Work, ACCA held the first accredited training institute in Louisville, Kentucky. The week long conference gave 4.2 continuing education credits to registrants that passed each class and test by a score of 85% or more. Later, the "Compliance Administrator" was divided into two training sessions of 21 hours each.

The American Contract Compliance Association continued to grow and serve. Relationships were developed with Senator Parren J. Mitchell, Arthur A. Fletcher, the Minority Business Enterprise Legal Defense and Education Fund (MBELDEF), and the leading attorneys in the field. The organization adopted a fitting slogan for the times it faced. It simply said, "Integrity, Courage, and Commitment". The subsequent federal and local activities and legal mandates proved the need for these new change agents. In living up to the challenge, a conference and public service forum was held in Richmond, Virginia following the case of J. A. Croson vs. City of Richmond (VA). The televised dialogue provided valuable information and insights into the court ruling and requirements. Strategic conferences were also held in Alabama, Texas, Florida, California, Minnesota, Pennsylvania, and Ohio, to name a few key locations. Over the years, the American Contract Compliance Association has served the needs of our country and constituents through strong leaders who were willing to lead.

#### The Geography of Innovation

Which type of place is more innovative—dense, diverse cities or sprawling, homogeneous suburbs? For most self-described urbanists, the answer would seem obvious. The density and diversity of cities enable all sorts of unique collaborations and chance encounters that foster innovation.

But this popular association between cities and innovation has long been confounded by the prevalence of suburban innovation hubs—the low-slung, car-dependent office parks that Joel Kotkin famously dubbed "nerdistans." This term describes nearly all of the most high-profile tech hubs, including California's Silicon Valley; the Route 128 beltway outside Boston; Seattle suburbs like Redmond where Microsoft is head-quartered; and similar collections of office parks

outside Austin, in the North Carolina Research Triangle, and elsewhere.

A recent study by economists Enrico Berkes of Northwestern University and my University of Toronto Rotman School colleague Ruben Gaetani cracks the proverbial code on the geography of innovation. They find that while there is actually a greater amount of innovation (as measured by patents) in suburbs, cities produce far more "unconventional innovations," which require a greater diversity of contributors and have a more disruptive economic impact.

The study examines the locations of patents across thousands of county subdivisions as defined by the U.S. Census. It covers more than a million patents filed between January 2000 and

#### **How to Create Good Jobs**

In his 2011 book The Coming Jobs War, Gallup Chairman Jim Clifton writes that after years of research, his firm had concluded that "what the whole world wants is a good job." That may not seem like much of a revelation, but Clifton's emphasis is on the word "good" -- not the "gig economy," but stable, regular, well-paid employment. The fact that the demand for good jobs far exceeds the supply is a real threat to political stability, Clifton writes, because "whether or not you have a good job defines your relationship with your city, your country and the whole world around you."

Indeed, there aren't enough good jobs -- even though we see plenty of work that needs to be done: infrastructure to be repaired or replaced, affordable housing to be built, and children, the sick and the elderly to be cared for. We frequently hear that jobs are disappearing due to globalization and automation. But their impact on jobs is probably minimal. Trade and technology could create as many good jobs as they destroy if we had the right policies in place, particularly those that impact women, immigrants and small businesses.

A report by McKinsey Global International last year estimated that by realizing the full potential of women in the workforce, every state and local government could add at least 5 percent to its economic output and half of the states could increase their GDPs by 10 percent. Policies that result in the increased availability of paid maternity leave, affordable child care and flexible work schedules would lead to significant increases in women's workforce participation.

We also need to make it easier for people to immigrate to the United States and provide a swift, rational path for them to become citizens. Clifton notes that a great deal of the internet technology boom can be traced back to just a thousand people, of whom more than half were immigrants. "America can't win the coming jobs war," Clifton writes, "without attracting the best talent and helping the talented become American citizens fast."

And we need to make it easier for small businesses to compete by returning to the regulatory policies that, until the early 1980s, limited corporations' market concentration through mergers and acquisitions. Mergers drive declining rates of entrepreneurship. From 1977 to 2013, the number of startups as a share of all firms fell from 16.5 percent to 8 percent, and their share of jobs declined from 5.7 percent to 2 percent.

"Sustainable job creation," Clifton writes, "can't be bought." Yet, despite an ever-growing pile of evidence that chasing jobs with tax incentives and relaxed regulations doesn't work, that's still the default strategy for many state and local government leaders. It might create a few jobs, but


rarely good ones. The communities whose leaders figure this out first are going to be the ones that win the jobs war.

## **Access to Capital**

#### Money Makes Small Businesses Go Round: Ensuring Access For All

When diverse perspectives are applied to financing, doors open for entrepreneurs. Last week, I wrote The Next Business Revolution: Diversity and how it fuels innovation and enhances employee engagement. This week, I look at how the diverse makeup of one company has created finance options for innovations that might otherwise never get to market ... and why more companies are going to follow their lead.

Entrepreneurial women have been limited in their ability to bring their innovations to market because they are only able to raise about 50% of the capital that men raise. Biases among bankers and venture capital firms limit entrepreneurial success to a few, well-connected people most notably white men.

In 2008, a new form of financing — rewards-based crowdfunding — premiered. With money raised on crowdfunding platforms like Indiegogo and Kickstarter, startups and companies with a new product idea connect directly with potential users for funding. Rather than relying on so-called experts to determine if the new product

has merit, potential customers do. As it turns out, the crowd knows what's it's doing. It's just as likely to fund a product that will be a success as institutional funders.

New products don't pop up out of nowhere. They are the result of unexpected connections based on life experiences. Different life experiences result in different connections or, from a business perspective, in a wider range of products and services. Danae Ringelmann, one of Indiegogo's founders, wanted to help small business owners like her mother and father who faced endless struggles raising money for their company.

Women are the decision-makers for the majority of consumer products. People of color will soon be the majority demographic in this country, noted Julia Nguyen, software engineer at Indiegogo. Many of the most successful products result when someone recognizes a pain point in their own life and sets about creating a solution. "User entrepreneurs" — people who developed a product or service to solve their own pain point, whether personal or business — are more likely to be successful than other entrepreneurs



according Kaufmann research.

Financing has to support these innovators. With crowdfunding, the diverse marketplace can di-

rectly support the entrepreneurs who solve real problems — their problems. As it happens,

#### Classes Provide ACCA **Professionals Tools To** Stimulate Future Growth

As part of a growing national trend, in the construction industry, many diversity compliance programs are moving away from awarding contracts to businesses based on racial and gender preferences.

That at least is one of the areas Ruby Jones, a board member of the American Contract Compliance Association (ACCA), swears is currently a hot topic.

She contends contracting inclusion programs today at the local and state government level. as well as with private companies, are geared toward disadvantaged, local and small busi-

Jones, the owner of Ruby Jones Consulting, a Raleigh, North Carolina-based national diversity compliance consulting firm, says the shift creates challenges.

"When you look at who is getting the contracts and who is not getting the contracts across the country African American companies are, unfortunately, still at the bottom of the pole,"

Fortunately, public agencies across the country are having disparity studies done which can be used as a tool when creating inclusion programs. How do you meet results of disparity studies that show African American companies are not being awarded contracts? How do agencies and major contractors stay within the confinement of the law where you can no longer target businesses based on racial or gender preferences?

The good news is, the answer can be found at the American Contract Compliance Association's 2017 National Training Institute (ACCA). More than 450 participants are expected to attend the six-day event that kicks off Tuesday, August 22, at the Marriott Country Club Plaza in Kansas City, Missouri.

Teaming up with Morgan State University, the institute offers college credits to public and private sector professionals working in fields including contract compliance, economic business development, and affirmative action and labor compliance.

In excess of 2,000 such practitioners have been certified by ACCA since the training institute began. Visit http://accaweb.org/nti/2017nti. html for more details.

The theme of this year's event is "Show-Me Compliance: Showing how compliance works to achieve diversity through collaboration."

Jones says states, including California and Washington, have passed legislation that did away with affirmative action programs that were racial or gender based. She says "Equal Employment Opportunity is still the law!" Attendees at ACCA's annual training gain insights on successful strategies and programs practitioners from other states and cities are doing to meet the changing compliance requirements.

"They're going to learn creative ways to be successful in creating and implementing successful inclusion programs which will work to assure

that all companies, specifically African American businesses, are afforded an equal opportunity in being awarded contracts," Jones says.

All told, nearly 20 different topics will be offered. They will include bonding, minority and disadvantaged certifications, disparity studies, industry legal update, large projects management, leadership development, project labor agreements and project goal setting, to name a few.

Observers pointed out that 2017 training participants will hear about best practices they can use to magnify future opportunities. Those insights will be connected to "Show-Me Compliance: Showing how compliance works to achieve diversity through collaboration," the theme of this year's event.

# Update on legal issues impacting affirmative action programs, recent cases, legislative, trends in federal/state courts tied to minority, women and disadvantaged business enterprise programs and employment issues.

# Learn about different forms of construction compliance programs and delivery methods, used by local, state, federal and how they apply to construction contractors, structured bid packages/drawings to reduce barriers as well as other related matters.

## The Geography of Innovation

#### Continued from page 1

December 2010 and granted between January 2002 and August 2014. Of the more than 35,000 total county subdivisions in the United States, slightly less than 11,000 generated one or more patents during this period; and just 1,645 were "continuously innovative," producing at least one patent per year over the course of the study. These hyper-productive areas account for 95 percent of all patents while housing about half of the population (53 percent) and 61 percent of college grads.

The study presents two big takeaways for understanding the distribution of innovation between cities and suburbs.

#### The suburbs remain a source of considerable innovation

Lower density places account for the lion's share of patented innovations. More than 40 percent of patents come from places that had a density below 2,500 people per square mile – roughly the cut-off for urban-like density established by the urban economist Jed Kolko. And, nearly three-quarters of patents come from places that had density below 3,650 people per square mile in 2000, about the level of Palo Alto, California in the heart of Silicon Valley.

While the geography of patented innovations is highly clustered around major metros and mega-regions like the Northeast Corridor, the Bay Area, Southern California, the Texas Triangle, and Greater Chicago, a great deal of innovation occurs in lower density, more suburban locations. This is in line with my own research, which finds that the suburbs are home to roughly 45 percent of all venture capital-financed innovation areas

Take a look at the maps below of patent activity in and around New York, San Francisco, Boston, and Chicago (the coloring is the same as in the national map above). In every case, while virtually all high density urban areas are marked as continuously innovative, so are most of the surrounding suburbs. In fact, suburban areas of continuous innovation outnumber urban areas by a considerable margin.

The study finds that although density has a positive effect on the probability of hosting permanent innovation activities, the optimum density for patenting appears to be about 3,500 people per square mile, roughly the density of Palo Alto, Austin or Raleigh.

#### But higher density places produce more unconventional innovations

That said, higher density, more urban places are the source of more unique or unconventional innovations. The researchers define unconventional patents as those which are outliers in the way they combine technology categories that are seldom seen together, as inferred by the overall universe of patent citations. Unconventional patents are more likely to come from smaller companies, university labs, or independent inventors than large, publicly-traded companies. And they are often the harbingers of revolutionary new technologies.
