# Los Angeles County a Microcosm of Nation's Diverse **Collection of Business Owners, Census Bureau Reports**

Los Angeles County, Calif., led the nation in the number of Hispanic-, Asian-, and American Indian and Alaska Native-owned firms, according to estimates released by the U.S. Census Bureau. It also ranked second in the number of black or African American- and Native Hawaiian and Other Pacific Islander-owned firms (after Cook County, Ill., and Honolulu County, Hawaii, respectively).


Collectively, Los Angeles County was home to 631,218 minorityowned firms: 332,967 Hispanic, 213,203 Asian, 81,563 black or African American, 11,081 American Indian and Alaska Native, and 3,798 Native Hawaiian and Other Pacific Islander. Consequently, with 3.2 percent of the nation's total population (according to the Census Bureau's July 1, 2012, population estimates), the county was home to 7.9 percent of its minority-owned businesses in 2012.

The majority of firms in Los Angeles County (55.0 percent) were minority-owned. This includes 29.0 percent Hispanic-owned, 18.6 percent Asian-owned, 7.1 percent black or African American-owned, 1.0 percent owned by American Indians and Alaska Natives, and 0.3 percent Native Hawaiian and Other Pacific Islander-owned.

These findings for Los Angeles County are an example of the local analysis possible using the final, revised statistics from the 2012 Survey of Business Owners.

Nationally, findings show the number of minority-owned firms in the U.S. rose from 5.8 million in 2007 to 8.0 million in 2012. This includes a 46.3 percent increase in the number of Hispanic-owned firms over the period, from 2.3 million to 3.3 million, and a 34.5 percent rise in the number of black or African American-owned firms, from 1.9 million to 2.6 million. Additionally, the number of Asian-owned firms climbed from 1.5 million to 1.9 million, an increase of 23.8 percent. For added context, total U.S. firms increased 2.0 percent during the same period, from 27.1 million in 2007 to 27.6 million in 2012.

The 9.9 million women-owned firms in 2012 were up more than 2 million from five years earlier when there were 7.8 million womenowned businesses, a 26.8 percent increase. As a comparison, maleowned firms increased 6.8 percent from 13.9 million to 14.8 million during the same period. The Survey of Business Owners is a sample

- Pay family-sustaining prevailing wages and ben-
- · Harmonize safety protocols at work sites; and
- Help create careers in construction.

"The Sewer System Improvement Program presents our City with unique opportunities to address chronic unemployment in communities impacted by construction projects," said Harlan L. Kelly, Jr., General Manager of the SFPUC. "Our new and improved Southeast Wastewater Treatment Plant will revitalize the Bayview, improve the quality of life for residents and create goodpaying jobs for San Franciscans."

Even with the bulk of the construction still to come, SSIP has already been an economic success for San Francisco workers:

- 37% of the work and 77% of all apprentice hours have been performed by SF residents;
- Women living in Supervisorial Districts 10 and 5 represent 95% of the total hours worked by women on SSIP projects thus far;
- \$100 million awarded to San Francisco-based community businesses;
- 50% of all subcontracting dollars have been awarded to Local Business Enterprises (LBEs); and,
- Of the total amount awarded to LBEs, 52% went to Minority-owned Business Enterprises (MBEs), 25% went to Women-owned Business Enterprises (WBEs) and 23% went to Other Business Enterprises (OBEs).

PLAs are more than just economic ladders up; they also establish protocols that help ensure projects are delivered safely, both on-time and on-budget.

This specific SSIP PLA is an extension to the historic Water System Improvement Program (WSIP) PLA originally signed in 2007. The WSIP continues to have a tremendous, positive impact on our local and regional economies. Through June 2016, on WSIP PLA-covered projects, more than 12,600 workers have earned \$460 million in wages and benefits. With WSIP winding down, SSIP will be the new job-creating engine, and unlike WSIP, SSIP will be entirely within the City.

"We are proud of the performance of the Water System agreement that we are extending. We have performed high-quality work on complex projects in the safest and timeliest manner, and as a result the City and its regional partners are assured of a secure and healthy water supply," said Michael Theriault, Secretary-Treasurer of the San Francisco Building and Construction Trades Council. "We have also provided entry into lifelong careers for scores of young men and women from underprivileged communities. We look forward to more success in our continuing collaboration with the San Francisco Public Utilities Commission.

# PNC Bank agrees to pay U.S. \$9.5 million to settle claims over small business loans

PNC Bank will pay \$9.5 million to settle claims by the U.S. Department of Justice in connection with loans guaranteed by the U.S. Small Business Administration.

The Justice Department said the bank failed to adhere to SBA requirements when it approved 74 SBA-guaranteed loans that were brokered by Jade Capital & Investments LLC. The bank failed to demand adequate bank and IRS tax records from borrowers or to apply "prudent" lending standards, the Justice Department said.

When the loans went into default, Pittsburghbased PNC then sought payment on SBA guarantees even though certain requirements were not met, the department said. The settlement was announced Tuesday by Maryland U.S. Attorney Rod J. Rosenstein.

Fred Solomon, a PNC spokesman, said the bank denies the allegations and was a victim of the fraud. The bank settled to avoid further costs of litigation, he said.

"The Jade principals carried out a fraud they successfully concealed from SBA and other lenders for years," Solomon said.

Under the SBA Act, banks partner with the agency to make loans to small businesses. If a borrower defaults, the SBA guarantees to repay the lender 75 percent of the loan balance.

"Banks that are trusted to make loans backed by the SBA have a duty to apply proper lending standards, because the United States is obligated to pay when federally-backed loans default," Rosenstein said in the announcement. "The government will vigorously pursue lenders that fail to enforce reasonable lending standards and stick the taxpayers with the bill for bad loans."

In 2006, some of Jade Capital's loans went into default and the SBA paid some of PNC's guaranty

claims. The Maryland U.S. Attorney's Office subsequently prosecuted Jade Capital principal Joon Park and others for conspiring to commit bank fraud by fraudulently obtaining SBA-backed business loans that resulted in losses of more than \$100 million. Park and other defendants admitted in plea agreements that they created and submitted false and fraudulent documents to secure PNC's loan approval and were convicted.

Solomon said the government had alleged in the criminal cases that PNC was a victim and never said the bank knew about the fraud.

# How Minority Entrepreneurs Can Tackle Business Loan Challenges

For minorities looking to become small business owners — or for established ones looking to expand — there can be obstacles involved in taking that next step.

In 2015, Inc.com shared an Associated Press report on loan rejections by minority candidates: A survey showed that 23 percent of Asian business owners had been rejected, 20 percent of black business owners and 19 percent of Hispanics. All three percentages were higher than the general owner number (14 percent).

"If you ask any small business what their No. 1, 2 and 3 concern is, it will be access to capital," according to Ron Busby, head of the US Black Chambers Inc, in the AP story. "As you relate to black businesses, it's their No. 1, 2, 3, 4, 5 and 6 concerns in reference to growing, starting or expanding their firms," Busby said.

There is also this report by Fundera, which examined a study by Brigham Young University. The project gathered nine people to apply for small business loans totaling \$60,000. Three of the nine were black, three were white and three Hispanic. All were supplied with the same background information and business type. But the nine did not receive equal treatment.

"... The minority loan applicants received less information about loans and less assistance from loan officers, and were asked more questions about their personal finances," the story says.

Here's a look at how minority entrepreneurs can approach the loan process, and several avenues that may help to achieve small business loans.

#### Be prepared

It's important to get organized before seeking out a loan. Here are several tips from Fundera for minority business owners.

- Credit score: No surprise here the higher the better. "Lenders know that you, the owner, is most likely paying the loan back, so they want to know how you've historically dealt with debt."
- Cash flow: A logical concern for lenders.
   "They'll look at things like your bank statements to figure this out. If you have a lot of overdrafts or NSFs, that might make them worry."
- Revenue: The amount of money coming in will be a big factor in a lender's decision. "Lenders want to know that you're making enough to afford the loan. Revenue requirements vary by lender, but many have hard minimums. Be sure to ask a lender what their requirements are if you're not sure if you'll qualify."
- Longevity: An established business can have a better shot at getting a loan. "Lenders want to know you'll be around to pay them back."

#### Online lenders vs. banks

The old-school manner of getting a loan usually went through a bank. That's still a legitimate route, but online lenders may be a better option. As Steve Nicastro writes for nerdwallet.com, online lenders are usually faster, "and with less stringent requirements."

"The cost for this convenience is a higher APR," he says. "These lenders don't specialize in minority clients, but if you don't qualify for a bank loan because you have bad credit or a limited business history, or you don't have any collateral — or you simply can't afford to wait months for financing — they provide a good option."

#### Options by credit score

As mentioned, credit score can mean a great deal in the loan process. But just because it isn't as high as you'd like doesn't mean there aren't possible loan avenues to examine. Nicastro breaks down possibilities for different scores in his nerdwallet. com story. For example:

 A business owner with a year or more in business and a credit score of 600 or higher can work with StreetShares: "It's also a good option for veterans; more than 60 percent of StreetShares' borrowers are former service members. Owners of more established businesses who can afford to wait longer for financing can turn to SmartBiz, which provides Small Business Administration loans at a faster pace than traditional banks. You'll need relatively high annual revenue to qualify."

• For those with a 500 and higher score: "Kabbage, which doesn't have a minimum credit score requirement, is a good option for business owners with poor credit who need fast cash for working capital. The lender provides lines of credit that you can tap into and repay on an as-needed basis. Business owners looking for expansion financing can turn to OnDeck, which offers term loans of up to \$500,000 and requires a minimum personal credit score of 500."

#### Explore what's out there

It may take some digging, but there is an array of available loans that can benefit minority businesses. Fundera has a list of 28 options. Here's a sample:

- Small Business Administration: The SBA's Community Advantage loan "encourages local, mission-based lenders such as nonprofit organizations to make loans of up to \$250,000 by guaranteeing up to 85 percent of the loan amount. The program is designed to service small business owners who might not qualify for traditional financing, so it is a great option if you are looking for minority business loans." Additionally, the Fundera list includes the SBA's microloan program for those seeking \$50,000 or less
- National Minority Supplier Development Council: This organization assists in getting people certified as minority business owners, and then providing networking opportunities with corporate partners, according to Fundera. "Once you are MBE-certified and have a supplier and/or vendor relationship with one of NMSDC's national or regional corporate



members, you can access working capital loans, specialized financing and long-term financing through the NMSDC's partner companies. It takes a little work to get there, but is a great source for small business loans for minorities."

- POWER: This stands for Partnerships for Opportunity, Workforce, and Economic Revitalization, which was started by President Barack Obama. The goal: "... to help communities hurt by the changing power industry. Look into the block grants the federal government awarded to state and local institutions, and if you're nearby, see if you can snag a contracting opportunity or second-hand grant from them."
- MillerCoors Urban Entrepreneurs Series: This is a grant program that, as Fundera clarifies, is not just for minority business owners. But it "focuses on diversity in entrepreneurship, which can be a good option if you are looking for minority business loans. They award up to \$150,000 to five winners, plus the consumer's choice award grant of \$10,000."
- National African American Small Business Loan Fund: JP Morgan Chase and the Valley Economic Development Centers team up for this program. It serves "minority-owned small businesses in low- or medium-income communities in New York, Los Angeles, and Chicago, providing access to capital, financial consulting, and technical help."





# Los Angeles County a Microcosm of Nation's Diverse

survey that provides the only comprehensive, regularly collected source of information on selected economic and demographic characteristics for businesses and business owners by gender, ethnicity, race and veteran status. Today's release provides data at detailed geographic (nation, state, metropolitan area, county and economic place) and industry levels (two-digit through six-digit industry coding level). In August, preliminary data were published for these groups at the national, state and two-digit sector levels.

Other highlights from the final 2012 Survey of Business Owners data:

#### Women

- There were 9.9 million women-owned firms nationally in 2012, up from 7.8 million or 26.8 percent from 2007.
- Nearly 90 percent (89.5 percent) of womenowned firms were nonemployer firms (businesses with no paid employees). This is higher than the total proportion of nonemployer firms, which is 80.4 percent (22.2 million nonemployer firms)
- Receipts for women-owned firms rose 18.7 percent, from \$1.2 trillion in 2007 to \$1.4 trillion in 2012.
- While women-owned firms accounted for 35.8 percent of all U.S. firms, they constituted the majority of firms in the health care and social assistance sector (62.5 percent), the educational services sector (54.2 percent), and the other services sector (51.8 percent). For comparison, women accounted for 51.4 percent of the 18 and older population in 2012.
- California led all states in the number of women-owned firms in 2012, with 1.3 million. Proportionately, the District of Columbia led all states with 42.7 percent of all firms owned by women.
- Los Angeles County had more women-owned firms than any other county in 2012 with 439,513.

#### Minorities

- There were 8.0 million minority-owned firms nationally in 2012, up from 5.8 million, or 38.1 percent, from 2007.
- Receipts for minority-owned firms climbed from \$1.0 trillion to \$1.4 trillion over the 2007-2012 period (34.7 percent).
- All but 908,800, or 11.4 percent, minority-owned firms in 2012 were nonemployers.
- Minority-owned firms accounted for 28.8
  percent of all U.S. firms in 2012; in the other
  services sector and the transportation and warehousing sector, this percentage rose to 43.8 percent and 43.3 percent, respectively.
- California led all states with 1.6 million minority-owned firms in 2012. However, proportionally speaking, both Hawaii and the District of Columbia outranked California with 62.6 percent and 47.3 percent, respectively. California was comprised of 45.6 percent minority-owned firms in 2012.

#### Hispanics

- There were 3.3 million Hispanic-owned firms nationally in 2012, up from 2.3 million, or 46.3 percent, from 2007.
- All but 287,501, or 8.7 percent, of Hispanicowned firms were nonemployers in 2012.
- About half (49.1 percent) of Hispanic-owned firms in 2012 were owned by people of Mexican, Mexican-American, or Chicano background. California and Texas were the only two states with over half a million firms owned by people of Mexican, Mexican-American, or Chi-

cano background, with 580,450 and 557,273 firms, respectively.

- Florida led all states in the number of firms owned by people of Cuban background (224,878) and Puerto Rican background (71,291).
- Although Hispanic-owned firms comprised 12.0 percent of all U.S. firms, they made up 22.8 percent in the administrative and support and waste management and remediation services sector. For comparison, Hispanics accounted for 14.8 percent of the 18 and older population in 2012.
- The number of Puerto Rican-owned firms grew faster between 2007 and 2012 (65.0 percent) than Mexican, Mexican American, or Chicanoowned (56.8 percent) and Cuban-owned firms (12.4 percent). Other Hispanic, Latino, or Spanish-owned firms grew 44.1 percent.
- Three states California, Texas and Florida — each had more than a half-million Hispanicowned firms in 2012. California led the way with 815,304. Texas had 687,570 Hispanicowned firms and Florida had 604,128 Hispanic-owned firms.
- Close to a third, 30.7 percent, of firms in New Mexico were Hispanic-owned — the highest rate in the nation. Hispanic-owned firms also comprised more than one-quarter of all firms in Texas and Florida (29.2 percent and 28.8 percent, respectively).
- In 2012, Los Angeles County led all counties in the number of Hispanic-owned firms (332,967), followed by Miami-Dade County, Fla. (319,653). In 2007, the order of the two counties was reversed.
- Among the 50 most populous U.S. cities, New York had the most Hispanic-owned firms with 199,085. El Paso and Miami had the highest proportion of Hispanic-owned firms with 73.9 percent and 69.2 percent, respectively.

#### Blacks or African Americans

- There were 2.6 million black or African American-owned firms nationally in 2012, up from 1.9 million or 34.5 percent from 2007.
- All except for 109,137 or 4.2 percent, of black or African American-owned firms were nonemployers.
- While 9.4 percent of all U.S. firms were black or African American-owned, the largest percentage was 19.2 percent in the health care and social assistance sector. For comparison, blacks or African Americans accounted for 13.1 percent of the 18 and older population in 2012.
- The Atlanta metro area had more black or African American-owned firms (176,245) in 2012 than any other metro area besides the New York metro area (250,890).
- Georgia had more black or African Americanowned firms in 2012 than any other state (256,848), followed by Florida (251,216).
- Cook County, Ill., led all counties in the number of black or African American-owned firms, with 110,155.
- The District of Columbia, Mississippi and Georgia were the only states where more than one-quarter of all firms were black or African American-owned (34.8 percent, 27.7 percent and 27.6 percent, respectively).
