Lacking the extensive resources and contacts of large companies, small businesses often fine themselves at a competitive disadvantage. As a small business owner and a lobbyist for small, minority-owned businesses, Gerald Johnson, co-founder of Small Business Exchange (SBE), understands this

He and his wife, Valerie Voorhies, established SBE in 1984 to reduce the information gap between small and large companies by providing small businesses with information on bid opportunities in the public and private sectors. Today, SBE offers the most extensive small business information database in California and publishes two weekly 40+ page newspaper filled with bid listings. Circulation has tripled since 1985, and the newspaper outsell all other weeklies and small business trade publications. With nearly \$2 millions in sales this year, SBE is positioned to grow to \$10 million in three to five years.

To manage its rapid expansion in bid opportunity tracking, database management, and desktop publishing, SBE uses an AS/400 F20, which provides the necessary processing power, response time, and storage to satisfy its customers' requests for information.

The Information Market

To compete with large companies, small ones need accurate, up-to-date information on public private contract load of information made is inaccessible to the small business owner – until SBE came along.

San Francisco-based SBE now publishes two weekly newspaper, Construction Outreach and Products and Services.

Covering both the public and private sectors and containing thousands of bid listings for construction, commodities, and business and professional services, the two newspapers "disseminate strategic information and alert subscribers to billions of dollars worth of work each year", Johnson says.

Knowing the importance of speed and accessibility, SBE also offers extensive online information and business outreach services. The result of SBE's efforts is an information bridge between government, corporations, banks--and the small businesses that have traditionally been undervalued and overlooked.

Building on the AS/400

When SBE published its first newspaper in March 1985, the company used proprietary hardware and software for bid opportunity tracking, database management, and desktop publishing. But when its suppliers went out of business a few years later, SBE realized the need to establish a secure computing platform on which to build its


SBE evaluated prospective vendors for longevity, service, and the ability to handle its current database needs plus 25 percent yearly growth. Intrigued by a series of Wall Street Journal articles highlighting the AS/400 and its data-crunching capability, Johnson added it to the list and the AS/400 emerged at the top.

Impressed with the AS/400 open systems approach and IBM's reputation for reliability, SBE purchased an AS/400 B20 in 1989, moved to a D20 two years ago and recently upgraded to

Minority Grants for Small Business Start-ups

Funding a business start-up is a major hurdle for most aspiring entrepreneurs. Many minority entrepreneurs give in to the appeal of minority grants in the belief that grant funds are available to help start minority businesses. In fact, minority business grants are more myth than reality. Government agencies do not have the legal authority to award grants for privately owned minority business start-ups and expansions.

Government Grant Basics

Federal and most state agency grants go primarily to fund programs serving a public purpose and that fit the activities of the granting agency. Some government grants help minorities attain necessary skills and training to be successful business operators. Others fund projects that stimulate economic development and job creation in under-served communities. Grant recipients are usually other government agencies, nonprofit organizations, educational institutions and for-profit companies skilled in business consulting.

Grant funds are available from the federal government for established small and minority businesses active in research and development. Small Business Innovation Research and Small Business Technology Transfer grants are intended to help fund small business research and development projects that advance the mission of the granting agency. SBIR and STTR grants always have strict federal performance and reporting guidelines.

Tax Law Snags

It is theoretically possible to find a foundation grant that funds minority business start-ups but highly improbable. Tax laws generally forbid foundations from awarding grants to for-profit businesses except for specific projects without jeopardizing the foundation's tax-exempt status.

Options for Funding Your Business Start-up

Professional advice on your financing options is available from reliable agencies, such as the Minority Business Development Agency and the Service Corps of Retired Executives. MBDA, part of the U.S. Department of Commerce, operates Minority Business Centers throughout the country. These agencies employ business consultants who are dedicated to helping minorities start and grow businesses. SCORE provides the same services as MBDA, but operates on a non-racial basis. According to its website, SCORE is a resource partner with the U.S. Small Business Administration and has been mentoring small business owners for more than 40 years.

Get Prepared

Assemble relevant information about yourself and your business proposition before meeting with one of the MBDA or SCORE consultants. At a minimum, you should have your personal financial information, including tax returns for the past three years and a business plan for your business start-up. Both MBDA and SCORE offer free business plan templates on their websites.



The Authority's Board of Directors previously approved the S/DBE Program with an amendment to include a 3 percent Disabled Veteran Business Enterprise (DVBE) goal within the overall 30 percent small business goal.

"This action by the Board ensures that small, disadvantaged and disabled veterans' businesses will be the backbone of the highspeed rail project. In doing so, we can be sure that the nation's largest infrastructure project will benefit from the creativity, diversity and commitment of the State's small business community," said Jeff Morales, Chief Executive Officer of the High-Speed Rail Authority.

Also announced was the appointment of Robert Padilla as the Authority's Small Business Advocate. Most recently Padilla was the DBE Program Manager for the California Department of Transportation and prior to that he served as Assistant Deputy Director for the Governor's Office of Economic Development.

"The Authority is committed to a robust and effective outreach to increase participation by California's small businesses in the high-speed rail project. The Small Business Advocate will be a key to our success in achieving this goal," said Morales. The advocate's office will be located in Fresno.

Contractors, small businesses meet about high-speed rail

About 500 small-business representatives from throughout the San Joaquin Valley and California met with potential prime contractors Tuesday in Fresno in hopes of finding work building California's high-speed train system.

An industry forum at the Save Mart Center outlined the latest plans for construction between Fresno and Bakersfield. It also served as a networking session for small businesses seeking work as project subcontractors.

"You all have a lot of experience, and we want to take advantage of that," Hans Van Winkle, construction manager for the statewide high-speed train project, told the audience.

The California High-Speed Rail Authority has set a goal for its prime contractors to promote subcontracting with small businesses and businesses owned by women, ethnic minorities or disabled veterans. The agency wants 30% of its work to go to those small businesses.

Five teams of contractors are putting their bids together for the first section of construction from Madera to the south end of Fresno -- a contract that is expected to be worth \$1.5 billion to \$2 billion.

Those bids are expected to be submitted in October, said Jeffrey Morales, the authority's CEO.

Tuesday's forum was to highlight work on three additional construction segments from Fresno to north of Bakersfield. About a dozen prospective prime contractors from the U.S., Europe and South Korea, including some that are expected to bid on the first segment, were on hand to meet with small-business owners.

The statewide system is planned to span 520 miles and connect Los Angeles and San Francisco with high-speed trains within 10-15 years. The price tag is estimated at \$68.4 billion.

Ed Johnson of Mariposa was on hand to drum up business for his group, Edward J. Johnson Affiliates, "to prevent things from running into delays" by providing dispute-resolution services to prime contractors as they negotiate with landowners and other contractors.

"We're hoping we can give someone the advantage of helping them meet their 30% small-business goal," he said.

Jack Ybarra and his company, Transmetrics Engineering and Construction Management, brought a team from his Campbell headquarters to meet with prime contractors.

"We need work, and this is the kind of work we do," he said. "This is the biggest public works project, and it will allow me to do what I do best, and that's hire people."

Engineers and contractors aren't the only ones hoping to find work on the Valley stages of construction.

Craig Chenot, an estimator with Clovis-based D/C Recycling and Trucking, said that being selected to move heavy equipment, haul away demolition materials and provide other transport needs could allow his company to hire 100 or more truck drivers full time.

But, he added, it falls to the small-business owners to make their best pitch to compete for business and keep the attention of the prime contractors. "You've got to stay on the ball, or you're going to miss the train," Chenot said.

Not officially present was China's second-largest railroad builder, the state-owned China Railway Construction Co., or CRCC. But Jeffrey Chang of Beijing-based Prometheus Partners said CRCC and other Chinese firms are interested in competing for work on the statewide rail project.

CRCC was part of a consortium tasked by China's Ministry of Railways to explore the California high-speed rail market in early 2011.

But a high-profile crash on China's high-speed train system last summer, in which 40 people died and 191 others were hurt, dampened China's enthusiasm for exporting its technology.

Even before the crash, Chang added, the nation's efforts were hindered by a political corruption scandal that resulted in the arrest of the rail minister and the ouster of one of his chief deputies. Chang said he didn't know if CRCC or other Chinese companies would enter the bidding for the Valley sections of high-speed rail construction.

He added, however, that China remains intent on competing for business for other stages of construction in the state.
