One billion in potential contract dollars lost annually by businesses owned by women and people of color due to Proposition 209

California's minority and women business enterprises (MWBEs) have lost the potential equivalent of \$1 billion in public contracts because of Proposition 209, according to a report by the Equal Justice Society.

EJS released the report during an informational hearing by the California State Assembly Committee on Judiciary. The hearing also heard other testimony related to the impact of Proposition 209 on public contracting.

2016 will mark the 20th anniversary of Proposition 209, which ended the use of race and gender conscious decision-making in California in the areas of public employment, public education, and public contracting or procurement.

Proposition 209 not only ended race-conscious programs in California, it unnecessarily ended the collection of procurement data related to race, ethnicity, and gender in most jurisdictions of California that had previously been collecting that data. Therefore, the report states the potential loss of contract dollars due to Proposition 209 and not the actual dollars lost.

EJS commissioned Tim Lohrentz, an expert in affirmative procurement and supplier diversity, to author the report. Lohrentz was formerly the Director, Inclusive Business Initiative, with the Insight Center for Community Economic Development. Lohrentz was assisted by Michael Sumner, Ph.D., former Research Manager at the Thelton E. Henderson Center for Social Justice, UC Berkeley School of Law.

The report was made possible by a grant from the Surdna Foundation.

"Taxes from women and people of color help fund public contracts, but are denied equal opportunities to obtain those contracts, said Eva Paterson, EJS President. "We often tout the great economic engine of California, and public contracting is a major part of fueling that engine. This report clearly shows that Proposition 209

CJWG: California must protect vulnerable communities

Fourteen environmental justice, public health and climate equity organizations are calling on the state of California to make sure its plan for adapting to climate change addresses the needs of frontline communities that suffer first and worst. The Climate Justice Working Group (CJWG), supported by Resources Legacy Fund, released a series of guiding principles and recommendations for funding and policy decisions, along with results of a recent survey of California voters of color indicating that these voters overwhelmingly favor stronger government action to help their communities prepare for climate change impacts.

AB 398, the cap-and- trade extension recently signed by Gov. Brown, designates "climate adaptation and resiliency" as a priority that must receive funding from cap-and- trade revenue. An Assembly Budget Committee hearing Aug. 23 will begin the process of determining how these funds will be spent.

In "Advancing Climate Justice in California," CJWG emphasizes that frontline communities - including people of color, immigrants, people with lower incomes, those in rural areas and indigenous people - already suffer more from socioeconomic, health, and environmental injustices and have fewer resources to prepare for and recover from environmental impacts caused byclimate change. These communities have been largely excluded from policy and funding

U.S. Department of Transportation Announces \$500 Million Funding Opportunity through TIGER Program

The U.S. Department of Transportation today announced the opportunity for state and local stakeholders to apply for \$500 million in discretionary grant funding through the Transportation Investment Generating Economic Recovery (TI-

"The TIGER grant program is a highly competitive program whose winners will be awarded with the funding they need to rebuild the infrastructure of their communities," said Secretary Elaine L. Chao. "TIGER grants will continue to fund innovative projects that will improve the safety of America's passengers and goods.

The Consolidated Appropriations Act, 2017 appropriated \$500 million, available through September 30, 2020, for National Infrastructure Investments otherwise known as TIGER grants. As with previous rounds of TIGER, funds for the fiscal year (FY) 2017 TIGER grants program are to be awarded on a competitive basis for projects that will have a significant impact on the Nation, a metropolitan area, or a region. The FY 2017 Appropriations Act specifies that TIGER Discretionary Grants may not be less than \$5 million and not greater than \$25 million, except that for projects located in rural areas the minimum TI-GER Discretionary Grant size is \$1 million.

The selection criteria remain fundamentally the same as previous rounds of the TIGER grants program, but the description of each criterion was updated. Additionally, the FY 2017 TI-GER program will give special consideration to projects which emphasize improved access to reliable, safe, and affordable transportation for communities in rural areas, such as projects that improve infrastructure condition, address public health and safety, promote regional connectivity, or facilitate economic growth or competitiveness

To provide technical assistance to a broad array of stakeholders, USDOT is hosting a series of webinars during the FY 2017 TIGER grant application process. Webinars on How to Compete for TIGER Discretionary Grants will be held from 2:00 to 4:00 PM EDT on Wednesday, September 13th and Tuesday, September 19th. To register, please visit the TIGER Webinar Series webpage. Additional webinars will be scheduled and more information posted online.

The deadline to submit an application for the FY 2017 TIGER grant program is Monday, October 16.

Since the TIGER grant program was first created, \$5.1 billion has been awarded for capital investments in surface transportation infrastruc-

Census Bureau News - Hispanic Heritage Month 2017

In September 1968, Congress authorized President Lyndon B. Johnson to proclaim National Hispanic Heritage Week, observed during the week that included Sept. 15 and Sept. 16. In 1989, Congress expanded the observance to a month long celebration (Sept. 15-Oct. 15) of the culture and traditions of those who trace their roots to Spain, Mexico and the Spanish-speaking nations of Central America, South America and the Caribbean.

Sept. 15 is the starting point for the celebration because it is the anniversary of independence of five Latin American countries: Costa Rica, El Salvador, Guatemala, Honduras and Nicaragua. In addition, Mexico and Chile celebrate their independence days on Sept. 16 and Sept. 18, respectively.

Positives and Pitfalls of Online Lending

Are you thinking about using an online lender to finance your small businesses? If so, there are a few things you should know before you get started

A new breed of online lenders is transforming the lending space and providing new financing options for small businesses. These lenders offer new benefits, such as speed, ease-of-use and convenience. Upon filling out an online application, small business borrowers can be approved in minutes and have the money in their account in just days, whereas in the traditional banking model borrowers may not be approved for several weeks to even months.

Here are 4 different types of online lenders:

- 1. Online marketplace lenders act as a marketplace by connecting borrowers with institutional and individual investors, which is a form of crowdfunding. An online marketplace loan is similar to a bank loan, as they have fixed, multi-year loan terms and APRs; they're often referred to as term loans.
- 2. Another option is an **online cash flow lender**, which is focused short-term working capital. For this type of financing, lenders provide funding and use your future cash flow as collateral for the loan.

- 3. The next option is **merchant cash advances**. Merchant cash advance providers have been around for decades, and work by deducting a portion of every purchase made through your credit card payment processor. These can be among the most expensive loans you can take, and should be a last resort.
- 4. Lastly, there's **crowdfunding**. Crowdfunding is a new and evolving fundraising alternative that marries social media and finance. With crowdfunding, entrepreneurs reach out to the "crowd"—typically their friends, customers, supporters and social network—for funding. The idea is that lots of smaller sums of money can take the place of one or two large investors or lenders. The most successful campaigns inspire people to donate. Crowdfunding has added benefits beyond financing, such as marketing and customer engagement.

For many small businesses, going online for business solutions is becoming the norm. However, we highly recommend business owners proceed with caution when considering online financing. While there are responsible lenders in the space, there are others whose obscure terms can mask extremely high rates—the business version of payday lending. The problem is it can be hard to tell them apart, but we can help!

denied Black, Latino, Asian American, and women-owned businesses equal opportunities to contribute to our state's economic growth."

Lohrentz and Sumner found that MWBEs, which had been erasing the disparity between their availability and their utilization by participating in race- and gender-conscious programs, were heavily impacted by Proposition 209. Some of these businesses never recovered.

This study shows the following impacts in today's dollars due to Proposition 209:

- The loss of about \$820 million per year in MWBE contracts with the State of California;
- The loss of about \$200 million per year in MWBE contracts with the City and County of San Francisco, with some of this loss materializing immediately after Proposition 209 and additional losses following the 2004 Coral Construction case, which definitively ended San Francisco's race-conscious procurement program;
- The loss of about \$30 million per year in MWBE contracts with the City of Oakland;
- The loss of an estimated \$20 million per year in MWBE contracts with the City of San Jose following the 2000 Hi-Voltage Wire Works case, which definitively ended San Jose's race-conscious contracting program.
- The biggest losses occurred with the state of California and city programs in San Francisco and Oakland. Eventually some MWBE firms were able to gain back some of those contract dollars through race-neutral small business enterprise programs, but many other procurement and sub-contracting processes remain effectively closed to MWBEs due to the changes brought by Proposition 209.

Small businesses do big business with the federal government. Think about the possibilities of generating sales and revenue with the government. Remember, the U.S. government is the world's largest customer and it by law, is required to purchase items from small businesses. The Small Business Administration plays a major role in supporting businesses that want to work with the government. Learn whether or not your business qualifies and how to access these resources.

When working with the Small Business Administration, size matters! The size of your small business may seem relative but when working with the SBA there are standards to meet. A small business is defined 'either in terms of the average number of employees over the past 12 months, or average annual receipts over the past three years.' Also, all federal agencies use SBA's size standards, and therefore it's important to determine your NACIS code.

In addition, SBA defines a U.S. small business concern as:

- · Organized for profit
- Has a place of business in the U.S
- Operates primarily within the U.S. or makes a significant contribution to the U.S. economy through payment of taxes or use of American products, materials or labor
- · Is independently owned and operated
- Is not dominant in its field on a national basis

The business may be a sole proprietorship, partnership, corporation, or any other legal form. In

determining what constitutes a small business, the definition will vary to reflect industry differences, such as size standards.

The Small Business Administration's Office of Government Contracting & Business Development works with several federal agencies to award twenty three percent of all prime government contract dollars to small businesses. This requirement helps ensure federal agencies meet specific statutory goals for groups including:

- Women-Owned Small Business
- Service-Disabled Veteran-Owned Small Business (SDVOSB)
- Historically Underutilized Business Zones (HUBZone)

Additionally, SBA's 8(a) Business Development Program supports eligible socially and economically disadvantaged individuals in building and growing their businesses through counseling, workshops, and matchmaking opportunities with federal buyers.

Prior to bidding, your small business will need a D-U-N-S Number, a unique nine-digit ID number for the physical address of your business. It's free and required.

decisions and processes. CJWG recommends that the state do more to include the voices of frontline communities in its planning, and focus both funding and planning on protection of essential facilities that provide health care, food and emergency shelter; bringing economic opportunities into these most vulnerable communities; and avoiding negative consequences such as displacement.

CJWG points to the need for California to assess the vulnerability of its regions, looking at the many factors that could come into play, and use these assessments inform plans to build climate resilience in frontline communities by 2020. In addition, the state should identify and invest at least \$1 billion by 2020 and \$10 billion by 2025 to accomplish this climate resilience.

We need more spaces where frontline communities provide a roadmap for what is needed to achieve a sustainable, just and prosperous future. AB 398 left out these voices from the conversation, and, even with a well-intended inclusion of investment, does not assist refinery communities in their ability to adapt. In fact, AB 398 directly preempts local frontline communities from carrying out our pollution prevention plans. More genuine interactions are needed to protect lives, and that is why we are calling on state leaders to center the voices and needs of frontline communities in their climate resilience funding and policy decisions," said Ernesto Arevalo of Communities for a Better Environment, co-chair of CJWG.

"Environmental justice communities throughout the state bear a disproportionate share of the harmful impacts of longstanding policy priorities and investment practices. The result: unhealthy, unsafe environments that cut short our lives. This is a critical time to confront both challenges and opportunities posed by climate change in a way that prioritizes the needs of communities most often left behind," said Veronica Garibay of Leadership Counsel for Justice and Accountability, co-chair of CJWG.

The survey of 800 California voters of color conducted by EMC Research for Resources Legacy Fund found that two thirds believe that the effects of climate changes have already started, and 85 percent want state and local officials to adopt stronger policies to help their communities prepare for these impacts.
