#### Find a Mentor or Counselor

When you're in the initial phases of getting your small business off the ground, you could probably use some guidance and advice from a mentor or counselor. Experts are available to assist you through local offices and for specific purposes.

#### Steps to Finding a Mentor

Once you're ready to start a business, you'll have many important decisions to make. This is especially true in the first months of opening your business. You might worry that you'll have to make every decision on your own. Ultimately, you are responsible for the decisions you make, but you can always consult others to get guidance. A mentor could be an invaluable resource to you.

A mentor is someone who has been been down the same path you're taking. A mentor is experienced, successful and willing to provide advice and guidance—for no real personal gain.

But how do you find a mentor? Here are some steps for finding and working with a mentor for your new small business venture.

## Steps for Finding and Working with a Mentor

## 1. Government-Sponsored Mentor Organizations

You might be surprised, but the government offers a great deal of free resources and

services to support small business owners, both online and locally.

## The following are some organizations you can reach out to:

**SCORE:** Provides free and confidential counseling, mentoring and advice to small business owners nationwide via its network of more than 12,400 retired business executives, leaders and volunteers. SCORE is sponsored by SBA and has volunteers share their expertise through in-person and online counseling.

Small Business Development Centers: Provides management assistance to current and prospective small business owners.

Women's Business Centers: Provides business training, counseling and other resources to help women start and grow successful businesses

Minority Business Development Centers: Part of the U.S. Department of Commerce, the Minority Business Development Agency was created specifically to foster the establishment and growth of minority-owned businesses in America, with more than 40 centers nationwide.

#### 2. Trade Associations

Many trade associations operate mentor/ protégé programs that provide guidance to help you build your business. These mentoring programs are often conducted through a combination of formal one-on-one mentoring sessions and group networking and discussion opportunities with fellow protégés. Business owners might be connected with several different mentors over a period of several months to gain a more holistic experience.

Most industries are represented by trade associations, as are genders, ethnic groups and business types. If you need help finding a trade association, consult any internet search engine.

#### 3. Mentoring for Government Contractors

If your business plans to sell anything to the federal government, you know that it can be tough to get started. The good news is that the General Services Administration (GSA) offers a Mentor/Protégé Program that is specifically designed to encourage prime contractors to help small businesses be more successful in government contracting and

enhance their ability to perform successfully on government contracts and subcontracts.

#### 4. Look to Your Network

Who do you know? Is there a previous boss who was very inspiring to you or a friend who is a business owner? Ask that person to be your mentor or share his or her successes and struggles. You have nothing to lose. Just be prepared to share with them why you chose them in particular, your goals and what you are looking for from them.

One of the best ways to find a mentor who knows your industry, your community and comes with a great referral is to use your network.

#### 5. Working with a Mentor

If you decide to work with a mentoring organization, ensure there is a formal mentor/protégé structure in place.

If you are working with an individual you will need to work together to establish a mutually beneficial structured relationship.

## The following are some tips to remember about mentoring:

- Be organized, prepared and consistent. No one wants to waste their time. Time is precious
- Plan your mentoring sessions in advance. These could be as simple as having a one-on-one consultation or lunch meeting once a month to discuss where you are against your business goals, how best to tackle business obstacles, getting advice on business processes or regulatory requirements that you don't understand, and so on.
- Casual one-on-one sessions are good, but also have more structured sessions that address different aspects of starting, running, managing and growing your business.
- Take notes, own action items and review progress against these in your next session.
- Be respectful of your mentor's time. Use their insight and apply as you best see fit.
- And last but not least, be thankful and communicative about the value they bring.



## THE CITY OF LOS ANGELES



## The Los Angeles, CA DWP is a Supporter of Supplier Diversity

"Our suppliers come from all over the country as well as many parts of the world," says Albert Stephens, director of supply chain services

The Los Angeles Department of Water and Power (LADWP) is a municipally-owned utility. In 1983, then-mayor Tom Bradley issued Mayoral Directive 1-B, followed by Mayoral Directive 1-C in 1989, establishing the groundwork for the City's current supplier diversity program.

Albert Stephens, director of supply chain services, explains that as a municipally-owned utility, LADWP relies on certification from the City of Los Angeles Department of Public Works' bureau of contract administration, which is the central certifying agent for diverse vendors for the City of Los Angeles. "Our suppliers come from all over the country as well as many parts of the world," Stephens says. He notes that LADWP now also accepts certification by reciprocal Phyllis Palomino is compliance officer and manager of supplier diversity.certifying agencies.

Phyllis Palomino, compliance officer and manager of supplier diversity, administers and oversees the program at LADWP. She and her staff ensure that LADWP managers and contract administrators as well as potential M/WBE suppliers understand the goals of the LADWP program.

#### Doing business

"At the beginning of the outreach program we had no specific goals, we just did it," Stephens says with a smile. When the first goals were set, they called for 12 percent MBE and 4 percent WBE participation, but soon they were raised to the current 15 percent MBE and 7 percent WBE.

How does LADWP seek out diverse suppliers? There's an extensive outreach

program that includes supplier diversity expos and networking receptions for potential diverse firms, and connections with the Southern California Minority Business Development Council (SCMBDC), the local branch of the National Minority Supplier Development Council (NMSDC). Stephens has served on the board of the SCMBDC for a number of years.

LADWP also has relationships with other trade associations, and takes advantage of a database managed by the bureau of contract administration and the mayor's office of minority business opportunity.


#### Promoting debundling

The business world in general tends to favor larger contracts with fewer contractors. "It's a natural kind of industry occurrence," Stephens says. But not so much for LADWP: "Over the last decade or so our board of commissioners has consistently promoted debundling larger contracts into smaller portions. We want to make bidding more attractive to small and medium size firms that may have a limited capacity for bonds and insurance.

"Once capability and capacity to perform are defined and specified, we look for firms that can fill that need. Our work is open to MBEs, WBEs, and in some cases small business enterprises in general, depending on the scope of the engagement."

#### Engineering their own

A lot of the work on construction projects is not contracted out at all, Palomino notes. "LADWP is essentially an engineering company as well as a public works company. We have a substantial base of professional engineers at various

levels, so a lot of design and engineering work is done in-house. We're also a collective-bargaining-impacted utility and just about everyone here is represented by some employment association." So a lot of the hardcore construction work of a new substation or transmission line would be done by the utility's own employees.

For example, Stephens points out, "We are soon going to commission our first wind farm.

That project was done partially inhouse and partially by outside contractors, with labor forces brought in through the local unions." In general, he says, "There are many opportunities."

Who does the work may depend on the size and scope of the project and sometimes the level of expertise required in various disciplines.

#### Mirroring the ratepayers

LADWP is sensitive to the business value of its supplier diversity program. "It goes far beyond just compliance," Palomino explains. "In many cases our suppliers are also our ratepayers

and we try to mirror that. It's good business to do business with people who are doing business with us."

#### Meet Nelson Chui of Vistec Consulting

Nelson Chui, president and CEO, started his Vistec Consulting company in 2000. Nelson Chui is president and CEO of Vistec Consulting (Los Angeles, CA), a company he started in 2000. Vistec offers Southern California quality services in planning, implementing and administering IT. It's currently in the process of getting certified by the Southern California branch of NMSDC.

How the company came to work for LADWP "is a good story," Chui says with a smile. He was working as a contractor for another consulting company while starting up his own, and was sent to help LADWP design an e-procurement system.

"They really liked my work. I built a team for them and besides design I also did the development part." It was very successful, but because of contract problems it was never finished.

"So LADWP put the project out to bid again, but they liked my work so much that they put me in touch with all the companies that were bidding on the RFP, nine or ten of them. Eight of them named me specifically in their proposals!"

Today that new contract is in its third year of development. Chui is working as a direct contractor to LADWP as a technology and business consultant "because they wanted to keep me on the project," he says, but another sub is doing the

actual development.

#### Going strong

Vistec has about twelve techies on its fulltime staff, with more IT pros brought in as needed; the company's principals have about forty-six years of collective IT experience. The firm's prime strengths are technology consulting and development, and Chui adds some management consulting work with private businesses.

Vistec is also working for the Southern California cities of Monterey Park and Calexico, hosting their websites and email, writing some programs and helping them manage their IT.

#### **Starting out**

Chui was born in Hong Kong. He moved to Canada for the last two years of high school and went on to Simon Fraser University in British Columbia, Canada. He got his MBA from City University of Seattle (Bellevue, WA).

When he completed the MBA he went to work in Dallas, TX as a business analyst for a Toronto-based distribution company. The firm sent him to California to set up systems back when EDI was first coming in; eventually Chui became VP of ops.

But the job kept him traveling between Dallas, Toronto and California; finally he quit that job and took his IT and business expertise into consulting in California.

Next came his work for LADWP and the after-hours launch of Vistec. His jobs with LA and other Southern California cities have netted him a list of happy clients to give him sparkling references. "But no matter how much business you have," Chui concludes, "you're not just relying on contacts. You have to establish your own credibility."

## Facts about Employer Background Checks and **Credit Reports**

If you're considering hiring a new employee, it only stands to reason that you'd want to know a little bit about them. You'd like to have some information regarding their past, especially their work history, to see if they've been a good employee–after all, you don't want to hire a trouble-maker. Another aspect of an employee's past that may be of interest is their credit history. Your intention is to hire reliable people who will help you make a profit, so trying to find out about their past is a no-brainer and hopefully won't create any problems. Following are a few facts about employer background checks and credit reports.

#### You're Simply Being Careful

When you do a background check or request a credit report on a potential employee, you're simply being careful. It's your business, and you owe it to yourself to hire people who can be trusted. Your intention is to make a profit, and having people on the payroll who have a history of unreliability could jeopardize your business. If you're hiring for a corporation, you have a responsibility to the shareholders to hire only the best candidates for any given position. A person's past is usually a good reflection of how they'll handle themselves in the future, so the more information you have about a potential employee before you hire them, the better off the company is likely to be.

#### **Sensitive Positions**

A background check and credit history report are almost

mandatory if you're considering placing someone in a position of authority or if they're going to come in contact with information that could damage the company. Potential employees that will have access to sensitive areas of a business's operation need to be screened. That's only common sense. You need to know that the person you're hiring isn't likely to put themselves in a situation where they'd be susceptible to turning over confidential information to pay off a debt or simply to make a few bucks under the table. That sort of thing could severely damage your company.

#### Fair Credit Reporting Act

The Fair Credit Reporting Act (FCRA) was enacted in 1970 to help ensure the privacy of individuals. Prior to this law being passed, people didn't have access to the information compiled by the credit reporting agencies. Since that time, a person's credit report was available to them. Businesses had been using a potential employee's credit history for years, as a means of determining whether or not their past financial practices were likely to create an ongoing problem. If it was determined to be an issue, the person may not have been hired. With the enactment of the FCRA, people could see what their credit rating was and try to improve their score before seeking a job. You should still access a potential employee's credit record in order to help you determine whether or not they're financially responsible. If you determine that they're trying to improve themselves, you may be inclined to presume they'll be a dependable employee.

#### More than Money Matters

In addition to checking a person's credit history, many employers conduct a background check to find out if the person has been in trouble with the law or has otherwise created problems in their past. More than money matters to you as an employer, because your employees are the first line of contact with your customers. You want to make sure your employees are responsible people, who will conduct themselves appropriately. Finding out about a person's past by checking into their background isn't really prying; it's merely another tool in your attempt to operate your business profitably.

#### **Legal Issues**

It may be illegal to conduct a background check into a potential employee in some states. You may also not be allowed to check their credit report. Before you decide to do a background check or purchase a credit report, you should check with a lawyer to make sure you're not violating anyone's right to privacy. The laws regarding background checks and securing credit reports are in a state of flux, so you'd be well advised to do a little research before you begin the process. If you have any doubt as to the reliability of a potential employee, whether you're able to conduct a background check or look at their credit report, you might be better off erring on the side of caution and not hiring them.

## Legal 101 for New Ventures: What You Need to Know about the False Claims Act

If you're considering starting a small business, it's important to understand the False Claims Act. The False Claims Act is a part of United States law that has been around since the Civil War, and it essentially allows non-government workers to act on behalf of the government to report fraud by contractors. This reporting is often referred to as "whistleblowing," and in some cases, the whistle blower can sue the contractor on behalf of the government and receive a portion of the judgment. Before you begin your next business venture, consider the following:

#### Your Business Could Be at Risk

While most whistleblowers are honest in their actions and intentions, some are not. Because a whistleblower stands to gain financially from blowing the whistle, some choose to abuse the False Claims Act and make false claims themselves. This can then lead to an investigation and a lawsuit, even if you've done nothing wrong.

#### Keep Accurate Records

The False Claims Act was created to act as a protective measure for the government against contractors who knowingly cheat the system. As a result, your business needs to keep accurate financial records for every interaction it has with the government, as this will demonstrate your desire to be honest. If a dispute arises, your documentation can serve to show that you did not knowingly do something dishonest.

#### Install Checks and Balances

One of the best ways to protect your business from someone making false claims of fraud is to install checks and balances. This means that your company's finances need to be checked over by multiple people on a regular basis. Additionally, even if you yourself are not a financial professional, you need to be aware of exactly what is happening with your company's finances at all times.

#### You May Be Affected Directly

While the law offers differentiation between business owners and their businesses, this does not mean that you yourself will not or cannot be targeted under the False Claims Act. If someone is truly intent on making a false claim against your business, they may be willing to lie

about any number of things, including your personal involvement in the fraud. It should be noted that the False Claims Act is meant to not only catch overt deception, but also covert deception. If it can be proven in court that you had even the intent to commit fraud, you may personally

#### Seek Legal Advice

A segment of the law profession deals expressly with the False Claims Act. Engaging a whistleblower attorney is a responsible way to keep your business protected from false claims of fraud, either as you're starting your business or once it's already established, or both. During consultation, you can get a better understanding - and professional advice – about what is expected of your business when dealing with the government and its agencies, and this can help you to make stronger, more informed decisions regarding how your business operates. If you find your business being targeted under the False Claims Act, an attorney can also represent your interests in court.

Starting a small business can be an exciting experience, but it should be done so with careful planning. By taking steps to protect yourself and your business now, you're sure to be more successful in the future.

## Starting a Business? 10 Steps Every Entrepreneur Needs to Know

Did you know that home-based businesses are required to hold permits to operate legally in most states? What about incorporation? Many new businesses assume they need to incorporate or become an LLC from the get-go – but the truth is, more than 70 percent of small businesses are owned by unincorporated sole proprietors (although even this group is required to register their businesses).

So, variables aside, there are still some fundamental steps that any business needs to follow to get started. SBA has compiled 10 steps that can help you plan, prepare, and manage your business – while taking care of the startup legalities. Not all these steps will apply to all businesses, but working through them will give you a sense of what needs your attention and what you can check off.

#### Step 1 – Write a Business Plan

Yeah, yeah, you know you should write a business plan whether you need to secure a business loan or not. The thing is, a business plan doesn't have to be encyclopedic and it doesn't have to have all the answers. A well-prepared plan – revisited often – will help you steer your business all along its growth curve. Try to think of your business plan as a living, breathing project, not a one-time document. Break it down into mini-plans – one for marketing, one for pricing, one for operations, and so on. Take a look at SBA's Business Planning Guide for more ideas.

#### Step 2 – Get Help and Training

Starting a business can be a lonely endeavor, but there are lots of free in-person and online resources that can help advise you as you get started. Check out what's offered at your Small Business Development Centers; SCORE (which offers free mentoring services); Women's Business Centers, or your local SBA office.

#### **Step 3 – Choose Your Business Location**

Where you locate your business may be the single most important decision you make. Many factors come into play such as proximity to suppliers, the competition, transportation access, demographics, and zoning regulations. #### Step 4 - Understand your Financing Options

You may choose to bootstrap, fall back on savings, or even keep a full-time job until your business is profitable, but if you are looking for an external source of financing, these resources explain your options.

#### Step 5 - Decide on a Business Structure

Going it alone or forming a partnership? Thinking of incorporating? What about an LLC? How you structure your business can reduce your personal liability for business losses and debts. Some choices can give you tax benefits. To help you determine the right structure for your business, here's an overview of your options and some information on how to file the necessary paperwork in your state and the tax implications of your decision. You might also want to read:

#### Step 6 - Register Your Business Name ("Doing Business As")

#### Step 7 – Get a Tax ID

Not every business needs a tax ID from the IRS (also known as an "Employer Identification Number" or EIN), but if you have employees, run a business partnership, a corporation or meet certain IRS criteria, you must obtain an EIN from the IRS. You'll also need to start paying estimated taxes to the IRS; this blog explains more about this process.

#### **Step 8 – Register with Tax Authorities**

Employment taxes, sales taxes, and state income taxes are handled at the state-level. Learn more about your state's tax requirements and how to comply.
