

## California awards \$500 million in transit and rail project grants



The California State Transportation Agency approved a grant to BART to help it expand its Fleet of the Future with the purchase of additional rail vehicles.

Long planned transit and rail projects in California received a financial boost on April 21 with the awarding of \$500 million from the California State Transportation Agency for 17 recipients in the Transit and Intercity Rail Capital Program (TIRCP).

The \$500 million will support the purchase of new electric transit buses and new light-rail vehicles, expand service, facility construction and more.

The state explained funding for these projects will be provided for their design and construction and is complemented by investments of federal, local and other state funds. In total, the projects receiving funding leveraged more than \$4.9 billion in additional investment.

“The \$500 million in grant awards made today will increase transit service on new and existing routes, provide for a more integrated transit system, reduce greenhouse gas emissions and support jobs,” said California State Transportation

Agency Secretary David S. Kim. “Although the current COVID-19 pandemic is putting tremendous stress on transit agencies, these funds support long-term capital projects to be completed in the years to come and will help support the economic recovery in the years ahead.”

TIRCP funding is provided through the Road Repair and Accountability Act of 2017 (SB 1) and from the Cap and Trade program proceeds. The funded projects will provide significant benefits to Californians through expanded transit and rail offerings that are faster, more frequent and more reliable. The program also supports the state’s climate and air quality goals, with a total reduction of five million tons of greenhouse gas emissions.

The largest grant of \$107.1 million went to Bay Area Rapid Transit (BART) for vehicle acquisition associated with the Transbay Corridor Core Capacity Program. The project will expand the rail car fleet to 306 with the purchase of 34 vehicles to the completion of the Core Capacity Program, allowing rail service through the Transbay tube to increase from 23 to 30 trains per hour in each direction, as well as the operation of 10-car trains on all service in peak hours.

“We are grateful to the California State Transportation Agency and State Transportation Secretary David Kim for awarding this grant, which will play a critical role in expanding the Fleet of the Future and serving the Bay Area,” said BART General Manager Bob Powers. “Though our ridership has dropped dramatically due to the coronavirus pandemic, the agency recognizes that eventually riders will return to BART and we need to add more cars to address future demand for Transbay trips.”

A similar sized award of \$107 million was provided to the Los Angeles County Metropolitan Transportation Authority (LA Metro) and Southern California Regional Rail Authority (Metrolink) for the Metrolink Antelope Valley Line Capital and Service Improvements. The project will allow regular 60-minute bi-directional service on the full Metrolink Antelope Valley Line and 30-minute bi-directional service between Los Angeles Union Station and Santa Clarita.

The city of Inglewood was awarded \$95.2 million for the Inglewood Transit Connector (ITC),

## Veterans Receiving Benefits Who Aren't Required To File Taxes Will Now Automatically Receive \$1200 Stimulus Check

The Internal Revenue Service, working in partnership with the Treasury Department and the Department of Veterans Affairs, announced today that recipients of VA benefits will automatically receive automatic Economic Impact Payments.

Veterans and their beneficiaries who receive Compensation and Pension (C&P) benefit payments from VA will receive a \$1,200 Economic Impact Payment with no further action needed on their part. Timing on the payments is still being determined.

Moving VA recipients into the automatic payment category follows weeks of extensive cooperative work between VA, Treasury, IRS as well as the Bureau of Fiscal Services.

“Since many VA recipients typically aren’t required to file tax returns, the IRS had to work with these other government agencies to determine a way to quickly and accurately deliver Economic Impact Payments to this group,” said IRS Commissioner Chuck Rettig. “Additional programming work remains, but this step simplifies the process for VA recipients to quickly and easily receive these \$1,200 payments automatically. We deeply appreciate the sacrifices and service to our country by each and every veteran and their families, as well as the assistance of VA and the Bureau of Fiscal Services in this effort.”

### No action needed by most taxpayers

Earlier this month, the IRS took a similar action to ensure those receiving Social Security retirement or disability benefits, Supplemental Security Income and Railroad Retirement benefits can receive automatic payments of \$1,200. While these groups receive Forms 1099, many in this group don’t typically file tax returns. Many people in these groups are expected to see the automatic \$1,200 payments later this month, with SSI payments expected to start in early May.

For eligible taxpayers who filed tax returns for 2019 or 2018, they will also receive the payments automatically. About 80 million payments are hitting bank accounts this week.

### For benefit recipients with dependents, extra step needed to claim \$500 for children; Register now for earlier delivery

The law provides eligible taxpayers with qualifying children under age 17 to receive an extra \$500. For taxpayers who filed tax returns in 2018 or 2019, the child payments will be automatic.

However, many benefit recipients typically aren’t required to file tax returns. If they have children who qualify, an extra step is needed to add \$500 per child onto their automatic payment of \$1,200 if they didn’t file a tax return in 2018 or 2019.



For those who receive these benefits – including VA, Social Security retirement or disability benefits (SSDI), Railroad Retirement benefits or SSI – and have a qualifying child, they can quickly register by visiting “Non-Filers: Enter Payment Info” available only on IRS.gov. For those who can use this tool as soon as possible, they may be able to get earlier delivery of the child payments by having these added to their automatic payments.

By quickly taking steps to enter information on the IRS website about them and their qualifying children, they can receive the \$500 per dependent child payment in addition to their \$1,200 individual payment. If beneficiaries in these group do not provide their information to the IRS soon, they will receive their \$500 per qualifying child at a later date, depending on when they complete the registration process.

The Treasury Department, not the VA, will make these automatic payments. Recipients will generally receive the automatic payments the way they receive their current benefits.

### Information for recipients using the IRS.gov Non-Filer and Get My Payment tools

We recognize that many non-tax filing beneficiaries have already begun using the “Non-Filers: Enter Payment Info” tool to provide basic per-

sonal information to receive their EIP. There will be no interruption to payments being processed using this portal, and Veterans with internet access are encouraged to continue providing information and track their EIP through the “Get My Payment” tool.

General information about the payment is available on the Economic Impact Payment Information Center section of IRS.gov.

### Watch out for scams related to Economic Impact Payments

The IRS urges taxpayers to be on the lookout for scams related to the Economic Impact Payments. To use the new app or get information, taxpayers should visit IRS.gov. People should watch out for scams using email, phone calls or texts related to the payments. Be careful and cautious: The IRS will not send unsolicited electronic communications asking people to open attachments, visit a website or share personal or financial information. Remember, go directly and solely to IRS.gov for official information.

which will construct a 1.6-mile electrically powered automated people mover system and three new stations in the city. The city says the ITC Project will complete the missing link by providing a direct transit connection from the LA Metro Crenshaw/LAX Line's downtown Inglewood station to the city's new housing and employment centers and sports and entertainment venues.

San Bernardino County Transportation Authority (SBCTA) and Omnitrans were awarded \$15 million for the West Valley Connector Bus Rapid Transit Phase 1 & Zero-Emission Bus Initiative, which is the largest grant in this round of TIR-CP funding for a bus project. The \$287-million

project will construct a green, state-of-the-art bus rapid transit system that will improve corridor mobility, transit efficiency and provide clean and efficient transit service connecting the cities of Pomona, Montclair, Ontario and Rancho Cucamonga. The project will provide connections to the Ontario International Airport passenger terminals from the Metrolink San Bernardino Line in Rancho Cucamonga, as well as the Riverside Line at downtown Pomona.
