

7 Major Trends That Will Impact the Construction Industry

The construction industry is always changing and evolving. Every year new trends appear within the industry, from technological advancements to a stronger focus on sustainability. If you run a construction company and you want to make sure you stay ahead of the game, it can be useful to be aware of emerging trends that could prepare you for the future.

After all, many of the trends make construction work easier and more efficient, so if you aren't aware of them, you may find it hard to keep up with your competitors. While it can be difficult to know which trends will be more popular than others, there are a few important trends already starting to emerge. Here are seven major trends that will impact the construction industry over the next year.

1. More Technological Integration

Technology is one of the main factors pushing change in nearly every industry, but in some ways, the construction industry has managed to partially avoid this. However, recent advancements have resulted in technology that is specifically suited to construction; with more drone usage and 3D printing than ever before, it is likely the construction industry will embrace both these forms of technology.

In fact, the National BIM report of 2017 by the NBS found that people are having a very positive response to the technology. The report found that nearly 80% of the participants believe BIM is the future of project management, and a further 60% believe the technology has the ability to make projects more time efficient.

2. Increase in Prefabrication and Modular Construction Projects

Prefabrication and modular construction have both become more popular over the last year or so, and it isn't hard to see why. Both trends are energy efficient and cost-effective, which is ideal at a time when most material prices are rising, or high already! This popularity is likely to increase

even more over the next few months, especially for construction companies looking to cut overall costs. And with the help of effective hot melt adhesives and the overall ease of design, the actual construction of the homes is quite quick. So, you can expect to see a lot more permanent modular buildings in the future, as well as pop-up buildings and prefabricated homes.

3. Additional Focus on Sustainability

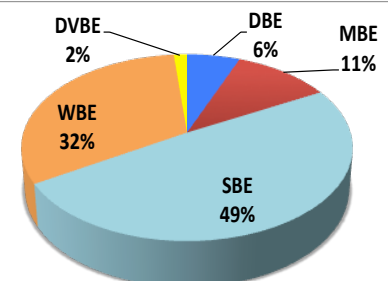

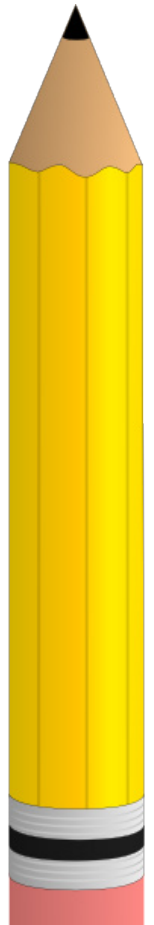

workplace accidents and fatalities, and this knowledge has resulted in an increased level of scrutiny on the industry. This scrutiny has resulted in the development of technology designed to make construction sites safer. 5. A Rise in the Popularity of Project Management Software

Arizona Leads Nation, Nevada Not Far Behind In Adding Construction Jobs

Over the last 12 months, and in tune with the national economy, states in the Southwest U.S. have been gaining jobs at a nation-leading pace, and June statistics reveal the trend is continuing.

“Construction is proving to be a reliable source of employment growth in nearly every state, and contractors are eager to hire even more workers,” says Associated General Contractors chief economist Ken Simonson in a release. “But finding qualified workers remains a significant challenge as other industries compete for talent, more workers reach retirement age, and fewer young adults chose to pursue careers in construction.”

Arizona and Nevada are among the states with the nation’s highest growth percentage of construction jobs.

According to the AGC, Arizona has gained more construction jobs than any other state percentage-wise from June 2017 to June 2018. Nevada is fourth in percentage increase over the same time period. New Mexico also posted a strong year-over-year percentage gain, ranking No. 11 in the nation.

Arizona

Arizona’s construction industry gained 4,500 jobs, the highest gain of all industries in the state from May to June 2018, according to data released by the Arizona Office of Economic Opportunity. That is twice as many jobs as the second category, professional and business services.

Year-over-year, the construction industry added 14,800 jobs, or about 10.2%, which is tops in the nation based on percentage increase. According to non-seasonally adjusted data, 161,300 work in the construction industry in Arizona as of June 2018.

Some notable projects underway in the Grand Canyon State include the LGE Design Build headquarters in Phoenix, Orbital and Intel campuses in Chandler and the Azure Mesa memory care facility.

Nevada

According to the Nevada Department of Employment, Training And Rehabilitation, the state’s employment agency, non-seasonally adjusted construction jobs total 91,400 for June, including 67,800 in the specialty trade contracting field and 15,700 on construction of buildings. Construction employment is second only to manufacturing increases in Nevada year-over-year, 6,400 jobs, or 7.2%. The percentage increase is fourth in the nation, trailing only Arizona, Georgia and Michigan.

From May 2018 to June 2018, the construction industry gained 1,200 jobs.

The Silver State is experiencing a boom in major sporting, casino, transportation and commerce projects, including in its biggest city: Las Vegas Raiders Stadium, Las Vegas Convention Center expansion project, Resorts World International and a Sephora Warehouse.
