Five myths about infrastructure

Myth No. 1

New infrastructure projects would reduce unemployment.

In his inaugural address, Trump vowed to "build new roads, and highways, and bridges, and airports, and tunnels, and railways all across our wonderful nation" and explained that we will "get our people off of welfare and back to work rebuilding our country with American hands and American labor." This is a familiar theme. President Barack Obama said essentially the same thing during his time in office.

While it is certainly true that more projects would mean more demand for man-hours of work, Americans are mostly already working, with the unemployment rate of roughly 4 percent at its lowest point in years. And while there is regional variation, the building trades are getting lots of work overall. It isn't clear that there would even be enough skilled American labor to undertake any massive infrastructure program without cannibalizing existing projects and driving up the price of construction by private enterprise, thus reducing incentives to create new jobs.

Myth No. 2

Regulations kill infrastructure projects.

In explaining his plans for rebuilding America during "Infrastructure Week," Trump proposed that "a few simple pages" of rules could replace

the current complex regulations, boosting infrastructure projects. Trump's promise echoed long-held conservative dogma that regulations, particularly environmental-review requirements, stifle major projects. For instance, in a report detailing alternatives for generating \$1 trillion in infrastructure investment, the conservative Heritage Foundation suggested "reforming regulations that hamper infrastructure projects.'

But if job data is any indication, regulations do not result in an overall reduction of activity in the infrastructure sector, though they may change what kinds of projects are undertaken.

Since the publication of Rachel Carson's classic book on environmentalism, "Silent Spring," 55 years ago, the implementation of regulations specifically environmental rules - has spurred infrastructure projects all over the country, from air pollution control to solar-power installations and more. In 2012, for example, a Marylandbased environmental group announced that cleaning up the Chesapeake Bay by upgrading sewage systems would create 240,000 jobs. And more regulations requiring, for example, smart grids to distribute renewable power would result in extensive project starts.

Myth No. 3

Private investment leads to infrastructure projects.

In his recent budget proposal, the president called for spending \$200 billion to "incentivize"

private investment to build infrastructure. Again, this is a familiar move. Obama regularly called for "leveraging" private companies to achieve a larger civil works agenda, focusing on an infrastructure bank that would organize this effort.

What Trump and Obama hoped was that investment in infrastructure equity by the private sector would fuel a building boom. What they have overlooked is that the private sector has always funded civil infrastructure by underwriting and buying municipal bonds, which allow local governments to borrow money from private investors in exchange for interest and tax benefits. What is now proposed is merely a different financing structure: private investment in equity — in other words, an ownership stake — in these public facilities, which supposedly will mean more new projects.

But this is a mistake. The mode of raising capital does not cause development. Projects happen either when there is an investable private opportunity or when the government levies a tax or authorizes a user charge, such as a toll, to fund the repayment of a capital investment. Private investment is a way to raise capital, but no evidence suggests that private investment itself causes projects to happen.

3 Places Women-Owned Businesses Turn for Financing

Male or female, finding financing for your small business can be daunting and time-consuming. Some research indicates women have a harder time securing small business loans than men, while other research says the gap is largest for those trying to raise investment capital.

Traditional funding from banks and credit unions is typically the most attractive in terms of both interest rates and repayment terms, but can be the hardest to get, especially for younger businesses and those looking for smaller loans. If you're a women- or woman-owned business and can't get your foot through the front door of the bank lobby, here are three alternative places to look for financing.

Community Lenders

There are many state and regional programs that provide funding to traditionally disadvantaged entrepreneurs, including women. These loans are often offered through Community Development Financial Institutions (CDFIs) and they usually come with valuable "technical assistance" training and consulting to help the business be successful. A few examples:

Working Solutions

This is a CDFI that serves nine Bay-area counties in California. It offers installment loans of \$5000 to \$50,000 with terms of three to five years, along with with free business coaching, advising and consulting for the life of the loan. Sixty percent of the loan portfolio is comprised of loans to women-owned businesses.

WomenVenture

The mission of this Minneapolis-based organization is "to help women attain economic selfsufficiency through the creation and growth of profitable and sustainable businesses." Through its Entrepreneurship Pathways program it offers a program that offers classes, consultation, networking and access to capital in the form of micro loans of up to \$50,000 for business startup and expansion costs. These loans are designed for clients unable to access capital from traditional lenders.

First State Community Loan Fund

This Delaware-based CDFI, "acts as the catalyst for providing in-depth, substantive, outcome-oriented business services to women entrepreneurs." It offers loans from \$20,000 to \$250,000 with a

focus on minority and women-owned businesses. It also operates a Women's Business Center and has developed a variety of programs for women entrepreneurs.

How do you find these programs? Your local Women's Business Center or Small Business Development Center can help. You can also check directories of microlenders through the Opportunity Finance Network CDFI locator.

Crowdfunding

There are four main types of crowdfunding: reward, debt, donation and equity crowdfunding. Each has its pros and cons, but all aim to make it easier for business owners with great ideas or products to reach a wide audience for funding.

The good news is that many women-owned businesses end up finding success with crowdfunding. A 2017 crowdfunding report by the National Women's Business Council, for example, found that 47% of successful campaigns on the popular crowdfunding platform Indiegogo were run by women. It also generally confirmed previous research that found that "women in general set lower funding targets but enjoy higher success rates" than men when it comes to crowdfunding. **Online Lenders**

You aren't likely to find online loans specifically reserved just for women-owned businesses. But at the same time, shopping online can make the process easier and open up a greater number of financing possibilities. Keep in mind that online business loan shopping sites may operate in a variety of ways:

Lead generation sites will simply gather your information then sell it to various lenders, which may
then call or email you with information or offers.

- Online lenders may offer a specific set of loan products aimed at specific types of borrowers (for example, those with significant credit card sales). Remember: just because you can't qualify with one lender doesn't mean you can't quality with others.
- Online brokers may try to help get you funding with various lenders with whom they have a relationship. They may charge a significant fee for this service, so be sure to ask.
- Online marketplaces will present you with options and allow you to choose which ones seem right for your needs. Ideally, you'll also see which loans are best matched to your qualifications. (Disclosure: Nav's small business loan marketplace operates this way.)

One advantage of online lending often especially

Myth No. 4

Infrastructure spending will spur growth.

The American Society of Civil Engineers annually issues a "report card" on the condition of American infrastructure. According to this year's report, we are not in good shape. What could fix our D-plus grade? The society reports that we need to close our "\$2.0 trillion 10-year investment gap" with a healthy round of infrastructure spending. According to the Treasury Department, these kinds of investments are important for "spurring growth."

During the global financial crisis, economists saw infrastructure spending as a better option than "throwing money out of helicopters" — metaphorically speaking — to goose the economy. They may have had a point at the time, but these days, U.S. economic growth is not particularly slow, so speeding it up would probably take more than spending on infrastructure (or throwing money out of helicopters). And though the condition of our existing infrastructure is generally appalling, that's a repair and maintenance issue, not a result of too little investment to begin with. (If we have gotten to the point of calling filling potholes and repainting bridges "infrastructure investment," then we have a bigger problem than we thought.)

Finally, it's not clear that an infrastructure boom would necessarily result in economic growth, especially not in the short term, when big projects can slow things down. For instance, a recent study of Uber trips in Melbourne, Australia, demonstrated that major transportation projects are creating significant traffic congestion. "You've got these very large projects ... that have a short-term impact on the travel pattern of a city," Brendan Lyon, chief executive of Infrastructure Partnerships Australia, told a Melbourne newspaper. And since congestion can slow economic growth, big projects shouldn't be deployed with short-term growth gains in mind.

Myth No. 5

We know what infrastructure we need.

With financing proposals on the table from the president and the Senate minority leader, among others, it seems we already know how we'd spend that capital. After all, if both parties want to drop \$1 trillion on infrastructure, presumably they know where it should go.

Contractors who can demonstrate experience, expertise and quality of work may be awarded a master agreement for a term of up to two years and not to exceed amount of up to \$250,000. The Contract Term may be extended up to 5 years to complete the work of issued CSOs, but no new CSOs will be issued after the first 4 years. When work is available, at least three contractors awarded a master agreement will be invited to submit a competitive quotation for the work. The contractor submitting the lowest responsive quotation may be awarded the Contract Service Order (CSO) to perform the work. There is no guarantee that a Contractor who has been awarded a master agreement will be awarded any CSOs.

No contractor or subcontractor may be listed in a bid or awarded a contract for a public works project unless registered with the DIR as required by Labor Code section 1725.5 [with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a)].

appreciated by time-starved female entrepreneurs, is the ability to shop for financing during nonbusiness hours. However, some options can carry very high interest rates and costs may be confusing since business lenders aren't required to state an Annual Percentage Rate (APR). Take advantage of free online small business loan calculators to translate costs to an APR.

Put Your Best Foot Forward

Credit requirements for the financing sources listed here vary widely. Crowdfunding platforms, for example, may not have minimum credit score requirements. CDFI's may be more forgiving of credit problems in the past. And online lenders vary; some have require good credit, while others are more interested in the revenue the business is generating. Regardless, it's a good idea to understand your personal and business credit scores before you begin shopping for a loan. Strong credit scores may increase your opportunities for lower-cost funding and make it easier to qualify.

How to Obtain Government Grants for Small Businesses

For most small business owners, the traditional avenues of financing include venture capitalists, angel investors, friends and family, and bank loans. One often overlooked method of financing is the government grant, which is usually provided for non-profit organizations. However, there have been instances when a for-profit business has been able to acquire a government grant. Some websites claim that acquiring a government grant is easy, resembling a get rich quick scheme you're likely to see on a late night infomercial. Quite the contrary - it's not, and requires an extraordinary amount of research and luck. Here are the steps you can follow to give it a try.

Where to Look and What to Avoid

First and foremost, avoid any websites that pop up on Google claiming that they can teach you "How to Get Grants". These are all simple rewrites of information freely available on the Catalog of Federal Domestic Assistance and Grants.gov. These websites have limited business categories in which they provide grants. However, contrary to popular belief, the U.S. Small Business Administration does not. Rather, the SBA offers loan programs for small businesses. The only grants it offers are for businesses which provide "business management", "technical assistance" or "financial assistance" to existing companies.

Narrow Niche Requirements

Be aware that most government grants are extremely specific with their requirements. An example requirement could read: "for minority business owners involved in transportation related contracts emanating from DOT - Disadvantaged Business Enterprises Short Term Lending Program". If you fail to meet any part of that requirement, then you're simply not eligible. However, due to a "life event" - for example, the death of a spouse - you could be eligible for government benefits, which could be in turn used to fund a small business. For more information, visit the government benefits portal. You may also have better luck with obtaining private grants - some small business owners have obtained grants from the Foundation Center's Foundation Grants for Individuals Online, a subscription based database for "students, artists, academic researches, libraries and financial aid offices" to obtain funding. However, entrepreneurs are not listed, but your business might be able to find a benefactor if your business piques their interest.
