

7 Construction Industry Trends to Expect in 2018

It's hard to believe, but 2017 is almost over.

What about Apple's new, sprawling 175-acre headquarters in Cupertino, California, which opened in April 2017 and has been nicknamed "The Spaceship" due to its circular design?

Chances are, you've accomplished quite a bit yourself this year, and are now turning your sights to bold new challenges in 2018.

As we head into the new year, it's important for you to understand the construction industry trends that may affect your business. We've got seven projections for 2018 to help you and your business put your best foot forward.

1. More 3D printing and drone usage

Technology is always the future, but exactly what type of technology are we talking about in the construction industry? The most likely candidates are 3D printing and drones.

Just a few years ago, 3D printing was a nascent technology used to create basic plastic models. Today? Its applications include building concrete houses in China. Engineers and Architects Gain Pass-Through Tax Deduction

The tax bill heading for adoption in Congress bestows one of its biggest and most controversial gifts—a 20% deduction for pass-through revenue—on the majority of U.S. firms that are partnerships, S-corporations and sole proprietorships.

The Senate and House versions of the tax bill excluded from the deduction architects, engineers, doctors, lawyers, financial services firms and numerous other types of businesses. Before, those type of companies were lumped together for tax purposes.

Instead, the engineers and architects lobbied key lawmakers. Their efforts were rewarded when a redraft of the compromise measure made a specific exception, tucked into the section on the deduction for pass-through entities, that entitles architects and engineers to the deduction.

The American Council of Engineering Companies, which represents 5,000 firms, argued for what staffers say was an “imperative” change.

The engineers lobbied key congressional and committee members, noting that the treatment

of engineers under the tax reform measure was inconsistent with another section of the tax code that recognizes such firms’ “integral role in facilitating capital investment” and, therefore, qualifies them for the proposed pass-through tax benefit.

Congress explicitly provided that engineering and architecture firms qualified for the Section 199 domestic manufacturing deduction, ACEC argued. “in contrast to other “specified services” industries such as law, accounting and financial services, engineering and architecture are the only industries that (a) lose a significant tax benefit (Section 199) and (b) are excluded from the proposed pass-through tax benefits, resulting in a net tax increase.”

In a Nov. 14 letter sent to Senate Finance Committee officials, ACEC said “there is no public policy justification for establishing a tax code that favors corporations over smaller firms, or one that creates arbitrary winners and losers among passthrough firms.”

Sen. James Inhofe (R-Okla.) proposed an amendment that would have peeled the architects and

engineers away from the other specified services firms, but that amendment “did not receive a vote, given the expedited consideration of the Senate bill,” said ACEC.

The American Institute of Architects also pressed for changes. It targeted conference committee members through AIA members in local districts, reaching out directly to other lawmakers through contacts on Capitol Hill or via member relationships. AIA also teamed up with engineering groups and distributed a letter.

The 20% deduction for pass-through entities is subject to income limitations; the breaks it provides real estate companies have made it a target of critics who say it will benefit, among others, President Trump. But the benefit for designers shows, as AIA President Carl Elefante said, “that the conferees listened to our members.”

Adds ACEC President and CEO David Raymond: “Achieving this equity was critical for our industry, and we are encouraged and pleased.”

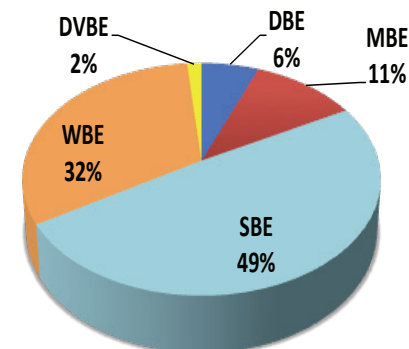

7 Construction Industry Trends to Expect in 2018

Continued from page 1

2. Increase in popularity of modular/prefab structures

We've talked before about the benefits of building modular homes. In 2018, expect the trend toward using more modular and prefabricated structures to continue.

Prefabrication has come a long way in recent years and is no longer limited to cheap, poorly constructed cookie-cutter designs. Top architects are getting involved in the prefabrication and modular construction business.

Similarly to the use of 3D printing, prefab and modular structures can help construction managers facing decreasing profit margins who are seeking innovative ways of lowering construction costs (and boosting profits).

3. Greater emphasis on green projects

Green is the new black in the world of construction. This trend is already a few years old, but expect it to continue past 2018.

A recent U.S. Green Building Council study found that green construction was outpacing overall construction growth and would add more than 2.3 million jobs in 2015 alone.

The study predicted that by 2018, green construction would account for more than 3.3 million jobs in the United States, and generate \$190.3 billion in labor earnings. The green construction industry was also projected to reach \$303.5 billion over that same time frame.

4. Slowdown in growth

Construction growth has been explosive in recent years, reaching double digits from 2012-15. It

looks like those numbers will settle into the low single-digits in 2018. Considering the brutal collapse suffered only a decade ago, slow and steady growth might be the best kind.

ConstructConnect predicts a 2-3% growth in nonresidential building starts between 2018 and 2021, while FMI expects 5% in 2018 and 4-5% in 2019-21.

Not everyone agrees that we're due for a slowdown, however. In November 2017, Building Design+Construction surveyed 356 architects, engineers, and contractors, and found that six in ten respondents expect 2018 to be a very good or excellent year for business.

The only thing to do here is wait and see.

5. Improvements in safety

Construction continues to be an extremely dangerous industry for workers. The Bureau of Labor Statistics recorded 924 deaths in 2015—the most recent year available—in the “construction and extraction” category, the second-most of any industry, falling behind only “transportation and material moving” (1,301).

Fortunately, technology is tackling this challenge head-on. A number of innovative concepts are giving construction managers new and interesting ways to mitigate safety risks on the job site.

Virtual reality simulators can help workers get the thorough training they need before using dangerous heavy equipment. Drones can be used to make construction sites safer by conducting inspections and keeping workers out of difficult-to-reach areas.

There are even safety-focused software options, such as iAuditor (which is devoted to site inspections and safety audits) and FallSafety Pro (which

detects falls and sends alerts to emergency contacts).

6. Rising materials costs

Outside of labor costs, materials are the top expense on your job site. Unfortunately, they're trending upwards.

Between February 2016 and February 2017, material prices rose by 4.8%, despite falling the prior two years (falling 3.5% in 2015 and 2.7% in 2016).

The strength of construction activity in recent years has led to a tremendous increase in demand for materials, and in 2018 we're really going to feel associated effects in the form of higher prices.

7. Even more construction management software will hit the market

We're still adding new software options to Capterra's construction management software directory, and there's no sign of slowing down. We have 369 options listed as of December 2017.

In 2018, more software companies will produce their own construction management options, seeking to meet the growing needs of construction managers who want to better organize their businesses.
