

## Construction Corner: California bridge could transform industry with nanocrystals

A new bridge will be built in California this summer. That's hardly earth-shattering news. But this one will be different.

Thanks to the work of researchers at Purdue University, this bridge will use concrete that has been infused with microscopic-sized nanocrystals from wood. The idea is that the nanocrystals will make the concrete stronger so that less of it is needed.

The nanocrystals are a byproduct generated by the pulp and paper industries, among others.

Nanotechnology has grown by leaps and bounds in the last 30 years. Nanoparticles have always been with us, but because they are so small, we didn't yet have the electron microscopes necessary to see them so that they can be manipulated.

They are, after all, as little as a billionth of a metre wide.

For perspective, a single strand of human hair is about 100,000 nanometres (nm) in diameter. A sheet of newspaper is about 160,000 nm thick.

The intriguing thing about nanoparticles is that nano-structured materials are often stronger or have different magnetic properties compared to other forms or sizes of the same material. Sometimes they're better at conducting heat or electricity. They may be more chemically reactive or

reflect light better, or change colour as their size or structure is altered. And they can add strength.

The research team at Purdue hopes the cellulosic nanocrystals — which are about 100 nm long and five nm wide — will yield stronger concrete through a chemical reaction that increases the hydration of the cement particles it contains.

Jeffrey Youngblood, a professor of materials engineering at Purdue, says "concrete scales with the degree of hydration. So the more hydrated it is, the stronger it is.

"So you'd think that if you add more water, the concrete would be stronger. The problem is water adds pores that make it weaker. But cellulose nanocrystals enhance hydration with less water, making the concrete stronger."

Another benefit, he says, is that cellulose-infused concrete sets faster, which means less time waiting for it to cure.

Researchers say the cost of using cellulose nanocrystals may be offset since builders will be able to use less cement, but the exact cost hasn't been determined. But even if only a small percentage of all the concrete produced used cellulose nanocrystals, it would have a big impact simply because concrete is the most common manmade material in the world.

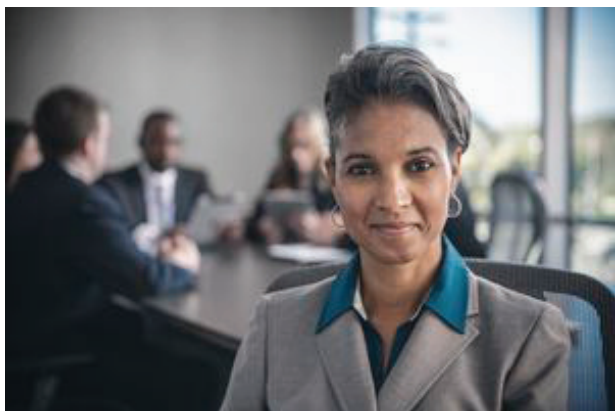

# High Paying Careers for Women

The question of how much money women make continues to be a significant issue in the job seeking world. Although the focus around women's paychecks tend to be centered on how they match up to those of men, there are also discrepancies between what women in different careers make compared to one another.

According to the United States Department of Labor's Bureau of Labor Statistics 2016 report, there is a varied range of careers that bring in high salaries for women: healthcare occupations, law, management, and technology jobs are among the top money-making positions.

Read on for the Department of Labor's ranking of the high earning occupations for women, based on median annual wages.

## 1. CEO

Chief executives plan, coordinate, and oversee a company's operations. They work to ensure that their companies meet their goals. Chief executives work in a variety of public and private-sector industries.

Although they earn, on average, the highest salary of all management positions, they also work extremely long hours and are essentially responsible for the success of their companies.

Female chief executives earned a median annual income of \$97,552.

## 2. Pharmacist

Pharmacists manage and dispense medications to patients who have received a prescription from their doctors. Pharmacists also offer advice on medication usage.

While most pharmacists work in grocery and drug store pharmacies, others are employed in hospitals or in clinical settings.

Pharmacists must possess a Doctor of Pharmacy degree, and also must be licensed. Pharmacists can obtain licensure by passing two professional exams.

Female pharmacists in the survey made a median amount \$95,628 per year.

## 3. Nurse Practitioner

Nurse practitioners coordinate patient care. Working independently or in collaboration with physicians, nurse practitioners provide either primary or specialty health care. They are also referred to as advanced practice registered nurses (APRNs), and must have at least a master's degree in the field, and a state license.

Female nurse practitioners earned a median annual income of \$91,156.

## 4. Computer and Information Systems Manager

Computer and Information Systems Managers — also known as Information Technology Managers — devise, coordinate, implement and analyze computer-related projects.

Their responsibilities may involve direct work in both software and hardware, web design database development, as well as the overarching job of designing a company's IT approaches and strategies.

In order to work professionally in the United States, lawyers must take and pass their state's bar examination.

Female attorneys earned a median income of \$84,188.

## 6. Software Developer

Software developers create and help devise computer programs. They do everything from analyzing users' needs to designing applications and helping write code to improving current software.

Female software developers earned a median annual income of \$80,756.

## 7. Physician Assistants

Physician Assistants (PAs) assess the medical status of patients, diagnose illnesses/injuries and recommend treatments. They work in hospitals, healthcare facilities and group medical practices. PAs consult with physicians and refer complex cases to physicians, surgeons and specialists.

Women PAs earned a median annual income of \$80,444 in 2016.

## 8. Physician

Physicians examine patients, diagnose medical conditions, prescribe medications and devise treatment plans. They intervene to treat emergencies, revive accident victims, and stop bleeding.

Female physicians earned a median annual income of \$76,752 in 2016.

## 9. Engineer

Human resources managers are responsible for recruiting, interviewing and hiring new members of a company's employee team.

In addition, they may be involved in other aspects of employee relations, including payroll, benefits and training. Human resources workers must also be equipped to handle workplace conflict and be ready to resolve disputes.

Female human resources employees earned a median annual income of \$66,716 in 2016.

## 10. Human Resources Manager

Engineers design, modify, and repair chemical, electrical, computer, mechanical, and other physical structures. They specialize in areas like civil, mechanical, computer, electrical, and chemical engineering.

Women engineers earned a median annual income of \$72,852 in 2016.

## California bridge could transform industry with nanocrystals

If concrete is ubiquitous, so is cellulose, which is the most abundant organic compound on earth.

We never think of it, but it's what makes plant stems, leaves and branches so strong.

If researchers pull this off, if the California bridge is a success, it could have a transforming effect on the concrete industry. Items made with concrete could be thinner and lighter while retaining the same strength.

And using less concrete means using less cement, which in turn means less carbon dioxide released

into the atmosphere. The construction industry has long been aware that cement plants account for about eight per cent of global emissions of carbon dioxide, which is one of the main causes of climate change.

The Purdue researchers began looking into cellulose about a decade ago.

Youngblood, who works mostly with plastics, said the challenge at first was determining where the water-soluble cellulose nanocrystals could be used. The idea of using them in concrete came while he was digging a post hole and preparing concrete.

He says the team quickly found the cellulose nanocrystals made concrete stronger, but no one knew why. The nanocrystals shouldn't have made the concrete stronger because they were too small.

"The fact that it did work was when we realized we had something," he says.

So now it's time to take the concrete out of the lab and use it to build a bridge in the real world. The size and location of the project should be announced soon.

Sealed bids will be received until **2:00 p.m., on Wednesday, April 11, 2018**, at the District Office, located at **900 High Street, Front Desk, Oakland, California**, at or after which time the bids will be opened and publicly read aloud. Any bid that is submitted after this time shall be non-responsive and returned to the bidder. Any claim by a bidder of error in its bid must be made in compliance with section 5100 et seq. of the Public Contract Code.

Pursuant to Public Contract Code section 20111.6, and the District's Prequalification for Prospective Certified Local/Small Local Resident Bidders, only prequalified bidders will be eligible to submit a bid for contracts \$1 million or more using or planning to use state bond funds.
