# Three Emerging Technologies Impacting The Construction Industry

Technology is shaping the world with everything from electric cars to hyperloop. But when it comes to the real estate construction industry, it is still underserved by technology. The construction industry contributes over 4% to the U.S. GDP, and it needs to adapt to new technologies in order to automate processes and decrease dependencies on manual labor.

However, the breakthrough technologies to make construction more efficient that have hit the market within the past five years have primed the industry for disruption. Below, read three of these technologies that I have come across and how each will shape the way we approach building in the future.

#### **Robotics**

No industry is as labor-intensive as construction. Since construction sites are uncontrolled (open) environments, it is most difficult to incorporate robotics, unlike in closed industrial environments. However, construction activities such as bricklaying are so repetitive and labor-intensive that the use of robotics is helpful to not only reduce costs, but also maintain quality and precision.

Very recently there have been breakthroughs in robotics for construction. One such pioneer product is the semi-automated mason — "SAM" — a bricklaying robot designed and engineered by Construction Robotics. It's the first bricklaying robot commercially available and doesn't actually replace a traditional mason. Rather, it works in collaboration with a mason, increasing their productivity up to five-fold.

Zak Podkaminer of Construction Robotics told me, "Construction will benefit from robotics in work that is dangerous, is repetitive, and where heavy lifting is required. [In] high precision work such as complex designs and patterns, robotics will provide a significant time savings allowing for more digital fabrication and provide architects more creative flexibility."

While just the thought of machines replacing humans sounds alarming, the technology of collaborative robotics that can work alongside humans in order to prevent accidents and save lives is one I'm happy to see is likely here to stay.

#### **Drone Imagery**

A good site analysis is the foundation required before any construction project can be started. In parts of the developing world, access to high-

## The U.S. States Most Reliant On Steel Imports

On Thursday, the Trump administration announced it was imposing tariffs on steel and aluminum imports of 25 and 10 percent respectively, arguing they were justified on the grounds of national security and necessary to fight back against an "assault on our country" by foreign competitors. On the campaign trail, Donald Trump promised to save the American steel and aluminum industries, which have been hurt by imports of cheaper products. While the move to impose tariffs fits in perfectly with his "America First" policy, there are growing fears about its consequences.

It has already caused serious friction within the Republican Party, where there are fears of a trade war, and some have questioned whether it will undermine decades of progress in international trade. One of the core questions is whether or not protectionism could impact U.S. economic growth, particularly at state lev-

el. While the tariffs may throw American steel and aluminum companies a lifeline in a market flooded by foreign competition, they have already had consequences such as the imposition of retaliatory tariffs on important American exports to other countries. Higher prices for steel and aluminum could also have a knock-on effect in U.S. states, impacting a huge range of important industries such as construction and auto manufacturing.

The following infographic was created using a Brookings Institute analysis of Census Bureau data and it shows the states most likely to be impacted by the new tariffs. Steel and aluminum accounted for the biggest share of total imports in Missouri and Louisiana last year at just over seven percent. Louisiana is especially reliant on foreign steel for its oil, gas and petrochemical industries. Canada and Mexico were granted exclusions from the tariffs, though Trump threatened that could change depending

on the outcome of NAFTA renegotiation talks. Last year, the U.S. imported 5.7 million metric tons of steel from Canada, the highest amount of any country, while 3.2 million tons came from Mexico. Even so, the impact could still prove severe in certain places with many states counting on a longer list of countries to meet their steel needs. Illinois is a good example, relying on Brazil for 41 percent of its steel and China for 29 percent of its aluminum.

### Diversity is a reason for optimism

As the waves from the nation's "Diversity Explosion" ripple out, young generations of new minorities—Hispanics, Asians, and multiracial Americans—are interacting with older minorities and white Americans in their pursuit of opportunities in a country that is in dire need of more youth. As the management textbooks might say, the growth of young, new minority populations from recent immigration and somewhat higher fertility is providing the country with a "just in time" demographic infusion as the largely white U.S. population continues to age.

Even though great disparities exist in wealth, income, and education between white and minority Americans, I think these demographic shifts are a reason for optimism. Opportunities will increase when the institutional players across our country—politicians, civic leaders, nonprofit leaders, and employers—recognize the potential of this new, more diverse generation.

Not least is the benefit to Social Security and other entitlement programs: in contrast to the population of labor-force age in Japan, Germany, Italy, and the United Kingdom—countries with generally older populations, lower fertility, and lower

immigration—the U.S. labor-force-age population is projected to grow more than five percent between 2010 and 2030. Yet were it not for new minorities, the country's labor force would decline by eight percent. Moreover, within the labor force, new minorities add needed youthfulness that brings with it innovation and an entrepreneurial spirit. Projections of the labor force show that in 2030, 54 percent of new minorities will be under age 40, compared to well under half of the rest of the labor force population.

# Wage discrimination in construction industry makes minimum standards a good idea Diversity

Equal pay for equal work remains elusive, even here in progressive California.

A recent study by Smart Cities Prevail showed that Latinos make up two thirds of the construction workforce, yet only make about 70 cents on the dollar of white workers with the same skills. The study noted that Latino construction workers also are significantly more likely to be uninsured and to struggle with housing affordability.

Low minimum wage standards are one factor that contributes to these types of disparities.

California legislators are soon expected to consider streamlining development of more housing across our state. At its core, the proposal involves removing certain regulatory hurdles in exchange for guarantees that a small percentage of new developments will include "affordable" units.

A similar effort failed last year when no agreement was reached on wage standards for workers on streamlined projects.

According to industry research, workers' wages and benefits are just 15 percent of the total cost of constructing housing. By comparison, profits for developers and contractors are 18 percent of costs and growing faster than the cost of labor.

And while inflation-adjusted construction wages are down 25 percent over the last 20 years, hous-

ing prices have soared as much as 54 percent in some markets. Declining wages mean more worker reliance on MediCaid, Food Stamps and other assistance programs.

And with labor standards being eroded, other problems have become more pervasive.

For example, wage theft occurs when employees are paid for fewer hours than they worked, less than legally required, or when their employer is paying in cash and cheating on payroll taxes. California's construction industry has seen a 400 percent increase in wage theft since the 1970s—a period that has also seen a dramatic increase in the share of immigrants in our construction workforce.

A recent study by the Economic Roundtable found that one in six California construction workers is now affected by these crimes. Construction wage theft's annual cost to California workers and taxpayers is in the billions of dollars.

By including things like prevailing wage in a housing streamlining package, California can take an important step in combatting this cycle of exploitation.

Prevailing wage requirements provide a livable, minimum pay rate for construction workers that is consistent with local market standards. By stabilizing the wage floor, the requirement closes pay gaps that disproportionately impact communities of color, decreases the likelihood of working people living in poverty, increases rates of health coverage and increases the probability of a non-white individual pursuing a career in construction

Prevailing wage also increases participation in skilled trade apprenticeship programs. These programs not only expand a worker's lifetime earnings by as much as \$240,000, but enable construction workers to acquire skills that improve safety, productivity and efficiency on the jobsite. These skills are essential if we hope to boost housing supply in sufficient quantities to close the affordability gap.

To formulate sound policy consistent with California's values, we need to have an honest conversation about how we arrived at our present crisis. By depressing wages and productivity and turning a blind eye to the growing wage theft epidemic, industry profits have exploded. But so has the income gap within the industry, as well as the number of Californians priced out of the housing market.

Something isn't working.

In housing reform, we are being asked to de-regulate one of our state's most lucrative industries. In return, aren't taxpayers entitled to ask that this industry do right by its workers?

# Why These Three Southern Cities Attract The Most Black Entrepreneurs

There are currently 2.5 million businesses owned and operated by African-Americans, according to the U.S. Census's most recent survey of business owners.

Although black entrepreneurship is on the rise, black founders are still receiving less VC funding than their white peers and have limited access to capital. Less than 1% of black founders receive funding, and this lack of capital leaves many black-owned business to be operated by one person, limiting their ability to hire other employees in order to grow and build their businesses. As cost of living soars, underrepresentation and limited support for these business continues for many of these black enterprising professionals in tech hubs like New York City and Silicon Valley. However, others are thriving in the Southeast.

A recent report by Blacktech Week that used data from the U.S. Census Bureau Statistics Data and Kauffman Foundation's 2017 Index for Startup Activity revealed that the top three cities where black-owned businesses are thriving are Memphis, Montgomery, Alabama, and Atlanta.

With a large number of African-Americans residing in the Southeast, a low cost of living, an increase in incubators like Atlanta's Digital Undivided popping up in Southeastern metro cities, along with support a historical lineage of supporting their own, black entrepreneurs are finding their niche below the Mason-Dixon line.

Mandy Bowman, the founder of the Official Black Wallstreet app and website, which has a listing of over 4,000 black-owned businesses in the U.S. (and has been downloaded over 70,000 times), isn't surprised that the Southeast is popular with black entrepreneurs. "The reason why these cities stand out so much is that the cost of living is much lower. The South also has a long history of entrepreneurship, especially through the Jim Crow era. People in these cities had no choice but to start their own businesses, and because of that history, I think it's something that's been ingrained in those cities. On top of that, these cities have a large African-American population, which is why there are many entrepreneurs in the Southeast."

There's also been an increase in new residents: In the first decade of the 2000s, there's been a reversal migration of black Americans moving to the South. According to USA Today, "From 2005 to 2010, the average result each year was a gain for the South of 66,000 blacks. Many came from the Northeast, but the flow also includes the Midwest and West." As the South attracts college-graduate crowds and retirees to economic opportunities, it's also attracting entrepreneurs to grow their businesses. There are also over 1,600 listings of black-owned businesses in the Southeast on the

Official Black Wall Street app. Here's a look at why these three cities are the top choices for black entrepreneurs.



#### 1. Memphis

Memphis reigns supreme as the top city for blackowned businesses. It offers more than great BBQ and music. The city's low unemployment rate in comparison to Atlanta and Montgomery supports a healthy economy to start a business. Nearby Bluff City also boasts a higher percentage of black-owned businesses than Atlanta, while having a lower cost of living index.

Brooklyn native Ekundayo Bandele moved to Memphis in 1994 and found a "thriving black intellectual and cultural community" where his love for theater flourished through his playwriting and eventually led him to become the founder and executive director of Hattiloo Theatre.

"The city invested in Hattiloo Theatre, which gave us \$1.5 million to help us build our infrastructure. We started as a community theater and have worked our way to the top. The generosity of the Memphis community to volunteer their time and talent helped make Hattiloo successful. The philanthropic community of Memphis understands the equity in Memphis," he says. His only drawback is access to talent. "Since Memphis is not categorically a theater town, there aren't as many technical theater people in terms of theater arts," he says.

Brit Fitzpatrick, the founder and CEO of MentorMe, chose to move to Memphis because of its affordability. "The biggest advantage to starting up in Memphis as opposed to Silicon Valley is that it's more affordable. Having raised a relatively small amount of money, I was able to stretch it a little further," she explains. Proximity to other cities also makes Memphis a great choice for Fitzpatrick. "In the first two years of MentorMe, I traveled a lot to meet new customers, create partnerships, and find advisory board members. Memphis is a reasonable driving distance to cities I needed to hit."

Although the city is in an early stage in comparison to New York City and San Francisco, "Memphis has a culture of hustle and hard work. I love

that about the city. It makes it really conducive to entrepreneurship," says Fitzpatrick.

Fitzpatrick participated in a pitch event where there was support for women in tech, and it reinforced for her the decision to develop her business in Memphis. Fitzpatrick feels the growing conversation around diversity in technology now draws people in the industry outside of traditional hubs. "The Southeast and Memphis have an opportunity to play a major role in the diversity conversation. Because of the shared demographics of minority-majority cities, larger companies should look to invest more resources and capital in this region," explained Fitzpatrick.

Resources, access to capital, and lack of density are the cons Fitzpatrick faces while building her business in Memphis. "The tech community is smaller here than in a larger city, so the importance of networking throughout your region or getting connected with the tech community at large is higher. I had to prioritize it more than someone who is lives in a city with a more established ecosystem," she says.



#### 2. Montgomery, Alabama

Montgomery is the city where Dennis Wesley chose to start his business, On Time Taxi. This city houses nearly one-third of the businesses owned by African-American entrepreneurs, according to MadeInAlabama.com. "My reason for starting in Montgomery was because I knew it was less costly than starting in cities such as Atlanta and Birmingham. I started with one van two years ago, and now I have eight vehicles," he explains. He is also in the process of launching a mobile app for his taxi service and expanding to Troy and Selma. "I started as the smallest taxi service in Montgomery and became the largest in two years," he says.

Montgomery has provided Wesley with a fresh start after moving from Georgia. "Montgomery has provided me with that good old southern hospitality, which I don't think you can get in metropolitan cities. I have customers that invite me to their house for dinner, work functions, and [people with whom I've built a] friendship," Wesley explains. The relationship with his clients

quality imagery via Google Maps is a struggle that increases the dependency on a manual workforce to gather on-site data before construction. Especially when it comes to retrofitting an old building or adding solar panels to an existing building, good-quality images captured by machine can reduce a lot of human hours spent measuring a building.

Enter drone photography. The use of drones in construction allows users to map a site and create two-dimensional as well as three-dimensional images. Since most of the advanced drones use a coordinate-based system, it is possible nowadays to achieve absolute accuracy in measurements, although it is expensive.

Deep Chakraborty, CEO of ENACT Systems, told me, "While the use of drones is proliferating now, the construction industry lacks good software platforms and tools that can process such images rapidly and simplify the analytical activity." Drone-image processing software programs are already simplifying image usability, and vertical-specific software platforms are now adopting the use of such drone image processing to simplify workflows for solar field professionals. The next two to five years will bring more sophistication to the use of drone imagery in construction.

#### Digital Project Collaboration Tools

While the world is closer to a paperless and fully digital management structure, quite a lot of the construction industry is still maintaining physical binders, logging responses in Excel, using fax machines and picking up the phone for even the smallest exchanges of information.

Project collaboration tools are transforming how the construction industry operates by making communication between various parties seamless, with some tools also offering a centralized storage of all project related files. Dustin DeVan, CEO of Building Connected, told me, "Before the hammer hits the nail, hundreds and sometimes thousands of businesses communicate with one another to set budgets and decide who's working on what." Digitizing these processes is a no-brainer for the industry moving forward.

Overall, this technology is being rapidly adopted by the construction industry and the companies who do not quickly adapt will find themselves less competitive in the market.

is one you won't find with Uber and Lyft, helping to build loyal repeat customers.



#### 3. Atlanta, Georgia

"In a given month [in 2016,] 430 adults out of every 100,000 inhabitants in Atlanta became entrepreneurs," according to Blacktech Week. That's why serial entrepreneur Maja Sly decided to call Atlanta home. Sly moved to Atlanta in 1998, and in four months had a full clientele and soon a salon in Buckhead that started her empire.

Sly calls herself an "accidental entrepreneur" whose journey led to the creation of her multiple businesses in the hair industry. After opening her first salon in 1998, she began her real estate venture that grew from her hair clientele. From there she opened her \$50 weave salons, Walk-In Weaves (she now licenses the name for franchise owners).

Her businesses led WeTV to make her a cast member of the reality series Cutting It in ATL, which garnered the national exposure to launch her successful online Pretty Hair packaged hair business and a coaching and marketing service for hair salon owners.

The Kauffman index showed that out of every four new entrepreneurs in Atlanta, three of them took their chances because they saw a market opportunity. "When I moved to Atlanta, I knew I found my groove. The streets are paved with gold here. If you can't make it in Atlanta, you can't make it anywhere," Sly explains. The low unemployment rate, a decent cost of living and city leadership like that of the newly elected mayor, Keisha Bottoms, makes Atlanta a popular metropolitan area for black entrepreneurs. Says Sly:

What I love about the city is that opportunities are everywhere. Unlike a lot of places, politics don't dictate the way businesses move here. This is an entrepreneurial city, so entrepreneurs dictate how things move here and the customer dictates how things move here. We don't have all of these bureaucratic guidelines and stipulations. It's not a city that you are boxed out. You can move here and not know anybody and make a name for yourself very quickly.

The African-Americans in the Southeast are not new to building a business out of necessity to maintain a living, but as the continued benefits of building a life in the South attracts interest, the opportunities to create are endless.
