

California Just Became the First State to Require Solar Panels on New Residential Construction

The mandate is part of California's "Energy Efficiency Strategic Plan," which includes the goal that both residential and commercial construction be zero net energy by 2030—meaning the buildings' annual energy usage is either less than or equal to the renewable energy generated on-site. California was also the first state to require net zero energy through building code.

The solar panel requirement, which applies to new single and multi-family home construction up to three stories high, was included in an update to the state's building energy efficiency standards. The California Energy Commission approved the standards today and they will become effective January 1, 2020.

California has been a leader in statewide initiatives to combat climate change, including setting aggressive goals like lowering carbon pollution to at least 40 percent below 1990 levels by 2030, as well as requiring that utility companies get at least 50 percent of all electricity from renewables by the same year. About 20 percent of California's new homes are built with solar arrays and the state has held about a third of the nation's total jobs in solar since 2013, according to the San Francisco Chronicle. A state energy department analysis estimates the new building code will add about 5,400 jobs to that market.

Environmentalists are celebrating the new building standards, and not just because of the solar panel mandate. "We're excited because [the new building standards] continue to help California move towards more renewable energy," Pierre Delforge, director of energy efficiency, energy, and transportation for the Natural Resources Defense Council says, noting that the new code also includes regulations for doors, windows, and insulation that will help reduce carbon emissions. "California is providing a framework and doing the research," Delforge continues. "They're putting out a model that other states can emulate."

The state's energy commission projects that the standards will reduce statewide greenhouse gas emissions by 1.4 million metric tons of carbon dioxide over three years. What's more, residents will save about \$80 per month on energy bills, and \$19,000 over a 30-year period.

But the mandate is projected to increase home building costs by an average of \$9,500—which could exacerbate the state's housing affordability problems. Last year, the California Association of Realtors released a report saying that about 70 percent of the state couldn't afford the median home price of more than \$550,000.

California Housing Partnership, a nonprofit that focuses on policy and research around affordable housing, has not yet taken a stance on the mandate, according to its policy director Stephanie Wang. "California's policies should support both affordable energy and affordable housing for those most vulnerable in the housing crisis," Wang says.

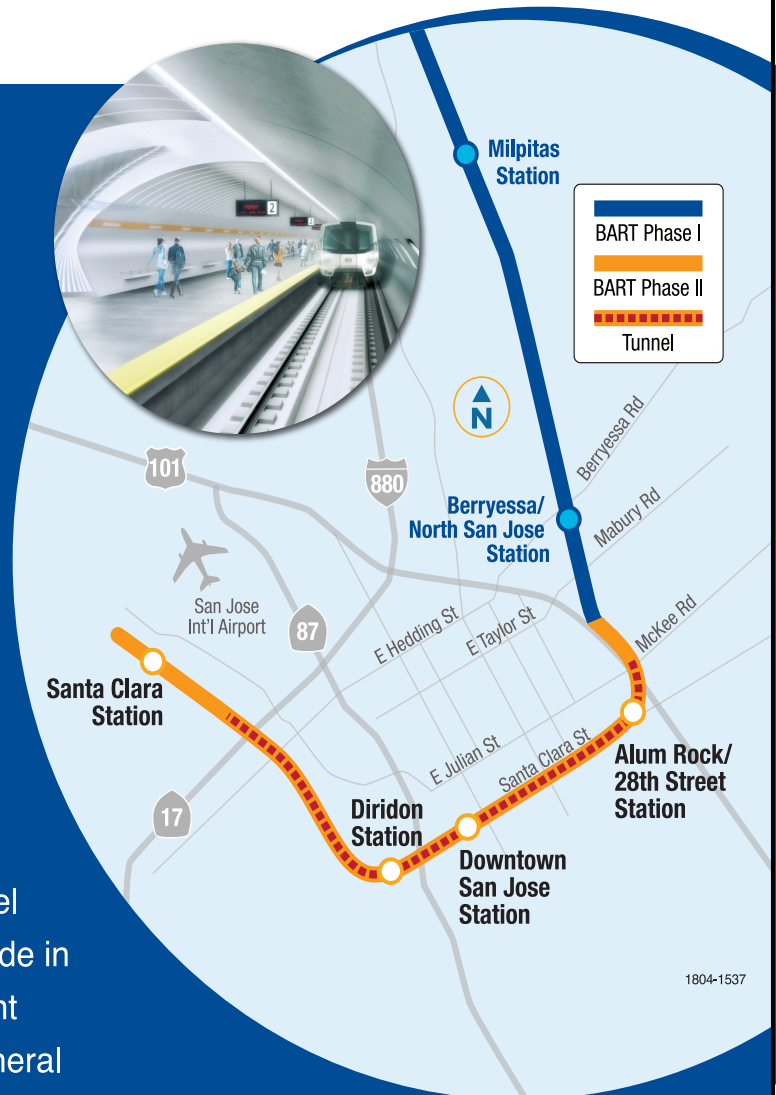

7 Tips for Hiring a Subcontractor

If you're on the job site and you know you won't be able to finish the job on time, you likely need to hire a subcontractor to help you get the work done. How do you go about finding the perfect subcontractor? Hiring a subcontractor takes time and energy you don't have to spare. These 7 tips will help you find a subcontractor quickly and efficiently, saving you time and money.

1. SUPPLIERS KNOW BEST

Material suppliers work with contractors and subcontractors every day. Chances are, they've heard some shop talk and know the good, the bad and the ugly when it comes to a person's work ethic. In a pinch, ask your supplier if he knows the right person to help you finish the job.

2. ASK OTHER SUBCONTRACTORS

Have you hired a crew of subcontractors for other tasks? Ask around the job site to see if anyone has a buddy or worked with a good man on a previous job. People who work beside each other know best how one's work ethic is—your guys already on the job are the best resource you have for hiring someone on the fly.

3. QUESTION THE CLIENT

Ask your client if they have any recommendations for a subcontractor. Chances are, your client did a bit of research before hiring you to work on their project and may have some names for you to start with. Your client may also have recommendations from friends about subcontractors in the area.

4. CHECK CRAIGSLIST

If you've exhausted all your contacts for advice, check Craigslist. If you are in a small town, you'll have to search through the closest big city, but there are always people looking for work on Craigslist. It may take a few days for a good hire to come to fruition, but Craigslist is worth a shot if your deadline is approaching fast.

5. PERFORM A BACKGROUND CHECK

Do your research on the person you choose to hire. Does this person have the correct licenses? Does this person have liability insurance? Subcontractors should have their own liability insurance, those who are not properly insured could end up costing you a lot of money. Make

sure your hire has sufficient liability insurance for the job he will be working.

Give the person you hire a trial period. During this trial run, your subcontractor will have time to prove to you that he or she can do the task that you have asked. Word-of-mouth is a good indicator of someone's work ethic, but it isn't the end-all be-all of hiring someone to do a good job. Make sure that they work well under your control, and that they get along with the rest of the team before you extend their contract.

7. BE MINDFUL OF A PRICE RANGE

No subcontractor's fees are alike. Don't discredit a person because their price per hour is much less than another person's. A lower price doesn't make this person's abilities any less than someone else's, it is possible that they haven't had any work in two to three months. Likewise, a person may charge more per hour than the average subcontractor, but that does not mean their skill set is above everyone else's. Don't only look at the subcontractor's price when choosing who to work with. Choose a subcontractor that fits your needs.

Choosing a subcontractor in a pinch is not a desirable task. Help yourself quickly find the right person by taking these 7 tips into account when the time comes to hire one.

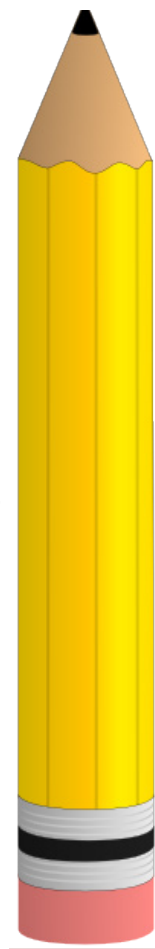

Eric Garcetti on Presidential Bid: America 'Needs' a Mayor

Los Angeles Mayor Eric Garcetti likes to joke that "no sane person would actually ever run for president."

He might just be crazy enough to do it.

Garcetti has made little secret of his presidential ambitions. In a new interview with Governing, Garcetti says he may well make the jump in 2020. "In an ideal world, I'd see this term out," he says. "I am, at the same time, really concerned about the country and the direction of the country."

Without naming President Trump, Garcetti said that a president needs to be "practical, results-oriented, inclusive and decent."

"We have a lot of indecency," Garcetti told Governing President Cathilea Robinett in an

interview for the new podcast "In the Arena," which is launching next month. "We have a lot of division, we have a lot of impracticality, we have a lack of experience in government."

Garcetti visited Iowa last month, making him the first prospective Democratic candidate to visit all four early voting states, following trips to New Hampshire, South Carolina and Nevada.

Garcetti, who is 47, will have a lot of work to do introducing himself to voters outside California. He won election to a second term last March with 81 percent of the vote, but it's unlikely many voters have heard of him outside Southern California.

Garcetti is fond of pointing out that more people live in Los Angeles than 23 states. Still,

Japan Wants Robots to Help Build Its Skyscrapers

It takes about half a million man-days to erect a 30-story office tower, a number that hasn't changed much over the years, because building sites have remained largely impervious to advances in automation. That's becoming a problem for construction companies in Japan.

The industry, which bore the brunt of Japan's prolonged labor shortage, is expecting the situation to get worse with at least a million people set to leave or retire from the profession over the next decade. Shimizu Corp., a Japanese general contractor founded more than 200 years ago, is seeking to soften the blow by introducing robots that can weld beams, haul supplies and install ceiling panels.

Industrial robots are everywhere in manufacturing, with more than 2 million operating on factory floors worldwide. In car assembly, as many as one robot per five workers are on factory floors, according to the International Federation of Robotics. Construction sites present tougher challenges, because of their unpredictable environments and the presence of humans. Automation efforts have been limited to the periphery, such as using drones to keep track of building materials.

"The biggest difference is that factory robots are made with the expectation that they will remain in the same place," said Masahiro Indo, a general manager at Shimizu's construction technology division. "We wanted the arms to be mounted on a moving platform and most robot makers said that's not possible."

Shimizu's Robo-Carrier automated forklift is equipped with laser rangefinders to navigate environments, not unlike the technology used in self-driving cars. The machine was able to safely maneuver in a room full of reporters and TV cameras during a demonstration at the company's research center in east Tokyo on Monday. But the lack of clear regulations would limit autonomous use at real construction sites to nights and weekends, Indo said.

A machine that installs ceiling panels, called Robo-Buddy, can heft 30 kilograms at a time, helping to relieve some of construction's most back-breaking labor. Shimizu plans to introduce the robots on a building site in Osaka around October.

While the robots will save thousands of hours of human labor for the tasks they perform, that will still be minimal, amounting to about 1 percent of the total for a typical high-rise, Indo said. Machines that can work on floors and walls could come next, but getting that number to even 10 percent is a difficult challenge, because the most laborious parts of construction take place inside the building, he said.

Recent advances in deep learning have improved the ability of machines to detect their environments, paving the way for applications such as navigation in self-driving cars, according to Pham Quang Cuong, assistant professor at the school of mechanical and aerospace engineering of Nanyang Technological University in Singapore.

"There will be more automation in the next few years, but most of it will happen off-site," he said. "We are still at the very beginning."

Delforge says that the increase in construction costs due to the solar panel mandate is “only half the equation,” and the monthly savings in utility bills for residents will outweigh the burden down the line.

Although unprecedented in many ways, the solar panel requirement will be incremental. New home

builds account for about one percent of the state’s total residences per year, according to Delforge, so don’t expect to see swaths of solar panels popping up on roofs across the state just yet. “The number of homes impacted by the building code is relatively small,” he admits, “but those homes will last for decades—and it’s much cheaper to build it right the first time than retrofit it later on.”

Garcetti concedes that the presidency “seems like a big jump for mayors to consider.”

Historically, there’s no question Garcetti is correct. No mayor has ever been elected president directly, and only three former mayors -- Andrew Johnson, Grover Cleveland and Calvin Coolidge -- have ever made it to the White House. The presidential runs of former New York Mayor Rudy Giuliani in 2008 and his predecessor John V. Lindsay in 1972 both fizzled quickly.

Garcetti says he hopes, even if he bows out, that other mayors will run. “We’re exactly what the country wants and needs right now,” he says.

Mayors Bill de Blasio of New York, Pete Buttigieg of South Bend, Ind., and Mitch Landrieu of New Orleans, who will leave office on Monday, have all either hinted at runs or been the subject of speculation.

In February, conservative columnist George Will noted that Garcetti’s combined Russian Jewish and Mexican heritage, to say nothing of his leadership of polyglot Los Angeles, can speak to the shifting demographics of the country. Garcetti is also a generation younger than some of the best-known aspirants in what is likely to be a crowded field -- an “impatient generation,” as Garcetti has said.

“Los Angeles mayors are not powerful -- the schools are run by others -- and he must get along with the mayors of 87 other cities in Los Angeles County,” Will wrote. “This is, however, training for the presidency, which is less powerful than those who seek it think it is, until, in office, they must deal with Washington’s rival power centers.”

Los Angeles is contending with a serious homeless problem, as well as a housing crunch in general. But Garcetti, who spoke with Robinett before addressing Governing’s Summit at Performance and Innovation in Los Angeles, has convinced voters to devote billions of dollars to housing and infrastructure.

The city’s economy is booming, posting record numbers of tourists last year. Garcetti can brag about landing both the 2028 Summer Olympics and a museum being built by Star Wars creator George Lucas, a billion-dollar project that ran into snags in both Chicago and San Francisco.

Given all that, Garcetti doesn’t sound as if he’d be too disappointed if he ultimately fails to catch fire among out-of-state primary voters. “I’m not looking too far in the future because I have a lot of work undone in L.A.,” he told Robinett. “I think this will be the best job I ever have in my life.”
