Now more than ever, women entrepreneurs are making their mark. The growing prevalence of women entrepreneurs hasn't happened by accident. A big part of the growth of women-owned small businesses is legislation that targeted the creation of resources and networks for women. The mission of the WBC program is to act as the catalyst for providing in-depth, substantive, outcome-oriented business services to women entrepreneurs. These include both budding and established busi-

nesses, many of which are socially and economically disadvantaged.

Today, there are more than 100 WBCs all over the country – including nine new centers that opened this year. These centers provide an incredible service for women entrepreneurs that helps them to launch and grow businesses and create jobs. In 2017, the WBCs supported more than 150,000 women, resulting in tremendous revenue and job growth for the businesses they served -- \$1.7 billion in revenue and 17,000 new job creations. Research shows that women who receive counseling and mentoring early in the development of their businesses are more successful than those who don't.

In addition, we recognize National Women's Small Business Month and the millions of women entrepreneurs who day after day pursue their passion of entrepreneurship and financial independence. We want women entrepreneurs to feel confident taking a risk on starting or expanding their small businesses. Whether they are writing a business plan, connecting with a business mentor, or receiving a loan to start or grow their businesses, each woman can access SBA resources.

As a former business owner, I know first-hand the resources, support, and access to networks and financing that women need. I applaud those who have worked hard to overcome the barriers to business ownership and I encourage those who have yet to fulfill their dreams of entrepreneurship.

For the next generation of women entrepreneurs, it will be equally critical for them to have the needed resources to start and grow their businesses, just as women did 30 years ago. As the nation's go-to resource for women entrepreneurs, the SBA will be here to help them. Access to capital, mentors and networking are some of the things women entrepreneurs need the most, and these continue to be the main barriers.

Through our 68 district offices and network of resource partners, we have the proven tools needed to help bridge the gap for women entrepreneurs as they grow their businesses, reach new markets and realize their full potential. We strive to reach as many entrepreneurs as we can through the Women's Business Centers, the Small Business Development Centers, SCORE and the Veterans Business Outreach Centers.

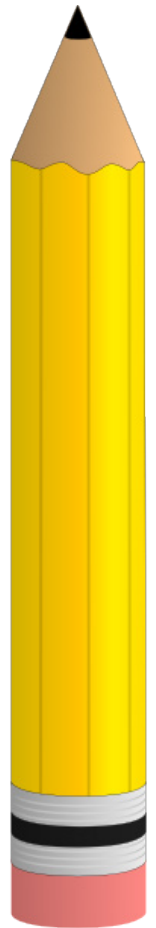

Got Subcontractors? Protect Your Interests with a Subcontractor Agreement

It's hard to find a talented independent contractor you can trust to represent your company when working with a client. Once you

do find a good one, however, it's a person that you want to keep on your team for future projects. The downside is, your favorite independent contractor is more than likely someone that your clients would love to have on their team – and in the absence of a subcontractor contract, they could very well hire your best contractor away.

No matter how much you trust your freelance contractors, there's always a risk that your client could try to lure him or her away with a job offer. If that happens, you stand to lose not just your subcontractor's skills and experience, but also your client's hard-earned business. The good news is, you can protect

yourself against this and other scenarios, including the risk of your subcontractor stealing your company's intellectual property or specialized expertise and selling it on his or her own. The place to start is with a 1099 independent contractor contract, signed by both you and the contractor you hire.

What's in a subcontractor agreement?

Independent contractor agreements typically address two key concerns for IT consultants: preventing your subcontractor from taking a job with your client, and protecting your intellectual property. But these agreements can

also do much more to protect your company and sustain healthy relationships with your freelance contractors.

A 1099 subcontractor agreement governs the relationship between a consultant and the independent contractor who has been hired to perform services. It typically includes a statement of work, which clearly defines the duties, obligations and services the contractor will perform on your behalf. The scope of work might define key project tasks and milestones, reimbursement of expenses, time and cost estimates, and project organization and resource specifics.

By clearly setting the scope of services you expect your independent contractor to provide, you set the stage for a successful relationship while providing a blueprint for meeting your client's needs. At the same time, you can use the contract to establish price and payment terms, as well as how it

will be handled should you or your client be unhappy with the level of service your contractor provides. Generally, such agreements also give you the authority to terminate your relationship with the independent contractor for any reason.

You can also use this type of contract to protect your intellectual property rights and ensure that your subcontractor keeps confidential information private. It also establishes the rights and responsibilities of each party when providing consulting services for your client, and limits your liability should anything go wrong.

In a **Red Transit Lane...**

You CAN:

- Make a turn at intersections and driveways
- Enter or exit a curbside parking space next to the lane
- Enter or exit with your bike to reach the curb

You CANNOT:

- Pick-up or drop-off
- Double park: *Double parking in transit-only lanes is enforced by automatic cameras on Muni buses, so you may get a ticket in the mail for those violations.*
- Drive: *People driving and bicycling are only allowed to enter a transit-only lane when necessary to turn park or reach the curb. Otherwise leave that transit lane to Muni, taxis and emergency vehicles only.*
