

# **On a Mission: Finding Life Cycle Environmental Solutions**

We often describe the U.S. Environmental Protection Agency's (EPA) Small Business Innovation Research (SBIR) program as the small program with the big mission, to protect human health and the environment. The mission is big and the areas of focus are broad: air, water, climate change, waste and manufacturing. We strive to promote "greening" it all.

The President's budget calls to equip the EPA with the best scientific information and research to underpin its regulatory actions and helps the agency find the most sustainable solutions for the wide range of environmental challenges facing the United States today. It supports high-priority research in such areas as air quality, sustainable approaches to environmental protection, and safe drinking water.

Through the years, the EPA SBIR program has supported advances in green technologies such as state-of-the-art monitoring devices and pollution

clean-up systems and processes. Recently though, we have expanded to support companies whose ideas are launched from a foundation of life cycle assessment (LCA). This proactive approach means solving an environmental problem in a way that takes into account resources, feedstock, emissions, toxicity and waste.

While clean-up, containment systems, and other "end-of-pipe technologies" are still important for managing pollution and potential contaminants after they have been produced, we want to foster game-changers that reduce or eliminate their production in the first place.

We have developed five criteria to evaluate applications for support in that area:

- Disruptive Potential
- Management and Technical Capabilities
- Life Cycle (environmental) Impacts
- Technical Soundness
- Commercialization Potential

Funding technologies that show promise for commercialization means getting finished products into the hands of people that will use them. That's impact!

Two companies we were fortunate to support are outstanding examples of just the kind of impact we hope for.

Ecovative developed MycoBondTM technology, a process that uses fungal mycelium grown on agricultural waste to make packaging, insulation and structural cores. Instead of those white shells made from hydrocarbon synthetics, imagine product casing made from a green feedstock with less energy that protects as well or better than the standard. In the last stage of its life cycle MycoBond is biodegradable or compostable. Ecovative has received many awards including the Tibbetts Award in 2013 which is given to the companies and individuals who best demonstrate excellence across all

aspects of the program's mission and the "2011 Innovator of the Year" in the Greener Package Awards (non-FDA regulated category). This innovative company has been featured in countless media, including a profile featuring its founders in the May 20, 2013 issue of The New Yorker.

Cambrian Innovation developed a bioelectrochemical system to treat wastewater and recover energy. Over 40 billion gallons of wastewater are produced every day by municipal and industrial sources such as dairies, breweries, and bottling plants. That's a significant waste challenge particularly in regions such as California suffering drought. Cambrian's system is unique in the wastewater technology field because its process uses microbes to recycle water and produce electricity. Housed in a shipping container, the system is modular and portable. Cambrian launched a new system for Bear Republic Brewing Company, a California brewery that expects to save hundreds of thousands of dollars in water and electricity costs from using the system. Founded in 2006, Cambrian received SBIR funding from NASA and EPA SBIR as well as other

funding from the National Science Foundation, Department of Defense, and U.S. Department of Agriculture. The company won an Artemis Top 50 Award and was featured in the Boston Globe earlier this year.

Many more of EPA's SBIR supported companies have followed similar paths as Ecovative and Cambrian towards impacting the environment for the good in more ways than one.

The so called "end-of-pipe" processes and technologies continue to help protect the environment and human health. But we know our environmental problems are more complicated today, and will be in the future. Rethinking problems using life cycle analysis means our solutions can meet the challenge of those complexities. Disruptive technologies multitask. Green disruptive technologies life cycle.
