# Diversity takes center stage at Microsoft annual meeting

Diversity took center stage at the Microsoft annual meeting on Wednesday as the technology giant agreed to release the diversity data it reports to the federal government by the end of the month.

Microsoft said it would make public the EEO-1 form which details workforce data by race and gender in different job classifications. Companies have been reporting the information to the federal government for decades.

The Redmond, Wash., company has provided some general information about the diversity of its workforce but last week refused to provide the more detailed EEO-1 form to USA TODAY.

Intel, Google, Facebook, Yahoo and LinkedIn have all made public their EEO-1s. But other companies have refused. Holdouts among top technology companies are Apple and Amazon.com. Jackson met this week with Microsoft CEO Satya Nadella to urge the company to release its EEO-1 and make a firm commitment to recruit more women and people of color to the board as well as the executive and employee ranks.

Microsoft's chairman John Thompson is African American, its CEO Nadella is Indian-born and the company's chief financial officer, Amy Hood, is a woman. But the company like others in the technology industry is 61% white and 71% male.

"The tech industry is data driven. And the diversity and inclusion data are indisputable and undeniable: the leadership and workforce of the technology industry does not look like America or reflect the population and consumers that it relies upon for success," Rev. Jesse Jackson told shareholders during the question-and-answer portion of Microsoft's annual meeting.

## You'd Never Know From These Beautiful Maps That U.S. Infrastructure Is Crumbling

These monochrome renderings depict only roads.

The news show 60 Minutes recently declared that America's infrastructure is neglected and falling apart. But that doesn't make it any less beautiful. Proving this point is Fathom, an information design firm based in Boston, Massachusetts.

The firm put together some stark maps of each U.S. state, plus Washington, D.C., Puerto Rico, and Guam. There are no labels, no words, no symbols, and no route markers, nor any rivers, lakes,

or subways. The monochrome maps only depict roads, and the results are surprisingly enlightening.

Urban areas are easy to spot, such as in the poster of Illinois, as Chicago and its suburbs leaves a dark splotch in the northeast corner of the state.

Mountains are apparent too, such as the bending forms of the Appalachians in Pennsylvania.

The national parks and forests of Washington appear to cleave the state nearly in two. Olympic National Park leaves a void in the northwest. Some states appear to have disintegrated from their familiar forms. The roadway skeleton of Louisiana reveals how much of the bayou is inaccessible by auto. (Much of the state itself has washed away in recent years.)


The map for Alaska bears no resemblance to its landmass, as much of the state is inaccessible by road.

The maps are derived from a project the firm worked on in 2009, when it created an image of the entire United States using the same method. It was displayed at monumental scale for a 2010 exhibition at the Frankfurter Kunstverein in Germany. The firm began selling posters of that image in 2011.

Fathom was founded by Ben Fry, a winner of a National Design Award in the U.S. and cofounder of the Processing programming language. Fry's work has been exhibited at the Museum of Modern Art, the Whitney, the Cooper-Hewitt and others.

## **Obama Administration Encourages Local Food Projects**

On behalf of the White House Rural Council, six federal agencies joined to announce 26 communities selected to participate in Local Foods, Local Places, a federal initiative providing technical support to integrate local food systems into community economic action plans. Over the next two years, the project will aim to increase access to locally grown, healthy fruits and vegetables for residents while boosting economic opportunity for farmers/producers in various areas.

The Youth Policy Institute in Los Angeles, Calif. will receive technical assistance to create a community-supported agriculture program that can improve the health of low-income residents by increasing access to local foods, boost economic opportunities for farmers and producers in the region, and help revitalize distressed neighborhoods.

Ajo, Ariz. will receive technical assistance to develop and implement an action plan promoting local foods and entrepreneurship in order to create an economically vibrant community.

The Churchill Economic Development Authority in Fallon, Nev. will receive technical assistance to create a local foods hub in an abandoned grocery store in the historic downtown.

Local Foods, Local Places is a partnership among EPA, USDA, Department of Transportation (DOT),

ARC, the Delta Regional Authority (DRA) and the Centers for Disease Control and Prevention (CDC). The initiative draws on the Administration's Partnership for Sustainable Communities, USDA's Seven Strategies for Economic Development and other place-based strategies to address regional challenges.

Under this effort, a team of agricultural, transportation, environmental, public health and regional economic experts will work directly with the communities to develop local food projects they proposed. The 26 Local Foods, Local Places communities were chosen from among 316 applicants The initiative is jointly funded and will provide \$800,000 in technical assistance to communities.

## **Deadline Extended to Apply for EPA's 2015 Environmental Justice Small Grants Program**

The U.S. Environmental Protection Agency (EPA) has extended the deadline for eligible non-profit groups and tribal communities to apply for the 2015 Environmental Justice Small Grants (EJSG) Program. The EJSG Program provides funding for projects that help communities understand and address exposure to multiple environmental harms and risks at the local level. The application deadline has been extended from Dec. 15, 2014, to Jan. 9, 2015.

EPA recognizes the critical role of helping communities with localized strategies to avoid, lessen, or delay the risks and impacts associated with our changing climate. As a result, this year's EJSG Program will have a special emphasis on proposals supporting community-based preparedness and resilience efforts (community climate resiliency). In an effort to ensure that support reaches new areas, the Agency also is prioritizing funding to organizations that have not recently received an award under the EJSG Program.

The total estimated amount of funding available for awards under this solicitation for fiscal year 2015 is approximately \$1.2 million. EPA anticipates awarding up to four grants per EPA region in amounts of up to \$30,000 per award for a two-year project period.

## **Protecting Yourself as a Contractor**

Many professionals may choose to follow the career path of an independent contractor instead of traditional employment because of the benefits of creating their own hours and defining their own hourly rates.

Not being on the payroll may come with some great advantages, but non-employees are responsible for certain legalities and liabilities. Contractors should be aware of these liabilities as they work with businesses. If you are a contractor (or hope to become one), it's important to know what you are liable for on the job and how to protect yourself.

#### Liability: Contractor vs. Employee

While the relationship between a company and a contractor may seem similar to that between a company and its employees, it is important to remember that there are very significant differences when it comes to liability. Keep these things in mind: Independent contractors are responsible for their own taxes. Taxes for contractors are not withheld on their paycheck, unlike employees who have taxes and other deductions removed by the business before they are paid. This means contractors must file and deduct on their own. Contractors' income is reported on a Form 1099, which only reports how much money they receive from the business.

- A contractor is liable for his or her own actions on the job. For example, contract pharmacists are responsible if they mix the wrong medication at a pharmacy where they are working. Contractors are responsible for any wrongdoing or harm they cause to third parties and are not protected by the contracting company. This includes any negligent conduct or wrongdoing committed while on the job.
- Contractors are not covered by workers' compensation. They are responsible for any injuries they incur on the job. This means that an independent contractor could face medical bills and unemployment after an injury. They also often don't usually get health insurance from the business they work for.

## **Protecting Yourself** as a Contractor

- Independent contractors are responsible for their own pension, retirement and other benefit plans if they desire them. These will not be offered or paid for by the contracting company.
- If a contractor quits or is fired, they don't retain the typical legal privileges that employees are generally covered by. An independent contractor does not qualify for unemployment insurance claims if they are let go, and they may receive a profit or a loss if they leave.

#### How a Contractor Can Be Protected

Although contractors do have a special set of liability concerns, they have several ways to protect themselves. Follow these guidelines to ensure you are protected:

- Contractors need an organized tax system for filing. Many contractors pay on a quarterly basis to stay updated on tax payments. This makes sure they don't have one large deduction in April that could set them back significantly. Meet with your accountant for advice, adopt an efficient tax system (such as Quick-Books or FreshBooks) and research online on the IRS website for advice on filing as an independent contractor.
- Since you are liable for your own actions on the job, it is highly recommended to invest in Independent Contractor Liability Insurance. Check with your current insurance provider to see if they offer this type of coverage, or search online or in the local Yellow Pages to find an insurance company with this option.

- On the same note, you should purchase your own worker's compensation insurance to cover yourself for any injuries or accidents that occur while working. This insurance may be provided through your current insurance provider, or you may be able to find it through an online search or through the local Yellow Pages.
- Look into personal pension and retirement plans, and be ready for the future. Speak with your banker or accountant if you need advice or help getting started with a retirement plan, or you can look into starting one online with a service like Vanguard.
- Have a plan for unemployment. Where can you find more contract work if your current work ends? Do you have a financial cushion to rely on?
- Be sure to sign freelancer agreements anytime you enter into a relationship with a new company. This will list your responsibilities and lay out all of the terms of the professional relationship. It can also protect you if the company expects you to perform above and beyond the duties you originally agreed upon.



## **Diversity takes center stage at Microsoft annual meeting**

Jackson sat in the second row next to former Microsoft CEO Steve Ballmer who is still the company's largest individual shareholder. Ballmer stepped down from Microsoft's board in August to focus on his \$2 billion purchase of the Los Angeles Clippers.

In an interview after the annual meeting, Jackson said he was pleased that Microsoft may consider a Rooney rule for open board seats.

He was referring to the 2003 rule that requires NFL teams to interview minority candidates for head coaching and senior football operation positions and has resulted in an increase in black coaches in the NFL.

He also wants Microsoft to put into a place an advisory board that would advise Microsoft from a broad range of perspectives.

Microsoft is sending representatives to a Dec. 10 meeting at Intel put on my Jackson's Rainbow PUSH Coalition to discuss strategies for bringing more diversity to the tech industry.

Microsoft's willingness to work toward more inclusion "signals to the rest of the industry that there is no reason to be afraid of our challenge to them to grow," Jackson said.

The shareholder meeting was Nadella's first since taking over as CEO nine months ago.

About 400 shareholders gathered for the meeting. Microsoft executives only touched briefly on the business strategy and finances of the company.

Nadella is looking to put his imprint on the company with a series of bold moves designed to reinvigorate the technology giant and bring it into the mobile and cloud computing era.

He has also placed an emphasis on hiring and promoting more women and people of color.

"We are focused on ensuring that Microsoft will be the best place to work for smart, curious people across cultures, genders, ethnicities and lifestyles," Nadella said during the shareholder meeting.

Nadella launched a diversity effort in October after making remarks at a technology conference for women that set off an international firestorm.

During an onstage interview at the Grace Hop-per Celebration of Women in Computing, Nadella said women should not ask for a pay raise but trust that "karma" will reward them. He apologized for the remarks.

Microsoft shareholders on Wednesday approved an \$84 million pay package for Nadella despite "significant concerns" about the size of the stock grants raised by an investor advisory group, Institutional Shareholder Services.

## Portrait of the Banker (as a 29-Year-Old)

On a recent drizzly Sunday afternoon, a 29-year-old New York banker was sitting in a West Village cafe, eating biscotti with a mocha cappuccino and a glass of grapefruit juice. "I want to retire early and maybe do something else," he sighed.

"My premium years were spent working very, very hard because of the crisis, and not getting paid for it," he said later. "I don't feel like I'm rich." To keep him from leaving last year, his bank said it would grant him a \$650,000 bonus, though he was just told this month that whatever he gets will be given mostly as deferred stock that can't be sold for ages.

The great parquet decades of investment banking are over—Lehman Brothers and Bear Stearns are long gone, and Goldman Sachs and Morgan Stanley have settled down as humdrum commercial banks. However the next era of Wall Street looks, whether it's unbowed or humbled or distrusted or distrustful, Manhattan's bankers are going to be something that they haven't been in a very long time: conflicted.

"I had these big dreams when I was a kid to help people. But it's much harder than one might think," the young man said. "You have to do your job. You're in the Army, and they send you to Vietnam. It's not a good war, but they tell you to shoot. You shoot. It's very complicated, but people don't see that. I have a job. I tried to do that the best I could."

THE HANDSOME YOUNG BANKER has olive skin and black hair, but slightly meanlooking eyes. He doesn't like working out, though he has shirtless photos of himself on Facebook. His girlfriend is three years younger. He likes The Economist and house music. He owns a few nice suits, which are Hugo Boss and were bought on sale: "I love," he said, "making good deals." He goes to private openings of meatpacking district clubs with colleagues, where they can party while talking business. Last month he saw a Lady Gaga concert with friends: "She puts on a great show, but the music is not that great."

He is the most extraordinarily typical banker on Wall Street, and he's on the minds of preachers, schoolchildren, shoe salesmen, prosecutors, matchmakers, retirees, the unemployed and the president. He is loathed, relied on and wondered about. At the cafe and in conversations afterward, he was willing to talk about himself on the condition that his name and his bank's weren't printed.

In the middle of the decade, he said, he got a master's degree in mathematics. It was Ivy League but easy. "Ph.D.'s are great, but everything before is just crap." Then he joined his bank to work with structured products—a young, lucrative and spectacularly murky corner of finance that pools together, slices up, repackages and makes bets on assets like mortgages or, in his case, corporate debt. "I have friends who are lawyers," he said. "Their starting salary was \$200,000. My starting salary was \$85,000. But I'm not a lawyer. And I don't want to be a lawyer. I'm good at math."

Specifically, he's good at handling an outstandingly strange kind of financial sausage called a synthetic collateralized debt obligation, which bundles up credit default swaps (basically insurance against the default of assets like, in this case, corporate bonds). When the crisis raged in October 2008, some corporate synthetic CDOs were trading below 10 cents on the dollar. In fact, they're siblings to the mortgage-backed securities that helped beat the global economy into an unrecognizable pulp, though he pointed out that what he was working on wasn't quite as toxic.

In early 2007, he was given a \$275,000 bonus, mostly in cash. A year later, that number was \$675,000, this time mostly in stock, although it was on top of a salary that had grown to six figures.

Early last year, after Wall Street had been brought to its knees, his bonus was only \$45,000. "When you work really, really hard—my group was working from 7 to 9 every day, sometimes weekends—to be paid \$150,000? I could have been making more." Friends left his bank. "At hedge funds, if you make money, you get paid."

But afterward his salary was raised to \$200,000, and he was told about the \$650,000 bonus he would get this year if he stayed. He did. Still, that sum didn't turn out to be what it seemed. "Every bonus I see as a jackpot. If I get it, great, if I don't ..." he said, trailing off. "I mean, you're very disappointed, yes. Imagine that happened to you."

The thing is that it's hard to empathize. According to the New York State comptroller, the average bonus on Wall Street was less than \$14,000 in 1985. That number didn't get much higher until it doubled in 1991 to \$31,000, which became \$100,000 by the turn of the century. In 2008, even when the average bonus fell by more than a third, it fell to \$112,000. How does one mull over or understand or argue about numbers like that? Goldman chief Lloyd Blankfein got a \$67.9 million bonus in 2007: It would have taken 4,350 averagely paid Wall Street bankers at the height of the go-go '80s to match him. Last month Mr. Blankfein was rumored to be receiving a \$100 million bonus, after an even better year for the bank, though he ended up with, as a Reuters headline said, only \$9 million.

"MOST PEOPLE, I THINK, THEY'RE UN-HAPPY about things. I'm usually an optimistic person," the young banker said this week. "Often I talk with my friends, they say, 'Oh, you should have gone to an NGO, you should have done this, you should have done that.' But the truth is, I have very good friends who left banking a few months ago and went to Africa or Haiti. You see these people. I talk to them regularly. And they can't really help. So you help better by working and getting money and then helping others."

But why is he making his money as a banker, the icon of villainy? "There have been lots of abuses on Wall Street, but Wall Street is a lot bigger than banks. There can't be just one bouc émissaire," he said. "The economy goes bad, and then you need someone to blame. And it's the bankers. And I don't think the bankers are the only people to blame." There are the rating agencies, for one thing, and sleepy regulators, and voracious consumers. And bankers' flaws, he said, are the flaws of man. "It's the way humans are, and that's a shame, but that's how the thing works. People think that there's one guy who plays the system. There's not one guy. Everyone plays it a little. It's a chain, and it's harmless, but altogether it's a disaster."

Over another cappuccino, he talked about leaving to travel and start up cafes. His father is an engineer who eventually started a farm, restaurants and an oil company. "I said to myself a long time ago that the day I have enough money to work for myself, I'll stop working. I don't like working for other people."

Then he started thinking about Wall Street people who have to look at screens for 14 hours every day, and that got him wondering about people in general, especially mothers pushing each other on Black Friday to shop for Christmas presents. "It's like, really?" he said. "That's what mankind has created?"

## Wells Fargo Deliberately Pushed Dangerous Loans On Blacks, Hispanics: Lawsuit

Wells Fargo has been accused of targeting minorities with predatory high-cost home loans that pushed them into default and foreclosure.

Cook County, Illinois, which is home to the city of Chicago, filed a lawsuit in federal court on Friday against the nation's largest mortgage lender. The suit alleges that Wells Fargo contributed to the housing crisis, which the county claims has cost it millions of dollars in lost property tax and the cost of having to deal with abandoned buildings, among other issues. The lawsuit says damages could exceed \$300 million.

Wells Fargo deliberately issued home loans with high interest rates and inflated or improper fees to black and Hispanic borrowers, many of whom would not have qualified for a traditional loan, the suit alleges. The lawsuit also charges that the bank did so even when it was clear the borrowers wouldn't be able to keep up with the costly payment plans. Such practices are known as "equity stripping," the suit says, because they "stripped and continue to strip borrower home equity." As a result, the chances that minority borrowers would fall behind on payments or be forced to submit to foreclosures were increased, it said.

Between 2000 and August 2014, Wells Fargo allegedly made about 55,000 loans to minority homeowners in Cook County that are suspected of being predatory and discriminatory, according to a statement released by Cook County Board President Toni Preckwinkle and Cook County State Attorney Anita Alvarez.

Wells Fargo vehemently denies the allegations, calling them "baseless." "It's disappointing they chose to pursue a lawsuit against Wells Fargo rather than collaborate together to help borrowers and home owners in the County," company spokesman Tom Goyda told HuffPost in a prepared statement.

"Wells Fargo's team members live and work in the Chicago area and we stand behind our record as a fair and responsible lender," Goyda said, adding that the company has an \$8.2 million down payment assistance grant program that "helped create 547 new homeowners" in Cook County over the past two years.

"We will vigorously defend ourselves and continue to focus on helping customers succeed financially and expanding homeownership in Illinois and across the United States," he added.

The suit alleges that Wells Fargo violated the Fair Housing Act, a federal law that prohibits racebased discrimination by mortgage lenders.

Cook County has walked this path before: Preckwinkle and Alvarez filed very similar suits earlier this year against HSBC and Bank Of America. Bank Of America spokesman Richard Simon said there "is no basis" for the claims the lawsuit makes. HSBC did not return a request for comment to HuffPost.

In the past, cities including Baltimore and Miami have also sued Wells Fargo and other banks on allegations of discriminatory home lending practices. A lawsuit brought by Baltimore against Wells Fargo charging that the bank steered minority homeowners into costly loan agreements and also charged minorities higher interest rates and fees than white borrowers with the same credit scores was ultimately settled in 2012 for \$175 million.

More recently, though, a judge dismissed a suit from the city of Miami against the bank, saying there was no standing to sue under the Fair Housing Act and that the suit had been brought too late, according to Bloomberg News.

## **Dollar Bank buys August Wilson Center for \$1,912.50**

After a late lien claim disrupted a final deal from closing last week, the August Wilson Center for African American Culture went to sheriff's sale where Dollar Bank, which holds a mortgage of more than \$7 million on the property, bought it for cost and fees of \$1,912.50.

There were no other bidders for the property.

Eric Schaffer, the lawyer who represented Dollar Bank in the proceeding, declined to comment as he exited the room in the Allegheny County Courthouse in which the sheriff's sale took place.

It was the latest twist in an ongoing legal process for the beleaguered downtown African American cultural center, which Dollar Bank sought to originally foreclose on in September 2013. Since then, the center's fate has been through the courtroom of Allegheny County Court of Common Pleas Judge Lawrence O'Toole. A New York-based bidder called 980 Liberty Partners was approved by the court as the high bid to buy the August Wilson Center and build a 200-room hotel on top of it, while working out an arrangement to maintain a cultural center function in the building on a more limited basis.

It was a prospect that galvanized the political leadership of the city and county against it, supporting instead a proposal by a group of foundations led by the Pittsburgh Foundation and the Heinz Endowment to buy the property and re-establish its original mission. A dispute filed by the Urban Redevelopment Authority of Pittsburgh, the original seller of the land on which the center was built, sought to maintain the restricted use of the facility as a center for African American culture. Then a deal was worked out where 980 Liberty dropped its bid to the buy the building and Judith Fitzgerald, the court-appointed receiver for the property, agreed to rescind the sale and instead

sell the property to the foundation group.

Dollar agreed to the deal to sell the property to the foundation group as part of the deal in late September, under the condition that the property would go to sheriff's sale if an agreement could not be finalized. But then a new snag happened in recent weeks, with a Bethel Park security firm trying to get \$200,000 it was owed. Now, Dollar is the owner of the August Wilson Center and it remains to be determined if the bank would follow through on the deal or pursue another option.

# Are Alternative Small-Business Lenders Headed for the Mainstream?

Online small business lenders frequently bill themselves as speedboats running circles around banks' lumbering cargo ships.

Because they're less encumbered by regulation, the theory goes, they can use creative, automated underwriting models to make faster lending decisions and extend credit to a broader range of borrowers. But as the industry gains popularity, more alternative lenders have been forging partnerships with banks — prompting the question of whether these digital disruptors could join the mainstream financial system.

At American Banker's Small Business Banking conference in Miami last week, a community banker in the audience asked a panel of online small business lenders whether their firms would ever consider becoming an insured institution. The panelists gave different answers.

"I don't think we should take deposits or be bought by a bank," said James Hobson, chief operating officer at OnDeck. "That would kill the role we have to play. We should be the innovators trying new things first, and we should be doing that on our dime."

Sam Graziano, chief executive and co-founder of Fundation, sounded more amenable to the idea of alternative lenders joining the ranks of the banking system. But he said that day, should it come, remains a ways off.

"To get comfortable with the way we predict risk and the risks we're willing to take is outside the tolerance many regulators have," Graziano said. Online lenders pride themselves on harnessing a wide range of data to pluck out creditworthy applicants rather than relying solely on more conventional indicators like FICO scores and tax returns.

However, Graziano predicted that as online lenders "get more cost-efficient and smarter," the industry will be primed to commingle with banks.

"That could be more tightly integrated partnerships, or it could mean becoming part of the banking system because of the proven way that models can work," Graziano said.

The unconventional nature of alternative lenders' underwriting models emerged as another hot topic at the panel. CAN Capital's vice president of product management, Krystl Black, explained her company's practice of incorporating small business owners' social media profiles into lending decisions.

"If you look at a nail salon's Yelp reviews or Facebook page, you can confirm that they're one that people enjoy visiting and that they'll be a good credit-quality customer," Black said.

That data, used alongside more traditional credit-risk indicators, "helps us make decisions when we don't have all the financial facts," she said. But Graziano disputed social media's usefulness as a tool for evaluating loan applicants, arguing that the people who post Yelp reviews are frequently friends of the store owner.

"It's not adding predictive power to predict the likelihood of default," he said.

Moreover, Graziano pointed out that reliably profitable businesses like doctor's and dentist's offices often "don't have digital footprints to the same degree that consumer [businesses] do."

OnDeck's Hobson acknowledged the limitations of using stores' online presence to determine credit risk, but pointed out that traditional measures like FICO scores can also fall short.

"We're taking a long time to develop models, and the only way to develop them is to have bad ones," he said. "That means you have to lose money and move at a responsible rate in terms of how you should grow. If you invest and build now, you can understand what the presence or absence of data means to a credit profile."
