

The Fight For Fair Housing Still Rages On

The Fair Housing Act, passed by Congress in the aftermath of the assassination of Rev. Dr. Mar-tin Luther King Jr. on April 4, 1968, and signed into law by President Lyndon B. Johnson, seven days later, is one of the great legislative achievements of the era. It is intended to prohibit discrimination in the financing, rental or sale of any lodging based on race/color, religion, ethnicity or national origin. Amendments to the Act have extended coverage to prohibit discrimination based on sex (gender), disability, or marital or familial status. Individual states have further extended protections to prohibit discrimination based on age, sexual orientation and gender identity, and veteran status. The Act also provided legal mechanisms people could use to help ensure they were given the right to live wherever and in whatever neighborhood they chose.

However, nearly 50 years after this historic legislation was passed, thousands of minorities still grapple with the issue of housing discrimination today, thereby being prevented from living their own housing dream.

Beginning in the late 1970s, the Department of Housing and Urban Development (HUD) has rigorously monitored trends in racial and ethnic discrimination in both rental and sales markets approximately once each decade through a series of nationwide paired-testing studies. Although the most blatant forms of housing discrimination refusing to meet with a minority home-seeker or provide information about any available units have declined since the first national paired-testing study in 1977, the forms of discrimination that persist — providing information about fewer units — raise the costs of housing search for minorities and restrict their housing options.

According to the 2012 Housing Discrimination Study conducted by HUD, Black renters who contact agents about recently advertised housing units (rentals) learn about 11.4 percent fewer available units than equally qualified whites and are shown 4.2 percent fewer units; Hispanic renters learn about 12.5 percent fewer available units than equally qualified whites and are shown 7.5 percent fewer units; and Asian renters learn about 9.8 percent fewer available units than equally qualified whites and are shown 6.6 percent fewer units.

Likewise, when it came to properties for sale, minority homebuyers are rarely denied appointments that their white counterparts are able to make. However, black homebuyers are slightly more likely than equally qualified whites to be denied an in-person appointment (2.4 percent-

Record-Breaking Year For Bay Area & California Tourism Economy

Visit California, a nonprofit organization dedicated to promoting California on behalf of the state's tourism industry, today announced at a press conference at Lake Merritt that 251 million people traveled in California in 2014, and total travel-related spending reached \$117.5 billion. That spending supported more than 1 million jobs and generated \$9.3 billion in state and local tax revenue. Visitors in the Bay Area spent nearly \$30 billion, which supported more than 221,000 jobs and generated \$2.5 billion in state and local tax revenue in the region. The growing value of the tourism industry demonstrates why California must continue attracting visitors in an increasingly competitive global market in order to remain a top-of-mind travel destination.

"The Bay Area is leading the growth of California's tourism economy, which benefits of all Californians," said Visit California President and CEO Caroline Beteta. "This report shows that visitors who inject billions of dollars into our economy – especially here in the Bay Area – lift businesses in all sectors, create jobs and support local economies."

A report by Dean Runyan Associates, conducted on behalf of Visit California, shows the economic impacts of travel to and through California from 1992 to 2014. The report includes statewide and county-by-county information as well the economic benefits of leading tourism sectors such as hotels, rental cars and retail. The study shows that 53 out of California's 58 counties saw an increase in direct travel spending compared to 2013, including:

- Alameda: \$3.65 billion in traveler spending, up from \$3.52 billion
- Contra Costa: \$1.49 billion, up from \$1.48 billion
- Marin: \$835 million, up from \$797 million
- Napa: \$1.16 billion, up from \$1.14 billion
- San Francisco: \$13.83 billion, up from \$13.08 billion

Presidential Proclamation -Asian American and Pacific Islander Heritage Month, 2015

The rich heritage of Asian Americans, Native Hawaiians, and Pacific Islanders spans the world and the depths of America's history. Generation after generation, Asian Americans and Pacific Islanders have forged a proud legacy that reflects the spirit of our Nation -- a country that values the contributions of everyone who calls America home. During Asian American and Pacific Islander (AAPI) Heritage Month, we honor the perseverance of those who courageously reached for their hopes and dreams in a new land, and we celebrate the important impact the AAPI community has made on our Nation's progress.

From the more than one million immigrants who journeyed across the Pacific and arrived on Angel Island to the Chinese-American laborers who risked their lives to link our coasts by rail, the determination of this vibrant community represents the best of our national character. In each chapter of our country's story -- in places like Selma and the grape fields of Delano, during the moments where our Nation's destiny has

been decided -- AAPIs of all backgrounds have set inspiring examples as leaders and trailblaz-ers, united by a common hope for civil rights, equal treatment, and a better tomorrow for all Americans.

Through times of hardship and in the face of enduring prejudice, these women and men have persisted and forged ahead to help strengthen our Union. Native Hawaiians have fought to protect their treasured traditions, language, and lands. And AAPI patriots have defended the beliefs for which we stand. Seventy years ago, the United States and our allies secured a lasting peace throughout the Asia Pacific region and much of the world -- a victory achieved in part by thousands of Filipino Americans who fought valiantly but were denied compensation, and also by Japanese Americans who served this country even as the freedom of their loved ones was denied.

Fifty years ago, the United States opened new doors of opportunity to more Asian and Pacific Islander immigrants through the Immigration and Nationality Act of 1965, ending the arbitrary and outdated policies that unfairly limited the potential of entire regions. This year also marks the 40th anniversary of the end of the This year also Vietnam War, which brought new Vietnamese, Cambodian, Hmong, and Laotian communities to this country. But as we recognize the enormous progress America has made, we must also acknowledge the many struggles AAPIs continue to experience in the face of persistent inequality and bigotry, including barriers to equal access to education, employment, and health care. South Asian Americans -- especially those who are Muslim, Hindu, or Sikh -- too often face senseless violence and harassment due only to the color of their skin or the tenets of their faith. And to this day, many AAPIs continue to live in the shadows and are separated from their families due to our broken immigration system.

My Administration is committed to addressing these unmet needs and the ugly discrimination that still exists. I was proud to re-establish the White House Initiative on AAPIs soon after I took office, to foster opportunities for increased access to and involvement in Federal programs. As part of that effort, my Administration is expand-ing its regional network of Federal leaders and hosting community meetings across the country to better understand the needs of the diverse AAPI community. Last year, I announced my intent to take actions that would allow more high-skilled immigrants, graduates, and entrepreneurs to stay and contribute to our economy, and I continue to call on the Congress to pass comprehensive immigration reform. To highlight the tremendous growth of the AAPI community and my Administration's commitment to increasing opportunity

Public Policy Freedmen's Super 8(a) Tribal Government Power


The Code of Federal Regulations (CFR) states the definition of an Indian Tribe; means any Indian tribe, band, nation, or other organized group or community of Indians [Freedmen's], which is recognized as eligible for the special programs and services provided by the United States to Indians because of their status as Indians. This allows Freedmen's forming Community Development Corporations (CDC) install tribally owned profit-making business subsidiaries' organizations, as prime federal government contractors. Tribally-owned concern means any

concern at least 51 percent owned by an Indian tribe (Freemen's) as defined in the Code of Federal Regulations (CFR).

The federal government spends hundreds of billions of dollars annually to acquire goods and services from the private sector to support agency missions. Under special Tribal Govern-ment Contracting Laws, Tribally Owned firms incorporate federal government market development, the process used to collect and analyze data about capabilities in the market that satisfy agency needs.

The federal government spent \$700 billion for goods and services in 2014, Freedmen's CDCs and their subsidiaries had and will continue to have direct access to the \$700 billion as special federal government contractors. As a Tribal Government, Freedmen's CDCs can accept or select federal contracts in all industries and need no experience of service. The CFR states that there are no dollar limits on the amount of contracts that a Participant (Freedmen Certified Organization) may receive. This is a special Small Business Administration 8(a) rogram, designed for Native Americans, see 13CFR124.109.

\$200 million Entertainment Village Breaks Ground in Inner City LA

Los Angeles-based Sassony Properties broke ground this week on a \$200 million retail destination center in a forgotten portion of South Los Angeles. The new, two-city-block long Vermont Entertainment Village will be located at the intersection of Vermont Avenue and Manchester Avenue, a corner left blighted and vacant since the 1992 Rodney King riots.

The nearly six-acre site of the project was previously used for an indoor swap meet that was burned down during the riots. In a symbolic gesture of rebirth, the city and developer broke ground on the new project on April 29, the 23rd anniversary of the upheaval.

When complete in late 2016, the 190,000 sqft Vermont Entertainment Village will boast retail shops, multiple sit-down restaurants, a grocery store, a pharmacy and a movie theater. There will also be a 40,000-sq-ft open-air central courtyard promenade with a performance stage to accommodate social gatherings, and a five-story parking structure with 426 on-site parking spaces (including two subterranean levels).

The project is being designed by Architecture Refined Corp. (ARC) of Diamond Bar, CA, the environmental engineer is Terry A. Hayes Associates or Culver City, CA, and the landscape architect is Phil May Landscape Architect of Upland, CA.

The website for Vermont Entertainment Village says the project is a unique retail, food, dining and supermarket blended together to create a cultural wonderland of shopping, dining and entertain-




ment." Project renderings show a development similar to The Grove in Los Angeles and Universal City Walk in Studio City. Estimates say that besides the shopping and entertainment components, the Vermont Entertainment Village is also expected to bring in somewhere in the neighborhood of

\$99 million annually in sales tax revenue to the city.



age points). And When homebuyers meet in person with housing providers, they are usually told about at least one available unit. However, agents frequently tell one tester about more available homes than the other, with whites significantly more likely to be favored than blacks and Asians. Consequently, for every two visits, black and Asian homebuyers learn about one fewer home than equally qualified whites.

Specifically, Black homebuyers who contact agents about recently advertised homes for sale learn about 17.0 percent fewer available homes than equally qualified whites and are shown 17.7 percent fewer homes; and Asian homebuyers learn about 15.5 percent fewer available homes than equally qualified whites and are shown 18.8 percent fewer homes.

Clearly, prejudice has by no means disappeared and the fact that minorities still face significant barriers to housing search, even when they are well-qualified as renters or homebuyers, is "a very serious problem," says Joe Rich, co-director of the Fair Housing & Community Development Project at the Lawyers' Committee for Civil Rights Under Law (Lawyers' Committee). "In areas that may have previously been predominantly white, we are seeing more diversity. But there is still a very stubborn pattern of African Americans and Latinos being completely isolated from (living in certain areas).

"Back in the 60s and 70s there was more blatant discrimination in housing practices. However, the very subtle, nuance discrimination that is found by the testing has continued and as a result, minorities continue to get fewer housing opportunities. The report shows some improvement but still serious problems," he continues.

In addition to the Fair Housing Act and its various amendments, since 1991, the Act has required every new apartment building to have basic accessibility features. And yet, as with other fair housing issues, violations are rampant and enforcement has been weak.

"There's significant discrimination against disabled people. In fact, I think the statistics show that there's probably more housing discrimination complaints filed alleging discrimination against disabled persons than other protected classes," says Rich. "The discrimination against disabled persons is in the form of not making rental property accessible even though the 1998 amendments to the Act made clear that there was a responsibility for anybody building multi-family housing of a certain size to meet the requirements to make the building and its units accessible to disabled people."

At the time of this printing, a major U.S. Supreme Court decision affecting fair housing is pending. In January, the Supreme Court heard arguments that challenge a key feature of the Act — the disparate impact standard. With the recent gutting of the Voting Rights Act, the civil rights and fair housing community have stressed the importance of protecting the vitality of the basic principles of racial equality.

"Continued enforcement of the Fair Housing Act through the use of the disparate impact standard is an essential component of our efforts in furtherance of that dream," says Rich. "Historically people have shown discrimination by proving through circumstantial or blatant evidence that discrimination has been done intentionally. That's been the traditional way of proving it. But for over 40 years, 11 out of 12 Courts of Appeals have also recognized another standard of proof that is called disparate impact. It does not require proof of intentional acts of discrimination. Instead, it's set up in a way that you can prove it through showing that actions by a housing provider or governmental agency has an unjustified disparate impact against minority people."

HUD passed a regulation about this standard of proof in 2013 and for the last few years the Supreme Court has taken cases that have challenged whether the Fair Housing Act actually recognizes this standard of proof.

"It's never been before the Supreme Court before, but there are 40 years of Courts of Appeals decisions unanimously saying, yes, that standard of proof can be used. The Supreme Court has taken three cases now asking that question for itself," says Rich. Two of those cases were settled before arguments could be heard; the third remaining case is a case from Texas in which arguments have been heard and a Supreme Court decision is expected sometime in the next two months. That will decide the question of whether such a standard of proof can, in fact, be used.

"The Supreme Court's decision is pending and the decision will affect the standard of proof for showing whether there's housing discrimination," says Rich. "(It) will have a major impact on fair housing enforcement – either way."

No matter the decision, those concerned about fair housing say steps to ferret out and address the discrimination and disparity must continue. According to the 2012 HUD study, because the forms of discrimination are very difficult for victims to detect, enforcement strategies should not rely primarily on individual complaints of suspected discrimination. HUD should encourage the local fair housing organizations it funds to conduct more proactive testing, especially in the sales market, where discrimination appears higher than in the rental market. Local fair housing organizations should also expand and strengthen their relationships with Hispanic and Asian communities to address the discrimination experienced by all people of color. Historically, the fair housing movement has focused on discrimination against blacks. Although some local organizations have extended their scope in light of changing demographic realities, others have not yet done so.

In addition, more locally targeted research testing may be needed to pinpoint the types of neighborhoods, housing providers, or homeseekers where discrimination is most prevalent. In particular, minority home-seekers with lower incomes, less wealth, weaker English language fluency, or blemished credit may face higher levels of discrimination than documented in this study. As attitudes and market practices evolve, policymakers and fair housing practitioners need reliable research not only on patterns of discrimination, but also on other factors that may contribute to residential segregation and disparities in neighborhood quality. Rich believes that not only does testing need to continue, we need to have more education so housing providers, lenders, Realtors, and the like, are fully aware of what the Act requires and what it prohibits.

Meanwhile, the Fair Housing & Community Development Project will continue to work tirelessly to continue to fight discrimination in housing through enforcement of the Fair Housing Act and will continue its effort to preserve disparate impact liability as a vital tool for realizing the promise of inclusive communities, meaningful fair housing choice, and Dr. Martin Luther King's dream.

In a press release the Project stated "The legacy of our country's unconscionable history of systematic housing discrimination manifests itself anywhere racial disparities exist. From the wealth gap, to life expectancy, to educational opportunities, to unemployment and more, every metric of well-being and opportunity is defined by zip code. These blatant inequities make it abundantly clear that the battle for fair housing has not yet been won."

- San Mateo: \$3.16 billion, up from \$3.03 billion
- Santa Clara: \$5.01 billion, up from \$4.78 billion
- Solano: \$637 million, up from \$622 million
- Sonoma: \$1.76 billion, up from \$1.73 billion

Bay Area spending increased by 4.7 percent from 2013 to 2014, tied with San Diego County for the largest percentage increase of any California region. For the first time, the report calculated the secondary impact of income spent by industry businesses and employees, bringing total direct and indirect employment supported by the travel industry to more than 1.73 million employees who earned a total of \$76.80 billion.

Visit California plays a leading role in the success of the industry by attracting potential travelers in domestic and top international markets to visit and explore the Golden State. The report found that Visit California's marketing efforts brought more than 4 million additional visitors to the state who spent approximately \$8.1 billion while visiting California – a return on investment of \$327 for each marketing dollar spent. To help California remain a premier travel destination, on May 22, a \$116 million budget for fiscal year 2015-16 will be presented to Visit California's board. This is an 87 percent increase from the 2014/2015 budget based on the tourism industry's support of an increased assessment to fund marketing activities.

"There is a direct link between tourism and California's economic success," said Beteta. Although Tyson is almost six now, he still seems a bit small for his age. No problem. In preparing his efficiently rustic lemonade stand for National Lemonade Day on May 3, 2015, he made the wise entrepreneurial decision to hire two skilled, reliable employees also known as Dad and Mom. Rather than diversifying his menu with cookies or other complementary items, Tyson opted for excellence in the basics.

Previously unaware of the yearly event, we were driving along in our van when we spotted the little stand that he and his staff had situated outside a trendy cafe by previous agreement with the owners. The stand had been sturdily constructed a month earlier with assistance from the pros at the local Home Depot kids workshop.

Tyson had serious competition from several other lemonade stands in the same few downtown blocks, but his business was brisk enough on a leisurely Sunday afternoon in a small city. Although his price was higher than others we had seen, he secured our patronage by pouring generous sample portions for each of us. They were delicious

We bought three large cups with domed lids and straws at \$2.00 apiece—a sweet lemonade and tea combo, and two strawberry drinks with fresh fruit and whipped cream. Classic lemonade was also available. Tyson earnestly selected the ingredi-

ents from the portable cooler, blended and served the beverages, took the money, and returned the change. Sorry, no checks, no plastic.

Dad and Mom chatted with customers and assisted as needed, without hovering. Tyson knew what he was doing. Encouraged by the national organizers, he had even budgeted his anticipated profits into three categories: some for himself to spend, some for a charitable cause, and some for saving or reinvesting. www.lemonadeday.org

Little Tyson started small, but his carefully planned step-by-step preparation over many weeks is evidence of a dream much bigger than his three hours of selling lemonade on a city sidewalk. He was surely inspired by the hundreds of thousands of other participating kids nationwide, including many in various Northeast cities. Each kid had registered and received free of charge a yellow backpack and an entrepreneurial workbook with fourteen lessons. Many people, businesses, organizations, and sponsors had helped along the way including countless local health departments that had approved permit waivers for a day.



The National Lemonade Day website explains some of the benefits beyond the financial: Youth learn the steps and planning necessary to start a business, but just as importantly, learn valuable life skills such as leadership, collaboration, responsibility, and teamwork. They learn to set a goal, make a plan, and work their plan to achieve their dreams. Community Banks Have the Power to Lighten Their Regulatory Burden

There has been much discussion in the press, legislature, among regulators and in the banking industry about the growing and untenable regulatory burden on community banks. There is a consensus that even with the current tiered regulation efforts, the burden is unfair, and threatens the very existence of the community bank model.

In the past few months several regulatory officials have made specific statements about their efforts to lighten the regulatory burden on community banks. In April, Maryann F. Hunter, the Deputy Director of the Division of Banking Supervision and Regulation at the Fed, stated before the U.S. House of Representatives:

The Federal Reserve has several internal efforts underway aimed at providing regulatory relief for community banks.

Later the same month, the Fed's Governor Daniel K. Tarullo, at the Independent Community Bankers of America 2015 Washington Policy Summit noted: At the level of application, we need to tailor prudential regulations and supervisory practices with an eye both to those varying objectives and to the characteristics of differing [sized] groups of banks.

Speaking for the Conference of State Banking Supervisors in March, Candace Franks, chairman of the CSBS, stated:

One of our big concerns is that a one-size-fitsall approach to regulation is really going to harm the viability of community banks.

While the government and the industry try to work out a achievable scenarios to lighten the regulatory load on community banks, what may have gone unnoticed is that the regulators have already outlined how community banks can relieve some of the burden themselves.

Deputy Director Hunter put it this way in her recent speech to Congress:

.... If a well-managed bank's activities are lower risk, we adjust our expectations for examiners to a lower level of review. In this way, we alleviate examination burden on community banks with histories of sound performance and modest risk profiles. This is a very clear statement of direction that equates the level of regulatory scrutiny with the level of risk management practices of the institution. While most community bankers would agree that banks with higher risk activity are treated more harshly, the statement by the Hunter appears to go a step further:

The Federal Reserve has an initiative currently underwayto identify high-risk community and regional banks, which would allow us to focus our supervisory response on the areas of highest risk and reduce the regulatory burden on low-risk community and regional banks...

This statement should create a very high incentive for community banks to find ways to be perceived by the agencies as "low risk".

What kinds of practices would help a community bank be considered "low risk"? Since the economic downturn numerous guidance and speeches from the various agencies have focused on best practices for risk management in community banks in three key areas:

- Capital Planning
- Stress Testing
- Concentration Management

From the OCC's 2012 bulletins on stress testing and capital planning and adequacy to the comptroller's handbook on concentrations of credit, the message is clear: Demonstration of a systematic approach to proactive credit risk management by a bank is a successful method to create a lower level of risk.

These areas are the obvious "regulatory hot buttons" for risk management and so naturally would be high visibility areas for community bankers to focus on to demonstrate their lower risk status. The regulators have repeatedly emphasized that the implementation of a framework of proactive risk management (including the three best practices listed above), whether it's described as "enterprise risk management" or just a sound credit risk management program, is a key component of risk management.
