First-ever White House Hispanic Business Leaders' Forum

business leaders from across the country for the first-ever Hispanic Business Leaders' Forum. The event, held in conjunction with the U.S. Hispanic Chamber of (USHCC), focused on jobs and the economy. It engaged representatives from the private sector with top-level Administration officials in robust dialogue about the most pressing issues affecting American businesses and how to collaborate more effectively to foster economic competiveness, particularly in Latino communities.

The day-long event included panels with senior Administration officials discussing the economy, innovation and entrepreneurship, health care, federal contracting and commonsense immigration reform. Around 80 top Hispanic business leaders attended the Forum, from a range of industries, many are from Fortune 500 firms or top professional firms, and the next generation of high-growth entrepreneurs.

Senior Obama Administration officials that presented at the Forum included Treasury Secretary Jacob L. Lew, Cecilia Muñoz, Assistant to the President and Director of the White House Domestic Policy Council, Todd Park, U.S. Chief Technology Officer and Valerie Jarrett, Senior Advisor and Assistant to the President for Public Engagement and Intergovernmental Affairs.

On the significance of holding the Forum in her opening remarks, Senior Advisor and Assistant to the President for Public Engagement and Intergovernmental Affairs Valerie Jarrett said: "To compete in today's economy, we must draw from the talents, perspectives, and leadership of every community in our country. Today's inaugural White House Hispanic Business Leaders' Forum is a key part of making this a reality.'

During an Economic Overview at the Forum, Treasury Secretary Lew underscored that "Our economy is stronger today because our businesses are doing what they do best—innovating, expanding and hiring," Treasury Secretary Lew continued "With the number of Hispanic-owned businesses growing at twice the national average, the Hispanic community is playing a critical role in the recovery. But as the business and community leaders I met with today agreed, we must do more to strengthen the middle class so that more Americans can get back to work and more businesses can succeed. Our top priority as a nation has to be growing the economy and creating good jobs in the United States."

Later at the Forum, during a panel on Entrepreneurship, Innovation & Open Data, Assistant to the President and US Chief Technology Officer Todd Park highlighted that "The Administration is undertaking all kinds of actions in support of technological innovation -- including making government information freely available to the public to fuel tech entrepreneurship and collaborating with educators, the private sector, and others to help connect all youth to tech skills and opportunity."

The White House looks forward to continuing these discussions with the Hispanic business leaders who attended today's Forum. In closing Director of the White House Domestic Policy Council Cecilia Muñoz emphasized that "Today's Forum highlights the critical role that Hispanic business leaders play in shaping economic growth and in fixing our broken immigration system to ensure that everyone plays

by the same rules." She added, "These business leaders know firsthand that commonsense, comprehensive immigration reform is good for our economy and positions America to continue to lead in the 21st century."

CDFI Fund Opens Application Period for FY 2013 CDFI Bond Guarantee Program

The U.S. Department of the Treasury's Community Development Financial Institutions Fund (CDFI Fund) today opened the inaugural application period for the CDFI Bond Guarantee Program by posting the application materials on its website in anticipation of the publication of the Notice of Guarantee Authority (NOGA) in the Federal Register on June 14, 2013. The NOGA makes up to \$500 million in bond guarantee authority available to eligible Community Development Financial Institutions (CDFIs) in fiscal year (FY) 2013.

Through the CDFI Bond Guarantee Program, certified CDFIs or their designees will issue bonds that are guaranteed by the Federal government and use the bond proceeds to extend capital within the broader CDFI industry for community development financing and for long-term community investments. The Secretary of the Treasury may guarantee up to five bonds in FY 2013, each at a minimum of \$100 million, with a total of up to \$500 million in bonds guaranteed. Multiple eligible CDFIs may pool together in a single \$100 million minimum bond issuance provided that each eligible CDFI participates at a minimum of \$10 million.

'I am proud to open the first round of the CDFI Bond Guarantee Program, which will ultimately lead to greater investment in low-income and distressed communities by CDFIs, and amplify the economic impacts of these essential financial institutions," said CDFI Fund Director Donna J. Gambrell. "This exciting opportunity also has great potential to strengthen and expand the CDFI industry.'

Through the CDFI Bond Guarantee Program, the Treasury Secretary will guarantee the full amount of bonds issued to support CDFIs that make investments for eligible community or economic development purposes

Authorized uses of the loans financed through bond proceeds may include a variety of financial activities, such as supporting commercial facilities that promote revitalization, community stability, and job creation/retention; the provision of basic financial services; housing that is principally affordable to low-income people; businesses that provide jobs for low-income people or are owned by low-income people; and community or economic development in low-income and underserved rural areas.

The CDFI Fund published the CDFI Bond Guarantee Program's Interim Rule in the Federal Register on February 5, 2013, and received more than 30 individual comment letters from CDFI industry leaders and practitioners. The 60-day comment period on the Interim Rule concluded April 5, 2013. The comment letters received have all been reviewed by the CDFI Fund, and are available on its website.

Gov. Brown Highlights Chinese Investments in Oakland

California Gov. Jerry Brown announced Sunday that California stood to gain from improved political and economic ties between China and the United States, reports the Sing Tao Daily. Speaking at a public event in Oakland, Brown highlighted the promise this held for the city.

In Oakland, Chinese investments promise to top \$1 billion, said Brown, alluding to a well-reported waterfront housing project agreed to during the governor's trip to China in April. The project is to be spearheaded by the Chinese-owned Zarsion Holdings Group.

Brown met with visiting Chinese President Xi Jinping on Saturday in Southern California. The meeting, which lasted some 40 minutes, followed Xi's summit with President Barack Obama, during which the two discussed a range of topics including cyber security, North Korea and bilateral trade ties.

"China has huge sums of capital they're looking to deploy around the world ... California would be one of the spots of focus," Brown, quoting Obama, told reporters after his meeting

Brown also raised the issue of climate change with Xi during their talks, highlighting measures that California has taken under his administration. An agreement on reducing the amount of hydrofluorocarbons, seen as a key contributor to global warming, was one of the highlights of Xi's meeting with Obama.

Despite being separated by an ocean, longstanding historical ties between China and California serve as a foundation for future cooperation, Brown told his audience in Oakland.

Prevailing Wage Recoupment Reporting: A Q&A

In the wake of the California Department of Industrial Relations' (DIR) recent citations against four contractors engaged in public works within the state, documenting recoupment becomes significantly important. This importance is driven, in part, by the DIR's new and clearly aggressive enforcement of prevailing wage and related requirements.



The question posed in the contracting community is, "How do I properly document repayment?"

Unfortunately, there is no single or simple answer.

Fortunately, it won't matter much, provided the contractor takes a key step: Document expansively.

Further, according to Reginald Cosey, a field interviewer for federal and state public works projects in California and Nevada, for SysTech Forensics, a labor compliance management firm, "Everything hinges on the enforcement agency. It will tell you what it wants and how it wants it. Even regulatory direction won't supersede agency direction."

Bambille Ayala, also with SysTech and a former U.S. Army purchasing agent and current labor compliance specialist, added, "(The) requirements for documenting recoupment vary from agency to agency and, within agencies, from agent to agent. I suggest the contractor record carefully whatever direction is given by the agent. That will be important down the road in the event recoupment is challenged."

In a LinkedIn online forum of

specialists, where the question was also posed, Renee Calvert, a compliance specialist with Brasfield & Gorrie LLC, of Gardendale, Alabama, offered, "Underpayment to employees should be documented with a letter of explanation to the employee that is clear on the date(s) for which the payment is for, whether it is overtime or straight time and the calculation of the amount for which the check is issued."

Nancy Smyth, president of Sunburst Software Solutions Inc., and a QuickBooks blogger and consultant, who'd just returned from a prevailing wage conference where the question was on the floor, said, "HUD (federal Dept. of Housing and Urban Development) will accept a single certified payroll report showing employees' total restitution hours, restitution rate, gross (pay), deductions, net (pay). Make sure that it is a separate check. (M)ake the employee sign off on the letter as to having received the money, make sure that you include the check number in the letter, keep paystubs, etc. "And, critically, she added, "Above all, document, document and keep excellent records!"

"Most people I have dealt with prefer to issue separate checks for each

prefer to issue separate checks for each week that was underpaid." added Calvert. "That way, it is easier to put with the revised payroll records that are turned in."

Cosey added, "Nothing is finished unless the paperwork is finished."

"And the paperwork isn't finished unless it is correct," chimed in Ayala.

California Labor Commissioner Holds Prime ContractorsResponsible For Its Subcontractors

Prime contractors are jointly liable for the wage violations of its subcontractors, announced California's labor commissioner in a press release dated June 6, 2013.

In a slate of recent citations, issued on four public works projects, California labor commissioner Julie Su held four prime contractors responsible jointly for violations of their subcontractors. Involving four public works projects in Central and Southern California, the violations totaled \$748.366, and covered 89 workers.

One case was in Orange County. A framing subcontractor failed to pay correct straight time and overtime wages to 25 of its workers. The subcontractor was assessed \$117,837 for unpaid wages,

\$30,800 in penalties, and \$539 in apprenticeship contributions, according to the press release.

The second case involved hospital construction in Los Angeles. The cement and carpentry subcontractor underpaid hourly and overtime rates, and Saturday overtime rates, t

o 9 of its workers. The subcontractor was cited \$98,187 in unpaid wages, \$24,075 in penalties, and \$2,307 in apprenticeship training funds.

A school district in Bakersfield was the site of the third violation. An electrical subcontractor was cited for failure to pay prevailing hourly wage rates and premium Sunday rates to its workers. The citation was for \$119,472 in unpaid wages, \$77,350 in penalties, and \$1,392 in unpaid training

fund contributions

San Diego was the location of the final case. The self-performing prime contractor on a school project failed to pay correct prevailing wages, training fund contributions, and employ the proper number of apprentices. It was cited for \$152,079 in wage underpayments, \$100,950 in penalties, \$7,936 for unpaid training fund contributions, and \$16,000 in apprenticeship fines.

In each of the first three cases, the prime contractors were held jointly liable for the wage violations of the subcontractors. In the last case, the prime contractor performed the concrete and related work with its own personnel.

The DIR released a report in May 2013, entitled "State of the Division of Labor Standards Enforcement," which reported that "2012 saw the highest amount of wages and penalties assessed on public works jobs by the Division since 2002."

From the press release: "The Labor Commissioner is committed to effective public works enforcement in the state," said Christine Baker, director of the Department of Industrial Relations (DIR). The Labor Commissioner's office, also known as the Division of Labor Standards Enforcement (DLSE), is a division of DIR.

"Failure to pay the proper prevailing wage is a form of wage theft," said Labor Commissioner Su. "We will crack down on not only the subcontractors who steal workers' wages and fail to pay apprenticeship training contributions, but also on the general contractors so we put proper incentives on them to deal only with honest, law-abiding businesses in California."

Among its wide-ranging enforcement responsibilities, the Labor Commissioner's office adjudicates wage claims, inspects work-places for wage and hour violations, enforces prevailing wage rates and apprenticeship standards in public works projects, investigates retaliation complaints, issues licenses and registrations for various businesses and educates the public on labor laws. You will need business cards. Primes meet many subs so make sure your cards are memo-

- Your contractor license number.
- The top three services or skills your firm does best on the reverse side.

People want to do business with people who communicate well, meet a specific goal, and have a strong reputation. How are your social skills in face-to-face conversations? To team with a prime, you must bring value that will help the prime win the contract. Do your homework. Look for opportunities through websites, printed media, networking, associations or affiliations, and existing relationships.

Attend Mandatory and Non-Mandatory Pre-bid Meetings in your area. Bring business cards, your resume that covers at least three years of relevant work, and your capability sheet. Go early and view the project plans. Give your business cards to the bidding primes and collect cards from other subs you may want to contact for future reference. Primes gauge how prepared you are and use this impression as a measure for consideration of doing business with you.

If you have a good reference from another job, bring copies with you and staple your business card to it along with your resume and capability sheet. Many primes keep a list of subs with whom to consider doing future business.

Business runs on word-of-mouth referrals. Good news travels in these circles as easily as bad news. Concentrate on doing your best work at all times – it's good insurance for future job opportunities.

Be Prepared.

When ready to bid, make sure that your resumes and proposal documents are relevant, concise and persuasive. Prime contractors are busy. Respect this fact and keep your resume and capability sheet to one page each.

- If you have previously worked on government projects, list the job name, its size, and a contact for each one.
- Include your contact information. Provide a telephone number where you can be reached at almost any time.
- Attach a current print out of your federal and/or state business certification.
- · Capability sheet.
- Include your contact information and contractor license number.
- · List the services you offer in short descriptive phrases (for example, asphalt paving).
- State your bonding capacity and insurance. You will submit your capability sheet to

primes when you submit your bid.


