## Pittsburgh Tenth Street Bridge Rehabilitation

Spanning the Monongahela River in Pittsburgh since 1933, the historic Tenth Street Bridge is scheduled for extensive rehabilitation during the next few years. The Pennsylvania Department of Transportation is now soliciting bids for the project, which will include deck rehabilitation, approach roadway work, painting, sidewalks, and suspension cable resocketing. The total cost of

construction is estimated to be \$19,005,497. The downtown Pittsburgh suspension bridge, more formally known as the South Tenth Street Bridge, carries Tenth Street from Second Avenue and Armstrong Tunnel to near Muriel Street on the South Side. As of 2014, the traffic volume was approximately 12,000 vehicles daily.

The Tenth Street Bridge is the longest span crossing the Monongahela River. The length of the main span is 725 feet, while the total length, including the longest elevated ramp, is 1,275 feet.

This project, like many other publicly funded endeavors, requires a certain level of participation by small Disadvantaged Business Enterprises (DBEs) in the contract that will soon be awarded. Prime contractors, including Skanska and others, are seeking subcontractor and supplier participation by DBEs that are certified by the Pennsylvania United Certification Program (PAUCP). Please note that the bids for this project are due by August 11, 2016. Interested DBEs should contact the prime bidders before that date.

Among the specific DBE subcontractor or supplier opportunities for the Tenth Street Bridge Rehabilitation project are excavation, asphalt, bituminous pavement, concrete, drainage, fence, barrier, survey, waterproofing, schedule, landscaping, pavement marking, MPT, signs, electrical, drainage, demolition, structural steel, bearings, temp platforms, painting, handrails, and utilities.

This bridge rehabilitation project, currently scheduled for completion by February 2019, is part of PennDOT's Decade of Investment plan for reinvestment in Pennsylvania's transportation



system. The plan prioritizes projects most in need of funding through Act 89 resources approved in 2013. The list includes highway maintenance, major highway improvements, bridges, and intersections. A detailed project and progress map is available
