How to Get Your Workforce Bill Passed

SkillWorks:



Partners for a Productive Workforce



In a recent What Works case study, we highlighted how Boston-based SkillWorks has spent the past decade rallying private sector support for industry-specific workforce development programming. A truly public-private partnership, SkillWorks has leveraged \$60 million in funds for workforce development. The results are impressive: over 4,500 people have enrolled in a SkillWorks funded program, 66% of whom were unemployed before training.

Part of the success of SkillWorks has been its ability to garner state resources that support the private sector investment. The legislative efforts of SkillWorks are insightful. In 2012, Mt. Auburn Associates issued a full public policy report accessing the advocacy efforts during the 2012 legislative session. Pulling takeways from that report, here's how to get your workforce solutions passed.

Background

The advocacy arm of SkillWorks operates primarily through the Workforce Solutions Group (WSG), a collaborative of workforce development agencies and policy think tanks. In 2010, after the release of a report called Massachusetts' Forgotten Middle-Skill Jobs, SkillWorks and WSG began a two-year campaign for the passage of a new "Middle-Skills Solutions Act."

The Middle-Skills Solutions Act would establish a middle-skills council that would advise on how to increase the readiness and success of working adults to help them acquire middle-skill jobs. The Act would also establish Regional Skills Academies that would address skill gaps identified by regional employers. And finally, the Act would require the regular reporting of local and regional labor market data in order to ascertain which sectors should be targeted for workforce training. The bill asked for \$8 million in annual support to fund the Regional Skills Academies. Funding would be administered through the preexisting Workforce Competitive Trust Fund (WCTF).

Middle-skill jobs are particularly important in Massachusetts, where there is a thriving economy but where most jobs require more than basic skills. Estimates suggest that between 2010 and 2016, there would be nearly 400,000 job openings in Massachusetts that require less than a bachelor's degree. Governor Deval Patrick reiterated this in his January 2012 State of the Commonwealth Address: Many [of the state's job] openings are for so-called middle-skills jobs that require more than a high school diploma, but not necessarily a four-year degree – jobs in medical device manufacturing, or as lab technicians, or solar installers, for example."

Getting on the Agenda

As most policy advocates known, legislators are always grappling with various agendas. This is why the industry for lobbyists has grown so large.

How to Get Your Workforce Bill Passed

In order to make workforce training a priority, SkillWorks and the WSG had to find an in-road.

Initial support for the Middle Skills Solutions Act appeared strong. The Labor and Workforce Committee seemed to support the bill. The governor even included \$5 million worth of funding for the WCTF in his budget. However, at the time, competing interests included healthcare reform, teacher evaluations, and job creation.

Rather than setting their agenda aside, they decided to attach their bill to the Jobs agenda. The House was drafting a Jobs Bill, which included \$10 million for WCTF funding. The Senate's Job Bills slated \$5 million for the WCTF. Naturally, SkillWorks and WSG would have preferred the \$10 million in funding, but they decided to be practical: the Senate's version was much more likely to be passed. \$5 million was much better than nothing. In turn, they attached their Middle-Skills Solutions Act to the Senate's Jobs Bill and then lobbied hard for its passage.

By the time the Jobs Bill had gone through multiple revisions, it included \$5 million in direct appropriations from the general fund for WCTF and included many of the provisions of the Middle-Skills Solutions Act, including the establishment of new career centers. On August 8, 2012, the Governor signed the Economic Development and Jobs Bill (H4352).

Tactics to Gain Support

- · Identify a few key legislatures who are influential and will lobby internally for your cause. SkillWorks and WSG found champions who were able to push the proposal through the legislative channels. These legislators also told SkillWorks and WSG who to contact and prod when things looked to be tying up in commit-
- Data, policy reports and op-eds were incredibly useful in shaping the debate around workforce development. The 2010 middle-skill jobs report pointed to the stark reality that even as job growth in Massachusetts was steady, there were too few people trained to meet the employers' needs. Garnering media attention helped to generate broad interest in the issue.
- Help individuals tell their stories. Legislators were most responsive when contacted by their constituents about how this policy issue directly impacted them. As one legislator put it, "When a business says, "I can hire six people today but can't find the six people to put in those jobs,' that's a serious problem." No legislature wants to appear unfriendly to the business community. For those sponsoring the legislation, it was critical to increase the advocacy and engagement of the business community.

• Focus on success, not receiving credit. SkillWorks and WSG worked tirelessly behind the scenes to nurture relationships and keep workforce development on the agenda. To this day, few - including policymakers - know who was behind the increased funding for the WCTF, and that's okay. In the end, SkillWorks and WSG were more concerned with making this a collaborative effort than receiving recognition for its success.

Of course, timing is everything. Had the nation not been in the midst of recession, adopting the Middle-Skills Solution Act through would have been more challenging. Given the weakened economy, jobs were at the forefront of everyone's mind, which offered a prime opportunity for SkillWorks and WSG to coordinate like organizations and push their agenda through an open
