

## New Recreational Opportunities Available at Candlestick Point State Recreation Area



Candlestick Point State Recreation Area (Candlestick Point), California State Parks Director Lisa Mangat, Literacy for Environmental Justice (LEJ) Executive Director Patrick Marley Rump, Assemblymember David Chiu and a number of partners celebrated new recreational opportunities at Candlestick Point. Starting October 1, outdoor enthusiasts can begin enjoying the panoramic views of the San Francisco Bay, the East Bay Hills and San Bruno Mountain from six new campsites located at the Sunrise Point, within Candlestick Point. Trail enhancements will provide ADA travel to the new campsites. In addition, for the first time in 20 years, new interpretive panels telling the story of how people's actions have shaped the shoreline will be displayed.

"California State Parks is proud to work with Literacy for Environmental Justice to offer these new recreational opportunities for families to create lasting memories at Candlestick Point," said Lisa Mangat, California State Parks Director. "Our partnership and the new hiking and camping opportunities at Candlestick Point State Recreation Area will result

in long-term park stewardship and make parks relevant to a much broader audience."

The new campgrounds are the first step in a multi-phase plan to enhance Candlestick Point, which is one of two state park units developed to bring park values into the urban setting.

California State Parks works with LEJ on maintaining the state recreation area. Over the last three years, LEJ and their volunteers have provided critical support in restoring this urban park with native plants.

"The improvements to Candlestick Point State Recreation Area will increase environmental health and strengthen community in Bayview Hunters Point," said Patrick Marley Rump, Executive Director at Literacy for Environmental Justice. "We are excited to continue our work with California State Parks and build community pride, ownership, and stewardship of Candlestick Point, our cherished Southeast San Francisco natural resource."

In addition to LEJ, the Candlestick project is supported by a broad coalition of community groups, as well as environmental and civic leaders, including the San Francisco Parks Alliance, Strategic Growth Council, SF Environ-

ment, Donna Plunkett of PracticeNature, and the San Francisco Bay Conservation and Development Commission.

Located on the western shoreline of the San Francisco Bay, Candlestick Point provides a variety of recreational opportunities from windsurfing, fishing, bird watching and walking to simply relaxing. The trails, group picnic sites, fishing piers and now new camping sites offer a get-away of open space and outdoor activities at this urban park.

# How certifications can help grow your business?

Certification can significantly help your business gain access to government contracts. Whether you are just starting a business or your company is already established, you can drastically benefit from these “set aside” contracts. There are several government agencies at the local, state or federal level which offer certification.

If your business wants to connect with private-sector buyers, simply contact NMSDC’s (National Minority Supplier Development Council) 24 regional councils. NMSDC will provide you with a standard application process along with requested verified documents. The council has many corporate members, including Marriott, Google, Shell and IBM, and connects to over 12,000 minority-owned suppliers. If you pass the certification regulations, your business may participate in one of several development programs, the Business Consortium Fund’s Working on Capital Loan Program, and many NMSDC national and regional business opportunity exchanges.

State agencies provide additional information on Minority Owned Business Enterprise and Disadvantage Enterprise. Department of Transportation Disadvantage Business Certification program provides a vehicle for increasing the participation by MBEs in state and local procurement.

**Your minority business may be able to qualify as:**

**How can MBEs participate in the HUB Zone program?**

The HUB (Historically Underutilized Business) Zone Empowerment Contracting Program is statutorily authorized to stimulate economic development and create jobs in urban and rural communities by providing Federal contracting preferences to small businesses.

In order to qualify for participation in the HUB-Zone program, a small business must be located in a “historically underutilized business zone”. A “HUBZone” is an area that is located in a qualified census tract or a qualified “non-metropolitan county.” These areas are defined in the Internal Revenue Code as having a median household income of less than 80 percent of the State median household income or with an unemployment rate of not less than 140 percent of the statewide average, based on US Department of Labor recent data; or lands within the boundaries of federally recognized Indian reservations. Additionally, to qualify as a HUBZone firm, a business must be owned and controlled by one or more US Citizens, and at least 35% of its employees must reside in a HUBZone.

A competitive HUBZone contract can be awarded if the contracting officer has a reasonable expectation that at least two qualified HUBZone small businesses will submit offers and that the contract can be awarded at a fair market price. In rare instances, sole source HUBZone awards are permitted. However, a sole source contract can be

awarded only if two or more qualified HUBZone firms will not likely submit offers and the government estimate will not exceed \$5 million for manufacturing or \$3 million for all other requirements. Also, price evaluation preferences may be given to HUBZone firms submitting offers on requirements to be filled through full and open competition. A firm that is certified both 8(a) and HUBZone may qualify for additional preference points.

Many MBEs have found that they are located in areas designated as HUBZones and many have successfully applied for HUBZone certification. However, many others have been challenged by the HUBZone residential employee requirement. MBDA and our resource partners can provide counseling to MBEs that seek to achieve HUB-Zone status.

**Section 8(a) Business Development Program**

The section 8(a) business development program is statutorily authorized to provide a vehicle through which Federal agencies can make prime contract awards to small businesses owned and controlled by individuals certified as socially and economically disadvantaged. Federal agencies are authorized to set aside specific requirements for competitions limited to 8(a) participants, and sole source awards may be made to participants where their dollar values do not exceed, inclusive of options, \$5 million for manufacturing requirements and \$3 million for all others.

To qualify for the program, a small business must be certified by SBA. By law, certain groups may be presumed to be socially disadvantaged. The legislation specifically refers to the likelihood that African Americans, Hispanic Americans, Asian Pacific Americans, Native Americans, and Subcontinent Asian Americans are socially disadvantaged. Other individuals can be admitted to the program if they show through a “preponderance of the evidence” that they are disadvantaged because of race, ethnicity, gender, physical handicap, or residence in an environment isolated from the mainstream of American society.

In order to meet the economic disadvantage test, all individuals must have a net worth of less than the applicable threshold, excluding the value of the business and personal residence. Successful applicant firms must also meet applicable size standards for small business concerns; be in business for at least two years (absent a waiver), and display a reasonable potential for success.

It is important that MBEs understand the requirement for “potential for success”? If SBA finds that a small MBE lacks that potential, the MBE will not be certified for 8(a) participation, and about half the minority applicants for the 8(a) program are denied certification based on this or economic reasons. The SBA regulations determine the po-

tential for success in terms of:

1. Access to credit and capital, including, but not limited to, access to long-term financing, access to working capital financing and bonding capability;
2. Technical and managerial experience of the applicant concern’s managers, the operating history of the concern, the concern’s record of performance; and
3. Requisite licenses if the concern is engaged in an industry requiring professional licensing.

Once certified, a firm is approved for program participation for nine years following notification of approval, and remains SDB certified for three years following the date of its last annual review.

**What opportunities are available to MBEs who are Veterans?**

Many minority group individuals have served America in the armed forces, and are eligible to take advantage of programs and services for veterans and service-disabled veterans. In 1999, the law expanded the eligibility for certain small business assistance programs, including those administered by SBA, to include veterans, and directed Federal departments and agencies establish and achieve a participation goal of 3% of the total value of all prime contract and sub-contract awards for each fiscal year for small businesses owned and controlled by veterans with service-connected disabilities.

There are no set-aside programs for veterans. There is, however, a 3% Federal prime contract and 3% subcontracting goal for all Federal agencies to achieve that applies to service-disabled veteran-owned small businesses. The 3 % contract goal for Federal agencies applies only to service-disabled veteran-owned businesses, not veteran-owned small businesses. According to the law, a concern owned and controlled by veterans or service-disabled veterans is a small business concern which is at least 51 percent owned by one or more veterans or service-disabled veterans; or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more veterans or service-disabled veterans; and, whose management and daily business operations are controlled by one or more veterans or service-disabled veterans or, in the case of a veteran with permanent and severe disability, the spouse or permanent care-giver of such veteran.

## Gov. Brown Signs Bill to Help Disadvantaged Communities Access Climate Funds

Last night, with climate leaders from around the world, California Gov. Jerry Brown signed first-of-its-kind legislation designed to level the playing field for disadvantaged communities seeking funding for climate change and clean energy projects funded either by California Climate Investments or other sources. Signed along with a group of other climate bills during the Global Climate Action Summit, SB 1072 was authored by Sen. Connie Leyva (D-Chino) and cosponsored by The Greenlining Institute and the Trust for Public Land.

"This bill represents a unique effort to build the capacity of local communities to participate in the clean energy economy," said Greenlining Institute Environmental Equity Manager Emi Wang, who led Greenlining's efforts in support of the bill. "Low-income communities of color that most urgently need the help often struggle to compete with larger, wealthier communities. SB 1072 levels the playing field."

Greenlining Environmental Equity Director Alvaro Sanchez, who has been attending the Global Climate Action Summit, noted, "Leaders from developing nations asked for both investments and capacity-building at the Summit, just like we've been hearing loud and clear in our own backyard. While California has lots of room to improve our fight against climate change, efforts like this can continue our state's global leadership in fighting climate change while working to ensure fair treatment of underresourced communities.

"We want to thank Sen. Leyva as well as Assembly co-authors Eloise Reyes and Lorena Gonzales-Fletcher along with Gov. Jerry Brown for helping to ensure that no part of California is left behind in our transition to a clean energy future."
