### Report: Bay Area Reaches Full Employment

The Bay Area job market is so robust that this region has reached full employment, and California should reach that condition by sometime in the second half of 2016, according to an economist with the UCLA Anderson Forecast, which released a new quarterly report Monday.

Jobless rates that have shrinking and employment gains that have expanded steadily, along with a surging economy, are the primary conditions that are pointing to a full employment picture for the nine-county Bay Area , said Jerry Nickelsburg , senior economist with the UCLA Anderson Forecast.

"The Bay Area is at full employment," Nickelsburg said. "Look at the unemployment rate in Santa Clara County and the San Francisco metro area. Santa Clara County is at around 4 percent, San Mateo County is at 3.3 percent, San Francisco is at 3.6 percent."

Each of the Bay Area 's metro regions have recovered all the jobs they lost during the Great Recession, and some even have set all-time records for employment or are near those peaks.

"The job market in the Bay Area is outstanding," said Scott Anderson , chief economist with San Francisco -based Bank of the West . "The Bay Area employment market is growing much faster than the nation or the state. It's attracting people to the region."

The tech boom is helping to drive the booming economy in the Bay Area .

"The main driver is what we are seeing in Silicon Valley with the growth of the technology sector," Anderson of Bank of the West said. "But this rebound is broader than tech. Health care, leisure and hospitality, retail, construction, and even manufacturing are growing."

Full employment isn't always precisely defined, but the Federal Reserve, the nation's Central Bank , has been using a 5 percent nationwide jobless rate as the target level that defines full employment for the United States , according to Nickelsburg.

"We are very nearly at full employment in California ," Nickelsburg said. "We should be at full employment by mid-2016."

In August, California posted a 6.1 percent unemployment rate, slightly better than the July statewide rate of 6.2 percent.

Despite the improving picture, the pace of job growth is expected to slow in California in the next two years, according to the Anderson Forecast.

California employment will increase 2.7 percent in 2015, but slow to 2.2 percent in 2016 and to 1.4 percent in 2017, the forecast stated.

The state's unemployment rate, now at 6.1 percent, will fall to about 4.8 percent over the next two years, the forecast stated. That would be a similar level to the national jobless rate.

With hiring at a brisk pace and the jobless rate improving, analysts believe employers will be forced to dangle pay raises in front of potential re-

cruits as well as existing workers they seek to retain.

"You tend to have wage pressure when there is full employment," Nickelsburg said.

Economists point out, however, that full employment poses significant challenges.

"Full employment means you have to build more housing," said Stephen Levy, director of the Palo Alto-based Center for Continuing Study of the California Economy.

Job seekers often migrate to seek employment opportunities, Levy said.

"When you reach full employment, and companies are still expanding and hiring people in the Bay Area, you need housing that is near job sites" Levy said. "People will move into the area for the jobs that are here."

#### EPA Adopts Rules to Limit Oil Refineries' Emissions into Neighborhoods



The U.S. Environmental Protection Agency adopted new rules Tuesday intended to clean the air around oil refineries across the nation, including communities near six major refineries in Southern California.

The rules for the first time require refineries to monitor and report levels of benzene, a cancer-causing compound, at the boundaries of their properties and to cut emissions if they are too high.

The rules target about 150 oil refineries across the nation, strengthening standards on storage tanks, coker units, pressure relief devices and flares, which burn off excess gases. The measures are designed to reduce emissions that cause respiratory illness, increase cancer risk and contribute to smog and global warming while making refinery operations more efficient, the EPA said.

Refineries will have to encircle their facilities with one to two dozen canisters that continuously sample the air for benzene, a carcinogen that is considered an indicator of other harmful pollutants.

The so-called fence-line monitoring devices will not provide real-time air quality readings, but if benzene concentrations over time exceed the EPA's limit of 9 micrograms per cubic meter, refiners will have to find the pollution source and fix it.

"This rule creates a kind of neighborhood watch for refinery pollution," EPA Administrator Gina McCarthy said in a conference call with reporters. "Refineries can be held accountable for these fugitive emissions and take actions to stop them."

The EPA was required to issue the long-delayed rules under a court-ordered consent decree with environmentalists and community groups in California , Louisiana and Texas , who sued the agency in 2012 for missing deadlines.

The rules drew praise Tuesday from those groups as bringing health benefits to predominately Latino and African American communities near oil refineries that have long fought for stricter regulations to control pollution, noise and smoke from the sprawling operations.

"Communities should finally start to see reductions in the pollution that refinery flares are releasing around the clock into our air," said Jesse Marquez , who heads the group Coalition for a Safe Environment in the Los Angeles neighborhood of Wilmington , where three major refineries operate. More than 6 million people live within three miles of a refinery, according to the EPA , with mi-

norities nearly twice as likely as the general population to live near the fence line.

In a statement Tuesday, the American Petroleum Institute said refinery air emissions were already at safe levels and have been declining for decades under existing regulations. "Companies have already spent billions of dollars to reduce emissions, and air quality continues to improve as a result of these voluntary programs and existing regulations," said Bob Greco, API's downstream group

While the EPA has made substantial improvements since proposing the new standards last year, the API said, the regulations could cost up to \$1 billion.

The EPA said implementing the rules by 2018 will cost \$283 million, with "no noticeable impact" on the cost of gasoline and other petroleum products. Cutting emissions of air toxins, including benzene, toluene and xylene, by 5,200 tons per year will reduce cancer risks for more than 1.4 million people, the agency said.

The South Coast Air Quality Management District does not currently require monitoring at the fence lines of the Los Angeles Basin's six major oil refineries in El Segundo, Torrance, Carson and Wilmington, spokesman Sam Atwood said.

Southern California activists have long demanded fence-line air monitoring because of the large number of families, schoolchlidren and other sensitive groups that live in close proximity to refineries and their emissions.

"Southern California is one of the few places in the country where you see daycare centers at the fence line and that's why we pushed really hard," said Jane Williams , who heads California Communities Against Toxics, another group that sued the EPA to issue the new standards. "This is a precedent-setting rule that we fought

# **Expand the Indiana Convention Center again?**

Behind-the-scenes whispers of again enlarging the mammoth Indiana Convention Center are turning into open calls, with some local hospitality leaders musing about locations for an expansion they want to see as soon as 2020.

But skeptics warn that Indianapolis should proceed with caution. Convention center space is on the rise nationwide, they say, and the oversupply is forcing some cities to dole out more incentives to snag big conventions and corporate gatherings.

Expansion supporters acknowledge the trends. However, they note that an addition completed in time for 2012 Super Bowl festivities has a sound record of success.

"We almost doubled the space, and we've been able to fill it with meaningful events," said Barney Levengood, executive director of the Indiana Convention Center and Lucas Oil Stadium. "It's very, very encouraging."

The convention center opened in 1972 as part of a strategy to revitalize downtown, and has been expanded four times. It now has 937,000 square feet, including parts of nearby Lucas Oil Stadium.

Ever-larger confabs are signing contracts—in the past couple of years, the venue hosted more than 60,000 each for the GenCon gaming convention and the National Rifle Association.

The convention center generates \$800 million a year in economic impact, according to Visit Indy, the city's convention and tourism marketing arm. In 2014, its 433 meetings, trade shows, conventions and other events generated more than \$32 million in hotel, rental car, and food and beverage taxes and another \$53 million in state sales tax.

Levengood isn't the only one talking expansion. So is Visit Indy President Leonard Hoops.

Indeed, the two say the numbers demonstrate the need for an eventual expansion.

In early 2011, Visit Indy and the city's Capital Improvement Board, which owns the convention center, raised the curtain on a \$275 million, 400,000-square-foot expansion.

Combined with the 2008 opening of the adjacent Lucas Oil Stadium, the expansion rocketed the center from 32nd largest in the nation to 16th.

Trepidation about filling the center coming out of the Great Recession has given way to confidence as the economy grows.
